### PETROLEUM PRODUCTS PRICING ACT 1983

#### PETROLEUM PRODUCTS PRICING (MAXIMUM PRICES FOR MOTOR FUEL) AMENDMENT ORDER (No. 6) 1989

MADE by the Prices Commissioner under section 12.

#### Citation

1. This order may be cited as the *Petroleum Products Pricing (Maximum Prices for Motor Fuel) Amendment Order (No. 6) 1989*.

#### Commencement

2. This order shall take effect on 18 April 1989.

#### Interpretation

3. In this order—

“the principal order” means the *Petroleum Products Pricing (Maximum Prices for Motor Fuel) Order 1984\**.
