## HOUSING LOAN GUARANTEE ACT 1957

## HOUSING LOAN GUARANTEE (APPROVED HOUSING SCHEME) ORDER 1989

MADE by His Excellency the Governor in Executive Council under section 7C.

**Citation**

1. This order may be cited as the *Housing Loan Guarantee (Approved Housing Scheme) Order 1989*.

**Commencement**

2. This order shall come into operation on the day on which it is published in the *Government Gazette*.

**Home Buyer Guarantee Scheme**

3. The housing scheme in the Schedule to this order is an approved housing scheme for the purposes of the Act.

## SCHEDULE

*Home Buyer Guarantee Scheme***Purpose of the scheme**

1. The purpose of the Home Buyer Guarantee Scheme is to—
  - (a) enable an applicant with an eligible housing loan from an approved lending institution to maintain repayments at a constant level for periods of 3 years irrespective of interest rate fluctuations during the term of the loan;
  - (b) indemnify an approved lending institution for any loss arising from deferred interest payments attributable to the scheme with respect to—
    - (i) a forced sale of the mortgaged property due to default by the applicant; and
    - (ii) the part of the capitalised interest (if any) which is outstanding after the maximum limit on the term of the loan has been reached;
  - and
  - (c) provide stamp duty concessions.

**Eligibility of applicant**

2. To be eligible under this scheme the applicant shall declare in a manner satisfactory to the Minister that the applicant intends—

- (a) to use the house the subject of the application as his or her principal residence; and
- (b) to occupy the house with his or her spouse and dependants (if any).

**Eligibility of loan**

3. To be eligible under this scheme the loan shall be—
  - (a) a *credit foncier* loan; and
  - (b) obtained from an approved lending institution.

**Maximum value of the loan**

4. The maximum value of the loan shall not exceed \$100 000 or such other amount as is fixed under section 7B of the Act by the Minister in relation to the area in which the house is or will be situated.

**Certain loans are not eligible**

5. A loan—
- (a) approved under the Deferred Repayment Scheme or any other scheme which is subject to a guarantee or indemnity by the Treasurer; or
  - (b) which has 3 years or less in the term of the loan, shall not be eligible under this scheme.

**Repayments**

6. (1) Subject to subclause (2) repayments by the applicant shall be reviewed within 3 months of the third and each succeeding third anniversary of the Home Buyer Guarantee Scheme and shall be, unless otherwise agreed by the Treasurer, the greater of—

- (a) an amount equal to 27.5% of the applicant's gross income at the time of review;
- (b) an amount equal to the proportion of the amount of the repayment to the gross income of the applicant when the loan was approved; or
- (c) the repayment being made at time of review increased by an amount equal to movements in the Award Rates of Pay Index over the preceding 36 months or by such other index as may be nominated by the Treasurer.

(2) Notwithstanding subclause (1) the repayment level at time of review shall not be required to be set at a level beyond the level of repayment needed to amortise the balance of the loan outstanding over the original term of the loan at the interest rate charged on the loan at the date of review.

(3) Where an amount is outstanding at the end of the term of the loan, that term shall be extended to the total maximum period of 30 years unless otherwise agreed to by the Treasurer.

(4) Where the outstanding amount of the loan, including arrears, exceeds 90% of the original value of the property the approved lending institution shall report at the end of each period of 12 months from the commencement of the indemnity—

- (a) details of the loan including—
  - (i) property details;
  - (ii) maturity;
  - (iii) the amount at deferment; and
  - (iv) interest rate at deferment;
- (b) the current outstanding balance of the loan;
- (c) the amount of arrears;
- (d) the actual interest rate charged on the loan;
- (e) the actual repayments being made;
- (f) the normal repayment required to redeem the loan over the balance of the term at actual interest rates (notional); and
- (g) the accumulated amount of capitalised interest arising from the deferment of interest payments.

**Forced sale of a home**

7. (1) A reserve price system shall be adopted for the sale of property referred to in clause 1 (b).

(2) Any sale of property will be at a fair and reasonable market price to the satisfaction of the Treasurer.

**Reimbursement of stamp duty charges**

8. (1) The Scheme shall apply to all approved lending institutions which as a general policy fix the level of housing mortgage repayments on the basis of a 3 year cycle for its borrowers.

(2) Stamp duty relief will apply where the Treasurer is satisfied that the lending institution complies with subclause (1).

(3) A lending institution is not required to comply with clauses 6 and 7 unless the protection of the indemnity by the Treasurer is sought but may still claim reimbursement of stamp duty charges where the institution complies with subclause (1).

(4) Where the protection of the indemnity is required the Treasurer will require written notification that the lending institution intends to participate in this aspect of the Scheme.

(5) Stamp duty charges will be reimbursed to the applicant on the refinancing of housing loans, at the same or a lesser principal amount before and up to the original term of the mortgage, from a non-participating financial institution to one which offers the scheme.

(6) Stamp duty charges will be reimbursed on the refinancing of a housing loan from an institution with higher interest rates to one with lower interest rates for housing, where the difference in these interest rates is at least 0.25% as assessed on a standard basis accepted by the Treasurer.

**Duration of the scheme**

9. (1) The scheme applies to all existing loans and to those entered into over the next 3 years.

(2) In relation to—

- (a) existing loans, the 3 year period shall run from the date of approval to a request to participate in the scheme; and
- (b) new loans, the 3 year period, shall run from the date of settlement of each loan account.

6. Adequate provision for on-site effluent disposal to be made in accordance with the standards and requirements of the Council. On-site effluent disposal systems should be separated by at least 100 metres from any permanent watercourse.
7. A reticulated water supply from the Water Authority of Western Australia network shall be provided to each lot.
8. One residential dwelling house only shall be permitted on each lot.
9. Council may grant approval for a "home occupation".
10. All other users are not permitted in accordance with Clause 3.4 Table No. 1.
11. (a) All trees with a trunk girth of 500 mm or greater, measured 1 metre above natural ground level, shall be retained unless their removal is authorised by Council.  
(b) All Christmas trees, Salmon White Gums and Butter Gums are to be protected and Council may vary setback and firebreak requirements in order to preserve such trees.  
(c) For trees and saplings which have to be removed to make way for regulation fire breaks, house driveways and housing constructions, the written consent of the Council is deemed to have been granted.
12. An easement is to be granted to the Water Authority of Western Australia for the purpose of protecting services to the summit water tanks.
13. No vehicular access from lots adjacent to Walters Road shall be permitted to Walters Road.

TOWN PLANNING PROVISIONS—SPECIAL RURAL ZONE AMENDMENT No. 50

Byford Hills

1. In addition to a building licence, the Council's prior approval to commence development is required for all developments. Submission of M.R.S. Form 1 is required.

2. (a) Within the Special Rural Zone Area, the following uses are permitted (P) Dwelling House, Public Recreation.

Not more than one private Dwelling House shall be erected on each lot. No Dwelling House shall be constructed having an external floor area of less than 110 square metres

or constructed of materials the nature, colour or texture of which is in the opinion of Council undesirable for the locality.

- (b) The following uses are not permitted unless special approval is given by Council (SP)—Home Occupation.
- (c) The following uses are not permitted unless approval is given by Council (AA) Rural Use, Stables.
- (d) All other uses not mentioned under (a), (b) and (c) are not permitted (X).

3. The breeding or keeping of animals for commercial gain shall not be permitted without the express approval of Council.

No horses or goats should be permitted on areas other than the upper plateau surface (Dwellingup and Yaragil units).

The keeping of animals to be restricted to the Department of Agriculture's general carrying capacity recommendation of four dry sheep equivalent per hectare.

4. Intensive Agricultural pursuits for commercial gain shall not be permitted without the express approval of Council.

5. (a) Prior to final clearance of survey diagrams, the developer will define building envelopes for selected lots to Council's satisfaction and no building dwelling or out-building shall be constructed outside the area defined by the building envelope. Particular attention will be paid to buildings towards the edge of the Scarp. The Council may vary the location or boundaries of a building envelope in any particular case if it is of the opinion that the variation is desirable for the purpose of—

- (i) securing or enhancing the amenity of the area;
- (ii) conserving the natural beauties of the area.

(b) Where Council determines that the definition of a building envelope is not necessary, the following setbacks will apply:

Front—20 m  
Sides and rear—15 m

(c) The coverage of each individual lot by buildings shall not exceed 3% of the area of that lot.

6. Prior to the occupation of any dwelling house within the Special Rural Zone, it shall either be connected to a water storage tank with a minimum capacity of 92 000 litres or to an alternative source of water that meets Council requirements. Within areas of the site where ground water is unlikely to be obtained, each lot shall have access to an alternative water supply source to the Council's satisfaction.

7. (a) All trees with a trunk girth of 500 mm or greater, measured 1 metre above natural ground level, shall be retained unless their removal is authorised by Council.

(b) No tree or sapling over 3 m high shall be removed from outside the defined building envelope on each lot within the Special Rural Zone area without the prior written consent of the Council.

(c) For trees and saplings which have to be removed to make way for regulation fire breaks, house driveways and housing constructions, the written consent of the Council is deemed to have been granted.

(c) All Christmas trees, Salmon White Gums and Butter Gums are to be protected and Council may vary setback and firebreak requirements in order to preserve such trees.

8. New roads within the Special Rural Zone shall be constructed to the Council's rural road standards with bitumen sealed pavement and gravel shoulders where necessary. The Council may, from time to time, modify its specifications if it is of the opinion that such a modification will contribute to the achievement of the objectives of the purpose and intent of the zone and will be in accordance with sound engineering practice.

9. The area to be reserved for "Parks and Recreation" in the MRS will be defined by survey and set aside as a single lot to be transferred to the State Planning Commission at the time of the finalisation of the first subdivision approval.

10. Strategic fire breaks will be identified upon survey and will be constructed by the subdivider. The fire break will be a minimum width of six metres with a four metre formed surface. Wherever practicable, they will be reserved as public ROW's vested in the Shire. The fire break shall be kept open at all times in a manner suitable for access by vehicles during emergency situations. Strategic fire breaks within private property will be incorporated as easements with public right of carriageway.

11. Water supply for bush fire fighting purposes shall be provided at the cost of the subdivider to the satisfaction of Council and the Bush Fires Board.

12. The subdivider will provide an escape access for motor vehicles from the property through Lot 1 to Admiral Road and that shall be protected by an easement to Council.

13. Maintenance of strategic fire breaks to the satisfaction of Council and other fire prevention measures subsequently required by Council will be at the cost of land owners in proportion to their landholdings to the whole.

14. Adequate provision for on site effluent disposal to be made in accordance with the standards and requirements of Council. On-site effluent disposal systems should be separated by at least 100 metres from any permanent water-course.

15. Subdivision of the Special Rural Zone will generally be in accordance with the approved structure plan, but with the approval of the State Planning Commission, may be modified. Average lot size is not to be less than 2 hectares.

16. Watercourses flowing through private property shall not be dammed or otherwise have their natural flow altered or impeded without the approval of Council. A caveat to this effect will be placed on the appropriate Certificates of Title.

17. The community use site is to be transferred on final subdivision approval of the appropriate stage of development to Council with a caveat on the Title to ensure its use for recreation purposes.

18. The minimum standard of fencing within the Special Rural Zone area shall be 1.4 metre post and four strand wire. Except with the approval of Council, no fence within the special rural zone shall be constructed of asbestos, metal sheeting or wooden pickets.

19. Quarries will be rehabilitated to the satisfaction of Council.

20. To avoid problems of erosion, provision for drainage management will be required to the satisfaction of Council.

21. Every application for a building licence shall be accompanied with a certificate from a suitably qualified engineer advising that:

- (a) An assessment of the ground on which the structure is to be erected has been carried out; and
- (b) The foundation design for the structure is adequate.

22. A copy of the relevant provisions of the Special Rural Zone are to be made known to intending purchasers prior to transfer.

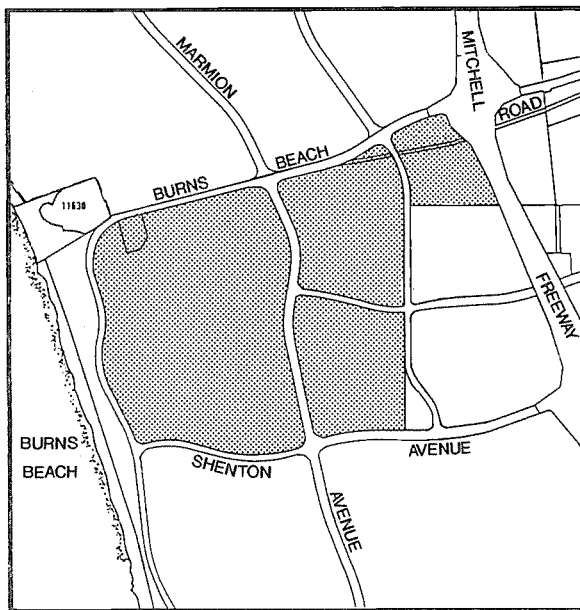

Report of the Auditor

A. Financial Statements

(i) We have audited the accompanying accounts of the Shire of Yilgarn comprising schedules 1 to 16 and 20 to 25 for the year ended 30 June, 1988, in accordance with the requirements of the Local Government Audit Directions and Australian Auditing Standards.

In preparing its financial statements it is not the policy of the Council to fully adopt the accrual method of accounting and to include in its balance sheet all accrued assets and liabilities. This policy does not comply with the Local Government Act and Accounting Directions, and is not in accordance with generally accepted accounting standards. The policy is consistent with the previous year.

(ii) In our opinion, except for the matter referred to in the preceding paragraph, the accompanying accounts are drawn up in accordance with the books of the Council, and fairly present the requirements of the Local Government Act and the Local Government Accounting Directions which are to be dealt with in preparing the accounts.

## B. Statutory Compliance

Our audit review indicated that the following provisions of the Local Government Accounting Directions were not complied with—

- 2.4 (Amended) Council did not adopt a formal policy on depreciation as required, and did not disclose the policy by way of note to the annual financial statements.
- 7.1 The transfer to plant reserve in the year exceeded the amount set aside in the budget, and was not separately authorised by Council.
- 17.1 Suppliers' invoices were not certified as to goods and services being duly received.
- 17.3 Suppliers' invoices were not certified as to prices and computations being correct.
- 17.6 Vouchers for payment were not dated as required.
- 17.7 Alternative provisions in respect of the certifying of vouchers were not adopted by Council.
- 17.7 Schedules of accounts for payment were not certified in the form laid down.
- 22.0 Invoices were not adequately cancelled once paid.
- 27.2 Consecutively numbered invoices for goods and services supplied were not in use.
- 42.4 Invoices for stores and materials were not certified as to goods being duly received.
- 43.2 A detailed report as to plant and equipment usage during the year was not prepared.
- 47.1 Corrections to the books of accounts should not be made by the use of correcting fluids.
- 51.1 The annual financial statements were not completed by the required date, or by the time of the audit visit.

With the exception of the abovementioned matters, and subject to our management report, we did not during the course of our audit become aware of any instances where the Council did not comply with the statutory requirements of the Local Government Act and the Local Government Accounting Directions.

The Agriculture Protection Board having declared Red-capped Parrots or WA King Parrots (*Purpureicephalus spurius*), Port Lincoln Ringnecks or Twenty-eight Parrots (*Barnardiuszonarius*), Western Rosella (*Platycercus icterotis*), Galahs (*Cacatua roseicapilla*), Little Corellas (*Cacatua pastinatorgymnotis*), Wedge-tailed Eagles (*Aquila audax*), Baudin's or Long-billed White-tailed Black-Cockatoos (*Calyptorhynchus baudinii*), Agile Wallabies (*Macropus agilis*) and Long-haired Rat (*Rattus villosissimus*) to be declared animals under Section 35 of the Agriculture & Related Resources Protection Act, 1976 and assigned them to Category A7 under Section 36 of that Act, has now in accordance with Section 66 (1) of the said Act approved the programmes set out herebelow for the management and regulation of those animals and in accordance with Section 66 (2) of the Act for the areas specified.

#### MANAGEMENT PROGRAMME FOR RED-CAPPED PARROTS OR WA KING PARROTS, PORT LINCOLN RINGNECKS OR TWENTY-EIGHT PARROTS AND WESTERN ROSELLAS

1. Red-capped Parrots or WA King Parrots and Port Lincoln Ringnecks or Twenty-eight Parrots may be taken in the Municipal districts of the Shires of Bridgetown, Capel, Chittering, Donnybrook-Balingup, Harvey, Kalamunda, Manjimup, Murray, Mundaring, Plantagenet, Serpentine-Jarrahdale, Swan and the Town of Armadale only if they are causing damage to production of cultivated fruits.  
 Western Rosellas may be taken in the Municipal districts of the Shires of Bridgetown, Capel, Donnybrook-Balingup, Manjimup, Serpentine-Jarrahdale only if they are causing damage to production of cultivated fruits.
2. The Minister for Conservation and Land Management may from time to time declare an "open season" on such animals during which time such animals may be taken by landholders on their properties without a permit.
3. If an "open season" is not current then no person shall take or attempt to take such animals without first obtaining a damage permit from the Department of Conservation and Land Management.

4. A person shall not take or attempt to take such animals by any other means than a firearm licensed under the Firearms Act, unless authorization has been obtained from the Department of Conservation and Land Management.

**MANAGEMENT PROGRAMME FOR GALAHS,  
LITTLE CORELLAS AND WEDGE-TAILED EAGLES**

1. Galahs, Little Corellas and Wedge-tailed Eagles may be taken in the whole of the State only if they are causing damage to agriculture or pastoral production.
2. No person shall take or attempt to take such animals without first obtaining a damage permit from the Department of Conservation and Land Management.
3. A person shall not take or attempt to take such animals by any means other than a firearm licensed under the Firearms Act, unless authorization has been obtained from the Department of Conservation and Land Management.

**MANAGEMENT PROGRAMME FOR BAUDIN'S OR  
LONG-BILLED WHITE-TAILED BLACK-COCKATOO**

1. Baudin's or Long-billed White-tailed Black-Cockatoo may be taken in Zones 4, 5, 6, 8 and 10 as constituted under Section 13 of the A.R.R.P. Act only if they are causing damage to production of cultivated fruits.
2. No person shall take or attempt to take such animals without first obtaining a damage permit from the Department of Conservation and Land Management.
3. A person shall not take or attempt to take such animal by any other means than a firearm licensed under the Firearms Act, unless authorization has been obtained from the Department of Conservation and Land Management.

**MANAGEMENT PROGRAMME FOR AGILE  
WALLABIES**

1. Agile Wallabies may be taken in the Municipal districts of the Shires of Wyndham-East Kimberley, West Kimberley, Halls Creek and Broome only if they are causing damage to agriculture or pastoral production.
2. No person shall take or attempt to take such animals without first obtaining a damage permit from the Department of Conservation and Land Management.
3. A person shall not attempt to take such animal by any means other than a firearm licensed under the Firearms Act, unless authorization has been obtained from the Department of Conservation and Land Management.

**MANAGEMENT PROGRAMME FOR LONG-HAIRED  
RAT**

1. The Long-haired Rat may be subject to control measures within the Shire of Wyndham/East Kimberley only if the populations of the rat are causing or are likely to cause damage to crops in irrigation areas.
2. The Agriculture Protection Board will monitor populations within the Ord River Irrigation Areas monthly, by live-trapping, during the period when rat numbers are likely to increase dramatically (December to May).

3. When control is considered necessary, the Agriculture Protection Board will liaise with the Department of Conservation and Land Management to determine the control measures to be taken.
