#### HOUSING LOAN GUARANTEE ACT 1957

Declaration Under and Pursuant to Section Seven F of the Housing Loan Guarantee Act 1957

I, THE Honourable David Parker, M.L.A., the Treasurer, have been requested under the provisions of section seven F of the Housing Loan Guarantee Act 1957 (in this notice called "the Act") to do so, do by this notice declare the following matters, that is to say—

- (a) the maximum amount which the Treasurer may guarantee under the Act during the period commencing the 19th May, 1958, and ending the 30th June 1990, is the sum of one hundred and fifteen million dollars (\$115 000 000);
- (b) the maximum amount in respect of which agreements for the indemnity may be entered into by the Treasurer during the period commencing the 1st January, 1962 and ending the 30th June, 1990 is the sum of one hundred and fifty million dollars (\$150 000 000);
- (c) the maximum rate of interest which an approved institution may charge on a loan to a borrower or on the purchase money to a purchaser in respect of any period whilst an agreement for indemnity is in force in respect of the loan or purchase money, is seventeen and one quarter per centum (17.25 per annum); and
- (d) for the purposes of Section Seven B of the Act the maximum amount which an approved institution shall advance to a borrower on the giving of a first mortgage of a new house or the maximum amount of the purchase moneys which an approved institution shall permit to remain payable under a contract for sale and purchase of a new house before an indemnity is given by the Treasurer under the Act, is seventy per centum (70%) of the value of a new house as defined in the Act.

**FAMILY COURT ACT 1975****FAMILY COURT OF WESTERN AUSTRALIA AMENDMENT REGULATIONS 1989**

MADE by His Excellency the Lieutenant Governor and Administrator in Executive Council.

**Citation**1. These regulations may be cited as the *Family Court of Western Australia Amendment Regulations 1989*.**Commencement**2. These regulations shall come into operation on the day fixed by proclamation under section 3 (1) of the *Family Court Amendment Act 1988*.**Principal regulations**3. In these regulations the *Family Court of Western Australia Regulations 1988\** are referred to as the principal regulations.

**Regulation 7 amended**

4. Regulation 7 of the principal regulations is amended by repealing subregulation (3).

**Part IIA inserted**

5. The principal regulations are amended by inserting after Part II the following Part—

“ Part IIA—Determination of Parentage:  
Medical Procedures and Reports

**Interpretation in Part IIA**

8A. In this Part, unless the contrary intention appears—

- “DNA” means deoxyribonucleic acid;
- “donor” means person required to provide a bodily sample of blood for the purposes of a prescribed medical procedure;
- “HLA” means human leucocyte antigen;
- “prescribed medical procedure” means medical procedure prescribed under regulation 8B;
- “sampler” means person taking a bodily sample of blood from a donor for the purposes of a prescribed medical procedure;
- “testing” means implementation, or part of the implementation, of a prescribed medical procedure.

**Prescribed medical procedures**

8B. For the purposes of definition of “parentage testing procedure” in section 4 of the Act, the following medical procedures are prescribed—

- (a) red cell antigen blood grouping;
- (b) red cell enzyme blood grouping;
- (c) HLA tissue typing;
- (d) serum markers;
- (e) DNA typing.

**Collection of blood samples**

8C. (1) When blood is collected from a donor for the purpose of a prescribed medical procedure, the sampler shall ensure that—

- (a) all needles and syringes to be used in relation to withdrawal of the blood for collection have not been previously used, have been sterilized and are disposable;
- (b) the area of the skin of the donor where, in relation to the withdrawal referred to in paragraph (a), a needle is to be inserted has been cleaned with an antiseptic;
- (c) the container to be used for storing the blood has not previously been used;
- (d) the container referred to in paragraph (c) is so labelled that—
  - (i) if the label or any part of the label were removed; or
  - (ii) if any writing inscribed in ink on the label were to be altered or erased, the removal or impairment of the label would be evident on inspection;
- (e) the following particulars are inscribed in ink on the label referred to in paragraph (d)—
  - (i) the full name of the donor;
  - (ii) the date of birth and sex of the donor;
  - (iii) the date and time when the blood sample was taken;
  - (iv) the signature of the sampler;
- (f) the blood is placed in a container labelled and inscribed in accordance with this regulation in the presence of the donor;
- (g) on the completion of the procedure specified in paragraph (f), the donor signs his or her name in ink on the label referred to in paragraph (d); and
- (h) the container referred to in paragraph (c) is so sealed that, if it were opened after being sealed, that fact would be evident on inspection.

(2) If the donor is a child under the age of 18 years or a person suffering from a mental disability, the procedure specified in subregulation (1) (f) is to be completed in the presence of, and the procedure specified in subregulation (1) (g) is to be completed by—

- (a) in the case of that child, a guardian of that child; or
- (b) in the case of the person suffering from a mental disability—
  - (i) a trustee or manager in relation to that person under the law of a State or Territory; or
  - (ii) a person having responsibility for the care of that person.

#### **Storage and testing requirements**

8D. (1) If—

- (a) blood is collected for the purposes of a prescribed medical procedure; and
- (b) testing related to the prescribed medical procedure referred to in paragraph (a) is to be carried out at a place other than the place where the blood referred to in that paragraph is collected,  
the container containing that blood shall be packed—
  - (c) if the proposed prescribed medical procedure is red cell antigen blood grouping that is not to be carried out within 24 hours of the blood having been collected, in an insulated package containing an ice pack or other device enabling the blood to be held at a temperature of approximately 5° Celsius throughout transportation to the place of testing;
  - (d) if the proposed prescribed medical procedure is red cell enzyme blood grouping, HLA tissue typing, serum markers of DNA typing, in an insulated package enabling the container to be transported at ground level temperature and atmospheric conditions to the place of testing; or
  - (e) if the proposed prescribed medical procedure is red cell antigen blood grouping that is to be carried out within 24 hours of the blood having been collected, in accordance with the method of packing specified in either paragraph (c) or (d).

(2) The sampler shall ensure that blood collected in accordance with this Part is available for testing at the place where testing is to be carried out—

- (a) if the testing relates to any of the prescribed medical procedures red cell antigen blood grouping, red cell enzyme blood grouping or serum markers, not later than 3 days after the collection of the blood; or
- (b) if the testing relates to the prescribed medical procedure HLA tissue typing or DNA typing, not later than 24 hours after the collection of the blood.

(3) There shall be forwarded to the place of testing, together with the insulated package referred to in subregulation (1), forms completed in accordance with each of Forms 1 and 2 in the Schedule.

(4) For the purpose of the completion of Form 1 in the Schedule, when blood is collected from a donor—

- (a) the donor shall—
  - (i) provide to the sampler a recent photograph of the donor measuring approximately 45 millimetres by 35 millimetres, full face view of head and shoulders and with plain background; or
  - (ii) make arrangements with the sampler for a photograph of the kind referred to in paragraph (a) to be taken;

and

- (b) the sampler shall affix the photograph referred to in paragraph (a) to that Form and sign his or her name partly on that photograph and partly on that Form in such a manner that, if that photograph were removed from that Form at any time after the sampler had so signed, that removal would be evident from inspection of that Form.

#### **Provision of information by donors**

8E. (1) Subject to this regulation, a donor shall, before blood is withdrawn from his or her body for testing, complete an affidavit in accordance with Form 2 in the schedule.

(2) If the donor is a child under the age of 18 years or a person suffering from a mental disability, the affidavit in accordance with Form 2 in the Schedule is to be completed by—

- (a) in the case of that child, a guardian of that child; or
- (b) in the case of the person suffering from a mental disability—
  - (i) a trustee or manager in relation to that person under the law of a State or Territory; or
  - (ii) a person having responsibility for the care of that person.

#### **Appointment of persons to make reports**

8F. (1) The Attorney General may appoint in writing a person or class of persons, being persons employed at a particular place, to prepare reports under section 82E (9) of the Act.

(2) An instrument of appointment under subregulation (1) shall be published in the *Gazette*.

(3) A report purporting to be made for the purposes of section 82E of the Act by a person other than a person appointed in accordance with this regulation shall be taken not to have been made in accordance with these regulations and may not be received in evidence under section 82E (10) of the Act.

#### **Form of report**

8G. A report under section 82E (9) of the Act shall be in accordance with Form 3 in the Schedule. "

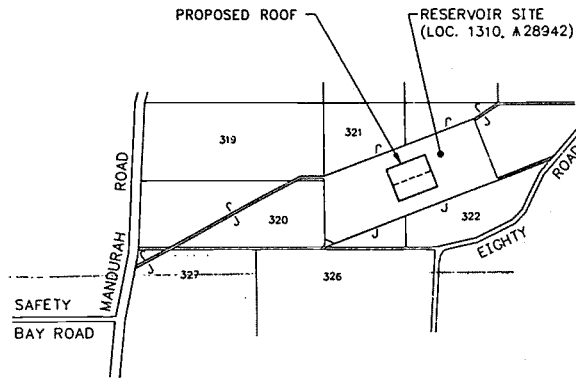

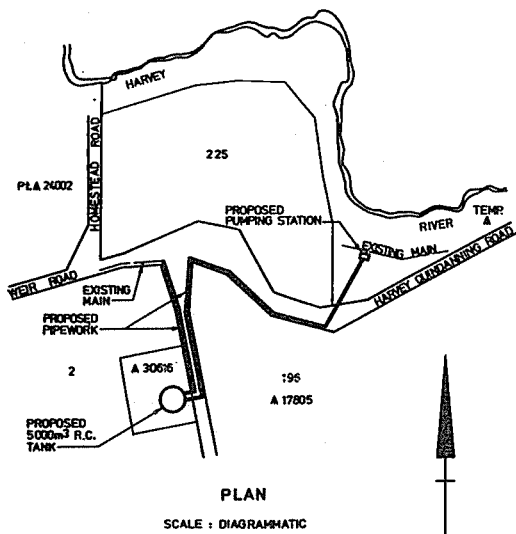

## A. Arrangement of Sections:

## Part IV: Residential Zone Requirements:

1. After "Tables S.R.2, S.R.3, G.R.4, G.R.4R and G.R.5 ... 31", insert "Outbuildings, Garages and Carports ... 31A".

## Part V: General Provisions:

2. Against "Building setback from street alignment, delete "38 to 39", and substitute "38".
3. Following "Building setback from street alignment ... 38", insert "Side/rear setbacks ... 39".
4. Following "Building on adjoining lots ... 45", insert "Land liable to flooding ... 45A".

## B. Clause 6—Interpretations:

1. Detached House—delete the words "outbuildings ordinarily used with such house and".
2. Duplex—amend Part (c) of the interpretation to read as follows:  
(C) is separated from the other unit by a wall conforming with the requirements of the Building Code of Australia; and
3. Frontage—delete the interpretation entirely.
4. Habitable Rooms—Delete existing interpretation, and substitute the following:  
"Habitable Room" means a room (other than a bathroom, laundry, water closet, or the like), that is designed, constructed, or adapted for the activities normally associated with domestic living, and for the purpose—
  - (a) includes a bedroom, living room, lounge room, music room, television room, kitchen, dining room, sewing room, study, playroom, sunroom and the like; and
  - (b) excludes in addition to bathrooms, laundries, water closets and the like, such rooms or spaces as food storage pantries, walk-in-wardrobes, corridors, hallways, lobbies, photographic darkrooms, clothes-drying rooms and other spaces of a specialised nature occupied neither frequently nor for extended periods".

5. Height—delete existing interpretation, and substitute the following:

"Height"—

- (a) in relation to a building means the measurement taken from the permanent footpath level immediately in front of the centre of the face of the building to the level of the top of the eaves, parapet or flat roof whichever is the highest;
- (b) in relation to a storey means the measurement taken from the floor level to—
  - (i) the underside of the ceiling; or
  - (ii) where there is no ceiling, the underside of the construction at the top of the storey;
- (c) in relation to a room means the measurement taken from the floor to—
  - (i) the underside of the ceiling; or
  - (ii) where there is no ceiling, the underside of the construction at the top of the room

except in the case of a room in a Residential Dwelling Unit or Residential Building where the term means the measurement to the underside of the lowest beam or other projection, other than a light fitting, below the ceiling level"

6. Plot Ratio—delete existing interpretation, and substitute the following:

"Plot Ratio" means the ratio of the gross total of the areas of all floors to the area of land within the site boundaries, and in calculating the gross total of the areas of all floors the areas shall be measured over any walls, and—

- (a) in the case of a Detached House or Duplex, include passages, lift shafts, stairs, garages, outbuildings and amenities but not
  - (i) verandahs, or carports attached to dwellings, the sides of which are completely open over not less than a half of their total perimeter; or
  - (ii) free standing carports completely open on all sides;
- (b) in the case of a Residential Building in a residential or residential flat area and Flat buildings, include passages, lobbies, amenities, and access ways, but not lift shafts, stairs, machinery rooms, air-conditioning equipment rooms, non-habitable floor space in basements, areas used exclusively for the parking of wheeled vehicles or open balconies of not more than 2 400 mm in depth, of which the longest open side has no enclosure other than a balustrade of 1 050 mm in height and to which there is no other access other than by way of the tenancy of which it forms an exclusive part; and
- (c) in the case of a Residential Building in other than a residential or residential flat area, do not include lift shafts, stairs, toilets and amenities, external wall thickness, plant rooms and the gross area of any floor space used for the parking of wheeled vehicles including access to and from that space within the building.

7. Quadruplex—amend Part (c) of the interpretation to read as follows:

(c) is separated from the other units by a wall conforming with the requirements of the Building Code of Australia; and

8. Residential Building—delete existing interpretation, and substitute the following:

"Residential Building" means a hostel, boarding or lodging house, residential Club, private hotel or any other building, but not including any other type of building or housing listed elsewhere in the column of use classes in the Zoning Table."

9. Triplex Housing—amend Part (c) of the interpretation to read as follows:

(c) is separated from the other units by a wall conforming with the requirements of the Building Code of Australia; and

10. Uniform Building Bylaws—delete interpretation entirely.

- C. Deletion of Reference to the Uniform Building Bylaws—in the following Clauses, delete the term "Uniform Building Bylaws", and substitute the Term "Building Code of Australia":

Clause 36 (2), Clause 37, Clause 57 (e), Clause 6 of Appendix 4, and Clause 5 of Appendix 5.

## D. New Clauses, and Modifications to Existing Text:

1. Tables S.R.2, S.R.3, G.R.4 and G.R.4R (which follow Clause 31)—under the Column headed "Maximum Plot Ratio", and against Detached House, delete the words "As in Uniform Building Bylaws", and substitute the figure "0.5".
2. Tables S.R.2, S.R.3, G.R.4, G.R.4R and G.R.5 (which follow Clause 31)—add the following footnotes to each of the Tables:

Wherever a minimum distance of a wall from a boundary of the site is provided by the Scheme, that distance shall be measured horizontally from the boundary to the out-most projection from the exterior wall, but where a chimney back, not more than 1 675 mm in width, is projecting, the extent of the projection shall be determined by the horizontal distance by which the projection exceeds 355 mm. This provision shall not preclude the roof of a dwelling unit being set back a distance of not less than 750 mm from a boundary.

Where the floor level of a storey of a building is more than 1 830 mm above the natural ground level at that point, that storey is determined to be a second storey for the purposes of the Scheme.

A Detached House or Duplex may be constructed so that the external walls that face the rear boundary of the site have an average distance of less than 7.5 m from that boundary if the external walls that face another boundary of the site (not being a street boundary) have an average distance of not less than 7.5 m from that other boundary.

Notwithstanding any other provision of clause 31, a wall of a building of unprotected metal or timber framed construction shall not be constructed nearer than 1 200 mm to the side boundary of an allotment not in the same occupancy as the site.

- (a) Subject to paragraph (b), Council may approve the issue of a building licence for the alteration of, or addition to, a Detached House which will result in the provision of two units of accommodation on the site of the building, if—
- (i) where the additional accommodation is added to the existing building, direct internal access is provided from the newly-added part of the building to the original part of the building; or
  - (ii) where the additional accommodation is not itself added to the existing building—
    - (A) there is constructed between the added accommodation and the existing building a fully-enclosed connection; and
    - (B) the total area of the added accommodation and the connection between the added accommodation and the existing building does not exceed 37 m<sup>2</sup>.
- (b) Council may not approve the issue of a building licence pursuant to paragraph (a) unless—
- (i) the Council is satisfied that the additional accommodation for which the building licence is sought is intended for occupation by—
    - (A) a parent or parents of the owner of the building or the spouse of the owner; or
    - (B) a relative of the owner or spouse, and if additional accommodation is intended for occupation by a relative of the owner or his spouse, the Council considers that, in all the circumstances of the case, it would be reasonable to allow the provision of the additional accommodation for the relative;
  - (ii) the owner permanently resides in the existing building; and
  - (iii) the Council is furnished with a statement signed by the owner of the building and each parent or relative of the owner or his spouse for whose occupation the additional accommodation is intended, stating that the additional accommodation is intended for use by that parent, those parents or that relative, as the case may be, and for no other purpose.
- (c) A person shall not knowingly make, either orally or in writing, a false or misleading statement or representation to Council or any member or officer of a Council for the purposes of, or in connection with, the seeking or obtaining the approval of the Council of the issue of a building licence under this provision.
- (d) Subject to paragraph (e), a building licence shall not be issued for the addition to or alteration of a Detached House which will result in the provision on the site on which the building is situated, of two or more units of self-

contained accommodation unless the approval of the issue of the building licence has been given by Council under and in accordance with paragraphs (a) and (b).

- (e) Nothing in this provision applies to or in relation to an addition to or alteration of a Detached House for the purpose of adding additional Dwelling Units in accordance with the above Table.

3. New Clause 31A, and heading—after existing clause 31, insert the following—

31A. Outbuildings, Garages and Carports: The following provisions shall apply to outbuildings in the S.R.2, S.R.3, G.R.4, G.R.4R and G.R.5 zones:

- (1) An outbuilding appurtenant to and detached from a Detached House, Dwelling Unit or Residential Building shall be located a minimum of:
  - (a) 1 800 mm from any building used as a dwelling on the same site;
  - (b) 15 m from the boundary of the street to which the site has its main frontage; and
  - (c) 6 m from any other street to which the site has a frontage, unless especially approved by the Council.
- (2) An outbuilding shall be located at least a minimum distance of 1 000 mm from a side and/or rear boundary of a site, provided that it may be located closer where the outbuilding is:
  - (a) constructed of brick, stone or concrete;
  - (b) has a fire-resistance rating not less than that required by the Building Code of Australia for an internal non-loadbearing wall of the building to which the outbuilding is appurtenant; and
  - (c) carried up as a parapet 375 mm in height above the roof, flat or gutter of the outbuilding, but a boundary wall may be of material other than brick, stone or concrete if it abuts on a right-of-way or lane over which the owner of the outbuilding has rights.
 

A wall of an outbuilding shall not exceed 3 m in height including the height of the parapet but Council may, if the circumstances so warrant, grant special approval for a wall to be of a height in excess 3 m.
- (3) (a) A person shall not without the special approval of Council, construct more than two outbuildings, or an outbuilding exceeding, or outbuildings exceeding in the aggregate, 46.5 m<sup>2</sup> appurtenant to a Detached House or Duplex.
 

(b) The provisions of this subclause do not apply to an area zoned for rural activities.

No outbuilding or part of an outbuilding shall be used as a habitable room without the approval of Council.
- (4) Private garages detached from a Dwelling Unit may only be located closer to a street than the Dwelling Unit where they are constructed of brick. In addition, no part of a garage detached from a Dwelling Unit may be located within 6 m of any street to which the site has frontage, except with the approval of Council.
- (5) A carport may be so located that its supports are on the boundary line if—
  - (a) the supports are—
    - (i) metal columns; or
    - (ii) brick piers not more than 350 mm in width or breadth, of which not more than four are on the boundary line;
  - (b) no part of the roof (other than beams, where these are metal) is nearer to the boundary line than 750 mm; and
  - (c) where the boundary line is a side boundary line, any dividing fence forming a side wall of the carport is not higher than 1 800 mm.

4. New Clause 39, and Heading—after existing clause 38, insert the following:

39. Side/Rear Setbacks: in the case of a site in a commercial or industrial area, a wall of a building of unprotected metal or timber framed construction shall not be constructed nearer to a side or rear boundary than 2 100 mm or a distance equal to the height of the wall, whichever is the greater."

5. Clause 40 (Averaging of Setbacks)—amend to read as follows:

40. Averaging of Setbacks: In any of the residential zones, the setback of a building from a street or rear boundary may be reduced, provided the area contained by that boundary and the building projected on that boundary is not less than would be the case where the minimum setbacks complied with; and provided also that where part of a building is proposed nearer than 6 metres to the street alignment, the consent of the Council to such shall be obtained.

In determining whether external walls have the relevant average setback distance from the site boundary which they face—

- the two most widely separated points on that boundary from which lines can be projected at right angles to meet those walls, shall be determined;
  - the area enclosed by that boundary, lines projected at right angles from the two points referred to in paragraph (a), and those walls, shall be calculated;
  - the area of a rectangle having one dimension of a length equal to the distance between the two points referred to in paragraph (a), and the other dimension of a length of the setback dimension shall be calculated;
  - if the area calculated pursuant to paragraph (b) is equal to the area calculated pursuant to paragraph (c), those walls shall be deemed to have an average setback dimension from that boundary.
6. New Clause 45A, and Heading: after existing clause 45, insert the following:
- 45A. Land Liable to Flooding: a building shall not be constructed upon any land defined by the Council as being liable to flooding or inundation.

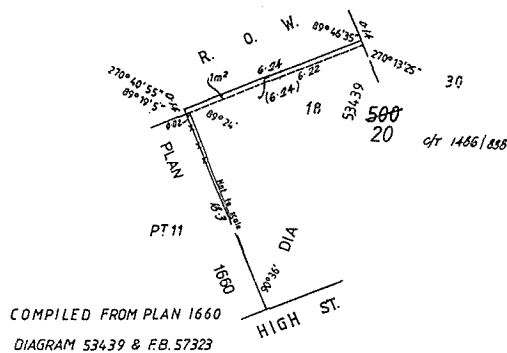

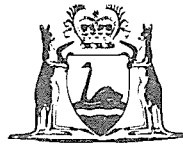
