Swimming Areas

ACTING pursuant to the powers conferred by Regulation 10 (a) and (b) of the Navigable Waters Regulations the Department of Marine and Harbours by this notice amends the gazettal of 30 October 1987, by the addition of paragraph (zb).

Shire of Harvey—Logue Brook Dam

All those waters of the dam as marked by signs on the foreshore 100 metres apart and by buoys in the water 50 metres from the foreshore at the southern end of the saddle embankment, in the north-eastern and south-eastern arms of the dam.

WESTERN AUSTRALIAN MARINE ACT 1982

Water Ski Areas

Department of Marine and Harbours,
Fremantle, 29 November 1989.

ACTING pursuant to section 48 (a) of the Navigable Waters Regulations the Department of Marine and Harbours by this notice cancels paragraphs (zb) (ii) and (z8) of the gazettal published on 30th October 1987, relating to Shire of Harvey, Logue Brook Dam and Shire of Waroona, Waroona Dam, respectively and substitutes the following—

- (ii) Logue Brook Dam: All those waters of the dam commencing from a line drawn 125 metres upstream and parallel with the Dam Head thence extending to the northern end of the saddle embankment, a distance of approximately 2 470 metres. Providing however that skiing is not per-

mitted within 60 metres of the foreshore, or the eastern arms of the dam, except at the three designated ski take off and landing areas which are situated on the south-west and north-west foreshore and on the southern foreshore approximately 840 metres upstream of the Dam Head as indicated by signs on the foreshore and buoys in the water. The rotation of all water skiing on the dam shall be in an anti-clockwise direction.

The boating public and water skiers are further advised that there are numerous submerged and semi submerged tree stumps along the foreshore and they should not approach the shoreline except at the designated ski take off or landing areas.

- (z8) Shire of Waroona—Waroona Dam: All the waters of the dam lying to the north and east of a line drawn 120 metres upstream and parallel with the dam wall to lines marked with buoys and signs 750 metres upstream in the north-east arm and 1 400 metres upstream in the eastern arm. Providing however that skiing is not permitted within 45 metres of the foreshore except at the designated ski take off and landing points as marked by signs on the foreshore in the north-east arm, the eastern arm and in the south-eastern bay.

The rotation of all water skiing on the dam shall be in an anti-clockwise direction.

Restricted Speed Areas—All Vessels

TRANSPORT CO-ORDINATION AMENDMENT REGULATIONS 1989

Citation

1. These regulations may be cited as the *Transport Co-ordination Amendment Regulations 1989*.

Commencement

2. These regulations shall come into operation on the day on which the *Transport Co-ordination Amendment Act 1989* comes into operation.

 - (i) in paragraph (a), by deleting “(aa) (i)” and substituting the following—
“ (c) (i) ”; and
 - (ii) in paragraph (b), by deleting “(aa) (ii) (b) or (c)” and substituting the following—
“ (b) or (c) (ii) ”; and
 - (b) in subregulation (2), by deleting “(aa) (i)” and substituting the following—
“ (c) (i) ”.

Regulation 8A repealed and regulations 8A, 8B and 8C substituted

5. Regulation 8A of the principal regulations is repealed and the following regulations are substituted—

Percentages and amounts prescribed for section 21 (1)

- “ 8A. For the purposes of section 21 (1) of the Act—
- (a) in relation to the fee for an omnibus licence—
 - (i) the prescribed percentage is 6%; and
 - (ii) the prescribed amount is \$20;
 - (b) in relation to the fee for a commercial goods vehicle licence the prescribed amount is \$5;
 - (c) in relation to the fee for an aircraft licence—
 - (i) the prescribed percentage is 6%; and
 - (ii) the prescribed amount is 20 cents;
 - and
 - (d) in relation to the fee for a ferry licence the prescribed amount is \$1.

Amounts prescribed for section 32A (2)

- 8B. For the purposes of section 32A (2) of the Act, the amount prescribed as the maximum fee—
- (a) for the issue of a single number plate, is \$15; and
 - (b) for the issue of a pair of number plates, is \$20.

Amounts prescribed for section 47B (8)

- 8C. For the purposes of section 47B (8) of the Act, the prescribed amount—
- (a) in relation to a licence or the renewal of a licence, is \$50; and
 - (b) in relation to a permit, is 5 cents. ”.

DOG ACT 1976

The Municipality of the Shire of Collie

By-laws Relating to Dogs

IN pursuance of the powers conferred upon it by the abovementioned Act and of all other powers enabling it, the Council of the abovementioned Municipality hereby records having resolved on the twenty eighth day of June 1988, to make and submit for confirmation by The Lieutenant Governor and Administrator following By-laws.

By-laws Relating to Dogs

Revocation

1. The By-laws of the Shire of Collie Relating to Dogs published in the *Government Gazette* on 23rd January 1973 and 26th September 1961, are hereby revoked.

Citation

2. These By-laws may be cited as the Shire of Collie By-laws Relating to Dogs.

Part I—Interpretation

3. In these By-laws, unless the context requires otherwise,

“Act” means the Dog Act 1976 as amended.

“Authorised Person” means a person who is authorised by or under Section 29 of the Dog Act 1976.

“Council” means the Council of the Municipality of the Shire of Collie.

“District” means the district of the Municipality of the Shire of Collie.

“Public Building” means a public building defined in Section 173 of the Health Act 1911 as amended.

“Public Place” means a public place as defined in Section 3(1) of the Dog Act 1976.

“Regulations” means the Dog Act Regulations 1976, as amended.

“Townsite” means a townsite as defined under Section 3(1) of the Dog Act 1976.

All other words and expressions have the same meaning as they have in the Act.

Part II—Impounding Dogs

4. Council may establish and maintain a Pound or Pounds for the impounding of dogs seized pursuant to the provisions of the Act or these By-laws as it deems necessary.

5. Charges in relation to the seizure and maintenance of a dog in accordance with Section 29(4) of the Act, and the fees payable in relation to a dog having been destroyed at the request of its owner are specified in the First Schedule to these By-laws.

6. The Pound or Pounds maintained by Council for the detention of dogs seized shall be attended by an Authorised Person at such times and on such days as determined from time to time by Council.

7. A person liable for the control of a dog, as defined in Section 3(1) of the Act, is not excused from liability under the provisions of the Act, Regulations or these By-Laws by virtue of the payment of fees or charges prescribed therein for the seizure, care, detention or destruction of a dog.

8. Any person applying for the release of a dog seized or impounded shall prove to the satisfaction of an authorised person the ownership of a dog and his authority to take delivery of it. An authorised person may accept such proof as he considers satisfactory and no person shall have any right of action against him or Council in respect of delivery of a dog in good faith.

Part III—Exercise Area

9. The land specified in the Fifth Schedule to these By-laws are designated as Dog Exercise Areas for the purpose of the Act. The exercising of the dogs in dog exercising areas are subject to the provisions of the Act.

Part IV—Restricted Areas

10. Except for a dog—

- (a) being used for guiding a blind person;
- (b) being trained for the purposes of becoming a guide dog for the blind; or
- (c) being used in accordance with Section 8(3) of the Act whereby the Minister has authorised a person to be accompanied by a specified dog,

a person liable for the control of a dog, as defined in Section 3(1) of the Act, shall prevent that dog from entering or being in any of the following places—

- (a) any public building, shopping centre or shopping mall;
- (b) any building construction site; or
- (c) any shop not being a shop where dogs are sold or treated for illness or injury.

Part V—Keeping of Dogs

11. (1) The owner or occupier of premises within a townsite on which a dog is kept shall cause the premises or portion of the premises to be fenced or enclosed in a manner capable of confining the dog in accordance with the provisions of this by-law.

(2) A fence used to confine a dog and every part of such fence shall, having regard to the species, age, size and physical condition of the dog, prevent the dog from passing over, under or through the fence.

(3) Every gate or door within a fence shall have a proper latch or other means of fastening and every such fence, gate or door shall be maintained in good order and condition.

12. The owner or occupier of any premises within the district shall not, unless the premises have been granted exemption under section 26(3) of the Act, keep, permit or suffer to remain thereon more than two dogs over the age of three months, unless such premises are licensed as an approved kennel establishment.

13. A kennel referred to in By-law 12 shall not be erected unless and until plans, specifications and location plan showing the proposed site for such kennel and of the yard appurtenant thereto have been approved by the Council.

14. An application for a licence to keep an approved kennel establishment shall be in the form of the Sixth Schedule attached to these By-laws and shall be accompanied by two copies of a plan showing the details and specifications of all kennels and yards appurtenant thereto and showing the distances from the said kennels to the boundaries of the land the subject of the application and all buildings on the said land together with such other information as the Council may require.

15. Unless the Council directs otherwise a person seeking the issue of a licence to keep an approved kennel establishment shall at least 14 days before the application is made to Council—

- (a) publish in a newspaper circulating in the district a notice of his intention to submit an application for a licence specifying that any interested person may within 14 days after the date of the publication object to or make representations in respect of the application in writing directly to the Council; and
- (b) forward a notice in the form of the Seventh Schedule attached to these By-laws to the owners and occupiers of all adjoining land and premises.

16. A licence to keep an approved kennel establishment shall be in the form of the Eighth Schedule attached to these By-laws.

17. The fees payable for the issue of a licence to keep an approved kennel establishment and for the renewal of such licence are as specified in the First Schedule.

18. A licence to keep an approved kennel establishment shall remain valid until 31st October next following the issue thereof and shall fall due for renewal in accordance with these By-laws on the first day of November each year.

19. A person seeking the renewal of a licence to keep an approved kennel establishment shall make application to the Council in the form of the Sixth Schedule attached to these By-laws. The Council may at its discretion require that the person seeking the renewal of the registration give notice of intention as provided for in by-law 15 of these By-laws.

20. The occupier of premises licensed as an approved kennel establishment shall ensure that the dogs in that establishment are kept in kennels and yards appropriate to the breed or kind in question and in accordance with the following requirements—

- (a) each kennel shall have a yard appurtenant thereto which is capable of retaining the dog within its confines;
- (b) each kennel and each yard and every part thereof shall not be at any less distance than 10 metres from the boundaries of the land in the occupation of the occupier and the subject of the licence;
- (c) each kennel and each yard and every part thereof shall not be at any less distance than 25 metres from any road or street to which the premises has its main frontage. In the case of a corner allotment, no part of any kennel or yard shall be at any less distance than 8 metres from the side boundary to which the premises has its secondary frontage.

- (d) each kennel and each yard and every part thereof shall be at a distance of not less than 10 metres from any dwelling, church, school room, hall, factory, dairy or any premises wherein food is manufactured, prepared, packed or stored for human consumption.
 - (e) the walls shall be constructed of concrete, brick, stone, or timber frame lined on both sides with either contoured fibre cement sheeting or galvanised iron.
 - (f) the roof of each kennel shall be constructed of impervious material;
 - (g) the lowest internal height of the kennel shall be at least 2 metres from the floor;
 - (h) all painted external surfaces of the kennel shall be kept in good condition and well painted and be subsequently repainted when directed by an officer of the Council;
 - (i) all gates shall be provided and fitted with proper catches or means of securely fastening;
 - (j) each yard shall be securely fenced and kept securely fenced with a fence not less than 2 metres in height constructed of link mesh or netting, galvanised iron or timber, or of any other material approved by the Council.
 - (k) the upper surfaces of a kennel floor shall be at least 10 centimetres above the surface of the surrounding ground and shall be constructed of granolithic cement finished to a surface having a fall of not less than 1 in 100 to a drain which shall be properly laid, ventilated and trapped in accordance with the health requirements of the Council;
 - (l) all floor washings shall pass through the drain and shall be disposed of in accordance with the health requirements of the Council;
 - (m) the floor area of each kennel shall be an area of not less than 2.5 square metres for every dog kept therein over the age of three months;
 - (n) the yard of any kennel or group of kennels shall not be less than twice the area of the kennel or group;
 - (o) all kennels and yards and all feeding and drinking vessels shall be maintained in a clean disinfected and sanitary condition and shall be cleansed and disinfected when so ordered by an authorised person or health surveyor;
 - (p) every approved kennel establishment shall be provided with reticulated water in the form of a supported stand pipe and hose for the hosing down of the kennels and yards.
21. The holder of a license to keep an approved kennel establishment shall—
- (a) maintain the establishment in a clean, sanitary and tidy condition;
 - (b) dispose of all refuse, faeces and food waste daily in a manner approved by the Council;
 - (c) take all practical measures for the destruction of fleas, flies and other vermin.

22. The occupier of any premises which have been licensed by the Council as an approved kennel establishment shall not allow, permit or suffer any dog to be at large or roam outside the kennel or exercise yard, except for the purpose of reasonable exercise where a competent person is in proximity to the dog.

23. In the event of a person not renewing the kennel registration on the date set out in by-law 18 of these By-laws, or the Council refusing to renew the registration if the kennels are not kept to the standard specified, the Council may require that the kennels be demolished to the satisfaction of Council.

Part VI—General

24. Any person liable for the control of a dog as defined in Section 3 (1) of the Act, who allows that dog to excrete on any street or public place within the District commits an offence unless the excreta are removed forthwith and disposed of either on private land with the consent of the occupier or in such other manner as the Council may approve.

25. Subject to by-law 24 of these By-laws, any person liable for the control of a dog as defined in Section 3(1) of the Act, who allows that dog to excrete on any land within the District without the consent of the occupier of that land commits an offence unless the excreta are removed forthwith and disposed of either on private land with the consent of the occupier or in such other manner as the Council may approve.

26. Any person who contravenes or fails to comply with any provision of these By-laws commits an offence and shall upon conviction be liable to a penalty not exceeding \$200.

27. The offences described in the Second Schedule are prescribed pursuant to Section 45A(2) of the Act as offences in relation to which a modified penalty applies and the amount appearing directly opposite each such offence is the prescribed modified penalty payable in respect of that offence.

28. (1) Where an authorised person has reason to believe that a person has committed an offence against these By-laws as prescribed in the Second Schedule, he may serve on that person an infringement notice and the infringement notices issued under these By-laws shall be in the form depicted in the Third Schedule attached to these By-laws.

(2) An infringement notice may be served on an alleged offender personally or by posting it to his address as ascertained from him, at the time of or immediately following the occurrence giving rise to the allegation of the offence, or as recorded by Council pursuant to the Act.

(3) Where a person who receives an infringement notice fails to pay the prescribed penalty within the time specified in the notice, or within such further time as may in any particular case be allowed, he is deemed to have declined to have the allegation dealt with by way of a modified penalty.

(4) An alleged offender on whom an infringement notice has been served may, within the time specified in that notice or such further time as may in any particular case be allowed, send or deliver to the Council the amount of the prescribed penalty, with or without a reply as to the circumstances giving rise to the allegation, and the Council may thereupon—

- (a) appropriate that amount in satisfaction of the penalty and issue an acknowledgement; or
- (b) withdraw the infringement notice and refund the amount so paid.

(5) An infringement notice may, whether or not the prescribed penalty has been paid, be withdrawn by the Council by sending a notice in the prescribed form to the alleged offender at the address specified in the notice or his last known place of residence or business.

(6) The prescribed form of Withdrawal of Infringement Notice issued under these By-laws shall be in the form depicted in the Fourth Schedule attached to these By-laws.

MARKETING OF EGGS ACT 1945**EGG GRADING AND PACKING CODE 1989**

FORMULATED by the Western Australian Egg Marketing Board, with the approval of the Minister for Agriculture, under section 31AA.

Citation

- 1. This Code may be cited as the *Egg Grading and Packing Code 1989*.

Commencement

- 2. This Code shall come into operation on the date of publication in the *Gazette*.

Application

- 3. This Code is the relevant code under the *Marketing of Eggs Act 1945* for the grading, marking and packing of eggs for sale.

Interpretation

4. In this Code unless the context otherwise requires—
“clean” means clean or reasonably free from dirt, foreign matter or stain;
“eggs” means hen eggs produced in Western Australia to be sold or intended for sale for human consumption in Western Australia, or in any other State of Australia and includes hen eggs imported into Western Australia and which are to be sold or intended for sale in Western Australia;
“Schedule” means the Schedule to this Code.

Eggs unfit for human consumption

5. Any egg which contains meat or a blood spot or which, in the opinion of an inspector, is not fit for human consumption shall be deemed to be unfit for human consumption.

Eggs to be graded, marked and packed

6. (1) All eggs shall be graded, marked and packed in accordance with this Code prior to sale.
(2) The requirements of subclause (1) do not apply in relation to eggs—
(a) that are intended to be sold or delivered to the Board; or
(b) that are intended to be sold to a purchaser who is licensed to grade eggs under the *Marketing of Eggs Regulations 1945*,
until such time as those eggs are delivered to the Board or that purchaser, as the case may be.

Grades of quality

7. Eggs shall be graded according to their quality as “First Quality” or “Second Quality”.

Standard of “First Quality” eggs

8. A “First Quality” egg shall comprise an egg—
(a) the shell of which is clean, uncracked and free from stain;
(b) the shell of which is not thin or misshapen;
(c) which, when candled, appears—
(i) free of bloodspots or any inclusions whatsoever;
(ii) to have a yolk which is translucent and only faintly visible;
(iii) to have a white which is translucent and firm; and
(iv) to have an air cell which is slightly tremulous and is not more than 5 mm in depth;
and
(d) which has not been subjected to incubation.

Standard of “Second Quality” eggs

9. A “Second Quality” egg shall comprise an egg, not being a “First Quality” egg, but which has not been adjudged unfit for human consumption under clause 5 and—
(a) which is free from foreign matter, or excreta, adhering to the shell;
(b) which is not affected by rot of any description;
(c) the shell membranes of which are intact;
(d) which, when candled, is free from bloodspots or any inclusions whatsoever; and
(e) which has not been subjected to incubation.

Weight grading of eggs

10. In addition to being graded as “First Quality” or “Second Quality”, eggs shall be graded by weight as follows—
(a) Grade 1 (a) which shall be known as “First Grade 68 gram Hen” and which shall consist of “First Quality” eggs each of which weighs not less than 68 g;
(b) Grade 1 (b) which shall be known as “First Grade 60 gram Hen” and which shall consist of “First Quality” eggs each of which weighs not less than 60 g but less than 68 g;
(c) Grade 1 (c) which shall be known as “First Grade 53 gram Hen” and which shall consist of “First Quality” eggs each of which weighs not less than 53 g but less than 60 g;
(d) Grade 1 (d) which shall be known as “First Grade 48 gram Hen” and which shall consist of “First Quality” eggs each of which weighs not less than 48 g but less than 53 g;
(e) Grade 1 (e) which shall be known as “First Grade 45 gram Hen” and which shall consist of “First Quality” eggs each of which weighs not less than 45 g but less than 48 g; and
(f) Grade 2 which shall be known as “Second Grade Hen” and which shall consist of “First Quality” eggs each of which weighs less than 45 g, or of “Second Quality” eggs, or both.

Marking of eggs

11. Graded eggs shall be marked as follows—
(a) each “First Grade Hen” egg shall be marked with the grading licence number allocated to the person grading the egg under the *Marketing of Eggs Regulations 1945* and in accordance with the description relating to item 1 in the Schedule; and
(b) each “Second Grade Hen” egg shall be marked in the form of item 2 in the schedule and in accordance with the description relating to that item.

Marking of packages

12. (1) The package in which eggs, other than those graded and packed by the Board, are sold shall bear a label or other marking specifying the following particulars—

- (a) the identity of the person who graded and packed the eggs;
- (b) the grade of quality and weight of those eggs.

(2) The package in which "First Quality" eggs graded and packed by the Board are sold shall bear a label or other marking specifying the following particulars—

- (a) the appropriate trading name of the vendor;
- and

- (b) the weight grade of those eggs.

(3) The package in which "Second Quality" eggs graded and packed by the Board are sold shall bear a label or other marking specifying the following particulars—

- (a) the appropriate trading name of the vendor;
- and

- (b) the grade of quality and weight of those eggs.

Mixing or contamination of eggs

13. (1) Eggs which have not been marked in accordance with this Code shall not be packed in the same package as eggs so marked.

(2) Eggs, whether intended for cold storage or not, shall not be packed in any package which is unclean or which is contaminated by contact or otherwise with any deleterious substance.

Eggs for export

14. Notwithstanding the provisions of this Code, eggs graded, marked or packed for export in conformity with any law of the Commonwealth and in accordance with the requirements of the Commonwealth Department of Primary Industry shall be deemed to be graded, marked or packed in accordance with this Code.
