Notice is hereby given pursuant to Regulation 6 of the Taxi Control Board (Elections) Regulation 1964, that pursuant to paragraph (c) of sub-section (3) of Section 8 of the Act, an election to elect Two Members for appointment to the Taxi Control Board will be held on 29 May, 1990 at the office of the Western Australian Electoral Commission, Perth, closing at 4.00 pm o'clock on that day.

Nominations of candidates are hereby called from members of the industry who are in any of the following categories:

- (i) Owners of a Taxi-Car;
- (ii) Full time drivers of a Taxi-Car, but who are not also the Owner; and
- (iii) Persons who are not actively engaged on the road in the operation of a Taxi-Car.

FISHERIES ACT 1905 ONSLOW PRAWN FISHERY NOTICE 1990 Notice No. 441

FD 134/75

Made by the Minister under sections 9 and 11.

Citation

1. This notice may be cited as the Onslow Prawn Fishery Notice 1990.

Description of Fishery and Areas

2. (1) The taking of prawns by means of trawling in the waters specified in item 1 of the Schedule shall constitute the Onslow Prawn Fishery.
- (2) The Onslow Prawn Fishery shall be divided into areas as described in item 2 of the Schedule.

Prohibition on Fishing

3. (1) The taking or attempting to take prawns by means of trawling is prohibited in the Onslow Prawn Fishery by all persons other than by licensed professional fishermen using a licensed fishing boat, the licence for which is endorsed to permit it to be so used in one or more areas of the fishery.

(2) A boat authorised to trawl for prawns in the Onslow Prawn Fishery in accordance with sub-clause (1) shall not be used in any area of the Onslow Prawn Fishery not specified in the endorsement of the licence.

Closure to Trawling

4. The taking of prawns by means of trawling is prohibited,
 - (a) in Area 1 from 0700 hours on 2 November in any year to 1800 hours on 2 April next following;
 - (b) in Area 2 from 0700 hours on 2 November in any year to 1800 hours on 2 April next following; and
 - (c) in Area 3 from 0700 hours on 2 November in any year to 1800 hours on 15 March next following.

Determination of Position by Reference to the Australian Geodetic Datum

5. (1) Where, for the purpose of this notice it is necessary to determine a position on the surface of the Earth by geographical coordinates, that position shall be determined on the Australian Geodetic Datum which is defined by an ellipsoid having a semi-major axis (equatorial radius) of 6,378,160 metres and a flattening of 1/298.25 and fixed by the position of the origin being the Johnston Geodetic Station in the Northern Territory of Australia.

(2) The Johnston Geodetic Station referred to in subclause (1) shall be taken to be situated at 25°56'54.5515" south latitude and at 133°12'30.0771" east longitude and to have a ground level elevation of 571.2 metres above the ellipsoid referred to in that subclause.

Revocation

6. Notice No. 317 published in the Gazette on 13 May 1988 and Notice Nos. 307, 315 and 316 published in the Gazette of 13 January 1989 are cancelled.

Schedule

1. **Onslow Prawn Fishery**
All waters of the Indian Ocean bounded by the high water mark of the mainland and the 200 metre isobath between longitude 116°45' east and a line drawn due north from a point on the high water mark of the mainland due south of the southernmost extremity of Locker Island to the high watermark of that extremity thence north westerly to the high water mark at the southernmost extremity of Serrurier Island thence northerly along the high water mark of Serrurier Island on its western shore to its northernmost point thence due north to the 200 metre isobath.
2. (1) **Area 1.**
All waters of the Indian Ocean bounded by a line commencing at the high water mark of the seaward extremity of the Beadon Creek breakwater near Onslow and extending northerly to the high water mark of the southernmost extremity of Direction Island thence along the high water mark of Direction Island along its eastern shore to its northernmost point thence westerly to the high water mark of the northernmost point of Serrurier Island thence southerly along the high water mark of Serrurier Island on its western shore to the high water mark at the southernmost extremity of Serrurier Island thence south easterly to the high water mark of the southernmost extremity of Locker Island thence due south to the high water mark of the mainland thence generally north easterly along the high water mark to the starting point.
- (2) **Area 2.**
All waters of the Indian Ocean bounded by a line commencing at the high water mark of the seaward extremity of the Beadon Creek breakwater near Onslow to the high water mark at the southernmost extremity of Direction Island thence along the high water mark of Direction Island on its eastern shore to its northernmost extremity thence westerly to the high water mark of the northernmost extremity of Serrurier Island thence due north to the 200 metre isobath thence generally north easterly along the 200 metre isobath to the intersection of a line drawn due north from Cape Dupuy on Barrow Island with the 200 metre isobath thence due south to the high water mark at Cape Dupuy on Barrow Island thence along the highwater mark of Barrow Island on its eastern shore to the highwater mark of Town Point thence to the lighthouse on Great Sandy Island thence to the highwater mark on the mainland at Robe Point at the mouth of the northern arm of the Robe River and thence along the highwater mark on the mainland to the starting point.
- (3) **Area 3.**
All waters of the Indian Ocean lying between a line commencing at the high water mark of Robe Point at the mouth of the northern arm of the Robe River drawn northerly to the lighthouse at Great Sandy Island thence northerly to the high water mark of Town Point on the eastern shore of Barrow Island thence along the highwater mark of Barrow Island on its eastern shore to Cape Dupuy thence due north to the 200 metre isobath thence generally north easterly along that isobath to the intersection of 116°45' east longitude thence due south to the highwater mark on the mainland and thence along the highwater mark to the starting point.

By-law Relating to Trading in Public Places

In pursuance of the powers conferred upon it by the abovementioned Act and of all other powers enabling it, the Council of the abovementioned Municipality records having resolved on the 23 August 1989, to make and submit for confirmation by the Lieutenant-Governor and Administrator the following By-law.

1. In this By-law, unless the context otherwise requires—
 - “Community Association” means an institution, association, club, society, or body, whether incorporated or not, the objects of which are of a charitable, benevolent, religious, cultural, educational, recreational, sporting or other like nature and the members of which are not entitled or permitted to receive any pecuniary profit from the transactions thereof;
 - “Council” means the Municipality of the City of Wanneroo;
 - “Public Place” includes a street, way and place which the public are allowed to use, whether the street, way or place is or is not on private property;
 - “Trading” means selling or hiring of goods, wares, merchandise or services, or offering goods, wares, merchandise or services for sale or hire, in a street or other public place and includes displaying goods, wares or merchandise for the purpose of offering them for sale or hire, inviting offers for sale or hire, soliciting orders or carrying out any other transactions therein, but does not include the setting up of a stall, or the conducting of business at a stall, under the authority of a licence issued under By-laws made under section 242.
2. This By-law shall not apply to the selling or offering for sale of newspapers or magazines unless they are sold or offered for sale from a stall.
3. No persons shall carry on trading in any public place unless that persons is acting in accordance with the specifications of a current licence including the conditions thereof issued under this By-law and for which all fees and charges have been paid.
4. An application for a licence or renewal of a licence shall be in writing in the form set out in the First Schedule hereto and be accompanied by the application fee.
5. In considering an application for a licence or renewal of a licence, the Council shall have regard to—
 - (a) any relevant policy statements;
 - (b) the desirability of the proposed activity;
 - (c) the location of the proposed activity; and
 - (d) the circumstances of the case.
6. The Council may grant the licence or renewal, or may refuse to grant the licence or renewal and it may so refuse on any of the following grounds—
 - (a) that the applicant has committed a breach of any provision of this By-law;
 - (b) the applicant is not a desirable or suitable person to hold a licence;
 - (c) the needs of the Municipal District of the Council or the portion thereof for which the licence is sought are adequately catered for by established shops or be persons to whom licences have been issued; or
 - (d) such other grounds as may be relevant in the circumstances.
7. The Council may issue a licence specifying such requirements, terms and conditions as in the opinion of the Council are appropriate including—
 - (a) the place to which the licence applies; which in the event of mobile traders may include a pre-determined approved route or area;
 - (b) the days and hours when trading may be carried on;
 - (c) the number, type, form and construction, as the case may be, of any stand, table, structure or vehicle which may be used for trading;
 - (d) the particulars of the goods or services or transactions in respect of which trading may be carried on;
 - (e) the number of persons and the names of persons permitted to carry on trading, and any requirements concerning personal attendance at the place of trading and the nomination of assistants, nominees or substitutes;
 - (f) whether and under what terms the licence is transferable;

- (g) any prohibitions or restrictions concerning the cause of any nuisance, the use of signs, the making of noise and the use of amplifiers, sound equipment, sound instruments and lighting apparatus;
 - (h) any requirements concerning the display of the licence holder's name and other details of the licence;
 - (i) the care, maintenance and cleansing of the place of trading;
 - (j) the vacating of the place of trading when trading is not taking place;
 - (k) any requirements regarding the acquisition by the licence holder of public risk insurance;
 - (l) the period not exceeding 12 months during which the licence is valid;
 - (m) designation of any place or places wherein trading is totally or from time to time prohibited by Council.
8. A licence shall be in or substantially in the form set out in the Second Schedule.
 9. Charges and fees shall be calculated and payable in accordance with the Third and Fourth Schedules hereto and notwithstanding Council's approval of the issue of a licence such licence shall not be valid until the appropriate fees have been paid.
 10. The Council may revoke a licence in the event that the licence holder breaches any provision of this By-law or fail to comply with any requirement term or condition of a licence.
 11. Where a licence is revoked the Council shall if requested provide the licence holder with reasons in writing and shall refund the charge having first deducted the charge applicable to the period from the issuing of the licence to its revocation.
 12. Any person who contravenes or fails to comply with any provision of this By-law commits an offence and is liable on conviction to a penalty for each offence of not more than \$1 000 or imprisonment for six months.
 13. Notwithstanding the provisions of Clauses 3 and 7 a licence may be validly issued to a community association notwithstanding that it is exempt from the payment of appropriate fees and charges and a community association may validly carry on trading under a valid licence issued under this By-law without having paid all fees and charges for that licence provided that the trading carried on by the community association is for the purposes of that Community association and for no other purpose and in the event that the trading is not for those purposes then the community association shall be liable to pay all charges and fees which it would have otherwise been liable to pay under this By-law.

Where the owner or occupier does not clear the land of such trees, scrub, undergrowth, or remove such refuse, rubbish, disused materials, unsightly items/objects, derelict motor vehicles, vehicle bodies or old machinery, the Council may, without payment of any compensation in respect thereof, clear and remove it and dispose of it at the expense of, and recover in a court of competent jurisdiction the amount of the expenses from, the owner or occupier to whom the Notice was given.
5. Every owner or occupier of land upon whom a Notice has been served under By-laws 2 or 3 of these By-laws shall comply with such Notice within the time specified therein or in that time give satisfactory reason why the materials should be retained or be given extra time in which to comply. Any person who fails to comply with the terms of any notice served under these By-laws commits an offence, and on conviction shall be liable to a penalty not exceeding five hundred dollars (\$500.00) and a daily penalty not exceeding fifty dollars (\$50.00) for each day on which the offence occurs after the expiry of the Notice.

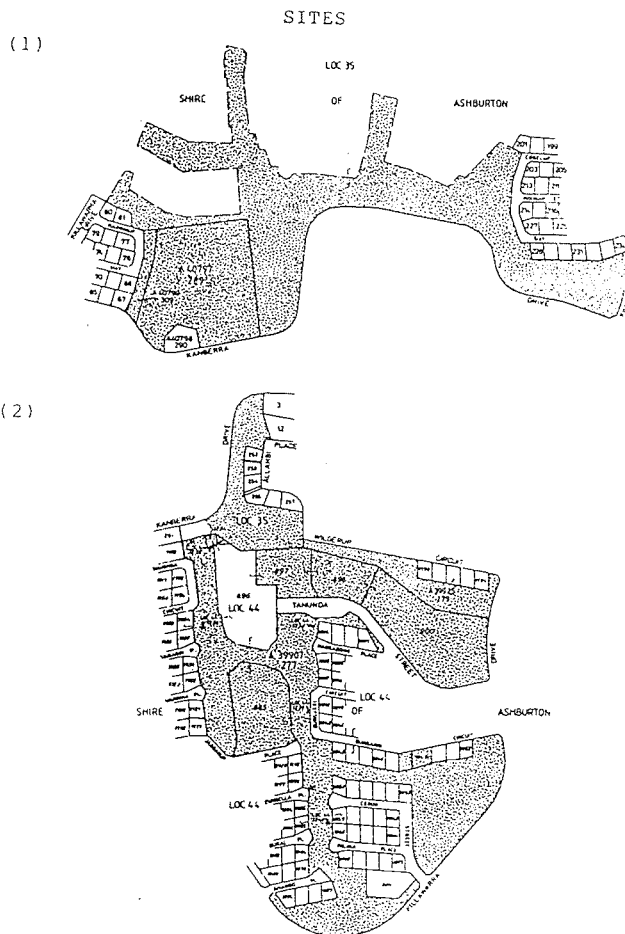

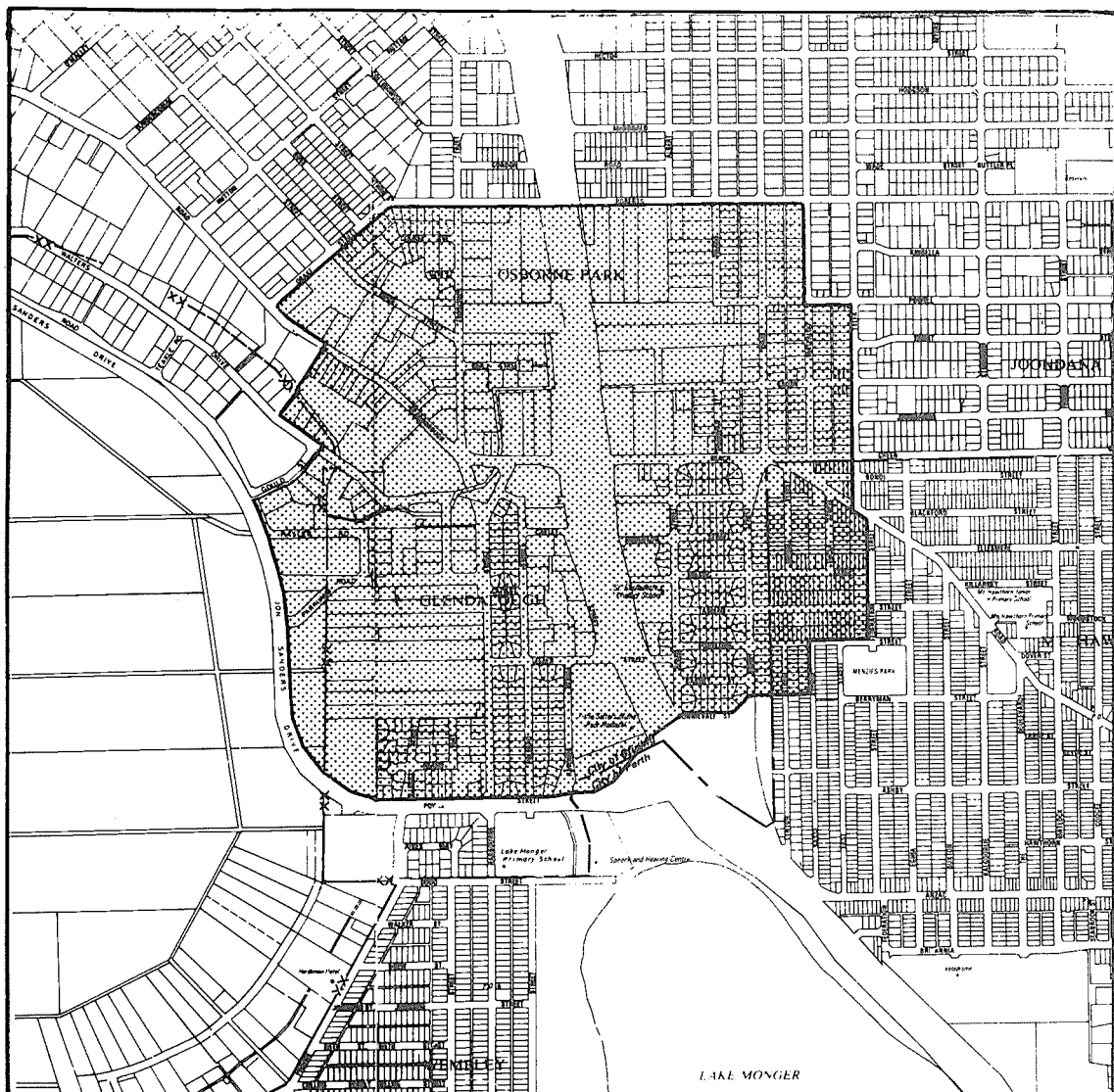

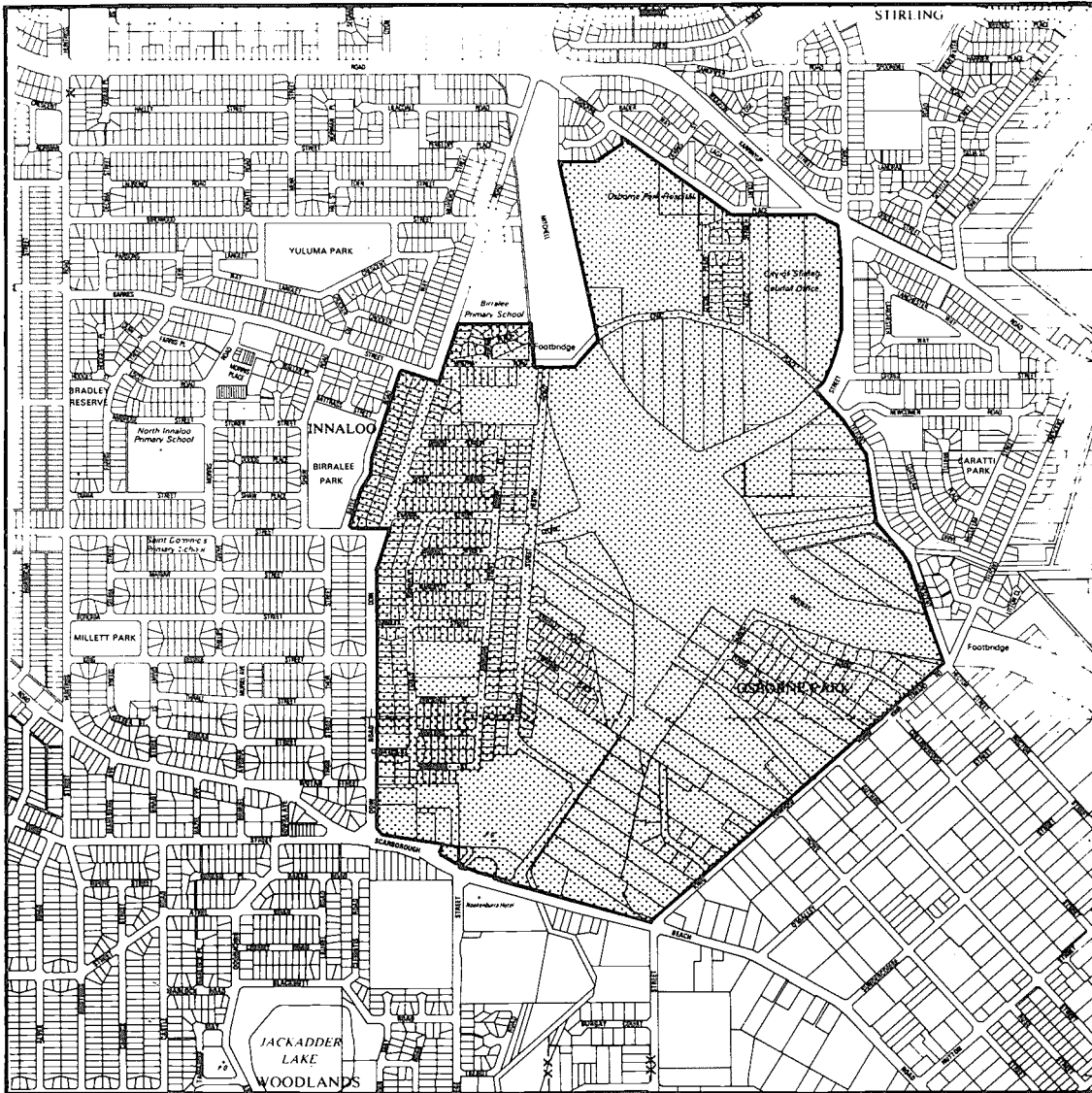
