AGRICULTURE

SOIL AND LAND CONSERVATION ACT 1945

SOIL AND LAND CONSERVATION (GASCOYNE/WOORAMEL LAND CONSERVATION DISTRICT) AMENDMENT ORDER 1990

Made by His Excellency the Governor in Executive Council under section 23 (2d) of the Soil and Land Conservation Act 1945 and on the recommendation of the Minister for Agriculture.

Citation

1. This order may be cited as the Soil and Land Conservation (Gascoyne/Wooramel Land Conservation District) Amendment Order 1990.

Principal order

2. In this order the Soil and Land Conservation (Gascoyne/Wooramel Land Conservation District) Order 1989* is referred to as the principal order. [*Published in the Government Gazette on 13 October 1989 at pp. 3806-07.]

Clause 1A inserted

3. The principal order is amended by inserting after clause 1 the following clause—

Interpretation

- " 1A. In this order-
 - "appointed member" means a person appointed under clause 4 (1) (b), (c) or (d) to be a member of the committee;
 - "committee" means the Land Conservation District Committee for the Gascoyne/Wooramel Land Conservation District;
 - "member" means a member of the committee;
 - "producer organizations" means bodies known respectively as the Western Australian Farmers Federation (Inc.) and the Pastoralists and Graziers Association of Western Australia;
 - "the district" means the Gascoyne/Wooramel Land Conservation District constituted under clause 2. ".

Clauses 3, 4 and 5 inserted

4. The principal order is amended by inserting after clause 2 the following

Establishment of the committee

" 3. Pursuant to section 23 (2) of the Soil and Land Conservation Act 1945 there is hereby established for the district a land conservation district committee to be known as the Land Conservation District Committee for the Gascoyne/Wooramel Land Conservation District.

Constitution of the committee

- 4. (1) It is hereby determined, on the recommendation of the Minister, after consultation with the Shire of Carnarvon and producer organizations, that the committee shall consist of 7 members of whom—
 - (a) one shall be the Commissioner for Soil Conservation or his nominee;
 - (b) one shall be appointed by the Minister on the nomination of the Shire of Carnarvon;
 - (c) 3 shall be appointed in accordance with subclause (2);
 - (d) 2 shall be appointed by the Minister and shall be actively engaged in, or affected by or associated with, land use in the district.
- (2) The Pastoralists and Graziers Association of Western Australia shall submit to the Minister a panel containing the names of persons willing to be appointed as members of the committee and, where a panel is submitted in accordance with this order, 3 persons whose names appear on the panel submitted by the Pastoralists and Graziers Association of Western Australia shall be appointed by the Minister.
- (3) Subject to this clause, each appointed member shall hold office for such period not exceeding 3 years as is specified in the instrument of his appointment and is eligible for reappointment.
- (4) The Minister may grant leave of absence to an appointed member on such terms and conditions as the Minister determines.
- (5) The Minister may terminate the appointment of an appointed member for inability, inefficiency or misbehaviour.

- (6) If an appointed member-
 - (a) is or becomes an undischarged bankrupt or person whose property is subject to an order or arrangement under the laws relating to bankruptcy;
 - (b) has his appointment terminated by the Minister, under subclause (5);
 - (c) is absent, except on leave duly granted by the Minister, from 3 consecutive meetings of the committee of which he has had notice; or
- (d) resigns his office by written notice addressed to the Minister, the office of that appointed member becomes vacant.

Proceedings of the committee

- 5. (1) The committee shall hold its meetings at such place on such days and at such intervals as the committee shall from time to time determine.
- (2) At any meeting of the committee-
 - (a) a majority of the members constitute a quorum;
 - (b) the Chairman shall preside and where he is absent from the meeting the members may appoint one of their number to preside at that meeting;
 - (c) each member present is entitled to a deliberative vote; and
 - (d) where the votes cast on any question are equally divided the Chairman, or the presiding member in terms of paragraph (b), shall have a casting vote.
- (3) The committee shall cause accurate minutes to be kept of the proceedings at its meetings.
- (4) To the extent that it is not prescribed, the committee may determine its own procedure. ".

CREDIT ACT 1984 ORDER UNDER SECTION 19

Made by His Excellency the Governor.

Citation

1. This Order may be cited as the Credit Order No. 60—Citibank Visa Facility.

Commencement and Duration

- 2. This Order takes effect on and from the date of publication in the *Government Gazette*.
- 3. It is declared that sections 52, 54 (2), 55 (1), 59 (1) (b) and 59 (1) (f) of the Credit Act 1984, and clause 1 (n) of schedule 7 to that Act, do not have effect in relation to Citibank Limited to the extent that it enters into continuing credit contracts for the use of the Citibank Visa facility.

CORPORATE AFFAIRS

COMPANIES (APPLICATION OF LAWS) ACT 1981 SECURITIES INDUSTRY (APPLICATION OF LAWS) ACT 1980

Made by His Excellency the Governor in Executive Council acting pursuant to sections 15 and 16 (2) of the Companies (Application of Laws) Act 1981 and sections 15 and 15A (1) of the Securities Industry (Application of Laws) Act 1980 following approval by the Ministerial Council for Companies and Securities in respect of the repeal of regulations relating to prescribed interests affecting retirement village schemes.

COMPANIES AND SECURITIES INDUSTRY (RETIREMENT VILLAGES)
REGULATIONS 1990

Citation

1. These regulations may be cited as the Companies and Securities Industry (Retirement Villages) Regulations 1990.

Repeal of regulations, and revival of Companies Act 1981 Commonwealth text

- 2. (1) The Companies (Application of Laws) Regulations 1987, published in the Government Gazette on 26 June 1987 as corrected by an erratum so published on 3 July 1987, are repealed.
- (2) Schedule 1 to the Companies (Application of Laws) Act 1981 is amended by deleting clause 36BA.

Repeal of regulations, and revival of Securities Industry Act 1980 Commonwealth text

- 3. (1) The Securities Industry (Application of Laws) (No. 2) Regulations 1987, published in the Government Gazette on 26 June 1987, are repealed.
- (2) Schedule 1 to the Securities Industry (Application of Laws) Act 1981 is amended, in clause (2) (1), by deleting paragraph (gaa) and paragraph (gb).

Repeal of regulations relating to exemptions in respect of retirement village schemes

4. The Companies and Securities Industry (Retirement Villages) (Exemption) Regulations 1985 published in the Government Gazette on 1 March 1985, are repealed.

CROWN LAW

CRIMES (CONFISCATION OF PROFITS) ACT 1988 CRIMES (CONFISCATION OF PROFITS) REGULATIONS 1990

Made by His Excellency the Governor in Executive Council under sections 56 and 61.

PART I—PRELIMINARY

Citation

1. These regulations may be cited as the Crimes (Confiscation of Profits) Regulations 1990.

Interpretation

- 2. In these regulations—
- "the New South Wales Act (1985)" means the Crimes (Confiscation of Profits)

 Act 1985 of New South Wales as amended from time to time;
- "the New South Wales Act (1989)" means the Confiscation of Proceeds of Crime Act 1989 of New South Wales as amended from time to time;
- "the Northern Territory Act" means the Crimes (Forfeiture of Proceeds) Act 1988 of the Northern Territory as amended from time to time;
- "the Queensland Act" means the Crimes (Confiscation of Profits) Act 1989 of Queensland as amended from time to time;
- "the South Australian Act" means the Crimes (Confiscation of Profits) Act 1986 of South Australia as amended from time to time;
- "the Victorian Act" means the Crimes (Confiscation of Profits) Act 1986 of Victoria as amended from time to time.

PART II—NEW SOUTH WALES

Division 1—Application of the New South Wales Act (1985)

Declaration—corresponding law

3. The New South Wales Act (1985) is declared to be a law which corresponds to the Act.

Declaration—forfeiture order

4. A forfeiture order made under section 5 (1) of the New South Wales Act (1985) is declared to be an order within the definition of "interstate forfeiture order" in section 3 (1) of the Act.

Declaration—pecuniary penalty order

5. A pecuniary penalty order made under section 10 (1) of the New South Wales Act (1985) is declared to be an order within the definition of "interstate pecuniary penalty order" in section 3 (1) of the Act.

Declaration-restraining order

6. A restraining order made under section 12 (2) of the New South Wales Act (1985) is declared to be an order within the definition of "interstate restraining order" in section 3 (1) of the Act.

Division 2—Application of the New South Wales Act (1989)

Declaration-corresponding law

7. The New South Wales Act (1989) is declared to be a law which corresponds to the Act.

Declaration-drug proceeds order

8. A drug proceeds order made under section 29 (1) of the New South Wales Act (1989) is declared to be an order within the definition of "interstate forfeiture order" in section 3 (1) of the Act.

Declaration-forfeiture order

9. A forfeiture order made under section 18 (1) of the New South Wales Act (1989) is declared to be an order within the definition of "interstate forfeiture order" in section 3 (1) of the Act.

Declaration-pecuniary penalty order

10. A pecuniary penalty order made under section 24 (1) of the New South Wales Act (1989) is declared to be an order within the definition of "interstate pecuniary penalty order" in section 3 (1) of the Act.

Declaration-restraining order

11. A restraining order made under section 43 of the New South Wales Act (1989) is declared to be an order within the definition of "interstate restraining order" in section 3 (1) of the Act.

PART III NORTHERN TERRITORY

Declaration—corresponding law

12. The Northern Territory Act is declared to be a law which corresponds to the Act.

Declaration—forfeiture order

13. A forfeiture order made under section 5 (1) of the Northern Territory Act is declared to be an order within the definition of "interstate forfeiture order" in section 3 (1) of the Act.

Declaration—pecuniary penalty order

14. A pecuniary penalty order made under section 10 (1) of the Northern Territory Act is declared to be an order within the definition of "interstate pecuniary penalty order" in section 3 (1) of the Act.

Declaration—restraining order

15. A restraining order made under section 14 (2) of the Northern Territory Act is declared to be an order within the definition of "interstate restraining order" in section 3 (1) of the Act.

PART IV—QUEENSLAND

Declaration—corresponding law

16. The Queensland Act is declared to be a law which corresponds to the Act.

Declaration-forfeiture order

17. A forfeiture order made under section 8 (1) of the Queensland Act is declared to be an order within the definition of "interstate forfeiture order" in section 3 (1) of the Act.

Declaration-special forfeiture order

18. A special forfeiture order made under section 60 of the Queensland Act is declared to be an order within the definition of "interstate forfeiture order" in section 3 (1) of the Act.

Declaration—pecuniary penalty order

19. A pecuniary penalty order made under section 13 (1) of the Queensland Act is declared to be an order within the definition of "interstate pecuniary penalty order" in section 3 (1) of the Act.

Declaration—restraining order

20. A restraining order made under section 17 of the Queensland Act is declared to be an order within the definition of "interstate restraining order" in section 3 (1) of the Act.

PART V-SOUTH AUSTRALIA

Declaration—corresponding law

21. The South Australian Act is declared to be a law which corresponds to the Act.

Declaration—forfeiture order

22. A forfeiture order made under section 5 (1) of the South Australian Act is declared to be an order within the definition of "interstate forfeiture order" in section 3 (1) of the Act.

Declaration-sequestration order

23. A sequestration order made under section 6 (1) of the South Australian Act is declared to be an order within the definition of "interstate restraining order" in section 3 (1) of the Act.

PART VI-VICTORIA

Declaration—corresponding law

24. The Victorian Act is declared to be a law which corresponds to the Act.

Declaration-forfeiture order

25. A forfeiture order made under section 7 (1) of the Victorian Act is declared to be an order within the definition of "interstate forfeiture order" in section 3 (1) of the Act.

Declaration—pecuniary penalty order

26. A pecuniary penalty order made under section 12 (1) of the Victorian Act is declared to be an order within the definition of "interstate pecuniary penalty order" in section 3 (1) of the Act.

Declaration-restraining order

27. A restraining order made under section 16 of the Victorian Act is declared to be an order within the definition of "interstate restraining order" in section 3 (1) of the Act.

FISHERIES ACT 1905

CLOSED WATERS NETTING (PRESTON BEACH TO DUNSBOROUGH) Notice No. 443

FD 728/74.

Made by the Minister under sections 9, 10 and 11.

Citation

1. This notice may be cited as the Closed Waters Netting (Preston Beach to Dunsborough) Notice 1990.

Interpretation

2. A reference to column 1, 2, 3 or 4 is a reference to the respective column in the Schedule.

Prohibition on taking fish by nets

3. Subject to clause 4, the taking of fish by means of nets in the waters specified in column 1 is prohibited other than during the times specified in column 2.

Time and means of taking fish

4. The fish listed in column 3 may be taken in the waters specified in column 1 at the times shown in column 3 by the means specified in column 4.

Revocation

5. Notice No. 200 published in the Gazette of 1 November 1985 is cancelled.



WORKERS COMPENSATION AND ASSISTANCE ACT 1981 WORKERS COMPENSATION BOARD AMENDMENT RULES 1990

Made by the Chairman of the Workers Compensation Board.

Citation and Commencement

1. These rules may be cited as the Workers Compensation Board Amendment Rules 1990 (2) and shall come into effect on 1 June 1990.

Principal Rules

2. In these rules the Workers Compensation Board Rules 1982* are referred to as the principal rules.

Rule 9 amended

3. The principal rules are amended by substituting for rule 9 a new rule in the following terms:

"Commencement of proceedings and applications in pending proceedings

- 9. (1) Subject to the provisions of the Act and of these rules every action in the Board must be commenced by application.
- (2) Interlocutory applications in pending proceedings must be made to the Board or the Registrar in accordance with Form 19".

New Rule 9A

4. There shall be inserted a new rule 9A in the following terms:

Application by worker

- "9A. (1) Except an application in chambers filed pursuant to rule 55, an application by the worker or by dependants for the determination of any matter or question by the Board shall be made by filing an application which, if the nature of the application permits, shall be in accordance with one of the forms in the Appendix A numbered inclusively 1 to 6 inclusive with such modifications as the circumstances require and the application shall state concisely the question which has arisen and the application together with one copy for each respondent to be served shall be delivered to the Registrar.
- (2) Particulars shall appear upon or be annexed to the application and, without limiting the particulars to the following matters, shall contain—
 - (a) a concise statement of the circumstances under which the application is made;
 - (b) a statement whether there is an admission of liability to pay compensation or a denial of such liability, wholly or partially, with (in the latter case) a statement of the grounds upon and extent to which liability is denied;
 - (c) a statement of the matters which the applicant desires to have determined by the Board; and
 - (d) the full names and addresses of the respondents and of the applicant, and of his legal practitioner or agent, if the proceedings are commenced through a legal practitioner or agent."

Rule 13 amended

5. The principal rules are amended by substituting for rule 13 a new rule in the following terms:

"Filing and service of application

13. A party filing an application shall for the purpose of service on all other parties to the proceedings at the same time obtain from the Registrar such service copies under the Seal of the Board as shall be required to effect service of the application on all such parties and a Notice in accordance with Form 8 requiring each party to comply with Rule 14 hereof and advising of the procedure provided for by Rule 16."

Rule 14 amended

6. The principal rules are amended by substituting for rule 14 a new rule in the following terms:

"Answer

14. (1) Every respondent or other party who desires to contest any part of the applicant's claim shall within 14 days of service of the application file with the Registrar for sealing an answer and shall forthwith serve on each other party to the proceedings a copy of the sealed answer.

(2) The answer shall state concisely but fully and with particularity the matters to be traversed and relied upon by the respondent or other party in opposing the application."

Rule 15 amended

7. The principal rules are amended by substituting for rule 15 a new rule in the following terms:

"Procedure where no answer

- 15. (1) Within 7 days of effecting service in accordance with Rule 13 the applicant shall file with the Registrar an affidavit in accordance with Form 8A in Appendix A, with such variations as the circumstances require, unless prior thereto the respondent shall have filed an answer.
- (2) In the absence of an answer, then subject to sub-rule (3), the facts alleged in the application, and in the case of a claim for compensation, the liability to pay compensation, shall be taken to be admitted.
- (3) In the absence of an answer and in the event that the applicant does not consent at the hearing of the application to a respondent availing himself of any matter of which he should pursuant to this rule have given notice by filing an answer or have included in any answer filed, the Board may proceed with the hearing without permitting the respondent to avail himself of such matter and may treat the relevant facts alleged in the application as admitted, or may, upon such terms as the Board considers appropriate, permit an answer or an amended answer to be filed and relied upon, or may adjourn the hearing to some later time or date and make such orders generally in respect of the matter as the Board considers fit."

Rule 16 amended

8. The principal rules are amended by substituting for rule 16 a new rule in the following terms:

"Procedure for Preliminary Hearing

- 16. (1) Forthwith upon the filing of the applicant's affidavit of service pursuant to sub-rule 15(1) or the filing of the answer pursuant to Rule 14 whichever is the earlier the Registrar shall list the matter for a preliminary hearing in chambers and shall give or send to the parties notice of the date of such preliminary hearing in accordance with Form 9 in Appendix A and in the event of a change of date of the preliminary hearing the Registrar shall notify all parties accordingly.
- (2) The date of the preliminary hearing shall be not less than 8 not more than 10 weeks from the date of the filing of the affidavit of service or the answer (whichever is the earlier) so as to enable all parties to settle the pleadings, exchange discovery of documents, administer and answer interrogatories and conduct preliminary enquiries into the questions in issue and the preliminary hearing may, at the Registrar's discretion, be adjourned to a date to be fixed or to a fixed date.
- (3) Where liability is admitted after the listing for a preliminary hearing the Registrar shall vacate the date of the preliminary hearing and shall list the application for hearing in chambers for the making of consent orders.
- (4) Unless expressly excused, every worker, employer and/or insurer, third party, intervener or other party to the matter shall, if an individual attend the hearing in person, or if a partnership or a body corporate shall attend the hearing by representative duly authorised to negotiate and, if appropriate, agree the terms of settlement.
- (5) The Registrar shall conduct the preliminary hearing and shall do so in an informal manner as the circumstances permit.
- (6) At the preliminary hearing, the Registrar-
 - (a) shall enquire into the likelihood of settlement, the delineation of issues in dispute, and the state of preparation of the cases of the respective parties and such procedural matters as he considers relevant; and
 - (b) shall give directions for the further conduct of the proceedings and, when appropriate fix a date for the hearing of the application.
- (7) Parties attending a preliminary hearing under this rule shall make a bona fide endeavour to reach agreement on relevant matters in issue between them.
- (8) Evidence of anything said, or of any admission made while discussing or negotiating terms of settlement in the course of such a hearing shall not be admissible in any further proceedings before the Board."

New rule 16A

9. There shall be inserted a new rule 16A in the following terms:

"Documents required at Preliminary Hearing

- 16A. (1) Not less than 48 hours before a preliminary hearing all parties to the proceedings shall, to the extent not already done, file and serve upon each other copies of all medical reports upon which they intend to rely at the hearing.
- (2) Where a preliminary hearing has been listed in relation to an application for redemption, payment of expenses in excess of the maximum amount provided for by sub-clause 17(1) of Schedule 1 of the Act or involving the financial standing of a party in any way in relation to an application, that party shall produce at the hearing all relevant and significant documents which that party has in that party's possession, custody or control or which, with reasonable diligence, that party could obtain relating to—
 - (a) the financial matters referred to in any pleading filed by that party; and
 - (b) the value of any item of property in which that party has an interest."

Rule 17 amended

10. The principal rules are amended by substituting for rule 17 a new rule in the following terms:

"Reference to the Board

- 17. Where there is failure on the part of a party to proceedings:-
 - (a) to comply with any of these rules;
 - (b) to comply with an interlocutory order; or

FISHERIES ACT 1905

Shark Bay Prawn Limited Entry Fishery Notice 1990 Notice No. 449

146/75 V5.

MADE by the Minister under Section 32.

Citation

1. This notice may be cited as the SHARK BAY PRAWN LIMITED ENTRY FISHERY NOTICE 1990.

Commencement

2. This notice shall come into operation on the day on which it is published in the Gazette.

Interpretation

3. In this notice unless the contrary intention appears—

"approved form" means in a form approved by the Director;

"area" means an area described in item 2 of the Schedule;

"boat units" means boat units calculated in accordance with clause 15;

"Fishery" means the Shark Bay Prawn Limited Entry Fishery declared under clause 4;

"headrope length" means the distance measured along the headrope from where the otter trawl net attaches to one end of the headrope to where it attaches to the other end of the headrope;

"licence" means a licence authorising a boat to operate in the Fishery;

"otter board" means one of the boards used on an otter trawl net to keep the mouth of the net open while under tow;

"prawns" means all species of decapod crustacea of the family Penaeidae;

"standard trawl net" means an otter trawl net with a headrope length exceeding five metres, but not exceeding 14.63 metres;

"try net" means an otter trawl net with a headrope length not exceeding five metres.

Declaration of limited entry fishery

- 4. (1) It is hereby declared that prawns shall constitute a limited entry fishery in the waters described in item 1 of the Schedule to be called the Shark Bay Prawn Limited Entry Fishery.
- (2) The waters referred to in subclause (1) shall be divided into areas as described in item 2 of the Schedule.

Prohibition on taking prawns

5. A person, other than a person to whom section 32(5) of the Act applies, shall not take, or attempt to take, prawns by any means in the waters described in item 1 of the Schedule other than in accordance with this notice.

Prohibition on selling or dealing

6. A person shall not sell or deal or attempt to sell or deal in any way with prawns taken in contravention of this notice.

Criteria to determine the boats which may operate in the Fishery

- 7. The criteria that shall be applied to determine the boats which may operate in the Fishery are—
 - (a) that immediately before the coming into operation of this notice the owner or person in charge of a boat was the holder of a licence authorising the boat to be used to take prawns in the Shark Bay Prawn Fishery from 21 March 1988 to 15 November 1988; or
 - (b) that the boat replaces a boat to which paragraph (a) applied.

Application for a licence

8. The owner of a boat which fulfils the criteria in clause 7 (a) or (b) may apply in accordance with clause 19 for a licence authorising the boat to operate in the Fishery.

Details on licence

- 9. A licence shall contain the following details-
 - (a) the name and licensed fishing boat number in respect to which it is issued;
 - (b) the name and address of the owner or licensee of that boat;
 - (c) the licence number;
 - (d) the day of issue;
 - (e) the period for which the licence is valid; and
 - (f) any conditions imposed on the licence.

Closure of the fishery

- 10. A person, other than a person to whom section 32 (5) of the Act applies, shall not take, or attempt to take prawns—
 - (a) during the periods commencing on 1 January and ending at 1700 hours on 11 April and commencing at 0800 hours on 2 November and ending on 31 December in any year, in any waters of the Fishery;
 - (b) during the period commencing at 1700 hours on 11 April and ending at 0800 hours on 18 April in any year, in that area of the Fishery described in item 2 (a) of the Schedule;

- (c) during the period commencing at 0800 hours on 18 April and ending at 0800 hours on 1 August in any year, in that area of the Fishery described in item 2 (b) of the Schedule;
- (d) during the period commencing at 0800 hours on 1 August and ending at 0800 hours on 2 November in any year, in that area of the Fishery described in item 2 (c) of the Schedule;
- (e) during the period commencing at 1700 hours on 27 April and ending at 0800 hours on 15 May in any year, in that area of the Fishery described in item 2 (d) of the Schedule.

Authorised means of operating in the Fishery

- 11. (1) A person shall not take, or attempt to take, prawns by any means from a licenced boat in the Fishery other than by—
 - (a) two standard trawl nets; and
 - (b) one try net.
- (2) Unless otherwise approved in writing by the Director a standard trawl net may—
 - (a) have attached to each end of the headrope a single otter board the measurements of which do not exceed 2.44 metres in length and 0.91 metres in breadth and have shoes which do not exceed 150 millimetres in width and 25 millimetres in depth; and
 - (b) have attached to it one ground chain the links of which do not exceed 10 millimetres in diameter.

Stowage of otter boards and otter trawl nets

12. Unless otherwise authorised in writing by the Director, otter boards and otter trawl nets carried by or attached to a boat shall be secured to the boat and be kept out of the water between 0800 hours and 1700 hours on each day of operation.

Transfer of licence

13. With the prior written approval of the Director a licence granted under this notice may be transferred and the licence shall be endorsed accordingly.

Boat replacement

14. (1) For the purpose of this clause—

"Code" means the Uniform Shipping Laws Code Adopted by the Marine and Ports Council of Australia and published in the Commonwealth of Australia Gazette on 11 May, 1981;

"B" means "breadth" as defined in the Code:

"D" means "depth" as defined in the Code;

"IEP" is installed engine power in kilowatts of the boat's engine as certified by the supplier;

"ML" means "measured length" as defined in the Code measured in accordance with Appendix A to Section 1 of the Code.

(2) Subject to the prior written approval of the Director a boat licensed to operate in the Fishery may be replaced by a boat provided that the replacement boat does not exceed 375 boat units calculated in accordance with the following formula—

$$\frac{\text{M L} \times \text{B x D x 0.6}}{2.83} + \text{IEP}$$

Boat modification

- 15. The owner of a boat licensed to operate in the Fishery shall not, without the prior written approval of the Director, repower the boat by—
 - (a) changing the configuration of the existing engine, gearbox, propeller, propeller shaft or other components; or
 - (b) installing a new engine.

Engine seals

- 16. (1) The owner of a boat licensed to operate in the Fishery shall—
 - (a) on the written instruction of the Director cause the suppliers of an engine for the boat to install a lead seal on the fuel pump of such engine; and
 - (b) authorise the Director to install or permit the installation of any such further lead seals as the Director may require.
- (2) The owner of the boat the engine of which has installed a seal in accordance with subclause
- (1) (a) or (b) shall—
 - (i) not permit the removal or allow any interference to such seal without the prior written approval of the Director; and
 - (ii) immediately report to the Director any interference to such seal caused by accident or mechanical requirements and as soon as practical thereafter arrange for re-certification of the installed engine power by the supplier and the installation of a new seal.

Inspection of engine and seals

17. The owner of a boat licensed to operate in the Fishery shall permit the inspection of the engine configuration and any seal by an officer of the Fisheries Department and shall permit on board the boat any person such officer may require for such inspection.

Applications and fees

- 18. Applications under clauses 8, 13 and 15 shall be-
 - (a) in the approved form;
 - (b) lodged in accordance with the instructions if any; and
 - (c) accompanied by the fee prescribed by regulation.

Determination of position by reference to the Australian Geodetic Datum

- 19. (1) Where, for the purpose of this notice it is necessary to determine a position on the surface of the Earth by geographical coordinates, that position shall be determined on the Australian Geodetic Datum which is defined by an ellipsoid having a semi-major axis (equatorial radius) of 6 378 160 metres and a flattening of 1/298.25 and fixed by the position of the origin being the Johnston Geodetic Station in the Northern Territory of Australia.
- (2) The Johnston Geodetic Station referred to in subclause (1) shall be taken to be situated at 25°55'54.5515" south latitude and at 133°12'30.0771" east longitude and to have a ground level elevation of 571.2 metres above the ellipsoid referred to in that subclause.

Revocation

20. Notice No. 398 published in the Gazette of 14 April 1989 is cancelled.

That area of the Fishery south of 25°15′50" south latitude and east of 113°30′20" east longitude and in that area described in Item 2 (b) (i) above.

ITEM 2(d)

That part of that area of the Fishery described in item 2 (c) above south of 25°18'50" south latitude.




