### SOIL AND LAND CONSERVATION ACT 1945

# SOIL AND LAND CONSERVATION (CARNAMAH SOIL CONSERVATION DISTRICT) AMENDMENT ORDER 1990

Made by His Excellency the Governor in Executive Council under section 23 (2d) of the *Soil and Land Conservation Act 1945* and on the recommendation of the Minister for Agriculture.

#### Citation

1. This order may be cited as the Soil and Land Conservation (Carnamah Soil Conservation District) Amendment Order 1990.

### Principal order

2. In this order the Soil and Land Conservation (Carnamah Soil Conservation District) Order 1985\* is referred to as the principal order.

#### Clause 1 amended

3. Clause 1 of the principal order is amended by deleting "Soil Conservation District" and substituting the following—

" Land Conservation District ".

#### Clause 3 amended

4. Clause 3 of the principal order is amended-

- (a) in the definition of "committee"—
  - (i) by deleting "District Advisory" and substituting the following— " Land Conservation District "; and
  - (ii) by deleting "Soil" and substituting the following—" Land ";

   "producer organizations" means the bodies known respectively as the Western Australian Farmers Federation (Inc.) and the Pastoralists and Graziers Association of Western Australia; "; and

- (e) 6 shall be appointed by the Minister and shall be actively engaged in, or affected by or associated with, land use in the district. ";
- (b) by repealing subclause (2) and substituting the following subclauses-
  - " (2) The Western Australian Farmers Federation (Inc.) shall submit to the Minister a panel containing the names of persons willing to be appointed as members of the committee and, where such a panel is submitted in accordance with this order, 2 persons whose names appear on the panel submitted by the Western Australian Farmers Federation (Inc.) shall be appointed by the Minister.

(2a) The Pastoralists and Graziers Association of Western Australia shall submit to the Minister a panel containing the names of persons willing to be appointed as members of the committee and, where a panel is submitted in accordance with this order, one person whose name appears on the panel submitted by the Pastoralists and Graziers Association of Western Australia shall be appointed by the Minister. ";

- (c) in subclause (5) by deleting "Governor" and substituting the following—" Minister "; and
- (d) in subclause (6) (b) by deleting "Governor" and substituting the following—
  - " Minister ".

### SOIL AND LAND CONSERVATION ACT 1945 SOIL AND LAND CONSERVATION (BIBBY SPRINGS LAND CONSERVATION DISTRICT) ORDER 1990

Made by His Excellency the Governor in Executive Council under sections 22 and 23 of the *Soil and Land Conservation Act 1945* and on the recommendation of the Minister for Agriculture.

#### Citation

1. This order may be cited as the Soil and Land Conservation (Bibby Springs Land Conservation District) Order 1990.

#### Interpretation

2. In this order—

- "appointed member" means a person appointed under clause 5 (1) (b), (c), (d) or (e) to be a member of the committee;
- "committee" means the Land Conservation District Committee for the Bibby Springs Land Conservation District;
- "member" means a member of the committee;
- "the district" means the Bibby Springs Land Conservation District constituted by clause 3;
- "the producer organizations" means the bodies known respectively as the Western Australian Farmers Federation (Inc.) and the Pastoralists and Graziers Association of Western Australia.

#### **Bibby Springs Land Conservation District**

3. The land described in the Schedule to this order is hereby constituted the Bibby Springs Land Conservation District.

#### Establishment of the committee

4. Pursuant to section 23 (2) of the *Soil and Land Conservation Act 1945* there is hereby established for the district a land conservation district committee to be known as the Land Conservation District Committee for the Bibby Springs Land Conservation District.

#### Constitution of the committee

5. (1) It is hereby determined, on the recommendation of the Minister, after consultation with the Shire of Dandaragan and the producer organizations, that the committee shall comprise 9 members of whom—

- (a) one shall be the Commissioner for Soil Conservation or his nominee;
- (b) one shall be appointed by the Minister on the nomination of the Shire of Dandaragan;
- (c) 2 shall be appointed in accordance with subclause (2);
- (d) one shall be appointed in accordance with subclause (3); and
- (e) 4 shall be appointed by the Minister, of whom-
  - (i) 3 shall be persons actively engaged in, or affected by or associated with, land use in the district; and
  - (ii) one shall be a representative of the Department of Conservation and Land Management being a Government department actively engaged in, or affected by or associated with, land use in the district.

(2) The Western Australian Farmers Federation (Inc.) shall submit to the Minister a panel containing the names of persons willing to be appointed as members of the committee and, where such a panel is submitted in accordance with this order, 2 persons whose names appear on the panel shall be appointed by the Minister.

(3) The Pastoralists and Graziers Association of Western Australia shall submit to the Minister a panel containing the names of persons willing to be appointed as members of the committee and, where such a panel is submitted in accordance with this order, one person whose name appears on the panel shall be appointed by the Minister.

(4) Subject to this clause, each appointed member shall hold office for such period not exceeding 3 years as is specified in the instrument of his appointment and is eligible for reappointment.

(5) The Minister may grant leave of absence to an appointed member on such terms and conditions as the Minister determines.

(6) The Minister may terminate the appointment of an appointed member for inability, inefficiency or misbehaviour.

(7) If an appointed member-

- (a) is or becomes an undischarged bankrupt or person whose property is subject to an order or arrangement under the laws relating to bankruptcy;
- (b) has his appointment terminated by the Minister, pursuant to subclause (6);
- (c) is absent, except on leave duly granted by the Minister, from 3 consecutive meetings of the committee of which he has had notice; or

(d) resigns his office by written notice addressed to the Minister, the office of that appointed member becomes vacant.

#### Proceedings of the committee

6. (1) The committee shall hold its meetings at such place on such days and at such intervals as the committee shall from time to time determine.

(2) At any meeting of the committee-

- (a) a majority of the members constitute a quorum;
- (b) the Chairman shall preside and where he is absent from the meeting the members may appoint one of their number to preside at that meeting;
- (c) each member present is entitled to a deliberative vote; and
- (d) where the votes cast on any question are equally divided the Chairman, or the presiding member in terms of paragraph (b), shall have a casting vote.

(3) The committee shall cause accurate minutes to be kept of the proceedings at its meetings.

(4) To the extent that it is not prescribed, the committee may determine its own procedure.

All that portion of land bounded by lines starting from the north-western corner of Melbourne Location 3748 and extending easterly along the northern boundary of that location to the western boundary of Location 3747; thence northerly and easterly along boundaries of that location and Location 3746 to the south western side of Yerramullah Road; thence generally south-easterly along sides of that road to the prolongation south-westerly of the south-eastern side of Cadda Road; thence northeasterly to and north-easterly, south-easterly and generally north-easterly along sides of that road to the northern corner of Location 3851 (A Class Reserve 31809); thence generally south-easterly along boundaries of that location and Location 3852 to the northern boundary of Location 3854; thence easterly along that boundary and the northern boundary of Lot 1 as shown on Office of Titles Diagram 65536 to the north-western side of Brand Highway; thence generally south-westerly, south-easterly and south-erly along sides of that road to the northern side of Wongonderrah Road; thence generally westerly along sides of that road to the prolongation northerly of the eastern boundary of the northern severance of Location 4053; thence southerly to and along that boundary, the eastern boundary of Location 4054 and the eastern boundary of the southern severance of Location 4053 to the southeastern corner of that severance; thence westerly along the southern boundary of that severance to the eastern most north-eastern corner of Location 3974 (Reserve 28393); thence westerly, generally northerly and again westerly along boundaries of that location to an eastern boundary of the western severance of Reserve 28393; thence northerly along the boundary of that severance and onwards to the southern corner of the eastern severance of Reserve 28393; thence northerly and westerly along boundaries of that severance and onwards to a north-eastern corner of the western severance of Reserve 28393; thence westerly along a northern boundary of that severance to the eastern boundary of Location 2490; thence southerly, generally south-westerly and northerly along boundaries of that Location and onwards to a north-eastern corner of the western severance of Reserve 28393; thence south-easterly to the western most north-western corner of Location 3953 (Reserve 29149), thence generally north-easterly along boundaries of that location to the prolongation southerly of the eastern boundary of Location 3922; thence northerly to and northerly, north-easterly and again northerly along boundaries of that location to the south-eastern corner of Location 3923; thence northerly along the eastern boundary of that location and onwards to the south-western corner of Location 3752; thence northerly along the western boundary of that location to the southern side of Cervantes Road, thence easterly and generally north-easterly along sides of that road and onwards to the north-eastern side of Munbinea Road; thence north-westerly along that side to the starting point.

### PRAWN TRAWLING PROHIBITION—ONSLOW NOTICE 1990

#### Notice No. 451

Made by the Minister under section 9.

Citation

This notice may be cited as the Prawn Trawling Prohibition—Onslow Notice 1990.

#### Prohibition on prawn trawling

The taking of prawns by means of trawling from the waters specified in the Schedule is prohibited at all times.

#### Schedule




