#### PETROLEUM PRODUCTS PRICING ACT 1983

PETROLEUM PRODUCTS PRICING (MAXIMUM PRICES FOR MOTOR FUEL) AMENDMENT ORDER (No. 23) 1990

Made by the Prices Commissioner under section 12.

## Citation

1. This order may be cited as the Petroleum Products Pricing (Maximum Prices for Motor Fuel) Amendment Order (No. 23) 1990.

#### Commencement

2. This order shall take effect on 24 September 1990.

# Interpretation

3. In this order—

"the principal order" means the Petroleum Products Pricing (Maximum Prices for Motor Fuel)
Order 1984\*.
