HEALTH ACT 1911

HEALTH (MEAT INSPECTION AND BRANDING) AMENDMENT REGULATIONS (No. 5) 1991

Made by His Excellency the Governor in Executive Council. Citation

1. These regulations may be cited as the Health (Meat Inspection and Branding) Amendment Regulations (No. 5) 1991.

Commencement

2. These regulations shall come into operation on 15 July 1991.

Principal regulations

3. In these regulations the Health (Meat Inspection and Branding) Regulations 1950^* are referred to as the principal regulations.

Regulations 5 amended


4. Regulation 5 of the principal regulations is amended by inserting after the item "Murray Area—Council Office, Pinjarra Road, Pinjarra" the following item—

" Nabawa-Rossvale Meats, Nabawa ".
