



Directing Destruction of the Declared Plant

Blackberry (Rubus fruticosus agg.)

To all occupiers and owners of private land situated in the Shires shown on the schedule below. The Agriculture Protection Board, pursuant to the provisions of section 50 of the Agriculture Protection Act 1976, hereby directs that the declared plant Blackberry (*Rubus fruticosus* agg.) present on private land owned or occupied by you, situated within the municipal districts, within the meaning of the Local Government Act, as amended, of the Shires specified in the schedule below shall be destroyed by you by the following methods—

- 1. Effective grubbing and/or cultivation of all plants, or
- 2. Spraying all plants with the recommended dose of a herbicide registered for this purpose, in accordance with the requirements of the Agriculture and Related Resources Protection (Spraying Restrictions) Regulations 1979-1989.

You are required to commence the requirement of this Notice on or before January 16, 1992 and to complete the requirements of this Notice on or before February 16, 1992.

DAIRY INDUSTRY ACT 1973

Directions by the Minister to the Dairy Industry Authority under section 27

I, Ernest Francis Bridge, Minister for Agriculture, being the Minister for the time being administering the Dairy Industry Act 1973, pursuant to the powers conferred by section 27 of that Act, hereby direct the Dairy Industry Authority to determine applications for market milk quota made to it under section 26 of the Act in respect of the quota year commencing on 1 January 1992, on the following bases or principles.

- (1) Subject to this paragraph, a dairyman holding a market milk quota at the end of the 1991 Quota Year shall, upon application duly made, be granted initially a market milk quota for the 1992 Quota Year of an amount that is not less on a daily basis than the sum of the amount of market milk quota held by him at the end of the 1991 Quota Year. Provided that—
 - (a) The dairy premises to which the application relates and in which milk is to be produced are the same as the dairy premises referred to in the quota certificate held by the applicant, or the registered premises authorised by the Authority under section 28 (2a) immediately before the end of the 1991 Quota Year; and
 - (2) Notwithstanding that the requirements of sub-paragraph (1) of this paragraph may apply to a dairyman, unless such requirements are satisfied by a dairyman in his application, he shall not be granted a market milk quota.
 - (3) Where a dairyman short-supplies market milk quota issued to him at any time during the course of the 1992 Quota Year, the quota shall be reduced in accordance with the approved terms and conditions for short supply.
 - 1. (1) The Authority may refuse an application if approval of the application would result in the applicant or the applicant, together with any person associated with the applicant (as determined by the Authority in accordance with sub-paragraph (2) of this paragraph), holding a market milk quota of more than 2300 litres daily for the 1992 Quota Year.
 - (2) The Authority may determine that a person is associated with an applicant if that person holds a market milk quota and is, in the opinion of the Authority—
 - (a) a partner of the applicant;
 - (b) a corporation of which the applicant is an officer or director;
 - (c) where the applicant is a corporation, an officer or director of the corporation;
 - (d) an officer or director of any corporation of which the applicant is an officer or director;
 - (e) an employee or employer of the applicant;
 - (f) an employee of a natural person of whom the applicant is an employee;
 - (g) a corporation whose directors are accustomed or under an obligation whether formal or informal, to act in accordance with the directions, instructions or wishes of the applicant or, where the person is a corporation, of the directors or management of that person;
 - (h) a corporation in accordance with the directions, instructions or wishes of which, or of the directors or management of which, the applicant is accustomed or under an obligation, whether formal or informal, to act;
 - (i) a corporation in which the applicant holds a substantial interest; or
 - (\mathbf{j}) where the person is a corporation—a person who holds a substantial interest in the corporation,

but persons shall not be regarded as associates if the Authority is satisfied on representations made by one or more of them and after its own enquiries (if any) that they are commercially independent in their respective enterprises.

NOTICE OF THE REVISED DRAFT ENVIRONMENTAL PROTECTION (KWINANA) (ATMOS-PHERIC WASTE) POLICY AND REGULATIONS 1991

The Environmental Protection Authority has prepared a revised draft environmental protection policy and regulations to control atmospheric waste in the air environment around Kwinana.

The revised policy and regulations will achieve their objectives by applying conditions to operating licences of industries which emit atmospheric waste.

The revised draft environmental protection policy incorporates information supplied in submissions received by the EPA on the initial draft environmental protection policy for sulphur dioxide and dust in the Kwinana region, released for public comment in December 1989.

In accordance with section 28 (c) (ii) of the Environmental Protection Act the EPA has submitted the revised draft policy and regulations to the Minister for the Environment.

After receiving and considering the draft policy, the Minister will consult organisations and individuals he considers likely to be affected by the revised draft policy.

CLOSED WATERS NETTING (FREMANTLE TO YANCHEP) NOTICE 1991

Notice No. 512

FD367/66

Made by the Minister under section 9, 10 and 11.

Citation

1. This notice may be cited as the Closed Waters Netting (Fremantle to Yanchep) Notice 1991.

Interpretation

2. A reference to column 1, 2, 3 or 4 is a reference to the respective column in the Schedule.

Prohibition on taking fish by nets

2.10.1 Where an application is made for Planning Consent to commence or carry out development which involves an "SA" use the Council shall not grant consent to that application unless notice of the application is first given in accordance with the provisions of this Clause.

2.10.2 Where an application is made for Planning Consent to commence or carry out development which involves an "AA" use, or for any other development which requires the Planning Consent of the Council, the Council may give notice of the application in accordance with the provisions of this clause.

- (c) A sign or signs displaying notice of the proposed development to be erected in a conspicuous position on the land for a period of twenty-one days from the date of publication of the notice referred to in paragraph (b) of this clause.

2.10.4 The notice referred to in Clause 2.10.3 (a) and (b) shall be in the form contained in Appendix 2 with such modifications as circumstances require.

2.10.5 Alter expiration of twenty-one days from the serving of notice of the proposed development, the publication of notice or the erection of a sign or signs, whichever is the later, the Council shall consider and determine the application."

Appendix 3

- Abattoir: means land and buildings used for the slaughter of animals for human consumption and the treatment of carcasses, offal and by-products.
- Battle-axe Lot: means a lot having access to a public road by means of an access strip included in the Certificate of Title of that lot.
- Building Envelope: means an area of land within a lot marked on a plan forming part of the Scheme outside which building development is not permitted.
- Camping Area: means land used for the lodging of persons in tents or other temporary shelter.
- Caravan: means a vehicle as defined under the Road Traffic Act 1974-82 maintained in condition suitable for licence under that Act at all times and being designed or fitted or capable of use as a habitation or for a dwelling or sleeping purposes.
- Caravan Park: means an area of land specifically set aside for the parking of caravans and park homes or for the erection of camps on bays or tent sites allocated for that purpose.
- Cattery: means the use of an approved out-building constructed in accordance with the Health Act Model By-laws Series 'A' Part One—General Sanitary Provisions (as amended) for the purpose of keeping more than three (3) cats over the age of three (3) months.
- Day Care Centre: means land and buildings used for the daily or occasional care of children in accordance with the Child Welfare (Care Centres) Regulations, 1968 (as amended).
- Dog Kennels: means land and buildings used for the boarding and breeding of dogs where such premises are registered or required to be registered by the Council; and may include the sale of dogs where such use is incidental to the predominant use.
- Equestrian Centre: means land and buildings used for the stabling and exercise of horses and includes facilities for events of a competitive nature.
- Garden Centre: means land and buildings used for the sale and display of garden products, including garden ornaments, plants, seeds, domestic garden implements and motorised implements and the display but not manufacture of prefabricated garden buildings.
- Home Occupation: means a business or activity carried on with the written permission of the Council within a dwelling house or the curtilage of a house by a person resident therein or within a domestic outbuilding by a person resident in the dwelling house to which it is appurtenant that—
 - (a) Does not cause injury to or prejudicially affect the amenity of the neighbourhood including (but without limiting the generality of the foregoing) injury, or prejudicial affection due to the emission of light, noise, vibration, electrical interferences, smell, fumes, smoke, vapour, steam, soot, ash, dust, grit, oil, liquid wastes or waste products or the unsightly appearance of the dwelling house or domestic outbuilding or the land on which the business is conducted;
 - (b) Does not entail employment of any person not a member of the occupier's family;
 - (c) Does not occupy an area greater than twenty square metres;
 - (d) Does not require the provision of any essential service main of a greater capacity than normally required in the zone in which it is located;
 - (e) Does not display a sign exceeding 0. 2 m^2 in area;
 - (f) In the opinion of the Council it is compatible with the principal uses to which land in the zone in which it is located may be put and will not in the opinion of the Council generate a volume of Trafiic that would prejudice the amenity of the area;
 - (g) Does not entail the presence, use or calling of a vehicle of more than two tonnes tare:
 - (h) Does not entail the presence of more than one commercial vehicle and does not include provision for the fuelling or repairing of motor vehicles within the curtilage of the dwelling house or domestic out-building.
 - (i) Does not entail the offering for sale or display of motor vehicles machinery or goods (other than goods manufactured or serviced on the premises); and
 - (j) Does not entail a source of power other than an electric motor of not more than 0.373 kilowatts (0.5 h.p.).

Industry—Cottage: means an industry which produces arts and crafts goods which cannot be carried out under the provisions relating to a "home occupation" and that—

- (a) Does not cause injury to or prejudicially affect the amenity of the neighbourhood including (but without limiting the generality of the foregoing) injury, or prejudicial affection, due to the emission of light, noise, vibration, steam, soot, ash, dust, grit, oil, liquid wastes or waste products,
- (b) Where operated in a Residential Zone, does not entail the employment of any person not a member of the occupier's family normally resident on the land,
- (c) Is conducted in an out-building which is compatible to the zone and its amenity and does not occupy an area in excess of 55 m²,
- (d) not require the provision of any essential service main of a greater capacity than normally required in the zone in which it is located, and;
- (e) Does not display a sign exceeding 0. 2 m^2 in area.
- Industry—Rural: means an industry handling, treating, processing or packing primary products grown, reared or produced in the locality, and a workshop servicing plant or equipment used for rural purposes in the locality.
- Industry—Service: means a light industry carried out on land or in buildings which may have a retail shop front and from which goods manufactured on the premises may be sold; or land and buildings having a retail shop front and used as a depot for receiving goods to be serviced.
- Kindergarten: means land and buildings used as a school for developing the intelligence of young children by object-lessons, toys, games, singing and similar methods.
- Market: means land and buildings used for a fair, a farmers' or producers market, or a swap-meet in which the business or selling carried on or the entertainment provided is by independent operators or stall holders carrying on their business or activities independently of the market operator save for the payment where appropriate of a fee or rental.
- Milk Depot: means land and buildings to which milk is delivered for distribution to consumers but in which milk is not processed or pasteurised.
- Nursery: means land and buildings used for the propagation, rearing and sale of products associated with horticultural and garden decor.
- Piggery: shall have the same meaning given to it in and for the purposes of the Health Act, 1911-1979 (as amended).
- Potable Water: means water in which levels of physical, chemical and bacteriological constituents do not exceed the maximum permissible levels set out in, International Standards for Drinking Water—Third Edition, World Health Organisation (1971).
- Poultry Farm: means land and buildings used for hatching, rearing or keeping of poultry for either egg or meat production which does not constitute an offensive trade within the meaning of the Health Act, 1911-1979 (as amended).
- Professional Office: means a building used for the purposes of his profession by an accountant, architect, artist, author, barrister, chiropodist, consular official, dentist, doctor, engineer, masseur, nurse, physiotherapist, quantity surveyor, solicitor surveyor, teacher (other than a dancing teacher or a music teacher), town planner, or valuer, or a person having an occupation of a similar nature, and Professional Person has a corresponding interpretation.
- Restaurant: means a building wherein food is prepared for sale and consumption within the building and the expression shall include a licensed restaurant, and a restaurant at which food for consumption outside the building is sold where the sale of food for consumption outside the building is not the principal part of the business.

Rural Pursuit: means the use of land for any of the purposes set out hereunder and shall include such buildings normally associated therewith—

- (a) The growing of vegetables, fruit, cereals or food crops;
- (b) The rearing or agistment of goats, sheep, cattle or beasts of burden;
- (c) The stabling, agistment or training of horses;
- (d) The growing of trees, plants, shrubs, or flowers for replanting in domestic, commercial or industrial gardens;
- (e) The sale of produce grown solely on the lot; but does not include the following except as approved by the Council—
 - (i) The keeping of pigs;
 - (ii) Poultry farming;
 - (iii) The processing, treatment or packing of produce;
 - (iv) The breeding, rearing or boarding of domestic pets.
- Rural Use: means uses carried out in pursuit of agriculture, horticulture, viticulture, grazing, dairying, or farming generally and the expression includes market gardens, stables, horse training, nurseries and the like.

Stables: means land and building used for the housing and keeping of horses.

- Temporary Accommodation: means any habitable building not permanently affixed to the ground and includes any caravan, transportable dwelling, or any structure used for habitation for the purposes of accommodation for a period not exceeding six months.
- Tavern: means land and buildings the subject of a Tavern Licence granted under the provisions of the Liquor Act, 1970 (as amended).
- Trade Display: means land and buildings used for the display of trade goods and equipment for the purposes of advertisement.
- Transport Depot: means land and buildings used for the garaging of motor vehicles used or intended to be used for carrying goods or persons for hire or reward or for any consideration, or for the transfer of goods or persons from one such motor vehicle to another of such motor vehicles and includes maintenance, management and repair of the vehicles used, but not of other vehicles.
- Transportable Home: means any structure designed for human habitation that is partly or wholly prefabricated at any place other than on the lot upon which it is to be erected.
- Veterinary Consulting Rooms: means a building in which a veterinary surgeon or veterinarian treats the minor ailments of domestic animals and household pets as patients but in which animals or pets do not remain overnight.
- Veterinary Hospital: means a building used in connection with the treatment of sick animals and includes the accommodation of sick animals.
- Warehouse: means a building wherein goods are stored and may be offered for sale by wholesale.
- Wayside Stall: means a building situated on private land which offers for sale to the general public produce or any commodity which is produced on the land upon which the buildings are located.
- Zone: means a portion of the Scheme area shown on the map by distinctive colouring, patterns, symbols, hatching, or edging for the purpose of indicating the restrictions imposed by the Scheme on the erection and use of buildings or for the use of land, but does not include reserved land.
- Zoological Gardens: means land and buildings used for the keeping, breeding or display of fauna and the term includes Zoo but does not include kennels or keeping, breeding or showing of domestic pets.

(ii) introducing the following new clauses:

7.1 Council's Approval Necessary:

In addition to a Building Licence (where applicable) Council's prior approval to commence development is required for all development except in the case of zoned land a "single house". For the purposes of this clause "single house" does not include the development of Radio Masts and Antennae in Residential and Special Residential zones where the Council's prior approval to commence development will be required."

7.3

In the case of an application for the Council's approval to commence a development of a Radio Mast and Antennae the Council shall consider the application and may grant the approval or may refuse its approval or grant its approval upon such conditions as it thinks fit, or may refer the matter to a subsequent meeting of the Council to be held not less than three weeks nor more than six months after the passing of a resolution recommending referral.

7.4 Council's Approval:

In granting its approval to commence a development of Radio Mast and Antennae the Council shall take into consideration the following matters:

- (a) The provisions of any Town Planning Scheme including this Scheme affecting the land the subject of the application of affecting land in the vicinity;
- (b) The nature of the proposed development in relation to the development of any land within the vicinity of the said land;
- (c) The size, shape and character of the parcel of land to which the application relates and the nature and the siting of the proposed development, and the effect of the amenity of the surrounding area;
- (d) Any representations which may be made by any statutory authority and any submissions received from surrounding residents;

- (g) Such other matters as the Council considers relevant.

FREMANTLE PORT AUTHORITY AMENDMENT REGULATIONS (NO. 3) 1991

Citation

1. These regulations may be cited as the Fremantle Port Authority Amendment Regulations (No. 3) 1991.

Principal regulations

2. In these regulations the Fremantle Port Authority Regulations 1971* are referred to as the principal regulations.

- 3. Regulation 68 of the principal regulations is amended
 - (a) by repealing subregulation (1) and substituting the following subregulations —

(1) The master of a vessel, which is subject to the payment of tonnage rates under regulation 127, shall notify the Port Authority of the vessel's expected arrival time —

- (a) 24 hours ahead, when the vessel is in the vicinity of the Fairway Buoy marking the approach to Gage Roads; and
- (b) 2 hours ahead, to confirm or alter the notification given under paragraph (a),

and this notification shall be given by either wireless telegraphy or facsimile.

(1a) The master of a vessel, which is subject to payment of tonnage rates under regulation 130, shall advise the Port Authority of the movements of the vessel through the waters of the Port and shall, in the opinion of the Port Authority, maintain sufficient radio contact with the Port Authority to do so.

Detention or cancellation of pilot

(2) Where the master or agent of any vessel detain a pilot, who is providing services under an application referred to in regulation 105, for a period exceeding that which the application specifies, the Port Authority may charge, and the master or agent shall pay, an amount of \$278 per hour or part thereof for the period that the pilot is detained.

(3) Where the services of a pilot are available, in accordance with an application under regulation 105, to conduct a vessel from a nominated pilot boarding ground to a berth, as specified in the application, and the vessel —

- (a) does not arrive at the boarding ground at the appointed time; or
- (b) is not ready to proceed within half an hour of the appointed time,

the Port Authority may charge, and the master or agent shall pay, an amount of \$278 per hour or part thereof for the excess period, calculated from the appointed time. ":

- (2) Where a mooring gang is ordered or requisitioned to provide a service for a vessel and the services of the gang are not required at the nominated time, the Port Authority may charge, and the ship owner or agent shall pay, the following amounts in the following circumstances
 - (a) where the mooring gang is detained for more than half an hour beyond the nominated time
 - during ordinary hours 25% of the charge for the appropriate service for each hour or part thereof that the gang is detained after the nominated time;
 - during overtime hours 50% of the charge for the appropriate service per 2 hours or part thereof that the gang is detained after the nominated time;
 - (b) where the request for the mooring gang is cancelled
 - (i) during ordinary hours
 - (A) where at least 2 hours notice is given no charge;
 - (B) where less than 2 hours notice is given — 25% of the appropriate service charge;
 - (ii) during overtime hours 100% of the appropriate service charge.
 - (3) For the purposes of this regulation
 - (a) each mooring and each unmooring is a separate service;
 - (b) "ordinary hours" are the hours between 7 am and 4 pm Monday to Friday, excluding public holidays;
 - (c) "overtime hours" are any hours which are not ordinary hours;
 - (d) "service charge" means the charge set out in subregulation (1).

239. A person shall not ply or tout for hire as a baggage porter at or on any wharf or upon any vessel within the port unless the person holds a licence issued under regulation 241.

"

Application for licence

240. An application for a licence or renewal of a licence shall be —

- (a) submitted on a form approved by the Port Authority;
- (b) in the case of an initial application, accompanied by 2 written testimonials supporting the application;
- (c) signed by the applicant; and
- (d) lodged with the Port Authority, at least 14 days prior to the expiry of any existing licence, together with an application, or renewal, fee of \$5.

Issue of licence

241. Following an application in accordance with regulation 240, the Port Authority may issue a licence to a person allowing that person to operate as a baggage porter independently, or as the servant, agent or contractor of a business.

Terms of licence

242. A licence issued under regulation 241 —

- (a) expires on 30 June after the issue of that licence unless otherwise provided in that licence;
- (b) is subject to the terms and conditions (if any) imposed upon that licence by the Port Authority; and
- (c) may, by written notice given personally or by post to the licensee by the Port Authority, be varied or revoked by the Port Authority.

Badge to be worn by licensee

243. A licensee under this Part shall wear an identifying badge, approved by the Port Authority, whenever operating under the licence.

Transfer of licence

244. A licensee under this Part shall not assign or transfer his licence, or allow his badge to be used by another, without the written consent of the Authority.

Carriers and drivers

245. (1) A person who enters the premises of the Port Authority with a vehicle to ply for hire for the carriage of passengers or passengers' luggage, or for the carriage of goods, shall not —

- (a) park other than in a space allotted by the Port Authority and indicated as such by signs;
- (b) discharge passengers or any light luggage in the vicinity of a vessel unless
 - (i) the vehicle is, in the opinion of the Manager, left in a safe position; and
 - (ii) the vehicle is removed immediately after the passengers or luggage have been discharged.

"

(2) A carrier or driver described in subregulation (1) may join a "rank" of other carriers or drivers in a space allocated by the Port Authority for that purpose and when joining that rank —

- (a) shall park in the next available position after those vehicles already parked in that rank; and
- (b) shall not accept a hiring before a carrier or driver with a prior position in that rank.

Cancellation of licence or refusal of entry

246. (1) Notwithstanding anything in this Part, where a licensed baggage porter, or a carrier or driver, refuses to comply with a direction given by a Port Authority officer or a police officer, or where, in the Port Authority's opinion, misconduct is established against a porter, carrier or driver, the Port Authority may —

- (a) in the case of a licensed baggage porter, suspend or cancel the porter's licence;
- (b) in the case of a carrier or driver, refuse that person entry to the premises of the Port Authority.

(2) A licensed baggage porter shall, if his licence is cancelled under subregulation (1) (a), deliver his licence and badge to the Port Authority.
