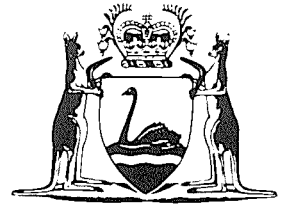

**PETROLEUM PRODUCTS PRICING ACT 1983**

**PETROLEUM PRODUCTS PRICING (MAXIMUM PRICES FOR MOTOR FUEL) AMENDMENT  
ORDER (No. 3) 1992**

Made by the Prices Commissioner under section 12.

**Citation**

1. This order may be cited as the *Petroleum Products Pricing (Maximum Prices for Motor Fuel) Amendment Order (No. 3) 1992*.

**Commencement**

2. This order shall take effect on 28 February 1992.

**Interpretation**

3. In this order—

“the principal order” means the *Petroleum Products Pricing (Maximum Prices for Motor Fuel) Order 1984\**.

**Clause 4 amended**

“ 69.1c ”; and

(c) “74.2c” in paragraph (c) and substituting the following—

“ 73.9 ”.
