Schedule 2**Interpretation****1. In this Schedule—**

“end stop position” means the position at the maximum extension of the spring or springs as determined by the extension limiting device;

“extension limiting device” means a cord or similar device which limits the amount of extension of the spring or springs;

“nominal load” means the minimum force required to extend goods to the stretched length, with the minimum force being determined on the third extension of the goods;

“stretched length” means the extension of the goods to a length marginally short of the end stop position.

Construction requirements**2. The goods shall incorporate an extension limiting device.****Test requirements****3. (1) The goods shall be part of a batch of those goods where a random sample subjected to the following two tests does not show any failure, breakage or distortion—****Test 1**

- (a) Condition a test specimen by extending it 1 000 times to the end stop position.
- (b) Render the specimen's extension limiting device inoperative.
- (c) Secure the test specimen in a suitable tension transmitting device by clamping the footpedals in position.
- (d) Apply a load of three times the nominal load to one handgrip of the specimen for a period of five seconds.

Test 2

- (a) Secure a test specimen in a suitable tension transmitting device by clamping one footpedal in position.
- (b) Apply a load of two times the nominal load to the footstrap of the unsecured footpedal such that the load is applied perpendicular to the specimen's spring for a period of five seconds.
- (c) Repeat procedure (b) a further four times.

(2) The goods are part of a batch of those goods where a random sample subjected to the following tests does not show any failure, or breakage:**Test 3**

- (a) Secure the test specimen in a suitable cyclic load transmitting device.
- (b) Set the cyclic rate at a frequency of between 10 and 20 per minute over the range determined by the specimen's unloaded position to its stretched length position.
- (c) Apply 50 000 cycles the specimen.

Labelling**4. (1) The goods shall be clearly and legibly marked with a statement of the name and address of the Australian manufacturer or the Australian importer and batch identification.****(2) The statement referred to in subclause (1) shall be permanently embossed or attached to the goods.****Instructions for Use****5. The goods shall be supplied with adequate safe use instructions relative to intended exercising with the equipment that in all cases shall include—**

- (a) a warning against while standing;
- (b) cautionary statements stressing the importance of security between feet or footwear and the foot pedals to avoid slipping; and
- (c) advice about checking before use that no part is broken, worn or loose.

The sale of these goods is restricted to persons aged 18 years or older and on the condition that the retailer is satisfied the purchaser is aged 18 years or older.

The retailer must keep a permanent written record of the name, address and age of each purchaser of these goods.

The packaging for these goods must display the following warning statement in a conspicuous position and in a legible form—

“WARNING: This replica is capable of causing eye injury. Not for sale to children under the age of 18 years.”

- (i) the word “WARNING” must be displayed in letters at least 2.5 millimetres in height.
- (ii) the remainder of the statement must be displayed in letters at least 1.5 millimetres in height.

TAXI CONTROL BOARD (ELECTIONS) REGULATIONS 1964

Regulation 6—Notice of Election

Notice is hereby given pursuant to Regulation 6 of the Taxi Control Board (Elections) Regulations 1964, that pursuant to paragraph (c) of sub-section (3) of section 8 of the Act, an election to elect two members for appointment to the Taxi Control Board will be held on 19 May, 1992 at the Office of the Western Australian Electoral Commission, Perth, closing at 10.00 a.m. on that day.

Nominations of candidates are hereby called from members of the industry who are in any of the following categories—

- (iii) not more than one shall be a person who is not actively engaged on the road in the operation of a taxi-car".

One who is registered as full-time driver of a taxi-car but is not also the owner of a taxi-car.

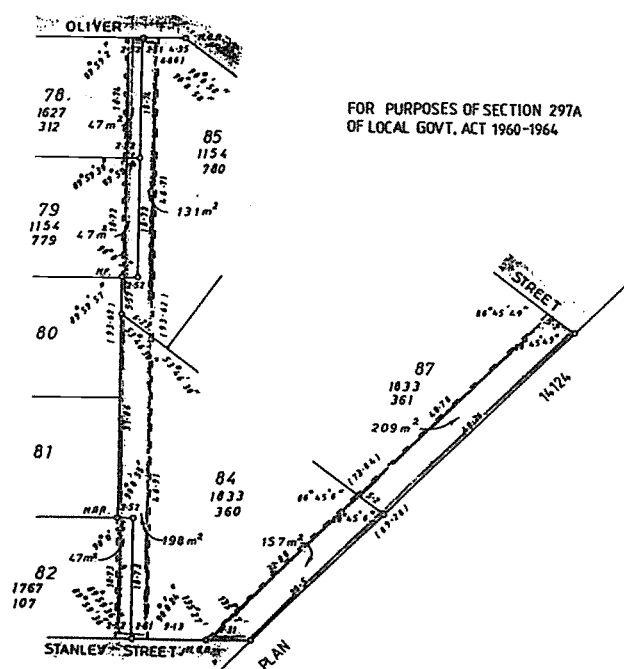

STATE SUPPLY COMMISSION REGULATIONS 1991

Made by His Excellency the Governor in Executive Council.

Citation

1. These regulations may be cited as the *State Supply Commission Regulations 1991*.

Public authorities that are totally exempt from section 19 (1)

2. The public authorities listed in Schedule 1 are public authorities which for the purpose of section 20 of the Act are totally exempt from section 19 (1) of the Act.

Partial exemption from section 19 (1)

3. (1) Before granting a partial exemption from section 19 (1) of the Act to a public authority under section 21 of the Act the Commission may request that the public authority submit to the Commission, in writing, a supply management business plan which complies with the relevant provisions of the supply policies regarding such plans.

(2) The Commission may approve of a supply management business plan submitted under subsection (1).

(3) A public authority shall manage the supply of goods and services in accordance with any supply management business plan approved in respect of that public authority.

Review of partial exemptions under section 21

4. (1) Subject to subregulation (2), the Commission shall review an exemption granted to a public authority under section 21 of the Act as provided in the exemption.

(2) The Commission may review an exemption granted to a public authority under section 21 of the Act at any time where the Commission is of the opinion that a review is required.

(3) In reviewing an exemption granted to a public authority under section 21 of the Act the Commission shall consider the effectiveness of any supply management business plan provided to the Commission by the public authority under regulation 3.

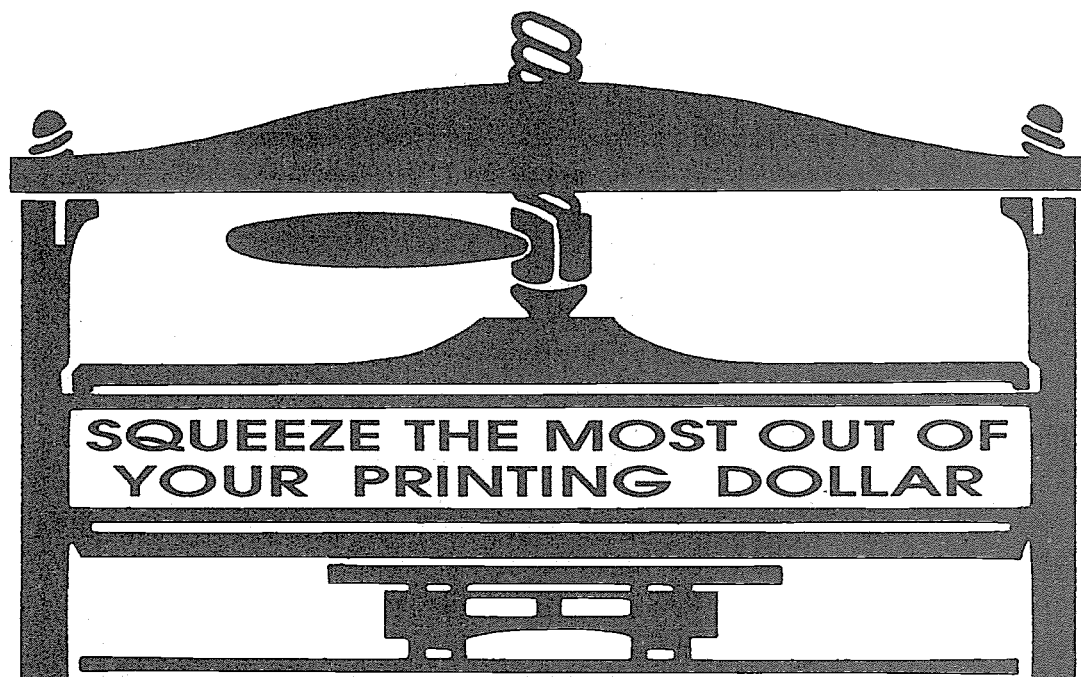
