**AGRICULTURE AND RELATED RESOURCES PROTECTION ACT 1976**

Acting pursuant to the powers granted by sections 35 and 36 of the Agriculture and Related Resources Protection Act 1976, the Agriculture Protection Board hereby declares—

- (i) *Kochia (Kochia scoparia)* to be a declared plant and assigns it to categories P1 and P4 for the whole of the State.
- (ii) Green-winged macaw (*Ara chloroptera*), Scarlet macaw (*Ara macao*), Blue and Yellow macaw (*Ara ararauna*) and Hyacinth macaw (*Anodorhynchus hyacinthinus*) to be declared animals, assigned to categories A2, A4, A6 for the whole of the State.

**EDUCATION ACT 1928****NON-GOVERNMENT SCHOOLS (RECURRENT FUNDING)  
NOTICE 1992**

Made by the Minister for Education under section 9A of the *Education Act 1928*.

**Citation**

1. This notice may be cited as the *Non-Government Schools (Recurrent Funding) Notice 1992*.

**Commencement**

2. This notice shall be deemed to have come into operation on 1 January 1992.

**Classification of schools**

3. (1) The classification of a non-government school in column 1 of the Schedule shall be in accordance with the classification of schools adopted by the Commonwealth Department of Employment, Education and Training.

(2) If a non-government school does not have a classification referred to in column 1 of the Schedule, then the Minister is to determine the classification of the school for the purposes of calculating assistance to the school.

**Assistance**

4. From the moneys appropriated by Parliament for the assistance of non-government schools, the Minister is to pay to each non-government school according to its classification referred to in column 1 of the Schedule or as determined by the Minister, the amount specified in column 2 or 3 of the Schedule appropriate to and in respect of each prescribed scholar attending the school who —

- (a) has attained or will attain 6 years of age before 1 January 1993;  
and
- (b) has not attained 19 years of age.

**Payments to be made in relation to attendance during school terms**

5. (1) Payments of moneys under this notice are to be made as follows:
- (a) A payment is to be made in February 1992 calculated by reference to the number of prescribed scholars attending the school in the second semester of 1991.
  - (b) A payment is to be made in May 1992 calculated by reference to the number of prescribed scholars attending the school in the first semester of 1992. The payment is to be adjusted to take account of any surplus or deficit in the February payment having regard to the number of prescribed scholars attending the school in the first semester of 1992.
  - (c) Payments are to be made in August and September 1992 calculated by reference to the number of prescribed scholars attending the school in the second semester of 1992.

(2) Where a non-government school has not had a previous enrolment the amount of money payable in respect of its prescribed scholars is to be calculated on the basis of actual enrolments at the non-government school and for this purpose payments under this notice may be made in arrears.

**Non-government school systems**

6. (1) Moneys payable under this notice may be made to non-government school systems.

(2) Where moneys are paid to a non-government school system the following conditions apply —

- (a) the amount of money payable in respect of a non-government school within the non-government school system shall be in accordance with clauses 4 and 5 as though the non-government school is not within the non-government school system;

- (b) on receipt of the moneys the non-government school system shall —
- (i) pay the amount so received into the account of the non-government school system at a bank approved by the Minister; and
  - (ii) disburse the amount to each non-government school within the non-government school system within 10 days of such receipt;
- (c) the chief executive officer, however designated, of the non-government school system shall, not later than the last school day of 1992 certify in writing to the Minister that payments to non-government schools within the non-government school system during 1992 have been made in accordance with this notice.

#### DAYLIGHT SAVING REFERENDUM HELD ON SATURDAY, 4 APRIL 1992

#### Statement of the Result of the Referendum

“Are you in favour of standard time being advanced one hour from the last Sunday in October, 1992, until the first Sunday in March 1993 and in similar fashion for each year thereafter?”

5.15 Outdoor Advertising

5.15.1 Power to Control Advertisements

- 1. For the purpose of this Scheme, the erection, placement and display, and subject to the provisions of Clause 5.15.4, the continuance of advertisements is development within the definition of the Act requiring, except as otherwise provided, the prior approval of the Council. Such planning approval is required in addition to any licence pursuant to the Council By-laws relating to Signs, Hoardings and Bill posting.
- 2. Applications for Council Planning approval pursuant to this Part shall be submitted in accordance with the provisions of Clause 5.1.3 of the Scheme and shall be accompanied by any Additional Information giving details of the advertisement(s) to be erected, placed or displayed on the land as required by the Council.

#### 5.15.2 Existing Advertisements

Advertisements which—

- (i) were lawfully erected, placed or displayed prior to the approval of this Scheme, or
- (ii) may be erected, placed or displayed pursuant to a licence or other approval granted by the Council prior to the approval of this Scheme;

hereinafter in this Part referred to as 'existing advertisements', may, except as otherwise provided, continue to be displayed or be erected and displayed in accordance with the licence or approval as appropriate.

#### 5.15.3 Consideration of Applications

Without limiting the generality of the matters which may be taken into account when making a decision upon an application for planning approval to erect, place or display an advertisement, the Council shall examine each such application in the light of the objectives of the Scheme and with particular reference to the character and amenity of the locality within which it is to be displayed and the amenity of adjacent areas which may be affected.

#### 5.15.4 Exemptions from the Requirement to Obtain Approval

Subject to the provisions of the Main Roads (Control of Signs) Regulations 1983 and notwithstanding the provisions of Clause 5.15.1, the prior approval of the Council is not required in respect of those advertisements listed in Appendix 6 which for the purpose of this Part are referred to as 'exempted advertisements'.

#### 5.15.5 Discontinuance

Notwithstanding the provisions of Part V of this Scheme, where in the opinion of the Council, an exempted or existing advertisement so seriously conflicts with the objectives of Part IV of this Scheme, it may by notice in writing require the advertiser to remove, relocate, adapt, or otherwise modify the advertisement.

#### 5.15.6 Where, in the opinion of the Council, an advertisement has been permitted to deteriorate to a point where it conflicts with the objectives of the Scheme or it ceases to be effective for the purpose for which it was erected or displayed, the Council may by notice in writing require the advertiser to:—

- (i) repair, repaint or otherwise restore the advertisement to a standard specified by the Council in the notice, or
- (ii) remove the advertisement.

#### 5.15.7 Notices

1. 'The advertiser' shall be interpreted as any one or any group comprised of the owner, occupier, licensee or other person having interest in or drawing benefit from the display of the advertisement concerned.
2. Any notice served pursuant to Clauses 5.15.5 and 5.15.6 shall be served upon the advertisement and shall specify:
  - (i) the advertisement(s) the subject of the notice,
  - (ii) full details of the action or alternative courses of action to be taken by the advertiser to comply with the notice,
  - (iii) the period, not being less than 28 days, within which the action specified shall be completed by the advertiser.
3. Any person upon whom a notice is served pursuant to this Part may within a period of 28 days from the date of the notice appeal to the Hon. Minister for Planning or the Town Planning Appeal Tribunal in accordance with Part V of the Act, and where any such appeal is lodged the effect of the notice shall be suspended until the decision to uphold, quash or vary the notice is known and shall thereafter have effect according to that decision.

#### 5.15.8 Scheme to Prevail

Where the provisions of this Part are found to be at variance with the provisions of the Signs, Hoardings and Bill Posting By-laws, of the Council the provisions of the Scheme shall prevail.

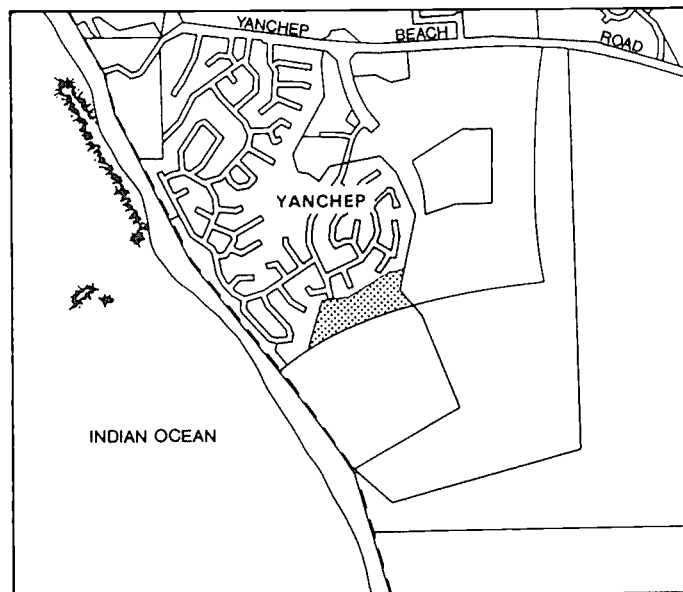
