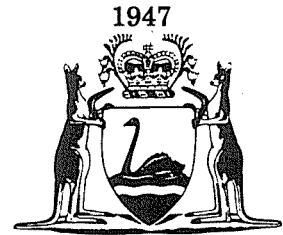

PETROLEUM PRODUCTS PRICING ACT 1983

**PETROLEUM PRODUCTS PRICING (MAXIMUM PRICES FOR MOTOR FUEL) AMENDMENT
ORDER (No. 7) 1992**

Made by the Prices Commissioner under section 12.

Citation

1. This order may be cited as the *Petroleum Products Pricing (Maximum Prices for Motor Fuel) Amendment Order (No. 7) 1992*.

Commencement

2. This order shall take effect on 12 May 1992.

Interpretation

3. In this order—

“the principal order” means the *Petroleum Products Pricing (Maximum Prices for Motor Fuel) Order 1984**.

“ 73.8c ”.
