The public is hereby notified that I have issued a permit to T. L. & L. M. - 6. Shall be registered as an export establishment, pursuant to the provisions of the parliament of the Commonwealth Export Control Act 1982, and Orders made thereunder, more specifically the Prescribed Goods (General) Orders and the Fish Orders, should it be used to process fish for export.

- 7. Shall not be used for the processing of fish or crustacean caught by any other vessel.
- 8. Shall not be used for the processing of marron (*Cherax tenuimanus*), unless a licence is held under Section 39C of the Fisheries Act 1905.

In accordance with the provisions of section 35K, any person aggrieved by this decision, may within fourteen (14) days, after publication of this notice, appeal against the decision or order by serving on the Minister for Fisheries a statement in writing on the grounds of their appeal.

# HOSPITALS (ADMINISTRATION OF PUBLIC HOSPITALS) AMENDMENT REGULATIONS 1992

Made by His Excellency the Lieutenant-Governor and Administrator in Executive Council.

# Citation

1. These regulations may be cited as the Hospitals (Administration of Public Hospitals) Amendment Regulations 1992.

## **Principal regulations**

2. In these regulations the Hospitals (Administration of Public Hospitals) Regulations 1940\* are referred to as the principal regulations.

## **Regulation 3A inserted**

3. After regulation 3 of the principal regulations the following regulation is inserted —

# " Returning Officer

**3A.** (1) Subject to regulations 4 (aa) and 5 (aa), the secretary of a board of management shall perform the functions of the Returning Officer under regulation 4 or 5 in relation to an election or ballot involving that board.

(2) Subject to regulation 8 (aa), the chairman of a board of management shall perform the functions of the Returning Officer under regulation 8 in relation to a ballot involving that board.

## **Regulation 4 amended**

- 4. Regulation 4 of the principal regulations is amended
  - (a) by inserting before paragraph (a) the following paragraph
    - (aa) The Minister may direct that the Returning Officer for every aspect of the nominating process shall be the Electoral Commissioner appointed under the *Electoral Act 1907*, or such other officer holding an appointment under that Act appointed by the Electoral Commissioner by notice to the Minister.
  - (b) in paragraph (a) by inserting after "board shall" the following
    - " direct the Returning Officer to "
  - (c) in paragraph (i) (v) by deleting "secretary of the board" and substituting the following
    - " Returning Officer ";
  - (d) by deleting paragraph (i) (vi) and substituting the following
    - (vi) the manner of voting shall be by preferential ballot;

- (via) for the purpose of casting his vote at an election where only one candidate is to be elected and there are not more than 2 candidates —
  - the elector shall mark his ballot paper by writing the numeral "1" opposite the name of the candidate for whom he votes; and
  - (II) the elector may mark his ballot paper by writing the numeral "2" opposite the name of the other candidate on the ballot paper,

so as to indicate the order of his preference;

- (vib) for the purpose of casting his vote at an election where only one candidate is to be elected and there are more than 2 candidates, the elector shall mark his ballot paper —
  - by writing the numeral "1" opposite the name of the candidate for whom he votes; and
  - (II) by writing the numerals "2", "3" and so on (as the case requires) opposite the names of the other candidates on the ballot paper,

so as to indicate the order of his preference;

- (vic) for the purpose of casting his vote at an election where 2 or more candidates are to be elected, the elector shall mark his ballot paper
  - (I) mark his ballot paper by writing the numeral "1" opposite the name of the candidate for whom he votes as his first preference;
  - (II) mark his ballot paper by writing the numeral "2" opposite the name of the candidate for whom he votes as his second preference; and
  - (III) give contingent votes for all the remaining candidates by writing the numerals "3", "4" and so on (as the case requires) opposite the names of the other candidates on the ballot paper so as to indicate by numerical sequence the order of his preference;
- (e) in paragraph (i) (ix) by deleting "secretary of the board of management aforesaid" and substituting the following ---
  - Returning Officer ";

"

- (f) by deleting paragraph (i) (xi) and substituting the following ----
  - (xi) A ballot paper shall be informal
    - (I) if the initials of the Returning Officer are not endorsed on the back of the ballot paper;
    - (II) if the voter has not marked it as prescribed by these regulations;
    - (III) if it has upon it any mark or writing not authorized by these regulations which, in the opinion of the Returning Officer, will enable any person to identify the elector;
    - (IV) if it does not indicate the elector's vote or, if there are more than 2 candidates, it is

not marked so as effectively to indicate the elector's preference as regards all candidates; or

- (V) if it is not marked.
- (g) by deleting paragraph (i) (xii);

- (h) by deleting paragraph (j) and substituting the following paragraphs ---
  - (j) Where only one candidate is to be elected, the successful candidate shall be ascertained in accordance with the method, prescribed under the *Electoral Act 1907*, for the counting of votes taken at an election of members of the Legislative Assembly.
    - (ja) Where 2 or more candidates are to be elected, the following provisions apply
      - (I) the count of votes shall proceed as provided by paragraph (j) until one candidate has received an absolute majority and the name of the person who receives such a majority shall be placed first on a list of persons ("the list") for appointment to the Board;
      - (II) the ballot papers shall again be brought into operation and sorted according to the first preference votes of the remaining candidates, and the second preferences of the candidate whose name has been placed on the list shall be added to their first preference votes;
      - (III) the count shall then proceed in the manner provided by paragraph (j) in order to determine which of the remaining candidates has received an absolute majority on that count and the name of that candidate shall be placed second on the list;
      - (IV) until all the vacancies have been filled, the count shall then proceed in a similar manner for each of the remaining candidates but on each further count the third, fourth or next consecutive preference, as the case may be, of the candidates whose names have been entered on the list shall be added to the first preference votes received by the remaining candidates; and
      - (V) until all the vacancies have been filled, the names of the candidates shall be placed on the list in the order in which they receive an absolute majority on the counts so undertaken.
    - (jb) Where on any count 2 or more candidates have received the same number of votes, the Returning Officer shall determine by lot which candidate's preference votes shall be first distributed.

Approval to any such variation will only be granted where the Bush Fire Control Officer for the area has first signified his approval for the variation.

The penalty for failing to comply with this notice is a fine of not less than \$40 nor more than \$400 and a person in default is also liable, whether prosecuted or not, to pay the cost of performing the work directed in this notice if it is not carried out by the owner or occupier and by the date required by this notice.

If the requirements of this notice are carried out by burning, such burning must be in accordance with the relevant provisions of the Bush Fires Act.

Made by the Fremantle Port Authority and approved by His Excellency the Governor in Executive Council.

# Citation

1. These regulations may be cited as the Fremantle Port Authority Amendment Regulations 1992.

### **Principal regulations**

2. In these regulations the *Fremantle Port Authority Regulations 1971\** are referred to as the principal regulations.

#### Regulation 102 amended

3. Regulation 102 of the principal regulations is amended by inserting after paragraph (f) in the Table the following paragraph —

(g) For every movement within the Port and every entry into or departure from the Port of a vessel of which the master holds a Certificate of Local Knowledge issued under regulation 122, other than such a vessel which plies between the Port and Rottnest Island or Hillarys Boat Harbour or a tug which provides towage within the Port

#### Regulation 122 repealed and regulations substituted

4. Regulation 122 of the principal regulations is repealed and the following regulations are substituted —

# Certificate of Local Knowledge

122. (1) In this regulation —

"Certificate" means a Certificate of Local Knowledge.

(2) For the purposes of subregulation (3) a person is a qualified applicant if at the date of applying for a Certificate the person has been the master or mate of a vessel of more than 150 tons gross register —

- (a) for at least 3 months during the period of 12 months preceding the date of the application; and
- (b) on at least 4 occasions in those 3 months when the vessel was navigated in those areas of the Port to which the Certificate is to relate,
- and
  - (c) if the person was master on any of those occasions, the person held a certificate of competency as Master Class IV, or a higher certificate, and the vessel had a pilot on board; or
  - (d) if the person was mate on any of those occasions, the master of the vessel was the holder of a Certificate relating to the area of the Port in which the vessel was navigated.
  - (3) If a qualified applicant
    - (a) pays the application fee of \$50 to the Port Authority; and
    - (b) satisfies the Harbour Master, by passing an examination, that the applicant
      - (i) is capable of navigating a vessel of more than 150 tons gross register within the Port; and
      - (ii) has a reasonable knowledge of the procedures and laws governing persons navigating vessels within the Port,

the Port Authority shall issue the applicant with a Certificate.

(4) If a person who has held a certificate of competency as Master Class IV, or a higher certificate, for the period of 12 months preceding 1 July 1992 applies for a Certificate before 1 July 1993 and —

- (a) satisfies the Harbour Master that on at least 10 occasions in that period the person has, as the master of a vessel of more than 150 tons gross register, navigated the vessel in those areas of the Port to which the certificate is to apply; and
- (b) satisfies the Harbour Master, by passing an examination, of the matters in subregulation (3) (b),

the Port Authority shall issue the applicant with a Certificate without charge.

- (5) A Certificate shall
  - (a) be in a form determined by the Port Authority;
  - (b) specify those areas of the Port to which it applies; and
  - (c) be signed by the Harbour Master.

(6) The Port Authority may, in its absolute discretion, revoke a Certificate.

(7) If the holder of a Certificate does not, as master, navigate a vessel of more than 150 tons gross register within the Port during a continuous period of 12 months, the Certificate shall be taken as having been revoked on the expiry of the 12 months.

"

#### Effect of Certificate of Local Knowledge

122A. (1) Subject to paragraph (g) in the Table to regulation 102, a vessel of 500 gross registered tons or less, or of a length overall of 50 metres or less, is exempt from pilotage if —

- (a) the master holds a Certificate of Local Knowledge issued under regulation 122; and
- (b) it is navigated in those areas of the Port to which the Certificate applies.

(2) For the purposes of subregulation (1), a person is deemed not to be the master —

- (a) of an inward bound vessel unless the person has been in charge of the vessel, and the person's name has been entered as master on the vessel's register, from prior to its departure from the last port of call until after its arrival at its berthing place in the Port; and
- (b) of an outward bound vessel unless the person's name is entered as master on the vessel's register from prior to its departure from its berthing place and until arrival at its next port of call.




