It is hereby notified that I, Graham Edwards administering the Bush Fires Act, 1954 hereby revoke all previous orders under Section 25B of the said Act with relation to the Shire of Albany Rubbish Disposal Sites situated on the locations listed hereunder and pursuant to the powers contained in Section 25B of the Act, approve the suspension of the operations of Section 25 that relate to a fire refuse or rubbish or any like purpose during the declared Prohibited and Restricted Burning Times on land set aside for the purpose in the Municipal district of the Shire of Albany. This notice shall have effect until revoked and is issued subject to the following specified conditions:

Specified Conditions

Kronkup Rubbish Disposal Site Reserve No. 38504.

Redmond Rubbish Disposal Site Reserve No. 22938.

Bakers Junction Rubbish Disposal Site Reserve No. 31472.

1. A single trench with a dividing wall, or two trenches shall be maintained for the purpose of dumping and burning rubbish and refuse.
2. Only one section of a single trench, or one trench is to be set alight at any one time.
3. Trenches, prior to being burnt, shall be fenced or have earth barriers constructed around the perimeter, to a minimum height of one metre.
4. Signs shall be erected and maintained in a legible condition, facing all approaches to a burning trench, warning the public the trench is alight, and the dumping of rubbish or refuse in the trench is prohibited.
5. A sign shall be erected and maintained in a legible condition at the entrance to the tip site, warning of the prohibition of the unauthorised lighting of fires within the tip site.
6. Only persons authorised by the Shire Clerk shall set fires to rubbish or refuse in the trenches.
7. At least one person appointed under the Bush Fires Act is to be in attendance, with a fully equipped fire unit, for at least one hour after the rubbish or refuse is ignited.
8. Trenches are not to be lit on Sundays, Public Holidays or on days which the fire danger rating for the locality, as forecast by the Bureau of Meteorology, is Very High or Extreme.
9. All bush, save standing trees, shall be removed or reduced by prescribed burning from the area of the site, or a 100 metre radius from the centre of the trench.
10. Trenches shall no longer be permitted to be burnt, once the refuse or rubbish level remains at a distance of 500mm below ground level, after being burnt and compacted.
11. An earth, or wire fence barrier shall be constructed around the perimeter of the trenches, with the exception of an area left open for the purpose of dumping rubbish, refuse or allowing access of plant equipment. The barrier shall be so designated as to stop or reduce rubbish or refuse from being blown from the tip site by prevailing winds. Once erected or constructed, the barriers shall be maintained in an acceptable state of repair.
12. The Shire Ranger, a Shire Officer or Bush Fire Control Officer responsible for the area in which the tip site is situated, shall be notified of the intention to set a fire at the site, at least eight hours prior to ignition.

In each case the outer 2.5 metres of the area must be totally free of any inflammable material and when mowing is the method used all residue of the mowing process must be removed from the area.

- (ii) Crops

Firebreaks at least 2.5 metres wide clear of all inflammable material.

- (iii) All owners or occupiers of land being used for pasture or crops which exceeds 20 hectares (50 acres) in area shall maintain a mobile fire fighting unit in working order with a capacity of not less than 400 litres of water.

NOTE: Boundary firebreaks are not compulsory within the Shire of Cranbrook Rural area. Landholders can provide firebreaks if they wish.

Townsites (All land within the Shire of Cranbrook which is within a townsite).

- (i) Where the area of land is 2 000 square metres or less, remove all inflammable material from the whole of the land; (for the purpose of this notice, inflammable material does not include live standing trees, cultivated plants or shrubs in gardens).
- (ii) Where the land exceeds 2 000 square metres, clear of all flammable material, firebreaks at least two and one half (2.5) metres wide immediately inside all internal boundaries of the land and also immediately surrounding all buildings and/or haystacks, fuel ramps and any drum or drums normally used for storage of fuel (whether they contain fuel or not) situated on the land.

PLANTATIONS

All planting of plantations (as defined) in rural areas of the Shire shall be at a distance of no less than 20 metres either side of the existing SECWA power lines and that the area under the lines be free of all inflammable materials and that a 6 metre firebreak be installed where possible (can be 3 metres either side of power lines). The Shire of Cranbrook has adopted a standard for the fire protection of plantations in the Shire. The standard covers requirements in regards to:

Notice to Owners and Occupiers of Land within the Shire of Broomehill

Pursuant to the powers contained in section 33 of the above Act, you are hereby required on or before the 13th November 1992, to plough, scarify, cultivate, burn, chemically spray or otherwise clear and thereafter maintain free of inflammable materials until 1st April, 1993, firebreaks of the following dimensions and in the following positions on the land owned or occupied by you.

1. Rural Land

Clear firebreaks not less than three metres wide:

- (a) Immediately inside the external boundaries of land whether it be cleared, partly cleared, bulldozed, chained, used for pasture or be undeveloped; and
- (b) Within twenty (20) metres of the perimeter of any building, hayshed or haystack.

2. Townsite Land (including Residential, Commercial, Industrial, Deferred Urban and Special Rural whether such land is occupied or not).

- (a) Where the area of land is 2 100 m² (approximately 1/2 acre) or less, remove all inflammable material from the whole of the land (for the purpose of this notice, inflammable material does not include live standing trees, cultivated plants or shrubs in gardens).

3. Fuel/Gas/Chemical Storage

In respect of any Rural or Townsite land upon which there is situated any container/drum/installation used to store flammable liquids, chemicals or gas fuel (be they empty or not), including any ramp or support so constructed you shall have the said land clear of all inflammable materials for a minimum distance of five metres from the site perimeter.

4. Definitions for the purpose of this notice:

Bush: Includes trees, bushes, plants, stubble, scrub and undergrowth of all kinds whatsoever alive or dead and whether standing or not standing and also part of a tree, bush, plant or undergrowth and whether severed therefrom or not so severed.

Haystack: Means any collection of hay including round bales stacked or placed together.

Inflammable Material: Includes bush, timber, boxes, cartons, paper and like inflammable materials, rubbish and also any combustible matter, but does not include green standing trees or growing bushes and plants in gardens or lawns.

5. Application to vary the above requirements

If it is considered impracticable or unnecessary for any reason to carry out works as authorised by this notice you may apply to the Council or its duly authorised officer for permission to provide firebreaks in alternative positions or to take alternative measures to abate fire hazards on the land or vary this notice in any other way.

Approval for such alternatives in relation to rural land will only be considered if submitted with the endorsement of the Bush Fire Brigade for the area concerned.

6. Penalty

The penalty for failing to comply with this notice is a fine not exceeding four hundred dollars (\$400) and a person in default is also liable, whether prosecuted or not, to pay the cost of performing the work directed in this notice if it is not carried out by the owner or occupier before the date required by this notice.

- (c) Firebreaks 3 metres wide shall be constructed between 10 and 20 metres distant from and surrounding all haystacks.
- (d) Stored fuel, oil and flammable materials shall be protected from fire as prescribed in the Explosives and Dangerous Goods Act 1961 and Flammable Liquids Regulations 1967 and which include that a firebreak 6 metres wide will be provided immediately surrounding storage areas.

General

If for any reason it is considered by the owner or occupier of land that is impractical to comply with the requirements of this notice a request may be made to the Council to approve alternative fire protection measures. RESIDENTIAL (RESTRICTIVE/SPECIAL—R20) ZONE POLICY STATEMENT

This policy is to be applied to proposals for development and subdivision of land within the City of Mandurah where Council initiates a rezoning to Residential (Restrictive/Special—R20) Zone to provide for development of lots in accordance with the Residential Planning Codes R20 requirements. The following conditions are to be agreed to by the developer prior to rezoning:

- a. Applications for subdivision to lots at a density of R20 and greater are to include building plans and a site layout plan of the proposed dwelling on the subject land in accordance with the R-Codes.
- b. The front setback of dwellings in small lot subdivision estates are to be staggered so as to ensure that no more than three (3) consecutive dwellings have the same setback from the front property boundary.
- c. The building materials, texture and colour of dwellings in a small lot subdivision are to compliment each other and should be harmonious in design of front elevations.
- d. Subdividers are to contribute 12.5% Public Open Space.
- e. Turning heads of cul-de-sac and road reserve widths are to accord with the "Residential Road Planning Policy" adopted by the Department of Planning and Urban Development.
- f. Small lot subdivision estates exceeding one (1) hectare in area are to contain a diversity of lot sizes. Small lots are to be created in precincts, not individually distributed throughout the estate.
- g. Each dwelling is to accommodate two (2) constructed carparking bays which may be in tandem and/or within the front setback.
- h. Lot shapes are to be regular and generally rectangular and dwellings are to be orientated to the north.
- i. Slopes exceeding 5% may not be supported for a small lot subdivision unless it can be demonstrated that overlooking, drainage and retaining walls will not be problematic.
- j. Carports may be permitted within the front building setback in accordance with the Residential Planning Codes provided that the verge is landscaped, crossover established and the structure does not impinge on the streetscape or affect driver visibility.
- k. Dual use paths are to be provided throughout the estate.
