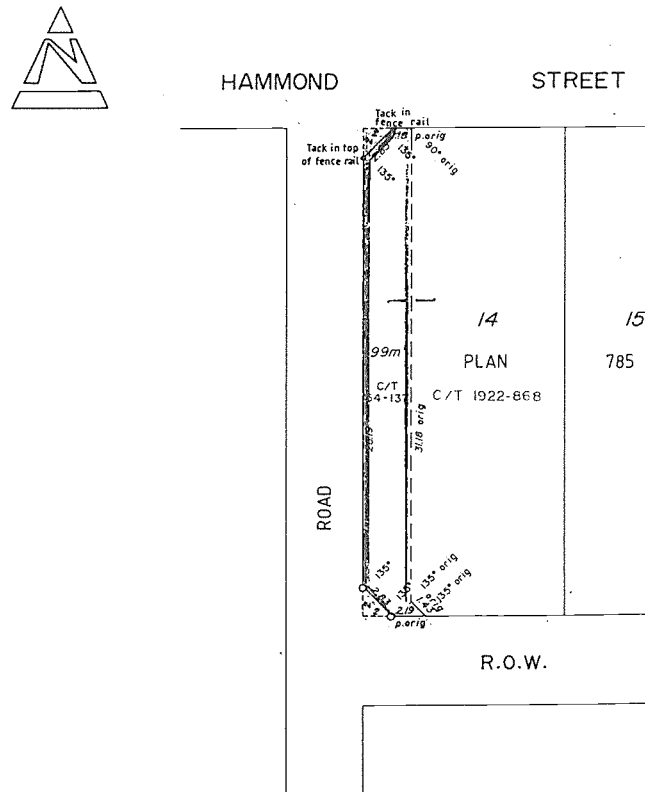

**BUSH FIRES ACT 1954***Shire of Murchison***Firebreak Order**

Notice to all Owners and/or Occupiers of land in the Shire of Murchison.

Pursuant to the powers contained in section 33 of the Bush Fires Act, you are hereby required on or before 30th November, 1992 to clear firebreaks and remove flammable materials from the land owned or occupied by you, as specified hereunder and to have the specified land and firebreaks clear of all flammable materials from 30th November, 1992, up to and including 30th April, 1993.

## (1) Land Outside Murchison Settlement—

- 1.1 All buildings on land which is outside the Murchison Settlement shall be surrounded by two firebreaks not less than two (2) metres wide cleared of all flammable material, the inner firebreak to be not more than twenty (20) metres from the perimeter of the building or group of buildings and the outer firebreak not less than two hundred (200) metres from the inner firebreak.

1.2 To remove flammable material from the whole of the land between the firebreaks required in paragraph 1.1 above.

(2) Land in Murchison Settlement—

All flammable material to be removed from the whole of the land.

If it is considered, for any reason, to be impracticable to clear firebreaks or remove flammable material as required by this notice, you may apply to the Council or its duly authorised officer not later than 26th November, 1992 for permission to provide firebreaks in alternative positions, or take alternative action to remove or abate fire hazards. If permission is not granted by Council or its duly authorised officer, you shall comply with the requirements of this notice.

“Flammable Material” does not include green growing trees or garden growing plants in gardens.

The penalty for failing to comply with this notice is a fine of \$400 and a person in default is also liable, whether prosecuted or not, to pay the cost of performing the work directed in this notice if it is not carried out by the owner or occupier by the date required by this notice.

The prohibited burning period for this Shire is from 1st August 1992 to 30th April, 1993.

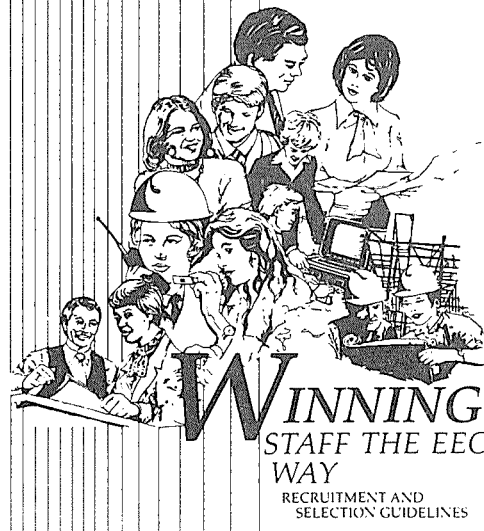
