1. These regulations may be cited as the *Justices Act (Extraordinary Licences) Amendment Regulations 1992*.

Commencement

2. These regulations shall come into operation on 1 January 1993.

ENVIRONMENTAL PROTECTION ACT 1986**ENVIRONMENTAL PROTECTION AMENDMENT REGULATIONS
(NO. 3) 1992**

Made by the Deputy of the Lieutenant-Governor and Administrator in Executive Council on the recommendation of the Environmental Protection Authority.

Citation

1. These regulations may be cited as the *Environmental Protection Amendment Regulations (No. 3) 1992*.

Regulation 14 amended

2. Regulation 14 of the *Environmental Protection Regulations 1987** is amended by repealing subregulation (b) and substituting the following subregulation —

“

- (b) at a waste disposal site licensed under the *Health Act 1911* or any other site approved by the Chief Executive Officer, by burial under a final soil cover of not less than 500 mm —
- (i) in batches separated from each other by at least 100 mm of soil and each consisting of not more than 40 cubic metres of tyres reduced to pieces; or
 - (ii) in batches separated from each other by at least 100 mm of soil and each consisting of not more than 1 000 whole tyres; or
 - (iii) in the case of tyres in any volume or number in a dump existing at the commencement of the *Environmental Protection Amendment Regulations (No. 3) 1992*, at the location of that dump,

in accordance with such conditions as are imposed by the Chief Executive Officer in respect of that burial for the purpose of ensuring that drainage, safety, soil erosion and soil stability at, and in the vicinity of, the site of that burial are adequately controlled; or

Citation

1. This Notice may be cited as the *Metropolitan Recreational Abalone Fishery Closure Notice 1992*.

Recreational Notice

2. In this Notice the *Metropolitan Recreational Abalone Fishery Notice 1992 No. 565** is referred to as the Recreational Notice.

Interpretation

3. In this Notice, unless the contrary intention appears, words and expressions used in the Recreational Notice shall have the same respective meanings.

Application of the Notice

4. The provisions of this Notice shall apply to all persons other than a person who is the holder of a Professional Fisherman's Licence and authorised to take abalone within Zone 3 of the Abalone Limited Entry Fishery.

Closure of the Fishery

5. Notwithstanding the provisions of the Recreational Notice the taking of any species of mollusc of the class *Gastropoda* and sea urchins of the class *Echinoida* by any means of capture in the waters described in the Recreational Notice is prohibited.

1992**

Notice No. 573

FD 897/78.

Made by the Minister under section 32.

Citation

1. This notice may be cited as the *Shark Bay Beach Seine and Mesh Net Limited Entry Fishery Notice 1992*.

Commencement

2. This notice shall come into operation on 1 January 1993.

Interpretation

3. In this notice unless the contrary intention appears—

“approved form” means in a form approved by the Director;

“bait” means garfish and mullet;

“bream” means all fish of the genus *Acanthopagrus*;

“Fishery” means the Shark Bay Beach Seine and Mesh Net Limited Entry Fishery declared under clause 4;

“fishing unit” means a licensed boat and a maximum of three netting dinghies;

“garfish” means all fish of the family Hemirhamphidae;

“licence” means a licence authorising a boat to operate in the Fishery;

“licensee” means the fisherman who holds a licence authorising a fishing unit to operate in the Fishery;

“mullet” means all fish of the family Mugilidae;

“net” means any net used or intended to be used for the purpose of catching fish but does not include an otter trawl net;

“snapper” means all fish of the genus *Pagrus*;

“tailor” means all fish of the genus *Pomatomus*; and

“whiting” means all fish of the genus *Sillago*.

Declaration of limited entry fishery

4. It is hereby declared that the use of nets to take fish shall constitute a limited entry fishery in the waters described in the Schedule to be called the Shark Bay Beach Seine and Mesh Net Limited Entry Fishery.

Prohibition on taking fish

5. A person, other than a person to whom section 32 (5) of the Act applies, shall not take or attempt to take fish in the Fishery other than in accordance with this notice.

Prohibition on selling or dealing

6. A person shall not sell or deal, or attempt to sell or deal, in any way with fish taken in contravention of this notice.

Criteria to determine fishing units which may operate in the Fishery

7. (1) The criteria that shall be applied to determine the boats which may operate in the Fishery to take fish for sale is that immediately before the coming into operation of this notice a boat, or a boat it has replaced, was authorised to take fish for sale in the Shark Bay Beach Seine and Mesh Net Fishery as described in the Instructions to Licensing Officers published in the *Government Gazette* of 23 February 1979;

(2) The criteria that shall be applied to determine the boats which may operate in the Fishery to take bait for sale or for bait use only is that immediately before the coming into operation of this notice a boat, or a boat it has replaced, was authorised to take bait for sale or for bait use only in the Shark Bay Beach Seine and Mesh Net Fishery as described in the Instructions to Licensing Officers published in the *Government Gazette* of 23 February 1979.

Application for a licence

8. The licensee of a fishing unit which fulfils the criteria in clause 7 may apply in accordance with clause 16 for a licence authorising the boat to operate in the Fishery.

Details on a licence

9. A licence shall contain the following details—

- (a) the names and licensed fishing boat numbers of the fishing unit in respect of which it is issued;
- (b) the name and address of the licensee of the fishing unit;
- (c) the licence number;

- (d) the date of issue;
- (e) the period for which the licence is valid; and
- (f) any conditions imposed on the licence.

Use of boats to take fish

10. (1) A fishing unit authorised to operate in the Fishery shall consist of—

- (a) a primary fishing boat; and
- (b) not more than three netting dinghies.

(2) Unless otherwise authorised in writing by the Director the boats specified on the licence shall only be used to take fish in the Fishery when the licensee is actively involved in the operation of the fishing unit.

(3) A boat licensed to operate in the Fishery in accordance with clause 7 (2) may only be used to take bait in the Fishery.

Restrictions on crew

11. A fishing unit used in the Fishery shall not be operated at any time by more than three persons including the licensee.

Permitted means of taking fish

12. A person operating in the Fishery from an authorised licensed fishing unit shall only use a net with a mesh—

- (a) not less than 48 mm throughout for taking whiting;
- (b) not less than 82 mm throughout the net for taking mullet;
- (c) not less than 76 mm throughout the net for taking tailor;
- (d) not less than 51 mm throughout the net for taking bream during the months of August, September and October;
- (e) not less than 76 mm throughout the net for taking bream during the months of January to July inclusive, November and December; and
- (f) not greater than 38 mm and not less than 26 mm throughout and the net shall not be more than 200 metres in total length and have a pocket not more than 30 metres in length when used to take garfish.

Minister may specify alternative management rules

13. Notwithstanding the provisions of clauses 10 (3), 12 and 14 the Minister may specify in writing—

- (a) the area or areas that a boat may or may not take fish from within the Fishery;
- (b) the species of fish that any boat may or may not take;
- (c) if a boat may take fish—
 - (i) for sale for human consumption or for bait; or
 - (ii) for sale for bait use only;
- (d) the gear that a boat may or may not use; and
- (e) if a licence may or may not be transferred.

Transfer of licence

14. (1) Subject to subclause (2) and with the prior written approval of the Director, a licence issued in accordance with the criteria specified in Clause 7 (1) may be transferred to—

- (a) the spouse;
- (b) a son;
- (c) a daughter; or
- (d) a grandchild,

of the licensee and the licence shall be endorsed accordingly.

(2) An approved transferee shall be a person—

- (a) who held a licence endorsed to authorise the holder to operate in the Fishery and worked in the Fishery for a minimum of 2 years in the five years immediately prior to the transfer application date; and
- (b) who, inclusive of the two years specified in subclause (2)(a) above, has held a licence endorsed to authorise the holder to operate in the Fishery and worked in the Fishery for the 12 months immediately prior to the application date.

(3) Notwithstanding the provisions of subclause (1) the Minister may approve the transfer of any licence issued in accordance with Clause 7 (1).

Boat replacement

15. With the written approval of the Director, a boat licensed to operate in the Fishery may be replaced if—

- (a) the boat is a primary boat, it may be replaced by a boat not exceeding 12 metres in length; or
- (b) the boat is a net dinghy, it may be replaced with a boat not exceeding 6.45 metres in length.

Applications and fees

16. Applications under clauses 8, 14 and 15 shall be—

- (a) in the approved form;
- (b) lodged in accordance with the instruction if any; and
- (c) accompanied by the fee prescribed by regulation.

Revocation

17. The following notices are cancelled—

- (a) The notice dated 21 December 1978 and published in the *Gazette* on 23 February 1979.

All owners and/or occupiers of land in the Shire of Nannup are required to carry out fire prevention work on land owned or occupied by you in accordance with the provisions of this order.

This work must be completed by:

1st December, 1992, in the townsite.

15th December, 1992, in rural areas.

The work must be maintained throughout the summer months until the close of the restricted burning period in 1993.

1. ALTERNATIVE MEASURES

If it is considered impractical for any reason, to clear fire breaks or remove inflammable material, as required by this notice, you may apply to the Council by no later than 8th December, 1992 for permission to provide fire breaks in alternative positions or to take alternative measures to abate fire hazards on the land. Any such application must bear the signature of the Fire Control Officer for the area signifying his agreement to the variation. If permission is not granted, you shall comply with the requirements of this Notice. The requirements of this order are considered to be the minimum standard of fire prevention work required to protect not only individual properties but the district generally. In addition to this Order Council may issue separate special orders to owner/occupiers if hazard removal is considered necessary in some specific areas.

2. PENALTIES

For the protection of the total community, penalties will be enforced for non-compliance with this Order, maximum fine is \$2 000. Additionally Council may carry out the work required at the cost of the person in default.

3. INSPECTIONS

Inspections of Fire breaks and hazard reductions will be carried out in selected areas by an authorised officer on or after the previously specified work completion dates.

4. YOUR RESPONSIBILITIES**Rural Land**

- (a) For the purposes of this Order rural land means all land located within the Shire of Nannup that is zoned rural pursuant to Councils Town Planning Scheme, however, does not include land being used for commercial plantation purposes.
- (b) Firebreaks must be installed around the inside of external boundaries of any holding of land and must not be less than 2 metres wide.
- (c) Contiguous holdings of land which are owned and/or occupied by you shall be treated as one holding of land.

Special Rural Land

- (a) Special Rural Land means rural holdings of land within the Shire of Nannup zoned as Special Rural under the Shires Town Planning Scheme.
- (b) Firebreaks, free of all flammable materials not less than 2 metres wide, shall be installed around the inside external boundaries of any holding of land.

Urban Land

- (a) Urban land means land within the Shire of Nannup which is within the townsite or is within any area which is subdivided for residential purposes.
- (b) Where the area of any holding of urban land is less than or equal to 2 024 m² all flammable material is to be removed from the whole of that land, with the exception of standing, living trees.
- (c) Where the area of any holding of land exceeds 2 024 m² firebreaks of not less than 2 metres wide are to be provided immediately inside all external boundaries and also around all buildings situated on that holding of land.

Contiguous holdings of urban land which are owned and/or occupied by you will be treated as one holding of land.

Pine Plantations (planted on or before 16/8/78)

- (a) Pine plantations mean any area of land within the Shire of Nannup, upon which are planted pine trees for commercial use or exploitation.
- (b) Firebreaks, 20 metres wide, are to be installed around the inside external boundaries of each plantation.
- (c) Firebreaks 20 metres wide are to be installed along portions of the plantation which are public roads.
- (d) Firebreaks, which are 6 metres wide, are to be installed in such places within the plantation as will ensure that no area exceeding 28 hectares in area in the plantation will be without a firebreak.

Pine Plantations (planted on or after 17/8/78)

- (a) Pine plantations means any areas of land within the Shire of Nannup upon which are planted pine trees for commercial use or exploitation.
- (b) Firebreaks 40 metres wide are to be installed along portions of the plantation which are public roads.
- (c) Firebreaks, which are 40 metres wide, are to be installed in such places within the plantation as will ensure that no area exceeding 28 hectares in area in the plantation will be without a firebreak.

Eucalyptus Plantations

- (a) A Eucalyptus plantation is any area of planted eucalyptus species, exceeding 3 hectares.
- (b) Firebreaks 15 metres wide, shall be installed around all boundaries of the plantation, including public roads.
- (c) Firebreaks, clear of all flammable materials, 6 metres wide shall be installed so as to surround compartments of approximately 30 hectares.
- (d) All firebreaks must be maintained in trafficable condition and trees on both sides of breaks progressively pruned to a minimum height of 4 metres to allow unrestricted access of maintenance and fire fighting equipment, so as to maintain an effective width of firebreak.
- (e) Where power lines pass through plantation areas, firebreaks as per S.E.C.W.A. specifications must be provided.
