The boundary parts of Sandalwood Road (both sides) are excluded from this optional area.

From the junction of Belmont Avenue and Great Eastern Highway, south-east along Belmont Avenue and its extension through the Belmont shopping centre to Fulham Street, north-east along Fulham Street to Abernethy Road, south-east along Abernethy Road to Keane Street, north-east along Keane Street to Whiteside Street, south-east along Whiteside Street and its extension to the Tonkin Highway, south-east along the Tonkin Highway to Horrie Miller Drive, north along Horrie Miller Drive and its extension to the local government authority boundary (City of Belmont and Shire of Swan), north-west along the local government boundary to Great Eastern Highway, south-west along Great Eastern Highway to Ivy Street, north-west along Ivy Street to the Swan River, south and south-west along the Swan River to the north-westerly extension of Belmont Avenue to the River, and south-east along this extension to the junction of Belmont Avenue and Great Eastern Highway.

The boundary parts of Belmont Avenue (north side), Abernethy Road (both sides), Keane Street (both sides), Whiteside Street (both sides) and Ivy Street (both sides) are included within the area for Belmont Senior High School. Children who live outside the areas and boundaries shall not attend the schools to which such boundaries apply unless written approval for such admission is obtained from the undersigned.

#### AUSTRALIND PRIMARY SCHOOL

The boundary for the abovementioned school is as follows:

From the Leschenault Inlet at a point adjacent to the westerly extension of Travers Drive, east from this point to and along Travers Drive to Hanks Way, southeast along Hanks Way (and including Knight Place) to Chapple Drive, northeast along Chapple Drive to Bedingfield Way, east along the northern arm of Bedingfield Way to the Brunswick River, south along the Brunswick River to Paris Road, east along Paris Road to the Australind Bypass, south along the Australind Bypass to the Collie River, in a general westerly direction along the Collie River to the northern boundary of the SCM Chemicals Ltd Refinery, and west along this boundary to the Leschenault Inlet.

The boundary parts of Paris Road (south side) and the Australind Bypass (west side) are included within the area for Australind Primary School, while the boundary parts of Travers Drive (both sides), Chapple Drive (both sides), Bedingfield Way (both sides) and the boundary streets of Hanks Way (both sides) and Knight Place (both sides) are excluded from the area for Australind Primary School.

#### BATEMAN PRIMARY SCHOOL

The boundary for the abovementioned school is as follows:

From the junction of Murdoch Drive and Leach Highway, east along Leach Highway to the Kwinana Freeway, south along the Kwinana Freeway to South Street, west along South Street to Murdoch Drive, and in a general northerly direction along Murdoch Drive to Leach Highway.

The boundary parts of Leach Highway (south side), Kwinana Freeway (west side), South Street (north side), and Murdoch drive (east side) are included within the area for Bateman Primary School.

The following is an optional area for Bateman, Kardinya and Winthrop Primary Schools for new families moving into the area or for families sending children to school for the first time. Children already enrolled at one of these schools may not transfer to another without the approval of the District Education Office or unless a change of residence places them within the boundary for one of these schools.

The area bounded by Prescott Drive (both sides), South Street (north side), Murdoch Drive (west side) and Somerville Boulevard (south side).

#### BAYSWATER PRIMARY SCHOOL

The following is an optional area (subject to the availability of accommodation at the chosen school) for Bayswater, East Maylands and Maylands Primary Schools:

From the junction of Caledonian Avenue and Guildford Road, eastnortheast along Guildford Road to Garratt Road, northwest along Garratt Road and its extension to the railway line, southwest along the railway line to Caledonian Avenue and southeast along Caledonian Avenue to Guildford Road.

The boundary parts of Guildford Road (north side) and Garratt Road (both sides) are included within the optional area, while the boundary parts of Caledonian Avenue (both sides) are excluded from the optional area.

#### BYFORD PRIMARY SCHOOL

The western boundary for the abovementioned school is the South Western Highway. The boundary parts of the South Western Highway (east side) are included within the area for Byford Primary School.

The following is an optional area between Byford and West Byford Primary School:

From the junction of Eleventh Road and the South Western Highway, south along the South Western Highway to Norman Road, west along Norman Road to the railway line, north along the railway line to Eleventh Road and east along Eleventh Road to the South Western Highway.

The boundary parts of Eleventh Road (south side), the South Western Highway (west side) and the boundary street of Norman Road (both sides) are included within the optional area.

#### CALISTA PRIMARY SCHOOL

The boundary for the abovementioned school is as follows

From the intersection of Wellard Road and Gilmore Avenue, north along Gilmore Avenue to Summerton Road, west along Summerton Road to Stanyford Way, west and north along Stanyford Way to Gentle Road, west along Gentle Road to Tasker Road, west along Tasker Road to the proposed Fremantle-Rockingham Highway, south along the proposed Fremantle-Rockingham Highway to Wellard Road and east along Wellard Road to Gilmore Avenue.

The boundary parts of the proposed Fremantle-Rockingham Highway (east side) are included within the area for Calista Primary School, while the boundary parts of Gilmore Avenue (both sides), Stanyford Way (both sides), Tasker Road (both sides), Wellard Road (both sides), and the boundary streets of Summerton Avenue (both sides) and Gentle Road (both sides) are excluded from the area for Calista Primary School.

The following is an optional area for Calista, North Parmelia and Orelia Primary Schools for families moving into that area or for those sending a child to school for the first time:

The area bounded by Challenger Avenue (both sides), Gilmore Avenue (both sides), Sulphur Road (both sides), and Parmelia Avenue (both sides).

The following is an optional area for Calista, Leda and North Parmelia Primary Schools:

The area bounded by Gilmore Avenue, Challenger Avenue, Parmelia Avenue, Sutherland Parade, the locality boundary of Parmelia and Casuarina, Bertram Road and Wellard Road.

The boundary parts of Bertram Road (both sides), and Gilmore Avenue (both sides), are included within the optional area, while the boundary parts of Parmelia Avenue (both sides), and Wellard Road (both sides) and the boundary streets of Challenger Avenue (both sides) and Sutherland Parade (both sides), are excluded from the optional area.

#### CARAWATHA PRIMARY SCHOOL

The boundary for the abovementioned school is as follows:

From the intersection of North Lake Road and Leach Highway, west along Leach Highway to Wheyland Street, south along Wheyland Street to Archibald Street, south along Wheyland Street to Archibald Street, west along Archibald Street to Ellison Street, south along Ellison Street to Garling Street, east along Garling Street to North Lake Road and north along North Lake Road to Leach Highway.

The boundary parts of Leach Highway (south side), Garling Street (north side) and North Lake Road (west side) and the boundary street of Wheyland Street (both sides) are included within the area for Carawatha Primary School, while the boundary parts of Archibald Street (both sides) and the boundary street of Ellison Street (both sides) are excluded from the area for Carawatha Primary School.

The following is an optional area for Carawatha and Willagee Primary Schools:

The area bounded by Leach Highway, Worley Street, Archibald Street and Wheyland Street.

The boundary parts of Leach Highway (south side) and Archibald Street (both sides) are included within the optional area, while the boundary streets of Worley Street (both sides) and Wheyland Street (both sides) are excluded from the optional area.

The following is an optional area for Carawatha, Kardinya and Winthrop Primary Schools for new families moving into the area or for families sending children to school for the first time. Children already enrolled at one of these schools may not transfer to another without the approval of the District Education Office or unless a change of residence places them within the boundary for one of these schools.

From the junction of Somerville Boulevard and North Lake Road, north along North Lake Road to a point adjacent to the northern arm of Freedman Way, east from this point to and along Freedman Way and its extension to Aitken Drive, south and southeast along Aitken Drive to Keall Pass, south and southeast along Keall Pass to Somerville Boulevard, and southwest and west along Somerville Boulevard to North Lake Road.

The boundary parts of North Lake Road (east side), Freedman Way (both sides) and Somerville Boulevard (north side) are included within the optional area, while the boundary parts of Aitken Drive (both sides), and the boundary street of Keall Pass (both sides) are excluded from the optional area.

The following is an optional area for Carawatha and Winthrop Primary Schools for new families moving into the area or for families sending children to school for the first time. Children already enrolled at one of these schools may not transfer to another without the approval of the District Education Office or unless a change of residence places them within the boundary for one of these schools

From the junction of Winthrop Drive and Leach Highway, west along Leach Highway to North Lake Road, south along North Lake Road to a point adjacent to the northern arm of Freedman Way, east from this point to and along Freedman Way and its extension to Aitken Drive, south and southeast along Aitken drive to Keall Pass, south and southeast along Keall Pass to Somerville Boulevard, in a general easterly direction along Somerville Boulevard to Winthrop Drive, and north along Winthrop Drive to Leach Highway.

The boundary parts of Leach Highway (south side), North Lake Road (east side), Aitken Drive (both sides), Somerville Boulevard (north side), Winthrop Drive (west side) and the boundary street of Keall Pass (both sides) are included within the optional area, while the boundary parts of Freedman Way (both sides) are excluded from the optional area.

# CHALLIS PRIMARY SCHOOL AND CHALLIS EARLY CHILDHOOD EDUCATION CENTRE

The boundary for the abovementioned schools is as follows:

From the junction of Railway Avenue and Armadale Road, west along Armadale Road to the southern extension of Dewar Street, northwest to and along Dewar Street to Braemore Road, northeast along Braemore Road to Cobar Street, northwest between Firetail Court, Bellbird Place, Skylark View and Peacock Close to the south and Petrel Close, Waterway Crescent and Fulmar Way to the north, to Seville Drive, southwest and south along Seville Drive to Poad Street, west and northwest along Poad Street to Lake Road, northeast along Lake Road to Champion Drive, southeast along Champion Drive to Railway Avenue and south along Railway Avenue to Armadale Road

The boundary parts of Armadale Road (north side), Seville Drive (northwest side), Champion Drive (southwest side), and Railway Avenue (both sides) are included within the area for Challis Primary School and Challis Early Childhood Centre, while the boundary parts of Braemore Road (both sides), Poad Street (both sides), Lake Road (both sides) and the boundary street of Dewar Street (both sides) are excluded from the area for Challis Primary School and Challis Early Childhood Education Centre.

The following is an optional area between Challis Early Childhood Education Centre and Challis Primary School and Willandra Primary School:

From the junction of Seville Drive and Armadale Road, east along Armadale Road to the southern extension of Dewar Street, northwest to and along Dewar Street to Braemore Road, northeast along Braemore Road to Cobar Street, northwest between Firetail Court, Bellbird Place, Skylark View and Peacock Close to the south and Petrel Close, Waterway Crescent and Fulmar Way to the north, to Seville Drive, and southwest, southeast and south along Seville Drive to Armadale Road.

The boundary parts of Armadale Road (north side), Braemore Drive (both sides) and Seville Drive (southeast, northeast and eastern sides) and the boundary street of Dewar Street (both sides) are included within the optional area.

#### CHARTHOUSE PRIMARY SCHOOL

The boundary for the abovementioned school is as follows:

From the Indian Ocean at a point coinciding with the westerly extension of Hokin Street, east from this point to Hokin Street, northeast along Hokin Street to Safety Bay Road, east along Safety Bay Road to Read Street, northnorthwest along Read Street to Malibu Road and west and southwest along Malibu Road and its extension to the Indian Ocean.

The boundary parts of Safety Bay Road (north side), Read Street (west side) and the boundary streets of Hokin Street (both sides) and Malibu Road (south side) are included within the area for Charthouse Primary School.

The following is an optional area for Charthouse, East Waikiki and Warnbro Primary Schools:

The area bounded by Gnangara Drive (south side), Read Street (east side), Safety Bay Road (north side), Ennis Avenue (west side) and Willmott Drive (south side).

#### CLARKSON PRIMARY SCHOOL

The boundary for the abovementioned (new in 1993) school is as follows:

From the junction of Marmion Avenue and Hester Avenue, in a general easterly direction along Hester Avenue to the extension of the Mitchell Freeway, south along the Mitchell Freeway to the locality boundary between Clarkson and Tamala Park, west along this locality boundary to Marmion Avenue, and north along Marmion Avenue to Hester Avenue.

The boundary parts of Hester Avenue (south side), the Mitchell Freeway (west side) and Marmion Avenue (east side) are included within the area for Clarkson Primary School.

Children attending Government schools in Year 7 in 1993 and living within the area for Clarkson Primary School, may complete their primary education at their 1992 school or may transfer to Clarkson Primary School.

Children in Years 1 to 6 inclusive in 1993 (Years 1 to 7 inclusive thereafter) and living within the area for Clarkson Primary School, shall attend Clarkson Primary School except that younger siblings of Year 7 (1993) children shall have the option of remaining with any Year 7 siblings who elect to complete their primary education at their 1992 school.

Children resident in the locality of Merriwa who attended Quinns Rocks Primary School in 1992 may remain at Quinns Rocks Primary School or may transfer to Clarkson Primary School. This option is extended to the younger siblings of these children.

Families moving into Merriwa after the end of 1992, and existing (1992) Merriwa families who have not had children attending Quinns Rocks Primary School, will be required to attend Clarkson Primary School.

The following is an optional area for Clarkson Primary School and Quinns Rocks Primary School: The locality of Mindarie, as delineated in the 1993 Perth StreetSmart Directory.

#### CONNOLLY PRIMARY SCHOOL

The boundary for the abovementioned school is as follows:

From the intersection of Marmion Avenue and Hodges Drive, east along Hodges Drive to the proposed alignment of the Mitchell Freeway, in a general northerly direction along the Mitchell Freeway alignment to Burns Beach Road, west along Burns Beach Road to the extension of Connolly Drive, south along Connolly Drive to Shenton Avenue, west along Shenton Avenue to Marmion Avenue and south along Marmion Avenue to Hodges Drive.

The boundary parts of Hodges Drive (north side), the Mitchell Freeway (west side), Burns Beach Road (south side), Connolly Drive (east side), Shenton Avenue (south side) and Marmion Avenue (east side), are included within the area for Connolly Primary School.

The following is an optional area for Connolly Primary School and Beaumaris Primary School:

The area bounded by Marmion Avenue (east side), Shenton Avenue (north side), Connolly Drive (west side) and Moore Drive (south side).

## COOLOONGUP PRIMARY SCHOOL

The boundary for the abovementioned school is as follows:

From the intersection of Rae Road and Read Street, southsoutheast along Read Street to a point adjacent to the northern arm of Frome Way, in an eastnortheasterly direction from this point to and along Frome Way to Breaden Drive, south along Breaden Drive to Norring Street, in an eastnortheasterly direction between Raby Court, Lara Court, Greta Court and Rydal Court to the

north and Tanby Place, Windale Place and Toora Place to the south to and across Linville Avenue and Willmott Drive to Grange Drive, continuing in a general northeasterly direction along Grange Drive to Ennis Avenue, northwest along Ennis Avenue to Rae Road and in a westsouthwesterly direction along Rae Road to Read Street.

The boundary parts of Read Street (east side), Breaden Drive (both sides), Ennis Avenue (west side), Rae Road (south side) and the boundary street of Grange Drive (north side) are included within the area for Cooloongup Primary School, while the boundary parts of Frome Way (both sides) are excluded from the area for Cooloongup Primary School.

The following is an optional area for Cooloongup and Safety Bay Primary Schools:

The area bounded by Read Street (west side), Rae Road (south side), Waikiki Road (both sides) and Malibu Road (north side).

The following is an optional area for Cooloongup and Hillman Primary Schools:

From the intersection of Dixon Road and the proposed Garden Island Highway, westsouthwest along the proposed Garden Island Highway to Ennis Avenue, southeast and south along Ennis Avenue to Willmott Drive, east from this point to Mandurah Road and in a general northerly direction along Mandurah Road to Dixon Road.

The boundary parts of the proposed Garden Island Expressway (south side), Ennis Avenue (east side) and Mandurah Road (west side) are included within the optional area.

#### EAST MAYLANDS PRIMARY SCHOOL

The boundary for the abovementioned school is as follows:

From the intersection of Guildford Road and Garratt Road, southeast along Garrett Road to the Swan River, south, west and north along the Swan River to the southern extension of Milmore Lane, north from this point to and along Milmore Lane to Kirkham Hill Terrace, east along Kirkham Hill Terrace to Watson Place, northwest along Watson Place to Elizabeth Street, northeast along Elizabeth Street and its extension to Peninsula Road, northwest along Peninsula Road to East Street, northeast along East Street to Caledonian Avenue, northwest along Caledonian Avenue to Guildford Road and eastnortheast along Guildford Road to Garratt Road.

The boundary parts of Garratt Road (south side) and Guildford Road (south side) and the boundary street of Watson Place (both sides) are included within the area for East Maylands Primary School, while the boundary parts of Kirkham Hill Terrace (both sides), Elizabeth Street (both sides), Peninsula Road (both sides), East Street (both sides) and Caledonian Avenue (both sides) and the boundary street of Milmore Lane (both sides) are excluded from the area for East Maylands Primary School.

The following is an optional area (subject to the availability of accommodation at the chosen school) for East Maylands, Bayswater and Maylands Primary Schools:

From the junction of Caledonian Avenue and Guildford Road eastnortheast along Guildford Road to Garratt Road, northwest along Garratt Road and its extension to the railway line, southwest along the railway line to Caledonian Avenue and southeast along Caledonian Avenue to Guildford Road.

The boundary parts of Guildford Road (north side) and Garratt Road (both sides) are included within the optional area, while the boundary parts of Caledonian Avenue (both sides) are excluded from the optional area.

#### EAST WAIKIKI PRIMARY SCHOOL

The boundary for the abovementioned school is as follows:

From Read Street at a point adjacent to the northern arm of Frome Way, in an eastnortheasterly direction from this point to and along Frome Way to Breaden Drive, south along Breaden Drive to Norring Street, in an eastnortheasterly direction between Raby Court, Lara Court, Greta Court and Rydal Court to the north and Tanby Place, Windale Place and Toora Place to the south to and across Linville Avenue and Willmott Drive to Grange Drive, continuing in a general northeasterly direction along Grange Drive to Ennis Avenue, in a general southerly direction along Ennis Avenue to Willmott Drive, west along Willmott Drive to Gnangara Drive, in a general westerly direction along Gnangara Drive to Read Street and northnorthwest along Read Street to a point adjacent to the northern arm of Frome Way.

The boundary parts of Frome Way (both sides), Ennis Avenue (west side), Willmott Drive (north side) and Read Street (east side) and the boundary streets of Grange Drive (south side) and Gnangara Drive (north side) are included within the area for East Waikiki Primary School, while the boundary parts of Breaden Drive (both sides) are excluded from the area for East Waikiki Primary School.

The following is an optional area for East Waikiki, Charthouse and Warnbro Primary Schools:

The area bounded by Gnangara Drive (south side), Read Street (east side), Safety Bay Road (north side), Ennis Avenue (west side), and Willmott Drive (south side).

#### EAST WANNEROO PRIMARY SCHOOL

The boundary for the abovementioned school is as follows:

From the junction of Ocean Reef Road and Wanneroo Road, north along Wanneroo Road to Dundebar Road, in a general easterly direction along Dundebar Road to Griffiths Road, north along Griffiths Road and its extension to the westerly extension of the northern arm of Casuarina Way,

east from this point to and along Casuarina Way and its extension to Franklin Road, south along Franklin Road to Rome Road, east from this point to Hawkins Road, south along Hawkins Road to Badgerup Road, south along Badgerup Road to the proposed extension of Ocean Reef Road, and east along the extension of Ocean Reef Road to Wanneroo Road.

The boundary parts of the proposed extension of Ocean Reef Road (both sides), Badgerup Road (both sides), Franklin Road (both sides), Hawkins Road (both sides), Casuarina Way (both sides), Dundebar Road (both sides) and Wanneroo Road (east side), and the boundary street of Griffiths Road (both sides) are included within the area for East Wanneroo Primary School.

#### FORRESTDALE PRIMARY SCHOOL

The boundary between Forrestdale Primary School and Oakford Primary School is as follows:

From where Hopkinson Road crosses the Birriga Drain, west and south along the Birriga Drain to Thomas Road, southwest and then in a general westerly direction along Thomas Road to the locality boundary between the Town of Kwinana and the Shire of Serpentine-Jarrahdale.

The boundary parts of Thomas Road (both sides) are excluded from the area for Forrestdale Primary School.

#### GWYNNE PARK PRIMARY SCHOOL

The boundary for the abovementioned school is as follows:

From the railway crossing at Eleventh Road, north along the railway line to Forrest Road, southwest along Forrest Road to Eleventh Road and southeast along Eleventh Road to the railway line.

The boundary parts of Forrest Road (south side) and Eleventh Road (both sides) are included within the area for Gwynne Park Primary School.

#### HILLMAN PRIMARY SCHOOL

The boundary for the abovementioned school is as follows:

The area bounded by Ennis Avenue, Dixon Road and the proposed Garden Island Highway.

The boundary parts of Ennis Avenue (east side), Dixon Road (both sides) and the proposed Garden Island Highway (north side) are included within the area for Hillman Primary School.

The following is an optional area for Hillman and Cooloongup Primary Schools:

From the intersection of Dixon Road and the proposed Garden Island Highway, westsouthwest along the proposed Garden Island Highway to Ennis Avenue, southeast and south along Ennis Avenue to Willmott Drive, east from this point to Mandurah Road and in a general northerly direction along Mandurah Road to Dixon Road.

The boundary parts of the proposed Garden Island Expressway (south side), Ennis Avenue (east side) and Mandurah Road (west side) are included within the optional area.

The following is an optional area for Hillman, Bungaree and Rockingham Beach Primary Schools: The area bounded by Patterson Road (south side), Read Street (east side), Rae Road (north side) and Ennis Avenue (west side).

### INGLEWOOD PRIMARY SCHOOL

The boundary for the abovementioned school is as follows:

From the junction of Walter Road West and Central Avenue, southeast along Central Avenue to Carrington Street, northeast along Carrington Street to Kennedy Street, southeast along Kennedy Street and its extension to the railway line, northeast along the railway line to Grand Promenade, northwest along Grand Promenade to Beaufort Street, northeast along Beaufort Street to Drummond Street, northwest along Drummond Street to Walter Road West and southwest and south along Walter Road West to Central Avenue.

The boundary parts of Central Avenue (north side), Grand Promenade (both sides), Beaufort Street (both sides), Drummond Street (both sides) and Walter Road West (east side) are included within the area for Inglewood Primary School, while the boundary parts of Carrington Street (both sides) and Kennedy street (both sides) are excluded from the area for Inglewood Primary School.

The following is an optional area, (subject to the availability of accommodation at the chosen school), between Inglewood Primary School and Maylands Primary School:

From a point on the railway line adjacent to the extension of Central Avenue, northeast along the railway line to the extension of Kennedy Street, northwest to and along Kennedy Street to Carrington Street, southwest along Carrington Street to Central Avenue and southeast along Central Avenue and its extension to the railway line.

The boundary parts of Kennedy Street (both sides), Carrington Street (both sides) and Central Avenue (north side) are included within the optional area.

#### JOONDALUP PRIMARY SCHOOL

The boundary for the abovementioned (new in 1993) school is as follows:

From the junction of Moore Drive and Joondalup Drive, northeast and north along Joondalup Drive to Burns Beach Road, in a general westerly direction along Burns Beach Road to the proposed extension of the Mitchell Freeway, south along the extension of the Mitchell Freeway to Moore Drive and east along Moore Drive to Joondalup Drive.

The boundary parts of Joondalup Drive (both sides), Burns Beach Road (both sides), the Mitchell Freeway (east side) and Moore Drive (both sides) are included within the area for Joondalup Primary School.

Children attending Government schools in Year 7 in 1993 and living within the area for Joondalup Primary School, may complete their primary education at their 1992 school or may transfer to Joondalup Primary School.

Children in Years 1 to 6 inclusive in 1993 (Years 1 to 7 inclusive thereafter) and living within the area for Joondalup Primary School, shall attend Joondalup Primary School except that younger siblings of Year 7 (1993) children shall have the option of remaining with any Year 7 siblings who elect to complete their primary education at their 1992 school.

#### KARDINYA PRIMARY SCHOOL

The boundary for the abovementioned schools is as follows:

From the junction of Somerville Boulevard and North Lake Road, north along North Lake Road to Garling Street, west along Garling Street to the locality boundary between Kardinya and O'Connor, south along this boundary to South Street, eastsoutheast along South Street to North Lake Road, south along North Lake Road to Progress Drive, east and north along Progress Drive to Farrington Road, northeast along Farrington Road to Windelya Road, north along Windelya Road to South Street, east and northeast along South Street to Prescott Drive, in a general northerly direction along Prescott Drive to Somerville Boulevard, and in a general westerly direction along Somerville Boulevard to North Lake Road.

The boundary parts of North Lake Road (north section, west side, southern section, east side), Garling Street (south side), South Street (western section, north side, eastern section, both sides), Progress Drive (both sides), Farrington Road (both sides), and Somerville Boulevard (south side) and the boundary road of Windelya Road (both sides), are included within the area for Kardinya Primary School, while the boundary street of Prescott Drive (both sides) is excluded from the area for Kardinya Primary School.

The following is an optional area for Kardinya, Bateman and Winthrop Primary Schools for new families moving into the area or for families sending children to school for the first time. Children already enrolled at one of these schools may not transfer to another without the approval of the District Education Office or unless a change of residence places them within the boundary for one of these schools.

The area bounded by Prescott Drive (both sides), South Street (north side), Murdoch Drive (west side) and Somerville Boulevard (south side).

The following is an optional area for Kardinya, Carawatha and Winthrop Primary Schools for new families moving into the area or for families sending children to school for the first time. Children already enrolled at one of these schools may not transfer to another without the approval of the District Education Office or unless a change of residence places them within the boundary for one of these schools.

From the junction of Somerville Boulevard and North Lake Road, north along North Lake Road to a point adjacent to the northern arm of Freedman Way, east from this point to and along Freedman Way and its extension to Aitken Drive, south and southeast along Aitken Drive to Keall Pass, south and southeast along Keall Pass to Somerville Boulevard, and southwest and west along Somerville Boulevard to North Lake Road.

The boundary parts of North Lake Road (east side), Freedman Way (both sides) and Somerville Boulevard (north side) are included within the optional area, while the boundary parts of Aitken Drive (both sides), and the boundary street of Keall Pass (both sides) are excluded from the optional area.

#### KOONDOOLA PRIMARY SCHOOL

The boundary for the abovementioned school is as follows:

From the intersection of Marangaroo Drive and Mirrabooka Avenue, south along Mirrabooka Avenue to the northern boundary of Mercy College and Mercy Primary School site, east along this boundary and its extension to the western arm of Brinckley Crescent, north along Brinckley Crescent to Whitehouse Drive, east and northeast along Whitehouse Drive to Hollingsworth Avenue, southeast along Hollingsworth Avenue to Durack Place, north along Durack Place and continuing north to Burlinson Crescent, eastnortheast along Burlinson Crescent to Butterworth Avenue, northeast from this point between Gabell Way to the north and Waddington Crescent to the south to the southern corner of the reservoir, east from this point to Alexander Drive, north along Alexander Drive to Marangaroo Drive and west along Marangaroo Drive to Mirrabooka Avenue.

The boundary parts of Mirrabooka Avenue (east side), Brinckley Crescent (western arm, west side), Whitehouse Drive (north side), Hollingsworth Avenue (north side), Burlinson Crescent (both sides), Alexander Drive (west side), Marangaroo Drive (south side) and the boundary street of Durack Avenue (both sides), are included within the area for Koondoola Primary School.

The following is an optional area for Koondoola, Girrawheen, Hainsworth and Montrose Primary Schools:

From the intersection of the alignment of the proposed Hepburn Avenue and Evandale Road, south along Evandale Road and its extension to Marangaroo Drive, east along Marangaroo Drive to the southern extension of Gerosa Place, north to and along Gerosa Place to Hillcrest Road, northeast along Hillcrest Road to Derbi Road, north along Derbi Road to the extension of Rangeview Road, north along Rangeview Road to the alignment of the proposed Hepburn Avenue and west along this alignment to Evandale Road.

The boundary parts of Marangaroo Drive (north side), and Hepburn Avenue (south side) are included within the optional area, while the boundary parts of Evandale Road (both sides) Hillcrest Road (both sides) and Rangeview Road (both sides) and the boundary streets of Gerosa Place (both sides) and Derbi Road (both sides) are excluded from the optional area.

#### KOORILLA PRIMARY SCHOOL

The following is an optional area between Koorilla and Southwell Primary Schools:

The area bounded by Stock Road (to the west), Phoenix Road (to the south) and Forrest Road (to the east and north).

The boundary parts of Stock Road (eastern side), Phoenix Road (north side) and Forrest Road (western and southern sides), are included within the optional area.

#### LEDA PRIMARY SCHOOL

The boundary for the abovementioned school is the locality of Leda, as delineated in the 1993 Perth StreetSmart Directory.

The following is an optional area for Leda, Calista and North Parmelia Primary Schools:

The area bounded by Gilmore Avenue, Challenger Avenue, Parmelia Avenue, Sutherland Parade, the locality boundary of Parmelia and Casuarina, Bertram Road and Wellard Road.

The boundary parts of Bertram Road (both sides), and Gilmore Avenue (both sides) are included within the optional area, while the boundary parts of Parmelia Avenue (both sides), and Wellard Road (both sides) and the boundary streets of Challenger Avenue (both sides) and Sutherland Parade (both sides), are excluded from the optional area.

The following is an optional area between Leda Primary School and Medina Primary School:

The locality of Wellard as delineated in the 1993 Perth StreetSmart Directory.

Transport will not be provided to Leda Primary School for children living in the locality of Wellard.

#### MAYLANDS PRIMARY SCHOOL

The boundary for the abovementioned school is as follows:

From the railway crossing at Caledonian Avenue, southwest along the railway line to the western extension of Packenham Street, east from this point to Packenham Street, southeast along Packenham Street and its extension to the Swan River, in a general easterly direction along the Swan River to the southern extension of Milmore Lane, north from this point to and along Milmore Lane to Kirkham Hill Terrace, east along Kirkham Hill Terrace to Watson Place, northwest along Watson Place to Elizabeth Street, northeast along Elizabeth Street and its extension to Peninsula Road, northwest along Peninsula Road to East Street, northeast along East Street to Caledonian Avenue and northwest along Caledonian Avenue to the railway line.

The boundary parts of Kirkham Hill Terrace (both sides), Elizabeth Street (both sides), Peninsula Road (both sides), East Street (both sides), Caledonian Avenue (both sides) and the boundary streets of Packenham Street (both sides) and Milmore Lane (both sides) are included within the area for Maylands Primary School, while the boundary street of Watson Place (both sides) is excluded from the area for Maylands Primary School.

The following is an optional area, (subject to the availability of accommodation at the chosen school), between Maylands Primary School and Inglewood Primary School:

From a point on the railway line adjacent to the extension of Central Avenue, northeast along the railway line to the extension of Kennedy Street, northwest to and along Kennedy Street to Carrington Street, southwest along Carrington Street to Central Avenue and southeast along Central Avenue and its extension to the railway line.

The boundary parts of Kennedy Street (both sides), Carrington Street (both sides) and Central Avenue (north side) are included within the optional area.

The following is an optional area (subject to the availability of accommodation at the chosen school) for Maylands, Bayswater and East Maylands Primary Schools:

From the junction of Caledonian Avenue and Guildford Road eastnortheast along Guildford Road to Garratt Road, northwest along Garratt Road and its extension to the railway line, southwest along the railway line to Caledonian Avenue and southeast along Caledonian Avenue to Guildford Road.

The boundary parts of Guildford Road (north side) and Garratt Road (both sides) are included within the optional area, while the boundary parts of Caledonian Avenue (both sides) are excluded from the optional area.

#### NORTH PARMELIA PRIMARY SCHOOL

The boundary for the abovementioned school is as follows:

From the junction of Sutherland Parade and Parmelia Avenue, north along Parmelia Avenue to Sulphur Road, west along Sulphur Road to Casserley Way, north along Casserley Way and continuing in a northerly direction to Hennessy Avenue, west along Hennessy Avenue to Orelia Avenue, north along Orelia Avenue to Thomas Road, east along Thomas Road to the locality boundary of Parmelia and Casuarina, south, west and south along this locality boundary to Sutherland Parade, and west along Sutherland Parade to Parmelia Avenue.

The boundary parts of Thomas Road (south side) and the boundary street of Sutherland Parade (both sides) are included within the area for North Parmelia Primary School, while the boundary parts of Parmelia Avenue (both sides), Sulphur Road (both sides), Casserley Way (both sides), Hennessy Avenue (both sides) and Orelia Avenue (both sides), are excluded from the area for North Parmelia Primary School.

The following is an optional area for North Parmelia, Calista and Orelia Primary Schools for families moving into that area or for those sending a child to school for the first time:

The area bounded by Challenger Avenue (both sides), Gilmore Avenue (both sides), Sulphur Road (both sides) and Parmelia Avenue (both sides).

The following is an optional area for North Parmelia, Calista and Leda Primary Schools:

The area bounded by Gilmore Avenue, Challenger Avenue, Parmelia Avenue, Sutherland Parade, the locality boundary of Parmelia and Casuarina, Bertram Road and Wellard Road.

The boundary parts of Bertram Road (both sides), and Gilmore Avenue (both sides) are included within the optional area, while the boundary parts of Parmelia Avenue (both sides), and Wellard Road (both sides) and the boundary streets of Challenger Avenue (both sides) and Sutherland Parade (both sides), are excluded from the optional area.

#### OAKFORD PRIMARY SCHOOL

The boundary between Oakford Primary School and Forrestdale Primary School is as follows:

From where Hopkinson Road crosses the Birriga Drain, west and south along the Birriga Drain to Thomas Road, west, southwest and then in a general westerly direction along Thomas Road to the locality boundary between the Town of Kwinana and the Shire of Serpentine-Jarrahdale.

The boundary parts of Thomas Road (both sides) are included in the area for Oakford Primary School.

The boundary between Oakford Primary School and West Byford Primary School is Hopkinson Road and a line drawn northwards from Hopkinson Road to Forrest Road.

The boundary street of Hopkinson Road (both sides) and the area to the east of the line between Hopkinson Road and Forrest Road are excluded from the area for Oakford Primary School.

#### PARKFIELD PRIMARY SCHOOL

The boundary for the abovementioned (new in 1993) school is as follows:

From the Leschenault Inlet at a point adjacent to the westerly extension of Travers Drive, east from this point to and along Travers Drive to Hanks Way, southeast along Hanks Way (and including Knight Place) to Chapple Drive, northeast along Chapple Drive to Bedingfield Way, east along the northern arm of Bedingfield Way to the Brunswick River, south along the Brunswick River to Paris Road, east along Paris Road to the Australind Bypass, and north along the Australind Bypass.

The boundary parts of Paris Road (north side), the Australind Bypass (west side), Travers Drive (both sides), Chapple Drive (both sides), Bedingfield Way (both sides) and the boundary streets of Hanks Way (both sides) and Knight Place (both sides) are included in the area for Parkfield Primary School.

Children attending Government schools in Year 7 in 1993 and living within the area for Parkfield Primary School, may complete their primary education at their 1992 school or may transfer to Parkfield Primary School.

Children in Years 1 to 6 inclusive in 1993 (Years 1 to 7 inclusive thereafter) and living within the area for Parkfield Primary School, shall attend Parkfield Primary School, except that younger siblings of Year 7 (1993) children shall have the option of remaining with any Year 7 siblings who elect to complete their primary education at their 1992 school.

#### QUINNS ROCKS PRIMARY SCHOOL

The boundary for this school is the locality of Quinns Rocks as delineated in the 1992 Perth StreetSmart Directory.

The following is an optional area for Quinns Rocks Primary School and Clarkson Primary School: The locality of Mindarie, as delineated in the 1993 Perth StreetSmart Directory.

Children resident in the locality of Merriwa who attended Quinns Rocks Primary School in 1992 may remain at Quinns Rocks Primary School or may transfer to Clarkson Primary School. This option is extended to the younger siblings of these children.

Families moving into Merriwa after the end of 1992, and existing (1992) Merriwa families who have not had children attending Quinns Rocks Primary School, will be required to attend Clarkson Primary School.

#### ROCKINGHAM BEACH PRIMARY SCHOOL

The following is an optional area for Rockingham Beach, Bungaree and Hillman Primary Schools: The area bounded by Patterson Road (south side), Read Street (east side), Rae Road (north side) and Ennis Avenue (west side).

#### SAFETY BAY PRIMARY SCHOOL

The boundary for the abovementioned school is as follows:

From the Indian Ocean at a point due west of the extension of Boundary Road, east from this point to and along Boundary Road to Safety Bay Road, east across Safety Bay Road to the proposed Garden Island Highway, southeast along the proposed Garden Island Highway to Rae Road, east along Rae Road to Waikiki Road, south along Waikiki Road to Malibu Road and southwest along Malibu Road and its extension to the Indian Ocean.

The boundary parts of the proposed Garden Island Highway (south side), Rae Road (south side), Malibu Road (north side) and the boundary street of Boundary Road (both sides) are included within the area for Safety Bay Primary School, while the boundary street of Waikiki Road (both sides) is excluded from the area for Safety Bay Primary School.

The following is an optional area for Safety Bay and Cooloongup Primary Schools:

The area bounded by Read Street (west side), Rae Road (south side), Waikiki Road (both sides) and Malibu Road (north side).

#### SOUTHWELL PRIMARY SCHOOL

The following is an optional area between Southwell and Koorilla Primary Schools:

The area bounded by Stock Road (to the west), Phoenix Road (to the south) and Forrest Road (to the east and north).

The boundary parts of Stock Road (eastern side), Phoenix Road (north side) and Forrest Road (western and southern sides), are included within the optional area.

#### WADDINGTON PRIMARY SCHOOL

The boundary for the abovementioned school is as follows:

From the intersection of Alexander Drive and Beach Road, west along Beach Road to Mirrabooka Avenue, north along Mirrabooka Avenue to the northern boundary of Mercy College and Mercy Primary School site, east along this boundary and its extension to the western arm of Brinckley Crescent, north along Brinckley Crescent to Whitehouse Drive, east and northeast along Whitehouse Drive to Hollingsworth Avenue, southeast along Hollingsworth Avenue to Durack Place, north along Durack Place and continuing north to Burlinson Crescent, eastnortheast along Burlinson Crescent to Butterworth Avenue, northeast from this point between Gabell Way to the north and Waddington Crescent to the south to the southern corner of the reservoir, east from this point to Alexander Drive and south along Alexander Drive to Beach Road.

The boundary parts of Beach Road (north side), Mirrabooka Avenue (east side), Brinckley Crescent (western arm, east side), Whitehouse Drive (south side), Hollingsworth Avenue (south side) and Alexander Drive (west side) are included within the area for Waddington Primary School, while the boundary parts of Burlinson Crescent (both sides) and the boundary street of Durack Place (both sides) are excluded from the area for Waddington Primary School.

#### WARNBRO PRIMARY SCHOOL

The boundary for the abovementioned school is as follows:

From the Indian Ocean at a point coinciding with the westerly extension of Hokin Street, east from this point to Hokin Street, northeast along Hokin Street to Safety Bay Road, east along Safety Bay Road to Ennis Avenue and south along Ennis Avenue to Mandurah Road.

The boundary parts of Safety Bay Road (south side) and Ennis Avenue (west side), are included within the area for Warnbro Primary School, while the boundary street of Hokin Street (both sides) is excluded from the area for Warnbro Primary School.

The following is an optional area for Warnbro, Charthouse and East Waikiki Primary Schools:

The area bounded by Gnangara Drive (south side), Read Street (east side), Safety Bay Road (north side), Ennis Avenue (west side) and Willmott Drive (south side).

#### WEST BYFORD PRIMARY SCHOOL

The boundary for the abovementioned (new in 1993) school is as follows:

From the intersection of Forrest Road and Eleventh Road, southeast along Eleventh Road to the railway line, south along the railway line to the branch railway line south of Bishop Road, northwest and west along this railway line to Hopkinson Road, north along Hopkinson Road to Rowley Road, continuing in a northerly direction to Forrest Road, and northeast along Forrest Road to Eleventh Road.

The boundary street of Hopkinson Road (both sides) is included within the area for West Byford Primary School, while the boundary parts of Eleventh Road (both sides), Forrest Road (both sides) and the area to the west of the line between Rowley Road and Forrest Road, are excluded from the area for West Byford Primary School.

Children attending Government schools in Year 7 in 1993 and living within the area for West Byford Primary School, may complete their primary education at their 1992 school or may transfer to West Byford Primary School.

Children in Years 1 to 6 inclusive in 1993 (Years 1 to 7 inclusive thereafter) and living within the area for West Byford Primary School, shall attend West Byford Primary School.

The following is an optional area between Byford and West Byford Primary School:

From the junction of Eleventh Road and the South Western Highway, south along the South Western Highway to Norman Road, west along Norman Road to the railway line, north along the railway line to Eleventh Road and east along Eleventh Road to the South Western Highway.

The boundary parts of Eleventh Road (south side), the South Western Highway (west side) and the boundary street of Norman Road (both sides) are included within the optional area.

#### WILLAGEE PRIMARY SCHOOL

The boundary for the abovementioned school is as follows:

From the intersection of Leach Highway and Stock Road, south along Stock Road to Garling Street, east along Garling Street to Ellison Street, north along Ellison Street to Archibald Street, west along Archibald Street to Worley Street, north along Worley Street to Leach Highway and west along Leach Highway to Stock Road.

The boundary parts of Stock Road (east side), Garling Street (north side) and Leach Highway (south side) and the boundary streets of Ellison Street (both sides) and Worley Street (both sides) are included within the area for Willagee Primary School, while the boundary parts of Archibald Street (both sides) are excluded from the area for Willagee Primary School.

The following is an optional area between Willagee and Carawatha Primary Schools:

The area bounded by Leach Highway, Worley Street, Archibald Street and Wheyland Street.

The boundary parts of Leach Highway (south side) and Archibald Street (both sides) are included within the optional area, while the boundary streets of Worley Street (both sides) and Wheyland Street (both sides) are excluded from the optional area.

#### WILLANDRA PRIMARY SCHOOL

The boundary for the abovementioned (new in 1993) school is as follows:

From the junction of Armadale Road and Seville Drive, north and northwest along Seville Drive to Poad Street, west and northwest along Poad Street to Lake Road, southwest along Lake Road to the northern extension of Brigade Road, southwest to and along Brigade Road and its extension to Armadale Road and east along Armadale Road to Seville Drive.

The boundary parts of Seville Drive (west and southwest sides), Poad Street (both sides), Armadale Road (north side) and the boundary street of Brigade Road (both sides) are included within the area for Willandra Primary School, while the boundary parts of Lake Road (both sides) are excluded from the area for Willandra Primary School.

Children in Years 1 to 6 inclusive in 1993 (Years 1 to 7 inclusive thereafter) and living within the area for Willandra Primary School, shall attend Willandra Primary School except that younger siblings of Year 7 (1993) children shall have the option of remaining with any Year 7 siblings who elect to complete their primary education at their 1992 school.

The following is an optional area between Willandra Primary School and Challis Early Childhood Education Centre and Challis Primary School:

From the junction of Seville Drive and Armadale Road, east along Armadale Road to the southern extension of Dewar Street, northwest to and along Dewar Street to Braemore Road, northeast along Braemore Road to Cobar Street, northwest between Firetail Court, Bellbird Place, Skylark View and Peacock Close to the south and Petrel Close, Waterway Crescent and Fulmar Way to the north, to Seville Drive, and southwest, southeast and south along Seville Drive to Armadale Road.

The boundary parts of Armadale Road (north side), Braemore Drive (both sides) and Seville Drive (southeast, northeast and eastern sides) and the boundary street of Dewar Street (both sides) are included within the optional area.

The following is an optional area between Willandra Primary School and Forrestdale Primary School:

The area bounded by Ranford Road, Lake Road, the locality boundary between Westfield and Armadale and the local authority boundary between the cities of Armadale and Gosnells.

The boundary parts of Ranford Road (both sides) and Lake Road (both sides) are included within the optional area.

#### WINTHROP PRIMARY SCHOOL

The boundary for the abovementioned school is as follows:

From the junction of Leach Highway and Winthrop Drive, south along Winthrop Drive to Somerville Boulevard, east along Somerville Boulevard to Murdoch Drive, north along Murdoch Drive to Leach Highway and west along Leach Highway to Winthrop Drive.

The boundary parts of Winthrop Drive (east side), Somerville Boulevard (north side), Murdoch Drive (west side) and Leach Highway (south side) are included within the area for Winthrop Primary School.

The following is an optional area for Winthrop, Bateman and Kardinya Primary Schools for new families moving into the area or for families sending children to school for the first time. Children already enrolled at one of these schools may not transfer to another without the approval of the District Education Office or unless a change of residence places them within the boundary for one of these schools.

The area bounded by Prescott Drive (both sides), South Street (north side), Murdoch Drive (west side) and Somerville Boulevard (south side).

The following is an optional area for Winthrop and Carawatha Primary Schools for new families moving into the area or for families sending children to school for the first time. Children already enrolled at one of these schools may not transfer to another without the approval of the District Education Office or unless a change of residence places them within the boundary for one of these schools.

From the junction of Winthrop Drive and Leach Highway, west along Leach Highway to North Lake Road, south along North Lake Road to a point adjacent to the northern arm of Freedman Way, east from this point to and along Freedman Way and its extension to Aitken Drive, south and southeast along Aitken drive to Keall Pass, south and southeast along Keall Pass to Somerville Boulevard, in a general easterly direction along Somerville Boulevard to Winthrop Drive, and north along Winthrop Drive to Leach Highway.

The boundary parts of Leach Highway (south side), North Lake Road (east side), Aitken Drive (both sides), Somerville Boulevard (north side), Winthrop Drive (west side) and the boundary street of Keall pass (both sides) are included within the optional area, while the boundary parts of Freedman Way (both sides) and excluded from the optional area.

The following is an optional area for Winthrop, Carawatha and Kardinya Primary Schools for new families moving into the area or for families sending children to school for the first time. Children already enrolled at one of these schools may not transfer to another without the approval of the District Education Office or unless a change of residence places them within the boundary for one of these schools.

1. This notice may be cited as the Abrolhos Islands and Mid West Trawl Limited Entry Fishery Amendment Notice 1992.

3. Subject to Clause 4, I hereby prohibit all persons from taking, or attempting to take, fish by means of a trawl net in the waters described in the Schedule.

## Application of notice

- 4. The provisions of this notice shall apply to all persons other than-
  - (1) licensed professional fishermen using a licensed fishing boat which is-
    - (a) being operated in a limited entry fishery declared by notice under section 32;
    - (b) authorised to be operated in that limited entry fishery; and
    - (c) being operated in accordance with the specifications published in the notice declaring the Fishery in which the boat is authorised to be used.
  - (2) licensed professional fishermen using a licensed fishing boat the licence for which is endorsed to permit the boat to be used to take fish by means of a trawl net and the boat is being used in accordance with that endorsement.

1. This notice may be cited as the Pilbara Fish Trawl Fishery Notice 1992.

## Commencement

2. This notice will come into effect on 1 January 1993.

## Interpretation

- 3. In this notice unless the contrary intention appears-
  - "bobbin" means one of the spherical, cylindrical or wheel-like attachments to the groundrope which assist the groundrope to clear rough sections of the seabed;
  - "bridles" means the ropes or chains which attach the trawl net to the sweeps;
  - "fish" means all species of fish except for prawns of the family Penaeidae;
  - "Fishery" means the Pilbara Fish Trawl Fishery described in Schedule 1;
  - "groundrope" means the rope onto which is attached the lower half of the mouth of the trawl net;
  - "headrope" means the rope onto which is attached the upper half of the mouth of the trawl net;
  - "headrope length" means the distance measured along the headrope from where the trawl net attaches to one end of the headrope to where it attaches to the other end of the headrope;
  - "otter board" means one of the boards used with a trawl net to keep the mouth of the net spread wide while under tow;
  - "sweeps" means the cables connecting the otter boards to the bridles; and
  - "Zone" means an area of water described in Schedule 2.

## Determination of position by reference to the Australian Geodetic Datum

- 4. (1) Where, for the purposes of this notice it is necessary to determine a position on the surface of the earth by geographical coordinates, that position shall be determined on the Australian Geodetic Datum which is defined by an ellipsoid having a semi-major axis (equatorial radius) of 6 378 160 metres and a flattening of 1/298.25 and fixed by the position of the origin being the Johnston Geodetic Station in the Northern Territory of Australia.
- (2) The Johnston Geodetic Station referred to in subclause (1) shall be taken to be situated at 25°56′54.5515″ south latitude and at 133°12′30.0771″ east longitude and to have a ground level elevation of 571.2 metres above the ellipsoid referred to in that subclause.

## Restrictions on trawling

- 5. (1) All persons, other than the class of persons specified in Clause 6 are prohibited from taking or attempting to fish by means of trawling in the waters specified in Schedule 2.
- (2) All persons are prohibited from taking, or attempting to take, fish by means of trawling in the waters specified in Schedule 3.

### Exempt persons

- 6. (1) A person who is the holder of a Professional Fisherman's licence issued under Regulation 3 and is using a boat—
  - (a) licensed under Regulation 2 and the licence is endorsed to permit the boat to be used to take fish by means of trawling in the Fishery; and
  - (b) the boat is trawling in a Zone of the Fishery and during the period in which it is authorised to operate.
- (2) A person holding a Professional Fisherman's License issued under Regulation 3 using a boat licensed to operate in the Nickol Bay Prawn Limited Entry Fishery\* or the Onslow Prawn Limited Entry Fishery\*\*, operating in accordance with their Prawn Limited Entry Fishery authorisation and providing that the boat is not using fish trawl gear and is targeting prawns.
  - (3) For the purpose of this clause a boat using-
    - (a) a net with a mesh greater than 50 millimetres; or
    - (b) only one net; or
    - (c) trawl gear with a sweep distance between the otter board and the head rope exceeding 3 metres,

is using fish trawl gear.

## Permitted means of operating in the Fishery

- 7. A boat authorised to operate in the Fishery shall not use trawl gear within the Fishery where—
  - (a) more than one net is used:
  - (b) the headrope length of the trawl net exceeds 36.58 metres;
  - (c) the overall length of the trawl gear including sweeps, bridles, and headrope exceeds 274.32 metres;
  - (d) the mesh of the trawl net is less than 100 millimetres;
  - (e) the diameter of bobbins attached to the groundrope is less than 203 millimetres;
  - (f) a second boat is used in the trawling operations.

## Carriage of trawl gear

8. Unless otherwise approved in writing by the Minister, otter boards, trawl wires and otter trawl nets carried or attached to any boat shall be secured to that boat and kept out of the water at all times in areas of the Fishery closed to trawling.

## Schedule 1 (The Fishery)

All waters of the Indian Ocean and Exmouth Gulf lying north of 21°35′ south latitude and between 114°9′36″ east longitude and 120° east longitude and on the landward side of the 200 metre isobath.

#### Schedule 2 (Zones)

## Schedule 3 (Closed areas of the Fishery)

All waters of the Fishery but not including the areas of Zone 1 or Zone 2.

## PILBARA FISH TRAWL FISHERY—DIRECTIONS TO LICENSING OFFICERS Notice No. 546

FD 134/75.

1. Pursuant to section 17 I hereby issue to licensing officers the following directions, including the imposition of conditions, regarding the granting, renewal and transfer of fishing boat licenses endorsed to operate in the Pilbara Fish Trawl Fishery.

### Commencement

2. These directions will come into effect on 1 January 1993.

## Interpretation

3. For the purposes of these directions and conditions, unless the contrary intention appears—

"Code" means the Uniform Shipping Laws Code adopted by the Marine and Ports Council of Australia and published in the Commonwealth of Australia Gazette on 11 May 1981;

"Fishery" means the Pilbara Fish Trawl Fishery as described in Schedule 2;

"fish" means all species of fish except for prawns of the family Penaeidae;

"Prawns" means all species of decapod crustacea of the family Penaeidae;

"transferred" means the passing of ownership or effective control of the licence from one person to another person; and

"Zone" means an area of the Fishery as described in Schedule 3.

## Directions to licensing officers

- 4. (1) Unless otherwise directed by the Minister a fishing boat licence shall not be endorsed to authorise the taking of fish by means of trawling in the Fishery except—
  - (a) if the boat, or a boat that it has replaced, was used to take fish, other than prawns, by means of trawling in the waters of the Fishery within the 3 years prior to 12 November 1987 and has continued to trawl for fish in each of the years 1988, 1989 and 1990; or
  - (b) if the boat, or a boat that it has replaced, is licensed to operate in the Nickol Bay Prawn Limited Entry Fishery\*\* and provided that the licence holder had indicated in writing to the Director prior to 12 November 1987 that he intended to trawl for fish within the boundary of the Fishery; and
  - (c) if the boat, or a boat that it has replaced, does not exceed 375 boat units calculated in accordance with the formula in Schedule 1.

- (2) (a) Notwithstanding the provisions of subclause (1) of this clause the licensee of a boat not licensed to operate in the Fishery may, on application and with the written approval of the Minister, be issued with an access endorsement to take fish by means of trawling in the Fishery.
- (b) An endorsement issued under this subclause may be restricted to any specified Zone of the Fishery and to any specified period of operation.
- (3) A fishing boat licence shall be endorsed to show the Zone or Zones and the period in which the boat may operate.
- (4) An endorsement authorising a boat to operate in the Fishery shall not be transferred.
- (5) Unless otherwise authorised in writing by the Minister, an endorsement allocated to a boat licensed to operate in the—
  - (a) Exmouth Gulf Prawn Limited Entry Fishery\*;
  - (b) Nickol Bay Prawn Limited Entry Fishery\*\*, or
  - (c) Onslow Prawn Limited Entry Fishery\*\*\*,

shall lapse on transfer of the Limited Entry Fishery licence referred to in (a), (b) or (c) above.

(6) Subject to the prior approval of the Director a boat authorised to operate in the Fishery may be replaced by a boat provided that the replacement boat does not exceed 375 boat units calculated in accordance with the formula in Schedule 1.

## Imposition of conditions on fishing boat licence

- 5. The following conditions are imposed on the fishing boat licence of any boat authorised to operate in the Fishery.
  - (1) The Zone or Zones of the Fishery and the period in which the boat is authorised to operate.
  - (2) The owner of a boat authorised to operate in the Fishery shall not, without the prior written approval of the Director, repower the boat by—
    - (a) changing the configuration of the existing engine, propeller, propeller shaft or other components; or
    - (b) installing a new engine.
  - (3) The owner of a boat authorised to operate in the Fishery shall—
    - (a) on the written instruction of the Director cause the suppliers of an engine for the boat to install a lead seal on the fuel pump of the engine;
    - (b) authorise the Director to install or permit the installation of any further lead seals as the Director may require;
    - (c) not permit the removal or allow any interference to a seal fitted in accordance with paragraph (a) or (b) without the prior written approval of the Director; and
    - (d) immediately report to the Director any interference to such seal caused by accident, mechanical requirements or any reason whatsoever and as soon as practical thereafter arrange for recertification of the installed engine power by the supplier and the installation of a new seal.
  - (4) The owner of a boat authorised to operate in the Fishery shall permit the inspection of the engine configuration and any seal by an officer of the Fisheries Department and shall permit on board the boat any person the officer may require for such inspection.
  - (5) Any other conditions imposed on the licence by the Minister.
