BUSH FIRES ACT 1954 SUSPENSION OF SECTION 25

Bush Fires Board, Perth.

Pursuant to the powers contained in section 25B of the Bush Fires Act, I hereby suspend the operation of the provisions of section 25 of the said Act, that relate to a fire lit, or which is lit, for the purpose of destroying garden refuse or rubbish or for the like purpose and shall have effect until revoked on land set aside for the Shire of Manjimup rubbish disposal sites situated on—

- (a) Manjimup Rubbish Disposal Site, Reserve No. 25706.
- (b) Pemberton Rubbish Disposal Site, Reserve No. 24003.
- (c) Northcliffe Rubbish Disposal Site, Reserve No. 29991.
- (d) Walpole Rubbish Disposal Site, Reserve No. 21092.
- (e) Windy Harbour Rubbish Disposal Site, Nelson Location 12439.

This order revokes any previous order relating to the abovementioned sites.

Specified Conditions

- 1. All flammable material, not including standing trees, is to be removed for a minimum of 100 metres from the rubbish dumping area. A firebreak 6 metres wide grader finished and trafficable to be constructed around boundaries of the 100 metre limit.
- 2. A sign warning of prohibition lighting of fires to be erected and maintained at the site. (Sign to display the penalty: Fine of \$250 000 or imprisonment for 18 years) and that only Council authorised personnel to light fires.
- 3. A 6 metre wide grader finished trafficable firebreak to be constructed around the perimeter of the Reserve.
- 4. Fires may only be lit in a pit or receptacle provided and rubbish may not build up higher than 1 metre from the top of pit or receptacle.
- 5. Fire to be lit by Council authorised personnel only and only after consultation with the Chief Bush Fire Control Officer, Shire Clerk and Local Fire Control Officer.

Shire personnel to be in attendance whilst burning is carried out. A minimum of 2 persons.

- 6. No fires to be lit or burning to continue on land subject to this suspension on a day for which the Fire Danger Forecast issued by the Bureau of Meteorology in Perth in respect of the locality is Very High or Extreme.
- 7. Lighting is not to commence prior to 1600 hrs and must be extinguished or buried by 0800 hrs the following day.
- 8. A mobile fire fighting unit must be in attendance while burning is carried out. This unit should be a minimum of 600 litres with 5kw power, 38mm pump with 30 metres of 19mm rubber hose. BOB WIESE, Minister for Emergency Services.

It is hereby notified that I, Bob Wiese MLA administering the Bush Fires Act 1954, hereby revoke all previous orders under section 25B of the said Act with relation to the Sandstone Rubbish Disposal Site situated on Reserve No. 11714 and pursuant to the powers contained in section 25B of the said Act, approve the suspension of the operations of section 25 that relate to a fire to be lit, or which is lit, for the purpose of destroying garden refuse or rubbish or any like purpose during the declared Prohibited and Restricted Burning Times on land set aside for the purpose in the Municipal District of the Shire of Sandstone. - 3. A sign declaring prohibition of unauthorised lighting of fires being erected and maintained at the entrance of the site.

- 4. All grass and bush of inflammable type being removed within 200 metres of dump area of the site prior to the first fire being lit.
- 5. Rubbish to be burnt regularly by the relevant Council employee or such other persons as authorised by the Shire Clerk.
- 6. A fire-fighting unit equipped with crew of 2 personnel, pump, engine and tank of minimum 500 ltr capacity be on site during the burning.
- 7. No fires to be lit on the site on days when the danger forecast issued by the Bureau of Meteorology in Perth in respect to the locality is "Very High" or "Extreme".
