TOBACCO CONTROL (EXEMPTION) NOTICE (No. 2) 1993

1. This notice may be cited as the Tobacco Control (Exemption) Notice (No. 2) 1993.

#### Exemption

  - (a) any trademark or brand name of a tobacco product shall be displayed only—
    - (i) on 2 A frame signs measuring 7 metres by 1 metre situated at the WACA; and
    - (ii) when incidentally or accidentally present in photographs used to publicize the Match;

- (b) any trademark or brand name of a tobacco product, or any tobacco advertisement, shall be accompanied by the health warning—
  - (i) "SMOKING CAUSES LUNG CANCER"; or
  - (ii) "SMOKING CAUSES HEART DISEASE",

together with the statement "Health Authority Warning";

- (c) the area exclusively devoted to the display of the health warning referred to in paragraph (b) and the statement "Health Authority Warning" shall be not less than 25% of the area devoted to the display of the trademark or brand name or tobacco advertisement referred to in that paragraph;
- (d) the health warning referred to in paragraph (b) shall—
  - (i) appear directly beneath the trademark or brand name or tobacco advertisement referred to in that paragraph and directly adjacent to the statement "Health Authority Warning";
  - (ii) appear in white Helvetica Bold capitals on a black background; and
  - (iii) occupy, together with the statement "Health Authority Warning", not less than 80% of the area devoted to the display of that health warning and that statement;

and

- (e) the letters of the statement "Health Authority Warning" shall-
  - (i) appear in Helvetica Medium capitals and Helvetica Medium lower case type; and
  - (ii) not exceed half the height of the letters used for the health warning referred to in paragraph (b).

- (ii) fell, remove, kill or irreparably damage any tree.
- (iii) erect any fence.
- (iv) commence or carry out any renovation, modification or demolition of any building.
- (v) alter or remove any building or object or part thereof.

#### 7.3 AGREEMENTS

That Council may

- (i) enter into agreements with the owners or occupiers of land on which any Schedule 4 place, building or object is situated for the purpose of ensuring its preservation or conservation.
- (ii) enter into agreements with the National Trust of Australia (Western Australia), Heritage Council of Western Australia, or any government department, authority or other body in Western Australia for the preservation or conservation of any Schedule 4 place, building or object.

#### 7.4 PURCHASE OR RESUMPTION

The Council may purchase or, subject to the Act, resume all or part of the parcel of land on which any Schedule 4 place, building or object is situated, as in the opinion of the Council is necessary for its preservation.


# 7.5 BRIDGETOWN SPECIAL DESIGN HERITAGE PRECINCT

- 7.5.1 In order to achieve the above objective all development including
  - demolition or removal of buildings
  - works which affect the external appearance of a building
  - construction of additions and outbuildings
  - erection of a fence or a wall
  - · development of new buildings

is not permitted unless written approval has been granted by Council, and in considering approval Council will have regard to any development guidelines which have been adopted to assist in the retention of the established and recognizable character of the Precinct.

- 7.5.2 Council will adopt, following advertisement thereof once of a notice in a local newspaper circulating in the district, and consideration of any Submissions, a Statement of Policy and Development Guidelines for the Precinct and there shall be kept and made available for public inspection at the offices of the Council.
- 7.5.3 Where Planning Approval is granted under the provisions of this clause Council will require that buildings and other structures are of a design and materials compatible with the general appearance of other buildings within the Precinct, as well as the intent of Council objective and development guidelines.
- 7.5.4 The provisions of this section will apply in addition to any other Scheme requirement applying to the relevant zone, and where any provision of this clause is not consistent with any other requirement of the Scheme the provisions of this clause shall prevail.




