BUSH FIRE NOTICE AND REQUIREMENTS

Shire of Augusta-Margaret River

Notice to all Owners and/or Occupiers of Land in the Shire of Augusta-Margaret River. In accordance with section 33 of the Bush Fires Act 1954, you are required to carry out fire prevention work on land owned or occupied by you in accordance with the provisions of this order. The penalty for non-compliance with this notice is a maximum fine of \$1 000, and notwithstanding prosecution, Council may enter upon the land and carry out required works at the owner/occupier's expense.

An inspection of firebreaks and hazard removal will be carried out in all areas of the Shire by an authorised officer (Townsites after 1 December 1993; Rural after 22 December 1993).

Rural and Special Rural Areas

This work must be carried out by 22 December 1993, and kept maintained throughout the summer months until 12 April 1994.

A. Rural Land

- 1. A firebreak not less than 2 metres wide must be constructed inside and within 100 metres of the boundary of each property where the boundary is adjacent to or adjoins a constructed or used surveyed road. (Firebreaks constructed on road verges do not constitute a legal firebreak under the Bush Fires Act, and Council approval is required prior to construction of additional firebreaks on roadside verges.)
- 2. A firebreak not less than 2 metres wide must be constructed within a perimeter of 20 metres of all homesteads, buildings, haystacks and fuel storage areas on the land.
- 3. Where uncleared land abuts a boundary, a firebreak not less than 2 metres wide must be constructed inside and within 100 metres of such boundaries.

B. Special Rural Land

- 1. The owners of all existing small rural holdings zoned "Special Rural" as Special Rural in Town Planning Schemes must construct a firebreak not less than 2 metres wide, immediately inside all boundaries.
- 2. A firebreak not less than 2 metres wide must be constructed within a perimeter of 20 metres of all homesteads, buildings, haystacks and fuel storage areas on the land.

3. Ungrazed pasture land can constitute a fire hazard, and orders will be issued under section 33 of the Bush Fires Act, if the hazard is not abated.

Townsites

This work must be carried out by 1 December 1993 and kept maintained throughout the summer months until 12 April 1994.

C. Townsites—Gracetown and Prevelly Park

In respect of land owned or occupied within these townsites or any area subdivided for other purposes, you shall—

- 1. Remove all flammable material (including ground fuel build-up) on the whole of the land except living standing trees, or
- Construct a firebreak not less than 1.5 metres wide, immediately inside both side and rear boundaries, together with a firebreak not less than 3 metres in width around all buildings on the land. All fuel residue material from firebreak construction to be removed from the block.
- D. All Other Townsites (including Molloy Island)

In respect of land owned or occupied by you within any townsite or any area subdivided for other purposes, you shall—

- 1. Where the area of land is up to and including 4 000 sq.m., remove all flammable material on the land except living standing trees, from the whole of the land, and
- 2. Where the area of land exceeds 4 000 sq.m., clear of flammable materials, firebreaks at least 2 metres wide, immediately inside all external boundaries of land, and also immediately surrounding all buildings situated on the land.
- E. Private Hardwood/Softwood Plantations

Any area planted with pines or eucalyptus species exceeding five (5) hectares but not exceeding fifteen (15) hectares—

- 1. Firebreaks not less than two (2) metres wide around the perimeter of land on which plantation is established.
- 2. Firebreaks not less than ten (10) metres wide, two (2) metres of which must be cleared of all flammable materials, on the boundary. The remaining eight (8) metres must be maintained in a low fuel condition, that is, short grass may be considered "low fuel", where the plantation is adjacent to or adjoins a constructed, used surveyed road or enjoys a common boundary. Plantations exceeding fifteen (15) hectares to comply with the Bush Fires Board recommendation.

F. Fuel and/or Gas Depots

In respect of land owned or occupied by you on which is situated any container normally used to contain liquid or gas fuel, including the land on which any ramp or support is constructed, you shall have the land clear of all flammable materials.

If it is considered impractical for any reason to clear firebreaks or remove flammable materials from the land as required by the Notice, you may make written application to the Council not later than the 15th day of November, 1993, for permission to provide firebreaks in alternative positions or to take alternative action to abate fire hazards on the land. This application must be countersigned by the Bush Fire Control Officer for the area in which the land is situated to signify his agreement to the variation. 



ESPERANCE PORT AUTHORITY AMENDMENT REGULATIONS 1993

Made by the Esperance Port Authority and approved by His Excellency the Governor in Executive Council.

Citation

1. These regulations may be cited as the Esperance Port Authority Amendment Regulations 1993.

Commencement

2. These regulations shall come into operation on 1 September 1993.

Principal regulations

- 3. In these regulations the *Esperance Port Authority Regulations 1969* * are referred to as the principal regulations.
 - [* Reprinted in the Gazette of 17 January 1991 at pp. 113-86. For amendments to 13 July 1993 see 1992 Index to Legislation of Western Australia, Table 4, pp.68-9.]

Heading to Part IV amended

- 4. The heading to Part IV of the principal regulations is amended by deleting "TONNAGE RATES" and substituting the following heading —
- " VESSEL CHARGES "

Regulation 68 repealed and regulations 68 and 68A substituted

5. Regulation 68 of the principal regulations is repealed and the following regulations are substituted —

Vessel charges and berthing dues

68. (1) Vessel charges shall be paid by all vessels using wharves as provided for in these regulations.

- (2) All vessels lying alongside wharves and trans-shipping cargo to or from lighters or other vessels shall be charged the same berthing dues in respect of that cargo as if the cargo had been landed on or taken off the wharves.
- (3) Subject to subregulation (4) when computing berthing dues for cargo carrying vessels, the officer in charge shall have the option of proceeding on the basis of the tonne of 1 000 kilograms, or the cubic metre, or the kilolitre, and the fractions of these units shall be charged on a *pro rata* basis.
- (4) Notwithstanding subregulation (3) the officer in charge shall compute berthing dues for the animals specified in this subregulation in accordance with the following
 - (a) one bullock, cow, steer, heifer or similar animal one tonne;
 - (b) 3 calves or foals one tonne;
 - (c) 15 sheep, pigs, goats or similar animals one tonne.
- (5) A vessel shall be charged at the rate of \$1.00 for each tonne/kilolitre of cargo loaded or discharged with a minimum charge of \$100.00 per vessel.
- (6) A vessel which occupies a berth but does not load or discharge cargo shall pay
 - (a) \$1 300.00 for the first day or part thereof; and
 - (b) \$650.00 for every following 12 hour period or part thereof.

Berthage dues — Taylor Street Jetty

- 68A. (1) Vessels using the Taylor Street Jetty shall pay

and

- (b) for a vessel licensed to carry passengers 300.
- (2) The berthage dues referred to in subregulation (1) are payable for a period of 12 months ending 31 December in each year but where the use of a vessel commences after 30 June in any year, one half of the prescribed dues are payable.

- (3) A vessel, other than a vessel referred to in subregulation (1), moored alongside any part of the Taylor Street Jetty, other than the Northern Berth face shall pay
 - (a) a fee of \$10.00 per day or part thereof; or
 - (b) at a rate of \$55.00 per month or part thereof.

Regulation 73 amended

6. Regulation 73 (3) of the principal regulations is amended by deleting paragraph (a).

- 7. The Second Schedule to the principal regulations is amended
 - (a) by repealing Part 1 and substituting the following Part —
