- 1 Consistent with the policy of maximising the return on cash balances, Treasury invest the value of cheques issued but not yet presented to the bank. As a result, Treasury's books of account show an overdrawn balance at 30 September, however the account at the bank was in credit. The intention is to minimise uninvested cash without overdrawing the account at the bank but on some occasions during the year unanticipated transactions can lead to that account being overdrawn.

## CONSOLIDATED FUND

The Consolidated Fund presentation in the Treasurer's Quarterly Statements for the three months ended on 30 September 1993 reflects the format of the State's new Consolidated Fund budget presentation.

The Consolidated Fund came into operation on 27 August 1993, effective from 1 July 1993. It combines the previous Consolidated Revenue Fund (CRF) and the General Loan and Capital Works Fund (GL&CWF) and includes various hypothecated revenues now required to be paid through the Consolidated Fund from 27 August 1993. The hypothecated revenues now paid through the Consolidated Fund and the revenue estimates for 1993-94 are:

The new Consolidated Fund separately identifies the nature of revenue and expenditure as either recurrent or capital whereas the previous Consolidated Revenue Fund and General Loan and Capital Works Fund were based on funding sources. The legislature was empowered to appropriate the Consolidated Revenue Fund and the General Loan and Capital Works Fund to such purposes as it decided and was not restricted in making expenditures for recurrent purposes from CRF nor making expenditures for capital purposes from GL&CWF. Separate Appropriation Bills are now submitted for Consolidated Fund recurrent services [Appropriation (Consolidated Fund) Bill (No.1) 1993] and Consolidated Fund capital services [Appropriation (Consolidated Fund) Bill (No.2) 1993]. The classifications utilised in the Treasurer's Quarterly Statements reflect the basis on which appropriations have been sought for 1993-94.

The previously published September 1992 figures for CRF and GL&CWF have been restated in terms of the revenue heads and expenditure Divisions utilised in the 1993-94 Consolidated Fund budget and are reported for comparative purposes.
