I, the Governor acting under section 10 (2) of the Shipping and Pilotage Act 1967, and with the advice and consent of the Executive Council---

- (a) revoke the proclamation made under section 10 (2) (a) of the Shipping and Pilotage Act 1967 and published in the *Government Gazette* on 1 August 1990 at p. 3648; and
- (b) declare the places described in the Schedule to be mooring control areas for the purposes of the Act.

# Bunbury-Koombana Bay Casuarina Boat Harbour

All that portion of Koombana Bay shown coloured blue on Department of Marine and Harbours Plan 275-05-01 and which is bounded by a line starting at a point "Z" at latitude  $33^{\circ}18'46.02"S$  and longitude  $115^{\circ}38'27.50"E$ ; thence on a true bearing of about  $318^{\circ}5'$  to the intersection with the high water mark at start point 'A"; thence continuing on a bearing of  $318^{\circ}5'$  about 230 metres to the high water mark on the western side of Koombana Bay; thence generally following the high water mark in a south-westerly, westerly, southerly and north-easterly direction back to the start point and containing an area of about 18.7 hectares.

#### Carnarvon Fishing Boat Harbour

All that portion of Carnarvon Fishing Boat Harbour Basin shown coloured blue on Department of Marine and Harbours Plan 201-06-01 and which is below the high water mark and the dredged entrance channel to an alignment between the port and starboard beacons at its intersection with Teggs Channel.

### Jurien Boat Harbour

The mooring control area includes Inner and Outer Harbours-

- (a) the Inner Harbour being all that portion of Jurien Boat Harbour shown coloured blue on Department of Marine and Harbours Plan 291-11-02 and which is bounded by a line starting from the starboard beacon on the southern breakwater at latitude 30°17′23.820″S and longitude 115°2′16.993″E; thence on a true bearing of 65°26′ distant about 10 metres to a start point "Z" on high water mark; thence continuing along the same bearing towards the port beacon to the intersection with the high water mark on the northern breakwater; thence in a clockwise direction around the high water mark of the Jurien Boat Harbour and breakwaters, back to the start point; and
- (b) the Outer Harbour being all that portion of Jurien Bay shown coloured blue on Department of Marine and Harbours Plan 291-11-01 and which is bounded by a line starting from SSM north head at latitude 30°14'00.718"S and longitude 114°59'37.004"E; thence on a true bearing of 183°59' towards Escape Island navigation light tower for a distance of about 100 metres to a start point "Z" on high water mark; thence continuing on that bearing for a distance of about 10.5 kilometres to the point of intersection with the western prolongation of the northern boundary of Victoria Location 9302; thence easterly along that prolongation and for a distance of about 4.3 kilometres to the high water mark; then intersection of a line between the starboard and port navigation beacons on the boat harbour breakwaters; thence along that line to its intersection with the high water mark on the northern breakwater; thence generally north-westerly and westerly back to the start point at north head.

### Port Denison

The mooring control area includes Inner and Outer Harbours-

- (a) the Inner Harbour being all that portion of Port Denison within the boundary shown coloured blue on Department of Marine and Harbours Plan 718-01-01 and which is bounded by a line starting from the starboard beacon on the western breakwater at latitude 29°16′22.931″S and longitude 114°54′46.692″; thence on a true bearing on 135°29′48″ about 10 metres to a start point "Z" on high water mark; thence continuing along the same bearing towards the port beacon to the intersection with the high water mark on the northern breakwater; thence in a clockwise direction around the high water mark of the Port Denison boat harbour and breakwaters, back to the start point; and
- (b) the Outer Harbour being all that portion of the Indian Ocean shown coloured blue on Department of Marine and Harbours Plan 718-01-02 and which is all the water below the high water mark within a radius of 0.75 nautical mile of the rear harbour lead beacon (obelisk) at latitude 29°16′42.99″S and longitude 114°54′49.88″E.

PETROL ROSTER ORDER (No. 9) 1993

# Citation

1. This Order may be cited as the Petrol Roster Order (No. 9) 1993.

### Commencement

2. This Order shall come into operation on 3 January 1994.

### **Petrol Roster**

3. Shopkeepers of zoned filling stations specified in the Schedule shall be open during the days and times respectively specified in that Schedule for the sale of fuel and requisites.

# Fuel and Requisites to be sold

4. All forms of fuel and the following requisites, namely-

(a) oil;

(b) lubricants;

(c) tyres;

- "set net" means any net used or intended to be used to take fish other than prawns, crabs or marron, is placed below high water mark and has a float line at or beneath the surface of the water; and
- "sunset and sunrise" means the time provided by the Perth Observatory (Astronomical Services) for sunset and sunrise respectively, in Perth on the relevant day.

# [31 December 1993

# Attendance and cleaning of set nets

4. (1) Any person, other than the class of person specified in Schedules 1 and 2, when using a set net in any inland waters shall—

(a) remain in attendance of the net at all times; and

(b) remove all the net from the water and remove all fish from the net at least once every hour,

during the time that the net is set.

(2) Any person, other than the class of person specified in Schedule 2, when using a set net in any ocean waters, shall remain in attendance of the net at all times during the time that the net is set.

(a) set gill nets may be used from one and a half hours before sunset on any day to one and a half hours after sunrise on the following day during the period commencing one and a half hours before sunset on 1 September in any year and ending one and a half hours after sunrise on 31 May in the following year; and

(2) The holder of an appropriate licence, or any other authorized person, may supply a Fourth Schedule drug on receipt of a written order, signed by the master of the ship and by the manager, or a person authorized in writing by the manager, of the ship's agents in the State, certifying that the drug is necessary to complete the equipment of the ship in order to comply with the applicable requirements of subregulation 1.

(3) The person in charge of an aircraft is authorized to be in possession of a Fourth Schedule drug, in a quantity that does not exceed the maximum permitted quantity, as specified by the Department of Transport of the Commonwealth, for the purposes of medical treatment on the aircraft.

(4) The holder of an appropriate licence, or any other authorized person, may supply a Fourth Schedule drug on receipt .... of a written order, signed by the manager, or a person authorized in writing by the manager, of the airline company or firm responsible for the operation of the aircraft in the State, certifying that the drug is necessary for the purposes of medical treatment on aircraft.

(4) The holder of an appropriate licence, or any other authorized person, may supply a drug of addiction on receipt of a written order, signed by the manager, or a person authorized in writing by the manager, of the airline company or firm responsible for the operation of the aircraft in the State, certifying that the drug of addiction is necessary for the purposes of medical treatment on aircraft.

(5) Any person who supplies a drug of addiction under this regulation shall, within 24 hours of so doing, report the details to the Chief Executive Officer or the officer in charge of the nearest police station.

#### OFFICE OF TRADITIONAL USAGE

#### **OF301**

#### LAND (TITLES AND TRADITIONAL USAGE) ACT 1993

#### LAND (TITLES AND TRADITIONAL USAGE) REGULATIONS 1993

Made by His Excellency the Governor in Executive Council.

#### Citation

1. These regulations may be cited as the Land (Titles and Traditional Usage) Regulations 1993.

#### Definitions

- 2. In these regulations
  - "Commissioner" means the Commissioner for Aboriginal Planning referred to in section 10 of the Aboriginal Affairs Planning Authority Act 1972;
  - "declaration" means a declaration under section 10, 11, 12 (2) or 34 (1) of the Act;
  - "general newspaper" means a newspaper circulating generally in Western Australia.

# How the Minister gives notice under section 26

**3.** (1) This regulation applies when the Minister proposes to issue a notice under section 26 of the Act ("the notice") extinguishing or suspending rights of traditional usage ("the affected rights").

(2) If the affected rights are the subject of a declaration the Minister is to give the notice, in writing, to the Aboriginal group whose members are identified in the declaration as being entitled to exercise the affected rights.

- (3) If the affected rights are not the subject of a declaration
  - (a) the Minister is to give the notice, in writing, to any Aboriginal group whose members may, in the opinion of the Commissioner, be entitled to exercise the affected rights; or
  - (b) if the Commissioner is unable to identify such an Aboriginal group, the Minister is to publish the notice in the *Gazette*.

(4) The Minister is to cause a copy of the notice to be published, for public information —

- (a) in the *Gazette* and in a general newspaper, if the notice was given under subregulation (2) or (3) (a); or
- (b) in a general newspaper, if the notice was published under subregulation (3) (b).
- (5) The notice has effect from
  - (a) the day on which it is given under subregulation (2) or (3) (a) or published under subregulation (3) (b); or
  - (b) such later day as is specified in the notice.

(6) Section 43 (1) of the Act applies if the notice is given under subregulation (2) or (3) (a).

#### Details that have to be set out in compensation claims

4. (1) A compensation claim under section 28 of the Act has to contain the information required by section 31 (2) of the Act and has to include particulars of —

- (a) the nature of the rights claimed to have existed under native title in relation to the land about which the claim is made; and
- (b) the historical and continuing use, occupation and connection of the claimants' group with the land about which the claim is made; and
- (c) the other Aboriginal groups (if any) that were entitled, or that may have been entitled, to exercise similar or other rights under native title in relation to the land about which the claim is made, or any part of it; and
- (d) the times or periods at or during which the rights referred to in paragraph (a) were exercised; and
- (e) the way in which the entitlement to exercise the rights referred to in paragraph (a) is said to have been lost or interfered with; and
- (f) any other form of compensation that the Crown or any other person has already provided, or arranged to provide, for the extinguishment or impairment of the rights referred to in paragraph (a); and
- (g) any other matters or information that the claimants believe to be relevant to the claim.

(2) A compensation claim under section 29 of the Act has to contain the information required by section 31 (2) of the Act and has to include particulars of -

- (a) the nature of the rights of traditional usage claimed to have existed in relation to the land about which the claim is made; and
- (b) the historical and continuing use, occupation and connection of the claimants' group with the land about which the claim is made; and
- (c) the other Aboriginal groups (if any) that were or are entitled, or that may have been or may be entitled, to exercise similar or other rights of traditional usage in relation to the land about which the claim is made, or any part of it; and
- (d) the times or periods at or during which the rights referred to in paragraph (a) were or are able to be exercised; and
- (e) the way in which the entitlement to exercise the rights referred to in paragraph (a) is said to have been lost or interfered with; and
- (f) any other form of compensation that the Crown or any other person has already provided, or arranged to provide, for the extinguishment, suspension or impairment of the rights referred to in paragraph (a); and
- (g) any other matters or information that the claimants believe to be relevant to the claim.

(3) A compensation claim has to state an address at which, or method by which, documents and information about the claim can be given to the people who are to represent the claimants in accordance with section 43 (3) of the Act.

#### Minister has to give notice of, and advertise, compensation claims

5. (1) As soon as reasonably practicable after the Minister receives a compensation claim the Minister is to cause -

(a) a copy of the claim to be recorded in the register of declarations and claims; and

- (b) notice in writing of the claim to be given to each Aboriginal group (if any) referred to in regulation 4 (1) (c) or (2) (c); and
- (c) notice of the claim to be published in a general newspaper.

(2) The Minister may also publish notice of the claim in any other newspaper circulating in the region where the land about which the claim is made is situated.

(3) A notice given or published under this regulation has to include a statement to the effect that submissions or objections may be given to the Minister within 42 days after the date of the giving or publication of the notice.

(4) If the Minister considers that notice in writing of the compensation claim should be given to any person or class of persons (in addition to notices under subregulations (1) and (2)), the Minister is to cause notice to be given accordingly.

# How submissions and objections are made about compensation claims

**6.** (1) If a compensation claim has been submitted to the Minister, an interested person may make a submission or objection in relation to the claim.

(2) A submission or objection has to be in writing and may be given to the Minister within 42 days after the latest day on which a copy of the notice of the compensation claim was given or published under regulation 5 but the Minister may, if he or she thinks fit, accept an objection or submission after the expiration of that period.

- (3) A submission has to include
  - (a) the name of the person making the submission; and
  - (b) the matters relating to the compensation claim, or to the extinguished or impaired native title or extinguished, suspended or impaired rights of traditional usage, that the person wishes to be considered in the settling or determination of the claim.
- (4) An objection has to include
  - (a) the name of the objector; and
  - (b) particulars of the grounds on which the objector objects to the claim and the matters the objector wishes to be considered in opposition to the claim; and
  - (c) an address at which, or method by which, documents or information about the claim can be given to the objector.

(5) The Minister is to cause copies of a submission or objection under this section to be -

- (a) recorded in the register of declarations and claims; and
- (b) given to the claimant,

as soon as practicable after the submission or objection is given to the Minister.

# Notice to objector of agreement under section 33

7. (1) The notice required to be given by the Minister to an objector under section 33 (3) of the Act is to be given to the objector in writing within 14 days after the agreement is entered into.

- (2) The notice is to include
  - (a) a copy of the agreement; and
  - (b) the names and addresses of the parties to the agreement.

(3) Within 28 days after receiving a notice under section 33 (3) of the Act an objector may object to the agreement by a notice of objection, in writing, to the Minister.

- (4) An objection under subregulation (3) has to include
  - (a) the name of the objector; and
  - (b) particulars of the grounds on which the objector objects to the agreement and the matters the objector wishes to be considered in opposition to the agreement.



(b) the owner or person having the control of a motor boat must not knowingly permit or suffer the motor boat to be driven or operated by a person under the age of 17 years otherwise than in accordance with this regulation.

(2) A person who is under the age of 17 years but not under the age of 14 years, who holds a current and valid *Certificate of Proficiency in the Operation of Pleasure Vessels*, issued under regulation 27A of the W.A. Marine (Certificates of Competency and Safety Manning) Regulations 1983, may drive or operate a motor boat.

(3) A person who is not under the age of 10 years may drive or operate a motor boat with a motor not exceeding 4.5 kilowatts brakepower.

#### IN THE MATTER OF THE MEDICAL ACT 1894 and amendments

and

IN THE MATTER OF DR. PHILIP RICHARD COURTENAY RANDALL

Medical Practitioner of Unit 1, 52 Highclere Blvde, Marangaroo, Western Australia The Medical Board of Western Australia held an Inquiry on the 15th December 1993 with reference to an allegation that Dr. Philip Richard Courtenay Randall had been guilty of infamous or improper

conduct in a professional respect contrary to section 13 (1) (a) of the Medical Act 1894 as amended. The charges arose as a result of Dr. Randall having-(a) in the period April 1991 to October 1991 prescribed pethidine for his wife, notwithstanding

that to his knowledge she was addicted to pethidine;

- (b) in the period October 1991 to March 1992, whilst his wife was registered as a drug addict with the Health Department, he accompanied her to different medical practitioners for the purposes of obtaining a prescription of pethidine for her use, when he was aware that a medical practitioner was prohibited from prescribing pethidine to a drug addict without the prior written consent of the permanent head of the Health Department; and
- (c) in the period April 1992 until September 1993 he wrote prescriptions for pethidine in the name of patients other than his wife which prescriptions for pethidine were intended for and used by her.


Dr. Randall pleaded guilty to the charge, and the orders made by the board were-

- (1) that the complaint against Dr. Philip Richard Courtenay Randall of improper conduct in a professional respect had been established;
- (2) that Dr. Philip Richard Courtenay Randall be reprimanded;
- (3) that the following conditions be imposed on the practice of Dr. Philip Richard Courtenay Randall—
  - (a) that his rights to prescribe or administer narcotic analgesics be removed;
  - (b) that he attended a psychiatrist of the board's approval and undergo any therapy recommended and that regular, at least quarterly, reports on his progress be made to the board; and
  - (c) that he no longer treats his wife as a patient for any medical condition;
- (4) that Dr. Philip Richard Courtenay Randall pay the costs of the inquiry as determined.




The State Supply Commission, in association with Edith Cowan University and its co-learn program, has produced a one hour video which provides a basic understanding of the principles of quality assurance.






