City of Subiaco

By-law No. 5—Relating to Eating Houses

In pursuance of the powers conferred upon it by the abovementioned Act and all other powers enabling it, the Council of the abovementioned Municipality hereby records having resolved on the 22nd March 1994, to make and submit for confirmation by the Governor, the following by-law—

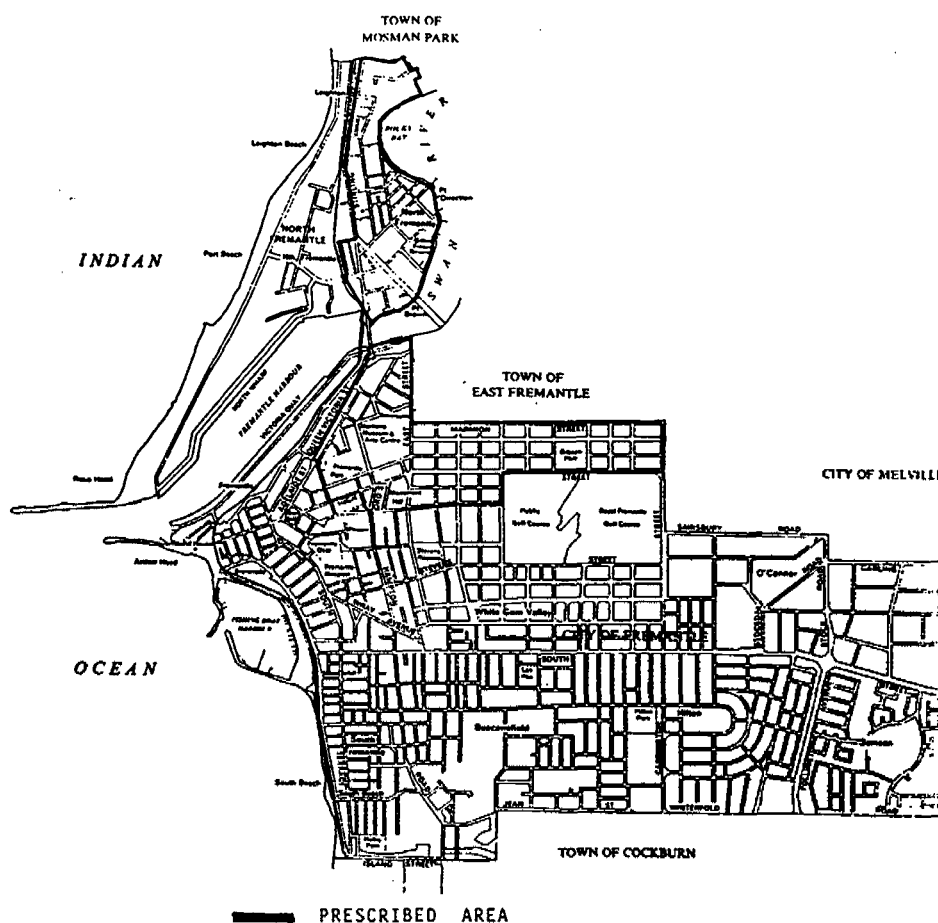

HEALTH ACT 1911*Shire of Trayning*

Pursuant to the provisions of the Health Act 1911, the Shire of Trayning being a local authority within the meaning of the Health Act, having adopted the Model By-laws described as Series "A" made under the Health Act 1911, and as reprinted pursuant to the Reprinting Act 1954 in the *Government Gazette* on 17th July, 1963, and as amended from time to time, has resolved and determined that the adopted By-laws shall be amended as follows:

The following By-laws are revoked.

Part I By-law 26

Part I By-law 28

After By-law 25 insert new By-laws 26, 27 and 28 as follows:

26. The occupier of any premises whereon a horse is kept shall provide a stable or shelter which shall comply with the following conditions:

- (a) It shall not be less distance than 15 metres from any dwelling house or any premises on which food is kept, prepared, manufactured, cooked, stored or sold.
- (b) A stable shall have walls to a number and height and thickness approved and such walls be constructed of concrete, bricks, stone, wood, galvanised iron or other materials approved of by Council.
- (c) A stable shall have a roof constructed of impervious material.
- (d) There shall be, on all sides of the stable between the walls, and the roof, a clear space of at least 150mm in height.
- (e) A stable shall have a minimum floor area of 11 square metres and walls with a minimum height of 3 metres.
- (f) If a shelter is provided, in a yard, for the protection of horses from inclement weather it shall:
 - (1) Have an area of not less than 9 square metres,
 - (2) Have height of not less than 2.4 metres,
 - (3) Not be capable of being closed,
 - (4) Have at least one side completely open to the outside air.
- (g) The upper surface of the stable floor shall be raised at least 75mm above the surface of the surrounding ground, and shall be constructed of granolithic cement, concrete or some other impervious material approved by the Council. The floor shall have a minimum fall of 1:100 to the front of the structure.
- (h) There shall be provided, outside each such stable or shelter a receptacle for manure. Such receptacle shall be constructed of approved, impermeable materials and capable of being sealed; it shall be provided with a tightly-fitting cover, and shall be emptied at least once weekly.
- (i) All manure produced on the premises shall be collected daily and placed in the receptacle for manure.
- (j) The stable shall be in a clean condition, and shall be cleaned and disinfected when so ordered by an Environmental Health Officer.
- (k) Every stable shall have approved impervious, rodent-proof receptacles suitable for the storage of chaff, bran, pollard, grain or seed and the like.
- (l) The land on which horses are kept shall be enclosed by a fence with a minimum height of 1100mm. Such fence shall consist of at least 4 strands of plain wire suitably strained or similar approved type of fence.

27. No stable shall be erected unless and until plans, specifications, and site of the proposed stables have been approved by Council.

28. (a) The Occupier of any premises shall not keep or allow to be kept thereon any horse, cattle, camel, donkey, or more than three (3) sheep or more than three (3) goats on a block having an area less than 2,000 square metres of alienated land.

- (b) The Occupier of a block of land 2,000 square metres or larger wanting to keep more than the above number of animals can do so only by obtaining the written approval of Council. The approval will stipulate the maximum number of animals that may be kept. The number of animals will be calculated using the following rate:—

Four (4) horses and two (2) foals up to the age of twelve months or twelve (12) sheep or twelve (12) goats per 2,000 square metres or part thereof.

- (c) A person shall not allow any horse, cattle, camel, donkey, sheep or goat within 15 metres of any dwelling or 18 metres from any place where food is stored, manufactured, processed, served or exposed for sale.
- (d) The requirements of this by-law apply within the boundaries of townsites within the Shire of Trayning.

1. In this By-law the “By-laws Relating to Signs” of the Town of Claremont, published in the *Government Gazette* on 7 October 1983 and subsequently amended, is referred to as “the Principal By-law”.
2. Clause 2 of the principal By-law is amended—
 - (a) by inserting before the definition of “Council”—

“ “community function” means a charitable, cultural, educational, recreational or other public or community function, exhibition, meeting event or activity not conducted for the purpose of commercial gain; ”;
 - (b) by inserting after the definition of “illuminated sign”—

“ “portable sign” means a sign not permanently attached to the ground or to a structure, wall, fence or building and includes a sandwich board sign consisting of two sign boards attached to each other at the top by hinges or other means; ”; and
 - (c) by inserting after the definition of “surveyor”—

“ “temporary community sign” means a portable sign relating to a community function; ”.

3. Clause 4 (1) of the principal By-law is amended by inserting in the first line after "Clause"—

" and Clause 20B ".

4. The principal By-law is amended by inserting after Clause 20 the following—

" Portable Sign

20A (1) A portable sign shall—

- (a) not exceed 1m in height;
- (b) not exceed 0.8m in area;
- (c) not advertise any matter other than the name of the owner or occupier of the premises to which it relates and the nature of the business carried on at those premises;
- (d) be placed so not to be hazardous to, or impede vehicular traffic or pedestrians;
- (e) be of sound construction and maintained in good condition.
- (f) be so constructed and be of sufficient mass or, suitably anchored so as to be stable at wind speeds of 80 kph.
- (g) not be placed in a street during any period when wind speed exceeds 80 kph.
- (h) be placed within 3 metres of the building to which it relates.

(2) A person shall not erect more than one portable sign in relation to the one shop, business unit or premises.

(3) A person who erects a portable sign shall remove that sign, or cause that sign to be removed, at the close of business each day.

Temporary Community Sign

20B (1) The Council upon receiving a written application may authorise in writing the erection and placement in or on a street, way or public place of a temporary community sign under the terms and conditions stipulated in the written authorisation.

(2) A sign authorised under subclause (1) shall—

- (a) be subject to all the provisions of this By-law other than Clause 4;
- (b) be placed so as not to cause interference or be hazardous to, or impede, vehicular traffic or pedestrians; and
- (c) not be fixed to a street tree.

(3) The Council may at any time revoke the authorisation granted under subclause (1).

(4) Upon the expiration or revocation of an authorisation issued under subclause (1), the person to whom it was issued shall remove the sign to which it relates.

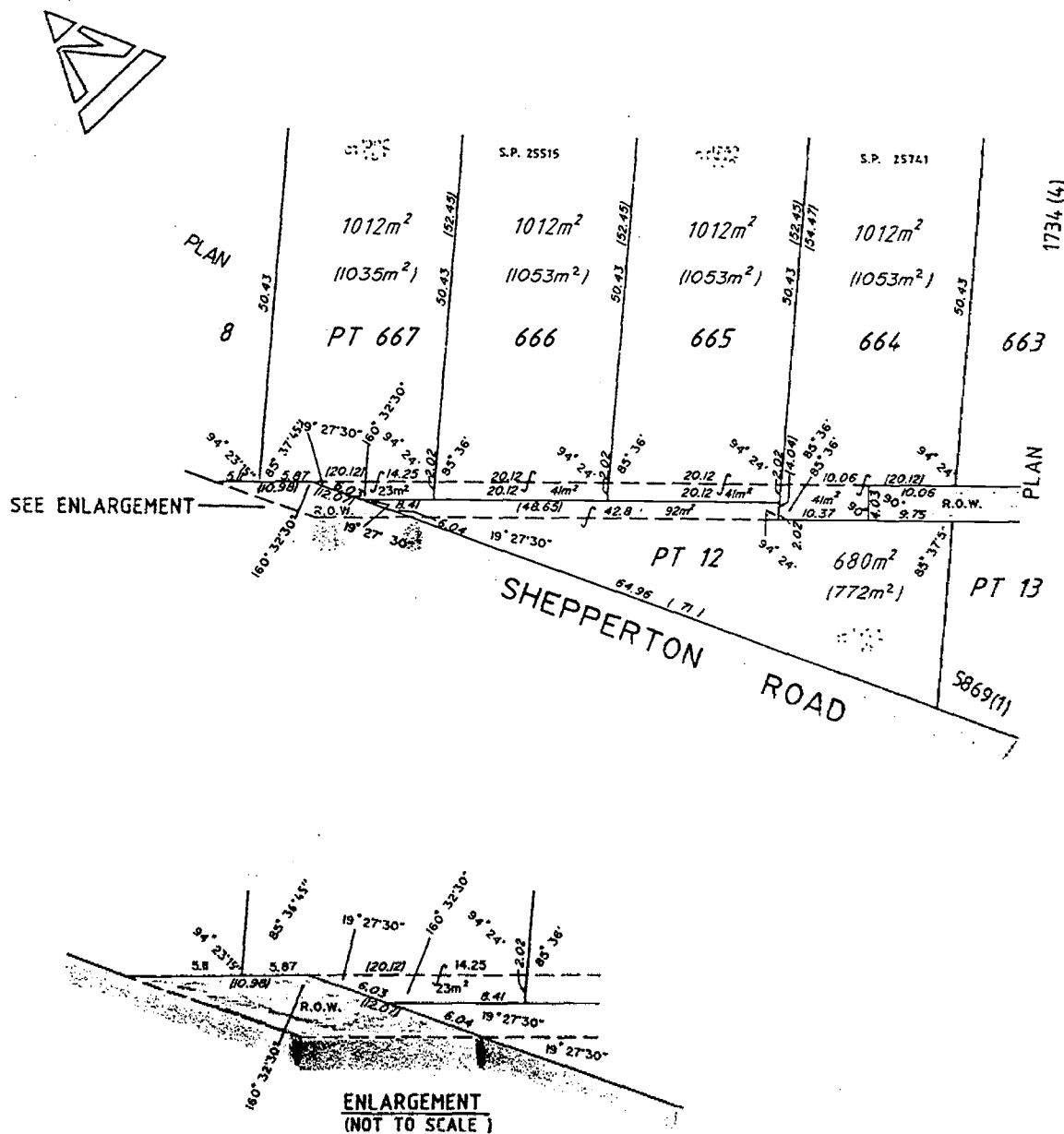

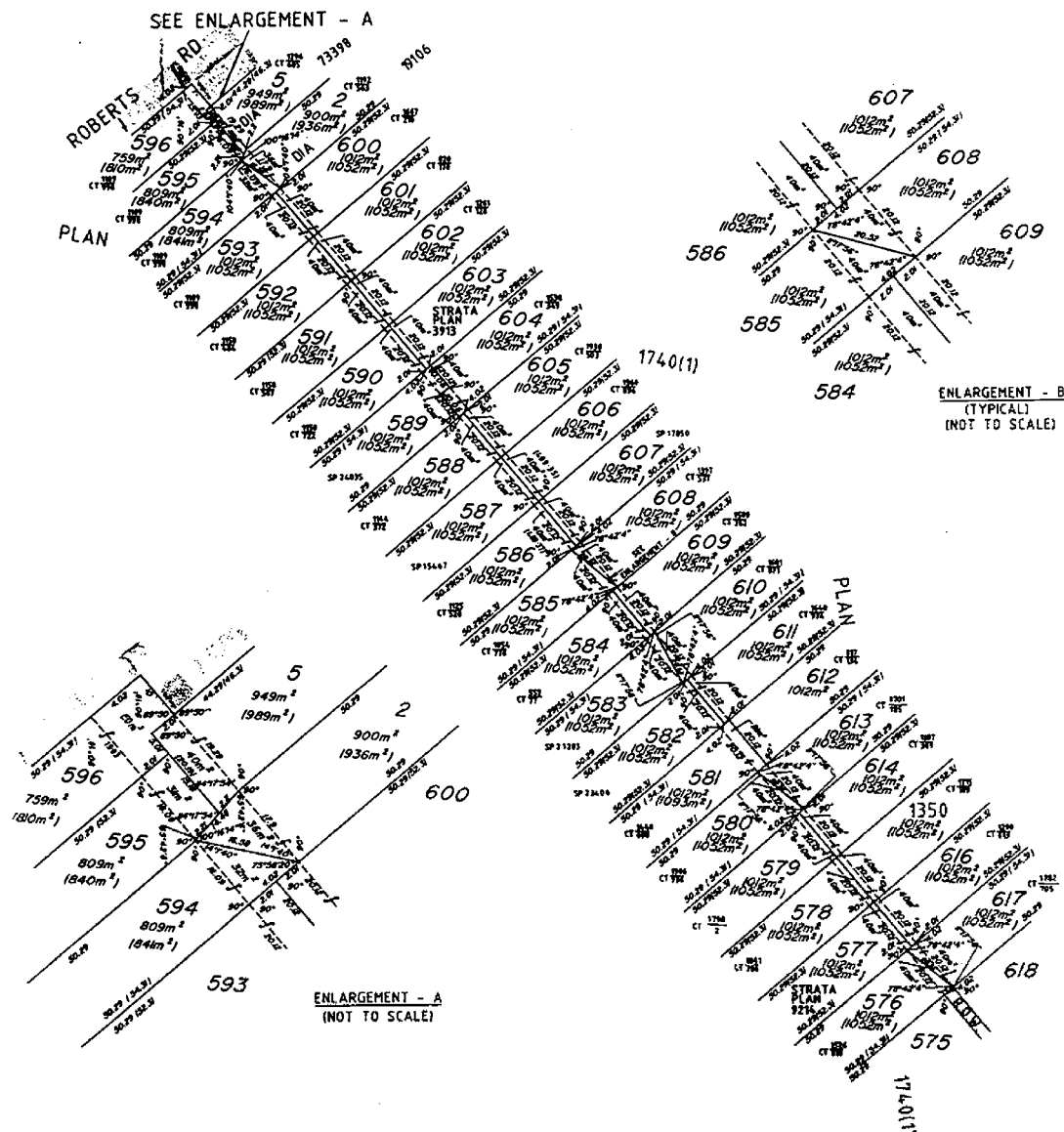

ELECTRICITY ACT 1945

ELECTRICITY (LICENSING) AMENDMENT REGULATIONS 1994

Made by the Lieutenant-Governor and deputy of the Governor in Executive Council on the recommendation of the State Energy Commission of Western Australia.

Citation

1. These regulations may be cited as the *Electricity (Licensing) Amendment Regulations 1994*.

Principal regulations


