RETAIL TRADING HOURS EXEMPTION ORDER (No. 9) 1994

Shire of Meekatharra

Shire of Meekatharra Health By-laws 1994

Under the powers conferred upon it by the Health Act 1911, the Council of the Shire of Meekatharra resolved on 21 May 1994 to make and submit for confirmation by the Executive Director of Public Health and approval by His Excellency the Governor, the following by-law.

Citation

1. This by-law may be cited as the Shire of Meekatharra Health By-laws 1994.

Incorporation by Reference

2. (1) In this clause, the "City of Perth Health By-law 1993";

- (a) means the City of Perth Health By-law 1993 published in the Government Gazette on 15 October 1993; and
- (b) does not include any amendments that might be made to that by-law.

(2) Subject to the modifications set out in the Schedule, the City of Perth Health By-law 1993 is incorporated with and forms part of this by-law.

Repeal

The Model Health By-laws—Series "A"—adopted by the Shire of Meekatharra and published in the *Government Gazette* on 30 June 1989 with amendments on 30 June 1989 and 24 January 1992 is repealed.

Schedule

Modification to the City of Perth Health By-law 1993

1. Amend the title on the cover page by deleting "City of Perth Health By-law 1993" and replacing it with "Shire of Meekatharra Health By-laws 1994".

2. Delete "City of Perth" wherever it is mentioned in the by-law and insert in its place "Shire of Meekatharra".

3. Delete "Controller of Health Services" wherever it occurs in the by-laws and insert in its place "Principal Environmental Health Officer".

4. Delete "Town Clerk" wherever it occurs in the by-laws and insert in its place "Shire Clerk".

After By-law 45 (3) (g) insert as follows-

"45 (4) A receptacle that is lost, stolen, damaged or becomes defective, shall be replaced at the owners/occupiers cost."

7. By-law 72 "Interpretation"

Delete the rest of By-law 72 after the sub-heading "the Prohibited Area" and insert in its place "means the portions of the town site zoned Commercial and Industrial under the current Shire of Meekatharra Town Planning Scheme."

8. Delete all of "Part 8—Food Premises" and insert in its place "Part 8—Sale of Food by Itinerant Vendors".

- "129 (1) A person shall not engage in trade as an itinerant vendor of food unless he/she is the holder of a licence from the local authority so to do.
 - (2) Every person desiring to engage in trade as an itinerant vendor of food, shall before so engaging, or if already so engaged then during the first week of January of each year, apply to the local authority in the form of Schedule "6" for a licence to carry on such trade, and shall with this application deposit a fee of \$100."

9. By-law 181 (d)--insert after "newspaper" in line one "and a local newspaper".

10. By-law 242.

Delete the passage in the first and second line "other than a provision of Part 8,".

11. Delete By-law 243 and its heading "Penalties for Part 8".

12. Delete Schedules "1", "2", "3", "4" and "5" and reference to them in the "arrangement".

RADIATION SAFETY ACT 1975

RADIATION SAFETY (GENERAL) AMENDMENT REGULATIONS (NO. 4) 1994

Made by His Excellency the Governor in Executive Council.

Citation

1. These regulations may be cited as the Radiation Safety (General) Amendment Regulations (No. 4) 1994.

Principal regulations

2. In these regulations the Radiation Safety (General) Regulations 1983* are referred to as the principal regulations.

[* Published in Gazette of 21 February 1983 at pp. 555-636. For amendments to 14 September 1994 see 1993 Index to Legislation of Western Australia, Table 4, pp. 219-20, and Gazette of 28 January, 4 February, 4 and 11 March and 27 May 1994.]

Regulation 7B amended

3. Regulation 7B (3) of the principal regulations is amended by deleting paragraph (b) and substituting the following -

- (b) complies with the requirements of
 - (i) the publication entitled "Smoke alarms", being AS 3786-1993 issued by the Standards Association of Australia; or
 - (ii) the publication entitled "Automatic fire detection and alarm systems Part 2: Point type smoke detectors", being AS 1603.2-1990 issued by the Standards Association of Australia;

and

Regulation 7C inserted

4. After regulation 7B of the principal regulations the following regulation is inserted —

Exemption for certain radioactive substances contained in electron capture detector

- 7C. (1) In this regulation
 - "ECD substance" means either of the radioactive substances Nickel 63 or Hydrogen 3;

"electron capture detector" means a device —

- (a) that contains an ECD substance in a sealed source; and
- (b) that is used in a laboratory or industrial application for the specific detection of electron absorbing compounds.

(2) An ECD substance contained in an electron capture detector that is part of equipment used for gas chromatography is exempt from the Act and these regulations, other than those provisions relating to the sale or disposal of radioactive substances.

(3) A person shall not sell or dispose of an electron capture detector unless the sale or disposal is to —

- (a) the supplier of the electron capture detector; or
- (b) the Radiation Health Section of the Health Department of Western Australia.

Regulation 31A inserted

5. After regulation 31 of the principal regulations the following regulation is inserted -

Near-surface disposal of radioactive waste

31A. (1) In this regulation —

"code of practice" means the publication entitled "Code of practice for the near-surface disposal of radioactive waste in Australia (1992)", approved at the 114th session of the NHMRC; "

"disposal facility", "disposal site" and "near-surface disposal" have the respective meanings given in the code of practice.

(2) Without limiting regulation 31 and subject to subregulation (3), a person shall not dispose of, or permit the disposal of, solid radioactive waste by near-surface disposal unless the disposal, the disposal facility and the disposal site comply with the requirements of the code of practice.

(3) Subsection (2) does not apply to a disposal of solid radioactive waste exempted by the Council from the requirements of the code of practice.

TOBACCO CONTROL (EXEMPTION) NOTICE (No. 3) 1994

- (b) any trademark or brand name of a tobacco product, or any tobacco advertisement, shall be accompanied, in accordance with paragraph (c), by the health warning—
 - (i) "SMOKING KILLS"; or
 - (ii) "SMOKING IS ADDICTIVE".

- (c) one of the signs referred to in paragraph (a) (i) shall display the health warning in paragraph (b) (i) and the other sign shall display the health warning in paragraph (b) (ii);
- (d) the area exclusively devoted to the display of each health warning referred to in paragraph (b) shall be not less than one third of the area devoted to the display of the tobacco advertisement in which the health warning appears; and
- (e) each health warning referred to in paragraph (b) shall—
 - (i) immediately precede the first word, number or symbol of the tobacco advertisement in which the health warning appears;
 - (ii) appear in white Helvetica Bold capitals on a black background; and
 - (iii) occupy not less than 80% of the area devoted to the display of that health warning.

CITY OF GOSNELLS

Scheme No. 20 Text

1. CITATION AND RESPONSIBLE AUTHORITY

This Town Planning Scheme may be cited as the City of Gosnells Town Planning Scheme 20 (hereinafter called "the Scheme") and shall come into operation on the publication of notice of the Minister for Planning's final approval in the *Government Gazette*. The authority responsible for enforcing the Scheme is the Council of the City of Gosnells (hereinafter referred to as "the Council").

2. SCHEME MAPS AND SCHEME AREA

The Land Use Map and Scheme Map form part of the Scheme. The Scheme shall apply to the land contained within the inner edge of the broken black line as shown on the Scheme Map. The said land is hereinafter referred to as "the Scheme Area".

3. GENERAL OBJECTS

The objects of the Scheme will be achieved by the control and co-ordination of development and subdivision within the Scheme Area. The Scheme Map forms the basis for subdivision and development and the framework within which this can take place.

The general objects of the Scheme are:

- (a) to plan and facilitate progressive redevelopment of the land within the Scheme Area;
- (b) to plan and provide within the Scheme Area suitable road modifications, truncations, accessways, dual use paths and footpaths;
- (c) to ensure the proper drainage of the roads and buildings and of those parts of the Scheme Area which require improvement to drainage and associated works;

- (d) to maintain and enhance the character and amenity of the area by the preservation and further planting of trees, street tree planting and upgrading public open space facilities;
- (e) to produce streetscape and architectural character studies that will be incorporated into planning and building approvals to ensure aesthetic enhancement of the area;
- (f) to encourage the amalgamation of lots to provide opportunities for better layout designs thereby providing an option to increase the Residential Density Code where amalgamation or superior design criteria is used.

4. DEVELOPMENT PROVISIONS

The Council shall prepare and may amend from time to time, a "RESIDENTIAL DEVELOPMENT GUIDE—GOSNELLS" which will include architectural development guidelines to be incorporated into new development proposals for the Scheme Area and the document will compliment, but does not form part of, the Scheme.

4.1 Residential development should comply with the principles contained within the "Residential Development Guide-Gosnells" and shall accommodate any applicable Scheme Works.

Council may, where it is of the opinion that special circumstances warrant, permit a departure from the principles of the "Residential Development Guide-Gosnells". This authority will be exercised if the Council is satisfied that:

- (a) approval of the development would be consistent with the orderly and proper planning of the locality and preservation of the amenity;
- (b) non-compliance will not have an adverse effect upon the intent of the overall planning of the area; and
- (c) the intent and purpose of the requirement or standard will not be unreasonably departed from.

4.2 (a) Notwithstanding the provisions of the City of Gosnells District Zoning Scheme Town Planning Scheme No 1, where a landowner amalgamates two or more existing lots to create a lot for residential unit development of five units or more, Council may approve such development up to the R.40 density code if, in the opinion of Council, the development proposal complies with the principles and requirements of the "Residential Development Guide-Gosnells".

(b) All developments shall incorporate a landscaping programme to Council's satisfaction and where required by Council shall include the planting of trees in the street verge for the frontage of the subject lot. The type, number and location of the trees is to be specified by Council.

(c) Where a proposed traffic control device, entry statement or other feature is located adjacent to a development site and it is required to be installed as part of that development by the Scheme the landowner may be required to fund the full cost of the installation of that work by the Council.

In this event the Scheme will reimburse the landowner as and when funds are available for any contribution made in excess of the amount that represents the Scheme Works contribution pursuant to Clause 6 of the Scheme plus interest, as calculated pursuant to Clause 6.1 "Calculation of Scheme Works Cost" of the Scheme.

5. DEVELOPMENT AND SCHEME WORKS

An owner of land within the Scheme Area who desires to develop land either alone or in conjunction with another owner or owners shall submit the required application form, details and plans to Council for planning approval as required by the City of Gosnells District Zoning Scheme. Where the application, details and plans conform with the requirements of the District Zoning Scheme the application will be processed in the normal manner subject to the payment of the contribution for Scheme Works under the Scheme.

Scheme Works are all works necessary for the development of the area that confer a general benefit on the area and are not related to a particular piece of land and include:

- (a) the installation of traffic management devices throughout the Scheme Area. The design and location of these devices will be resolved by Council from time to time after consultation with local residents;
- (b) drainage works, including new pipe works, improvement of the existing drainage system and the construction and landscaping of compensation basins within and/or near the Scheme Area that directly benefit the Scheme Area;
- (c) a landscape programme involving the planting of street trees, landscaping associated with traffic management devices and additional tree planting and landscaping of existing and planned local open space areas within the Scheme Area;
- (d) construction of footpaths, dual use paths and pedestrian accessways within the Scheme Area;
- (e) the upgrading of existing roads and rights of way within the Scheme Area;
- (f) the administration costs incurred by the Council involving the preparation and ongoing supervision and management of the Scheme.

6. SCHEME WORKS COSTS

6.1 Calculation of Scheme Works Costs

The costs of Scheme Works as described in Clause 5 to be paid by each owner of land within the Scheme Area shall be calculated at the time of issue of the building licence for any new residence and shall be calculated at the time of total payment or revised at the time of pro-rata payments and shall be the lesser of:

- (a) the actual costs of the works compounded annually at 10% as an inflationary factor;
- (b) the estimated costs of the works at the time of full or part payment determined by an independent expert and in default of agreement, by arbitration.

An existing residence or additions thereto contained within a development will not be included for the purpose of calculation of Scheme Costs.

Payment of Scheme Works Costs

Subject to the provisions of the Scheme each owner of land shall prior to the issue of the building licence for any new residence pay to the Council an amount equivalent to 0.1% of the total Scheme Works Costs for each new residential unit approved by that building licence.

Where a lot is developed for a use other than residential units, e.g. offices, the owner shall pay to Council a sum equivalent to the number of units (or part thereof) that would be permitted under the R.30 Code in lieu of the approved development for that property.

6.2 If an owner of land disagrees with Council's determination of the proportion of Scheme Works Costs that is required to be paid by that owner, the matter may be determined by arbitration in the manner specified in Clause 11 provided that the owner notifies the Council of the intention to take the matter to arbitration within 30 days of receiving notice of his costs.

7. SCHEME ACCOUNT

The Council shall establish a Scheme Account for the purpose of receiving contributions towards Scheme Works Costs as required to be paid to the Scheme by landowners within the Scheme Area. These funds are a contribution towards the various services and improvements as described under Clause 5, Development and Scheme Works of this Scheme. The Scheme Account shall not form part of the Council's general revenue and any surplus funds after completion of the Scheme shall be spent on upgrading of facilities within or near the Scheme Area.

8. POWERS OF COUNCIL

In carrying out the provisions of the Scheme the Council shall have the following powers and authorities subject to the arbitration provisions of Clause 11:

- (a) to enter and inspect at any reasonable time, land and buildings within the Scheme Area and to carry out works either by itself, its agents, employees or nominees that are pertinent to the Scheme;
- (b) to make agreements with the owners or occupiers of the land within the Scheme Area in respect of any matters affecting the Scheme;
- (c) to make agreements with the Water Authority of Western Australia, or any other Government instrumentality, concerning any matters relating to the Scheme;
- (d) to enter into agreements with purchasers or prospective purchasers or prospective occupiers of land within the Scheme Area concerning matters relating to the Scheme;
- (e) to purchase, develop and/or sell land within the Scheme Area.

9. ADMINISTRATION

9.1 Twenty-eight (28) days written notice is hereby prescribed as the notice to be given pursuant to Section 10 of the Town Planning and Development Act, 1928 (as amended). Any expenses incurred by the Council under the said section may be recovered from the person in default as a simple contract debt in such Court of jurisdiction as is competent to deal with the amount of the claim.

9.2 The Council may at any time exercise the powers conferred by Section 13 of the said Act.

9.3 In this Scheme, the word "lot" has the meaning given to it by the Town Planning and Development Act, 1928 (as amended) and includes a lot on a Strata Plan.

10. CLAIMS FOR COMPENSATION

Claims for compensation by reason of the coming into operation of the Scheme shall be made within six months of the date of the Scheme's final gazettal.

11. ARBITRATION

Any dispute or difference between the owners or an owner or owners and Council (except where there is a right of appeal to the Minister for Planning) as to their respective rights under the Scheme and any matter which by the terms of this Scheme may be determined by arbitration may be referred to the arbitration of a single arbitrator in the manner provided by the Commercial Arbitration Act 1985, or any statutory modification thereof for the time being in force and if the parties fail to agree upon any one single arbitrator he will be nominated by the President of the Australian Institute of Valuers (Inc) WA Division. The Arbitrator shall allocate costs in the dispute.

12. LAND OWNED OR ACQUIRED BY COUNCIL

All or any of the land now owned by or subsequently acquired by the Council within or near the Scheme Area may be used by the Council for any purposes appropriate to the Scheme. If such purpose is one for which any owner is required to make land available, or for which land may be acquired by the Council pursuant to this Scheme, the Council shall be compensated for the value of the land so used by the Council. If the Council shall subdivide or develop any land owned by it, the provisions of this Scheme shall apply to the Council.

GOVERNMENT GAZETTE, WA

13. REVOCATION

Without limiting the generality of the obligations under Section 7AA of the Act, the Council within 10 years of the coming into operation of the Scheme shall consider whether the Scheme can be revoked or whether any works could be carried out or other things done to permit the Scheme to be revoked.




