### PLANT DISEASES AMENDMENT REGULATIONS 1995

Made by His Excellency the Governor in Executive Council.

#### Citation

1. These regulations may be cited as the *Plant Diseases Amendment Regulations 1995*.

#### Schedule 1 amended

2. Schedule 1 to the *Plant Diseases Regulations 1989\** is amended —

(a) in Part A by inserting an item after the item commencing "Lucerne" in the following manner —

(i) in column 1 by inserting the following —

" Lupin . . . . . ";

- (ii) in column 2 by inserting the following —  
     “ 51 ”; and
- (iii) in column 4 by inserting the following —  
     “ 51 ”;  
 and
- (b) in Part B by inserting in the appropriate numerical order the following item —  
     “  
         51. Lupin plant and seed — Lupin Anthracnose and Fusarium Wilt  
     To be —  
         (1) certified by an officer of the Department of Agriculture (or its equivalent) from the exporting State, Territory or Country as being grown in a State, Territory or Country which is free from lupin attacking strains of —  
             (a) the fungus Anthracnose (*Colletotrichum gloeosporioides*); and  
             (b) *Fusarium Wilt (Fusarium oxysporum f. lupini)*;  
         or  
         (2) approved by the Director-General, Department of Agriculture, Western Australia, to be grown in post-entry quarantine, screened for disease, and found to be free from lupin attacking strains of the fungus Anthracnose (*Colletotrichum gloeosporioides*) and *Fusarium Wilt (Fusarium oxysporum f. lupini)* prior to the release of progeny.  
     ”

## VETERINARY PREPARATIONS AND ANIMAL FEEDING STUFFS AMENDMENT REGULATIONS 1995

Made by His Excellency the Governor in Executive Council.

### Citation

1. These regulations may be cited as the *Veterinary Preparations and Animal Feeding Stuffs Amendment Regulations 1995*.

### Principal regulations

2. In these regulations the *Veterinary Preparations and Animal Feeding Stuffs Regulations\** are referred to as the principal regulations.

**Commencement**

3. These regulations come into operation on the day Division 1 of Part 11 of the *Agricultural and Veterinary Chemicals (Western Australia) Act 1995* comes into operation.

**Regulation 2 amended**

- (c) for the renewal of registration of an animal feeding stuff for a 3 year period is \$25.00.

".

(1) An application for the issue of a temporary permit under section 30 (4) of the Act in respect of an animal feeding stuff shall be in the form of Form 2 and shall be lodged with the Registrar.

(a) on the face that is partly covered by the flap when the package is closed; and

(b) not in the area that is covered by the flap when the package is closed.

(5) If the flap of a pouch described in item 4 of Schedule 2 is, in area, at least 33⅓% of the area of the face on which the warning message is to be printed, the explanatory message is to be printed on the outside of the flap.

(6) For a package of a kind described in item 8 of Schedule 2, the 2 warning messages are to be printed on the package as far apart as possible.

(7) For a package of a kind described in item 9 of Schedule 2 —

(a) the warning message is to be printed on the face of the package specified in the item; and

(b) the explanatory message is to be printed as far as possible from the warning message on the package.

**"brand"**, in relation to a poison, means a name given to the poison by a manufacturer of it and listed in the Australian Register of Therapeutic Goods, other than its approved name.

(2) If a prescription issued by a medical practitioner or a dentist prescribes a poison and describes the poison by its approved name, a person dispensing the prescription may dispense or supply any brand of the poison.

(3) Except as provided by this regulation, if a prescription issued by a medical practitioner or a dentist prescribes a poison and describes the poison by reference to a brand of it, a person dispensing the prescription must not dispense or supply the poison other than in accordance with the description in the prescription.

(4) If a prescription issued by a medical practitioner or a dentist prescribes a poison and describes the poison by reference to a brand of it, a person dispensing the prescription may dispense or supply any brand of the poison, unless the prescription shows a contrary intention.

(5) If a prescription issued by a medical practitioner in respect of a patient in a public hospital (as defined in the *Hospitals Act 1927*) prescribes a poison and describes the poison by reference to a brand of it, a person dispensing the prescription may dispense or supply any brand of the poison, whether or not the prescription indicates a contrary intention.

(6) For the purposes of this regulation, a contrary intention is shown on a prescription if it bears the words "No substitution" or words with a similar effect.

“Meru Refuse and Recycling Facility” means that portion of Victoria Location 2268 and part Victoria Location 2227 and “Flores Road Landfill Site” means that portion of Reserve 24569; both under the control of Geraldton Greenough Regional Council.

“Regional Council” means the Geraldton Greenough Regional Council.

“Secretary/Manager” means the duly appointed Chief Executive Officer of the Regional Council or the person acting from time to time in that capacity.

“Site Controller” means an authorised officer of the Regional Council charged with the conduct of operations at the Meru Refuse and Recycling Facility and Flores Road Landfill Site and includes any person acting in that position; and

3. All persons using or entering upon the Facility shall be subject to the provisions of these By-laws.

4. The drivers of all vehicles entering the Facility shall observe the speed limits as depicted on standard signs erected in proximity to the access roadways.

5. All persons using or entering the Facility shall act in accordance with any lawful instruction given by the Site Controller or authorised staff member.

6. In the event of a person contravening any of these By-laws or failing to obey the instructions of the Site Controller or an authorised staff member, then, and in addition to any penalty imposed by these By-laws, the Site Controller or authorised staff member may request the person to leave the Facility and failure to do so shall constitute a contravention of these By-laws.

7. No person shall place or dispose of waste at the Facility other than at a place designated by notice or by an instruction of the Site Controller or an authorised staff member.

8. No person shall remove or carry away from the Facility any waste unless authorised to do so by the Site Controller.

9. No person shall damage, deface or otherwise cause a loss of value in any building, sign, plant and equipment of the Regional Council situated on the Facility.

10. No person shall light any fire within the precincts of the Facility unless so authorised by the Site Controller.

11. No person shall dig up, remove or otherwise damage native flora and growth contained at the Facility unless so authorised by the Site Controller.

12. No person shall trap, chase, worry or otherwise injure or maim any native fauna at the Facility unless so authorised by the Site Controller.

13. The Regional Council may from time to time set and amend by resolution the hours of operation of the Facility and such hours will be displayed for public information.

14. The Council may from time to time set and amend by resolution a scale of fees and charges payable for admission to dispose of or dump waste at the Facility and such scale may specify classes and differing classes of waste to which differing fees and charges shall apply.

15. No person shall enter the Facility to dispose of or dump waste without paying the appropriate admission fee or charge except in those circumstances where so authorised by the Regional Council, the Secretary/Manager or the Site Controller.

16. Except where authorised under by-law 15, it shall be an offence for any person to enter upon the Facility and dump any waste without paying the appropriate charge.
17. No person shall dispose of or dump at the Facility any liquid, toxic or hazardous waste declared by the Health Department of Western Australia to be of a class which requires to be disposed of and treated at other declared facilities suitable for that class of waste.
18. If any person contravenes by-law 17 hereof then in addition to the imposition of any penalty that person shall also be liable to the Regional Council for the cost of removing such liquid, toxic or hazardous waste and of making good any damage thereby caused.
19. Any person who contravenes or fails to comply with any provision of these By-laws commits an offence and is liable on conviction to a penalty not exceeding \$400.

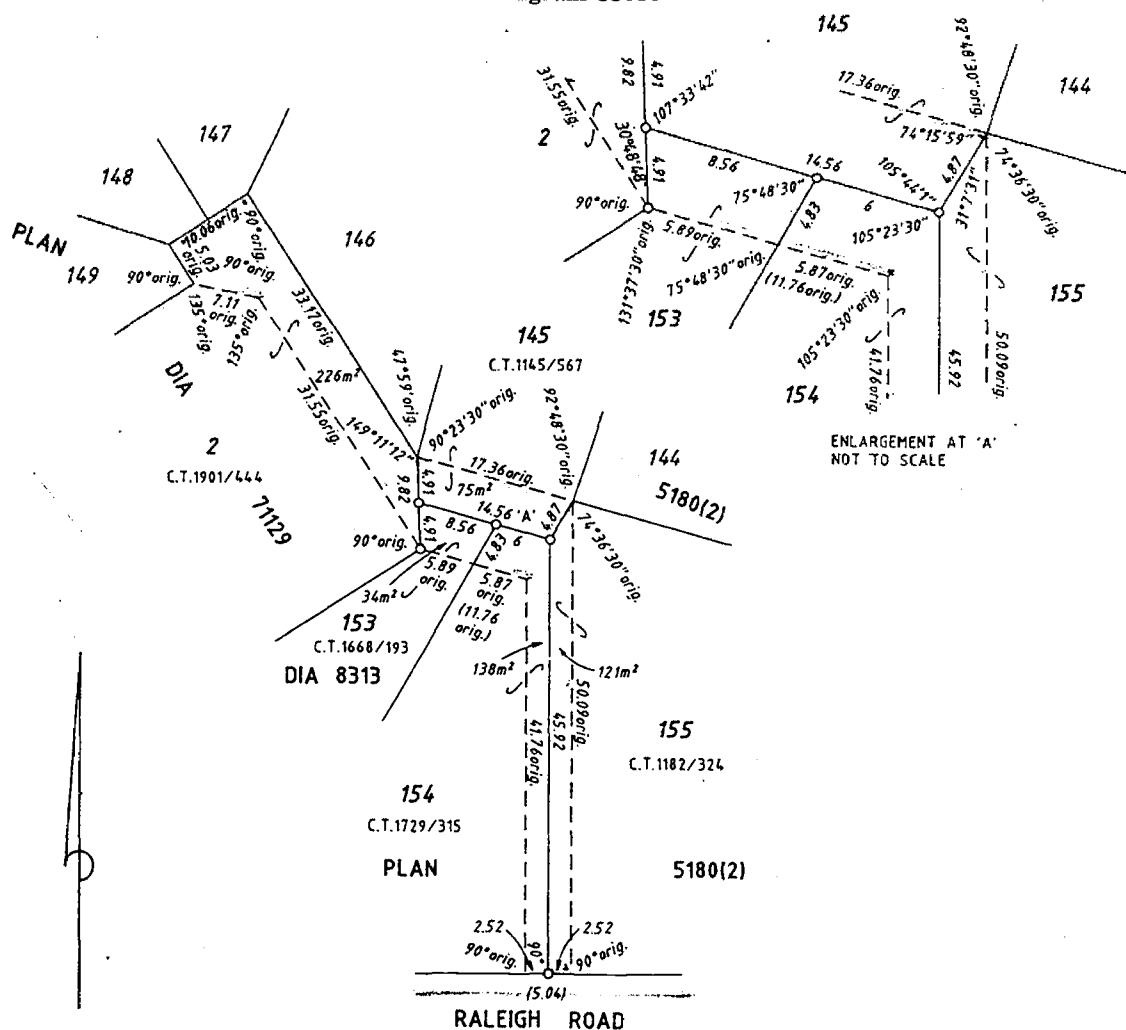
