# HEALTH ACT 1911

# HEALTH (PESTICIDES) AMENDMENT REGULATIONS (NO. 3) 1995

Made by His Excellency the Governor in Executive Council on the advice of the Pesticides Advisory Committee.

# Citation

1. These regulations may be cited as the Health (Pesticides) Amendment Regulations (No. 3) 1995.

# Principal regulations

2. In these regulations the *Health (Pesticides) Regulations 1956\** are referred to as the principal regulations.

#### **Regulation 2 amended**

"registered pesticide" means a pesticide registered under Part 2 of the Agvet Code of Western Australia;

"substance" has the same meaning as it has in section 3 of the Agvet Code of Western Australia;

"supply" has the same meaning as it has in section 3 of the Agvet Code of Western Australia;

# Regulations 4, 5, 6A, 6B, 7, 8, 9 and 9A repealed

4. Regulations 4, 5, 6A, 6B, 7, 8, 9 and 9A of the principal regulations are repealed.

Permission required to possess or use certain registered pesticides

10. (1) Subject to subregulation (2), a person shall not —

- (a) except for the purpose of supply, possess a registered pesticide; or
- (b) use a registered pesticide,

that contains any substance listed in Schedule B.

(2) Subregulation (1) does not apply to a person who possesses or uses a registered pesticide that contains any such substance with the written permission of the Executive Director, Public Health, and in accordance with any conditions on which the permission is granted.

### HEALTH ACT 1911

# Municipality of the Shire of Swan

**By-laws Relating to Eating Houses** 

Whereas under the provisions of the Health Act 1911, a local authority may make or adopt by-laws, and may alter, amend or repeal any by-laws so made or adopted. Now, therefore, the Shire of Swan, being a local authority within the meaning of the Act and having adopted the Eating House By-laws made by it and published in the *Government Gazette* on 22 January 1988, doth hereby resolve and determine that the said by-law shall be amended as follows---

#### Sixth Schedule

- (i) Replace the figures "\$150" in subclause (a) with "\$250".
- (ii) Replace the figures "\$120" in subclause (b) with "\$200".
  - (iii) Replace the figures "\$90" in subclause (c) with "\$150"; and
- (iv) Replace the figures "\$10" in Clause 3 with "\$30".
