#### ABORIGINAL HERITAGE ACT 1972

#### ABORIGINAL HERITAGE AMENDMENT REGULATIONS 1995

Made by His Excellency the Governor in Executive Council.

#### Citation

1. These regulations may be cited as the Aboriginal Heritage Amendment Regulations 1995.

#### Commencement

2. These regulations come into operation on the day on which the Aboriginal Heritage Amendment Act 1995 comes into operation.

## Principal regulations

- 3. In these regulations the Aboriginal Heritage Act Regulations 1974\* are referred to as the principal regulations.

### Regulation 1 amended

- 4. Regulation 1 of the principal regulations is amended by deleting "Aboriginal Heritage Act Regulations, 1974" and substituting the following —

## Powers of warden, and certificate (s. 50)

- 11. (1) For the purposes of section 50 (1) of the Act, the powers of a warden are those set out in the Act and these regulations, limited according to the terms of his appointment.
- (2) For the purposes of section 50 (2) of the Act, a warden shall be furnished with a certificate in the form of Form 1 set out in the Schedule.
