HEALTH ACT 1911

HEALTH (ADOPTION OF FOOD STANDARDS CODE) AMENDMENT REGULATIONS 1995

Made by His Excellency the Governor in Executive Council on the advice of the Food Advisory Committee.

Citation

1. These regulations may be cited as the *Health (Adoption of Food Standards Code) Amendment Regulations 1995*.

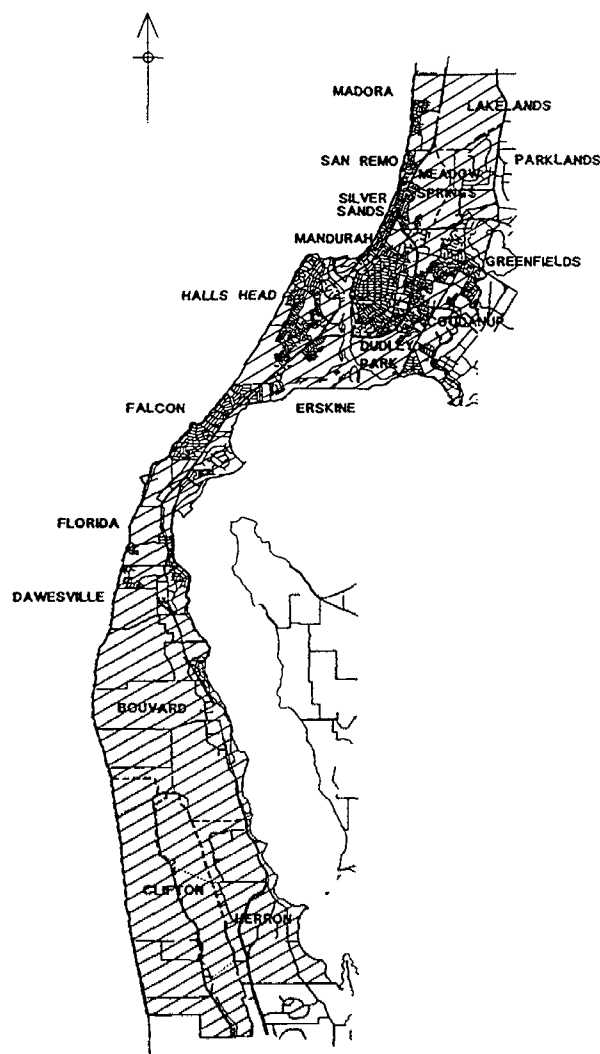
