**FAIR TRADING****FT301****FINANCE BROKERS CONTROL ACT 1975**

## Sections 44 (1) and (2)

The Finance Brokers Supervisory Board has fixed the following schedule to be the maximum amounts of remuneration for services rendered by persons carrying on the business of a Finance Broker. The Schedule shall apply in the case of contracts made on or after the date of publication of this notice and replaces the schedule published in the *Government Gazette* on 31 January 1992.

---

**Schedule****1. Application Fee—**

- (i) For loans up to \$50 000:  
\$125 non refundable for each loan. The Application fee is a payment against the eventual Brokerage charge.
- (ii) For loans over \$50 000:  
Fee establishment by prior mutual agreement in writing between the client and broker.

**2. Inspection Fees—**

- (i) Initial Inspection:  
Up to 30 Kilometres radius—\$100  
Over 30 Kilometres radius—\$100 plus \$100 per hour spent outside the 30 kilometre radius with a maximum of \$225 per half day or part thereof or \$450 per day.
- (ii) Subsequent Inspections:
  - (a) For progress advances for residential properties within 30 kilometres radius \$100 per inspection with a maximum of \$225 per property.
  - (b) For progress advances for residential properties beyond 30 kilometres radius and commercial properties in the course of erection by negotiation with the client.

**3. Brokerage Fees—**

- (i) Local Money Loans:
  - (a) For loans up to \$100 000—2%
  - (b) For loans over \$100 000—  
Fee established by prior mutual agreement in writing between the parties.
- (ii) Bridging Loans:  
On loans of 6 months or less \$115 plus 1 per cent.  
Over 6 months—normal rates.
- (iii) Interstate and Overseas Loans:  
Rates subject to prior written agreement between broker and client. If interim Bridging Finance also arranged additional brokerage of 1 per cent to be charged. Subject to loans in excess of \$100 000 being by negotiation between parties.
- (iv) Conditions of Brokerage Charges:
  - (a) Brokerage should NOT be charged by a selling agent where a Contract of Sale or Mortgage to Vendor is arranged. The agent Broker may, however, charge on a time basis for consultations and work done (see miscellaneous charges).
  - (b) Where the selling agent is also the broker a separate written Loan Application is also required before brokerage can be charged.
  - (c) No brokerage or other fees shall be charged by a broker in respect of a Building Society loan expressly for the purpose of financing the purchase of the borrower's principal place of residence.

**4. Transfer of Mortgage between Investor Clients—**

Standard scale of fees plus out of pockets, payable by the Transferer.

**5. Extension of Mortgages—**

50% standard brokerage inclusive of any reinspection, but revaluations, solicitors costs, stamp duty and registration should be in addition.

**6. Finalisation Fee (discharges)—**

Flat fee of \$100 to include all services required of a broker, in addition to legal costs, out of pockets, and settlement fees.

## 7. Commission on Interest Collections—

- (a) Interest Collections only—6% of interest collections inclusive of postages, cheque duty and bank charges.
- (b) Total Mortgage Management—including interest collection and supervision of mortgagor's compliance with all mortgage clauses:  
8% of interest collections, inclusive of postages, cheque duty and bank charges except where the broker is acting as an agent for an insurance company in which case fee of 5% applies.

## 8. Miscellaneous Charges—

- (a) Production of Title—\$100.
- (b) Titles Office Searches \$30 plus Titles Office fees.
- (c) Additional Interest Statements as provided in the Finance Brokers Code of Conduct \$25 for each statement issued.
- (d) Bank cheques—\$15 including costs.
- (e) Where no brokerage fees are payable consultations, advice, investigations and negotiations on finance—standard charges of \$115 per hour based on the actual time spent.
- (f) Disbursements directly and reasonably incurred by the broker in the negotiations relating to a loan or a proposed loan and without limiting the generality of the foregoing would include search fees, production fees, telephone trunk calls, telex, telegrams, accommodation expenses, postages and courier service and relevant Government charges.  
The broker shall at the request of the client produce to the client such evidence of disbursement that the client should reasonably require.
- (g) Where a broker is appointed as an Agent for the mortgagee under the terms of mortgage charge to be negotiated with the mortgagee but not to exceed \$115 per hour or as mutually agreed between the parties.

“Clerk” means the Shire Clerk or Chief Executive Officer of the Shire of Kondinin.

“Council” means the Council of the Shire of Kondinin.

“district” means the Municipal District of the Shire of Kondinin.

“licence” means a licence granted under this By-law.

“motor vehicle” means any vehicle as defined under the Road Traffic Act 1974.

“prescribed fee” means a fee set by a resolution of Council in accordance with section 191 (A) of the Local Government Act 1960.

“reserve” means a reserve specified in the First Schedule to this By-law.

“sell” includes: barter; exchange; supply or perform for profit; let or hire; offer for sale or for letting on hire; have in possession for sale or for letting on hire; and expose for sale or for letting on hire;

“services” includes the supply of transport; information; instruction; or supervision.

“ticket” includes a written permit or sticker.

**Entry onto a Reserve**

3. (a) A person shall not drive a vehicle onto a reserve or enter a reserve unless an entrance ticket has been purchased by payment of the prescribed fee.

(b) An entrance ticket entitles a vehicle or person to enter a reserve during the period shown on the ticket.

(c) Entry tickets for vehicles shall be displayed inside the vehicle so that the ticket number if any, the date and time of issue of the ticket are clearly visible to and able to be read by an authorised person from outside the vehicle at all times while the vehicle remains standing or parked on a reserve.

(d) Council shall, on application being made in writing, waive payment of the purchase price of the prescribed fee if it is satisfied that the ticket is to be issued to a person ordinarily a resident in the district.

(e) Persons who are bona fide tenants of the Wave Rock Caravan Park may, for the duration of any continuous period of occupancy and on the initial payment of the entry fee to the reserve, be issued with a pass exempting them from paying any further entrance fees to the reserve for the duration of the tenancy.

#### **Licence to sell Goods**

4. (1) A person shall not, without a licence, sell any goods or services on land prescribed in Schedule 1.
  - (2) The Council may grant a licence in writing to any person to sell goods or services on any land to which this By-law applies.
  - (3) (a) An application for a licence under clause 4 shall—
    - (i) be made to the Clerk in a form approved by the Council;
    - (ii) specify the goods or services the applicant proposes to sell; and
    - (iii) be accompanied by the fees and charges specified in Schedule 2.(b) The applicant shall provide the Clerk with such further information as the Council requires in any particular case.
  - (c) The Council may waive payment of the fees and charges specified in Schedule 2.
  - (4) Subject to this clause a licence is valid for such period as is specified in the licence.
  - (5) (a) The Council may, on payment of the fees and charges specified in Schedule 2, renew the licence of any person.
  - (b) The licence renewal fee and charges are payable annually one year from the date of issue of the licence.
  - (c) The Council may waive payment of the licence renewal fees and charges specified in Schedule 2.
  - (6) (a) A licence may be granted or renewed subject to such conditions and restrictions as the Council thinks fit, including conditions and restrictions as to—
    - (i) the area on the land to which the licence applies;
    - (ii) the class or description of goods or services to which the licence applies.(b) Where a licence, is granted or renewed subject to conditions or restrictions, those conditions or restrictions shall be endorsed upon or attached to the licence when granted or renewed, as the case may be.
  - (c) The holder of a licence shall not contravene or fail to comply with any condition or restriction endorsed upon or attached to the licence.
  - (7) The holder of a licence shall, when required to do so by the Council, the Clerk or an authorised person, produce for inspection his or her licence to the Council, the Clerk or the authorised person.
  - (8) (a) The Council may cancel, suspend for any period, or refuse to renew, the licence of any person on the grounds that—
    - (i) the person has been convicted of an offence against these By-laws;
    - (ii) any condition or restriction imposed upon the person's licence has been contravened or has not been complied with; or
    - (iii) the licence was obtained by fraud or misrepresentation.(b) If the Council proposes to cancel, suspend, or refuse to renew the licence of a person, the Council shall give to the person, notice in writing of the proposal and the Council's reasons for the proposal.
  - (c) A notice given under clause 5(8)(b) shall state that within 21 days after the notice is given, the person to whom it is given may make representations in writing to the Council concerning the matter, and the Council shall not determine the matter without considering any representations received within that period of 21 days.
  - (d) If the Council cancels, suspends, or refuses to renew the licence of a person under this clause, the Council shall give to the person, notice in writing of the cancellation, suspension or refusal to renew.
  - (9) The Council may require the holder of a licence to return the licence to the Clerk where the licence has been cancelled, suspended or has not been renewed.
5. A person who commits a breach of or fails to comply with any of these By-laws commits an offence and is liable upon conviction to a maximum penalty of \$200 with a maximum daily penalty of \$20.

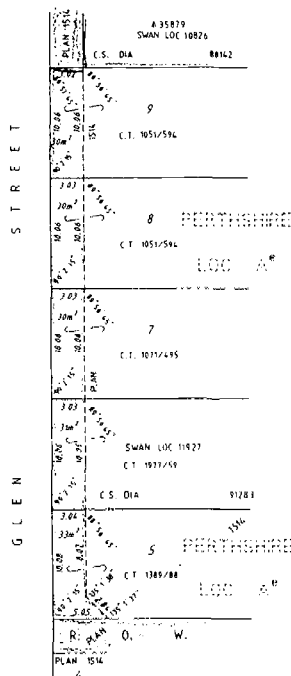

1. Urban Land (Land within a townsite). During the period from the 15th November to the 31st May inclusive, you shall have firebreaks in the following positions—
  - 1.1 On land which is 4 000 square metres or less in area, you shall remove all inflammable material from the whole of the land.
  - 1.2 On land which exceeds 4 000 square metres (one acre) in area as per item 2.1 hereunder.
  - 1.3 However, owners of property with an area greater than 4 000 square metres that boundaries a developed residentially zoned property, must install a satisfactory 2.4 metre wide boundary firebreak on their land abutting that residential property.
2. Rural Land—Homesteads, Buildings, Haystacks, Bulk Fuel, Drums and Liquid Petroleum.
  - 2.1 During the period from 15th December, to the 31st May inclusive you shall have fire breaks at least 20 metres wide, if provided by burning, cultivating or spraying or 60 metres wide, if provided by being closely grazed or mowed to the satisfaction of a Bush Fire Control Officer in such positions as are necessary to completely surround the perimeter of any homestead building (excluding isolated non flammable buildings) fuel installation (including drums), hay stack (but only haystacks within 100 metres of any building) or group of such structures or installations. In each case the outer 2.5 metres of the area must be totally free of any inflammable material and where mowing is the method used all residue of the mowing process must be removed from the area.

**Note—**Boundary firebreaks are not compulsory within the Shire of Kojonup Rural Area. Land holders can provide fire breaks if they wish.

**General Information—**If its considered impractical for any reason to clear firebreaks on the land as required by this notice you may apply to Council or its duly authorised officer for permission to provide firebreaks in alternative positions or take alternative action to abate fire hazards on the land. If permission is not granted by Council or its duly authorised officer you shall comply with the requirements of this notice.

**Please Note:** Following the method adopted by Council to inspect the firebreaks required in this notice, it is not necessary for Council to notify you or give you any prior warning that legal action may proceed for failing to comply with the requirements of this notice.

The penalty for failing to comply with this notice is a fine of not less than \$80 and a person in default is also liable, whether prosecuted or not to pay the cost of performing the work directed in this notice if it is not carried out by the required date.

**Harvesting:** As per the Bush Fires Act it is now compulsory that an engine powered pumping unit and not less than 400 litres of water be in attendance during grain harvesting operations.

Swathers and Balers are subject to the same conditions as harvesting, i.e. an engine powered pumping unit and not less than 400 litres of water be in attendance during operations from 1st December.

Oxyacetylene, Arc welders, friction cutting equipment (whilst used in the open) are subject to the same conditions as swathers and balers, and that in addition, the worksite be adequately cleared of flammable material prior to the use of the above mentioned equipment.

**Please note:** The Bushfire Advisory Committee recommends the prior installation of a preliminary chemical firebreak around your house and sheds and also around the 20 metre boundary mark to burn your break from/to. This practice will help reduce the number of protective burns which escape. The chemical break should be installed in June, or thereabouts, however, annual seasonal conditions should be considered.
