#### 1. FIREBREAKS

Pursuant to the powers contained in section 33 of the above Act, you are hereby required, on or before, the 1st day of November 1995, to plough, scarify, cultivate, or otherwise clear, and thereafter maintain free of all inflammable material, until the 31st day of January 1996, (inclusive) in the following positions and of the following dimensions on the land owned or occupied by you.

#### 2. RURAL LANDS

Firebreaks not less than three metres in width, inside and along the whole external boundaries of the properties owned by you, but where this is not practical: the firebreaks must be provided as near as possible to, and within such boundaries.

Shire of Augusta-Margaret River Bush Fire Notice and Requirements

Notice to all owners and/or occupiers of land in the Shire of Augusta-Margaret River

In accordance with section 33 of the Bush Fires Act 1954, you are required to carry out fire prevention work on land owned or occupied by you in accordance with the provisions of this order.

The penalty for non-compliance with this notice is a maximum fine of \$1 000, and not withstanding prosecution, council may enter upon the land and carry out required works at the owner/occupier's expense.

An inspection of firebreaks and hazard removal will be carried out in all areas of the Shire by an authorised officer (Townsites after December 1, 1995; Rural after December 22, 1995).

Rural and Special Rural Areas

This work must be carried out by December 22, 1995, and kept maintained throughout the summer months until April 12, 1996.

#### A Rural Land

- A firebreak not less than 2 metres wide must be constructed inside and within 100 metres of
  the boundary of each property where the boundary is adjacent to or adjoins a constructed or
  used surveyed road. (Firebreaks constructed on road verges do not constitute a legal firebreak under the Bush Fires Act, and Council approval is required prior to construction of
  additional firebreaks on roadside verges.)
- 2. A firebreak not less than 2 metres wide must be constructed within a perimeter of 20 metres of all homesteads, buildings, haystacks and fuel storage areas on the land.
- 3. Where uncleared land abuts a boundary, a firebreak not less than 2 metres wide must be constructed inside and within 100 metres of such boundaries.

#### B. Special Rural Land:

- 1. The owners of all existing small rural holdings zoned Special Rural' in Town Planning Schemes must construct a firebreak not less than 2 metres wide, immediately inside all boundaries.
- 2. An area of 30 metres around the house must be cleared of hazardous material to create a fuel-free zone. This zone is defined as an area devoid of understorey, leaves, rubbish and dead timber. Trees within the fuel-free zone are acceptable, provided they are not heavily barked and do not overhang the house.
- 3. Pasture land shall be grazed, slashed, or the fire hazard reduced by some other means, to the satisfaction of a duly appointed officer.

#### Townsites

This work must be carried out by December 1, 1995, and kept maintained throughout the summer months until April 12, 1996.

C. Townsites—Gracetown and Prevelly Park

In respect of land owned or occupied within these townsites or any area subdivided for other purposes, you shall:

- 1. Remove all flammable material (including ground fuel build-up) on the whole of the land except living standing trees, or
- 2. Construct a firebreak not less than 1.5 metres wide, immediately inside both side and rear boundaries, together with a firebreak not less than 3 metres in width around all buildings on the land. All fuel residue material from firebreak construction to be removed from the block.

#### D. All other townsites (including Molloy Island)

In respect of land owned or occupied by you within any townsite or any area subdivided for other purposes, you shall:

- 1. Where the area of land is up to and including 4 000 sqm, remove all flammable material on the land except living standing trees, from the whole of the land, and
- 2. Where the area of land exceeds 4 000 sqm, clear of flammable materials, firebreaks at least 2 metres wide, immediately inside all external boundaries of land, and also immediately surrounding all buildings situated on the land.

#### E. Private Hardwood/Softwood Plantations

Any area planted with pines or eucalyptus species exceeding five (5) hectares but not exceeding fifteen (15) hectares:

- 1. Firebreaks not less than two (2) metres wide around the perimeter on land on which plantation is established.
- 2. Firebreaks not less than ten (10) metres wide, two (2) metres of which must be cleared of all flammable materials, on the boundary. The remaining eight (8) metres must be maintained in a low fuel condition, e.g. short grass may be considered 'low fuel', where the plantation is adjacent to or adjoins a constructed, used surveyed road or enjoys a common boundary. Plantations exceeding fifteen (15) hectares to comply with the Bush Fires Board recommendation.

#### F. Fuel and/or Gas Depots

In respect of land owned or occupied by you on which is situated any container normally used to contain liquid or gas fuel, including the land on which any ramp or support is constructed, you shall have the land clear of all flammable materials.

Special Notice to Land Owners & Occupiers

The Council forwards a copy of this Firebreak Order each year. The Notice is also published in the Augusta-Margaret River Mail and copies are available at the office counter.

If it is considered impractical for any reason to clear firebreaks or remove flammable materials from the land as required by the Notice, you may make written application to the Council not later than the 15th day of November, 1995, for permission to provide firebreaks in alternative positions or to take alternative action to abate fire hazards on the land. This application must be countersigned by the Bush Fire Control Officer for the area in which the land is situated to signify his agreement to the variation. If permission is not granted by the Council or its duly authorised officer, you shall comply with the requirements of this notice.

Bush Fire Precautions, Prohibited Burning Times

"Conservation" means, in relation to any place or Heritage Precinct, the management of that place or precinct in a manner that will

- a) enable the cultural heritage significance of that place or precinct to be retained; and
- b) yield the greatest sustainable benefit for the present community without diminishing the cultural heritage significance of that place or precinct, and may include the preservation, stabilisation, protection, restoration, reconstruction, adaptation and maintenance of that place or precinct in accordance with relevant professional standards, and the provision of an appropriate visual setting;

"Cultural heritage significance" means, in relation to a place or heritage precinct, the relative value which that place or precinct has in terms of its aesthetic, historic, scientific or social significance, for the present community and future generations.

"Heritage precinct" means an area of heritage value having a distinctive nature, which may contain elements of only minor individual significance but heightened collective significance, where controls may be necessary to retain and enhance its character.

"Heritage List" means the Municipal Inventory, as amended from time to time, prepared by the Council pursuant to Section 45 of the Heritage of Western Australia Act 1990.

"Place" means an area of land sufficiently identified by survey, description or otherwise as to be readily ascertainable, and includes:

- a) an area of land situated below low water mark on the seashore or on the bank of tidal waters, or in the bed of any watercourse, lake or estuary;
- any works or buildings situated there, their contents relevant to the purpose of this Scheme, and such of their immediate surroundings as may be required for the purposes of the conservation of those works or buildings; and
- c) as much of the land beneath the place as is required for the purposes of its conservation.

#### PART 9—GENERAL PROVISIONS

#### 9.9 Heritage Provisions

Conservation of Buildings and places of heritage significance

#### 9.9.1 Purpose and Intent

The purpose and intent of the heritage provisions are:

- a) to ensure the conservation of any place, area, building, object or structure of heritage value:
- b) to afford the opportunity for existing traditional uses to be continued or allow for the approval of alternative uses which are compatible with the heritage values and amenity of the locality;
- c) to ensure that development or redevelopment within or adjacent to places of heritage value has due regard to the heritage value of the place and is in harmony with the character of the locality.

#### 9.9.2 Heritage List

- 9.9.2.1 The Council shall establish and maintain a Heritage List of buildings, objects, structures and places considered by the Council to be of heritage significance and worthy of conservation.
- 9.9.2.3 The Council shall keep copies of the Heritage List with the Scheme documents for public inspection during normal office hours.

#### 9.9.3 Designation of Heritage Precincts

- 9.9.3.1 The Council may designate an area of land to be a heritage precinct where, in the opinion of the Council, special planning control is needed to conserve and enhance the heritage values and character of the area.
- 9.9.3.2 The Council shall adopt for each heritage precinct a policy statement which shall comprise
  - a) a map showing the boundaries of the precinct;
  - b) a list of any buildings, objects, structures or places of heritage significance;
  - c) objectives and guidelines for the conservation of the precinct.
- 9.9.3.3 The Council shall keep a copy of the policy statements for any designated heritage precincts with the Scheme documents for public inspection during normal office hours.
- 9.9.3.4 The provisions of clause "9.2" of the Scheme apply to policy statements for heritage precincts.
- 9.9.3.5 The Council shall before designating a heritage precinct—
  - a) advertise notice of Council's intention in a newspaper circulating in the district, erect a sign in a prominent location in the area affected by the designation, and use such other methods as the Council considers necessary to ensure widespread notice of the proposal, describing the area the subject of the proposed designation;
  - b) invite submissions on the Council's proposal to designate the heritage precinct within 28 days of the date specified in the notice in (a) above;
  - c) carry out such other consultations as it thinks fit, including notification of owners of land within the proposed heritage precinct who will be affected by the designation of the heritage precinct;
  - d) consider any submissions made and resolve to designate the heritage precinct with or without modification or reject the proposal;
  - e) forward notice of its decision to the Heritage Council of WA and the WA Planning Commission.
- 9.9.3.6 The Council may modify or may cancel a heritage precinct by following the procedures set out in clause 9.9.3.5 above.

- 9.9.4 Applications for Development Approval
  - 9.9.4.1 In dealing with any matters which may affect a heritage precinct or individual entry on the Heritage List, including any application for development approval, Council shall have regard to any relevant policy of the Council.
  - 9.9.4.2 The Council may, in considering any application that may affect a heritage precinct or individual entry on the Heritage List, solicit the views of the Heritage Council of WA, the Australian Heritage Commission, the National Trust of Australia (WA) and those of any other relevant bodies, and take those views into account when determining the application.
  - 9.9.4.3 Notwithstanding any existing assessment on record, Council may require a heritage assessment to be carried out prior to the approval for any development proposed in a Heritage Precinct or place listed on the Heritage List.
  - 9.9.4.4 Notwithstanding any other provision of the Scheme, no person shall commence or carry out any development affecting any building, object, structure or place listed on the Heritage List or contained within a heritage precinct without first having applied for and obtained the planning approval of the Council pursuant to the provisions of clause "11.1" of the Scheme.
  - 9.9.4.5 Notwithstanding any other provision of the Scheme, no person shall do any act or thing in relation to any building, object, structure or place entered in the heritage list or contained within a heritage precinct that—
    - a) is likely to change the character of the place or the external appearance of any building; or
    - b) would constitute an irreversible alteration to the fabric of any building; without first having applied for and obtained the planning approval of the Council pursuant to the provisions of clause "11.1" of the Scheme.

#### 9.9.5 Formalities of Application

- 9.9.5.1 In addition to the application formalities prescribed in clause 9.9.4 of the Scheme and any requirements relating to development applications contained in any other provision of the Scheme, the Council may require an applicant for development approval, where the proposed development may affect a place of cultural heritage significance or a heritage precinct, to provide one or more of the following to assist the Council in its determination of the application.
  - a) Street elevations drawn to a scale not smaller than 1:100 showing the proposed development and the whole of the existing development on each lot immediately adjoining the land the subject of the application, and drawn as one continuous elevation;
  - b) side and rear elevations of the proposed development, drawn to a scale of not smaller than 1:100;
  - c) in addition to a site plan, a plan of the proposed development site showing existing and proposed ground levels over the whole of the land the subject of the application, and the location, type and height of all existing structures and of all existing vegetation exceeding 2 metres in height, and marking any existing structures and vegetation proposed to be removed; such plan shall be drawn to the same scale as the site plan;
  - d) an assessment of the cultural significance of any existing buildings and the development site itself according to policy guidelines adopted by the Council in relation to the precinct or place which may be affected;
  - e) a detailed schedule of all finishes, including materials and colours of the proposed development, and unless the Council exempts the applicant, a detailed schedule of all finishes, including materials and colours, of existing developments on the development site and on each lot immediately adjoining the development site; and
  - f) any other information which the Council considers relevant.

### 9.9.6 Power to Determine Application

- 9.9.6.1 Without affecting the generality of any other provision of the Scheme specifying the manner in which the Council is obliged or permitted to deal with an application for development approval, the Council in dealing with any application for development approval may for reasons related to the conservation of a place of cultural heritage significance or a heritage precinct
  - a) refuse approval;
  - b) grant approval without conditions; or
  - c) grant approval with conditions including conditions relating to conservation of the place or precinct.

#### 9.9.7 Conservation Incentives

9.9.7.1 In considering an application for development approval concerning or affecting a place of cultural heritage significance or a Heritage Precinct, the Council may for the purpose of conserving or enhancing the place or precinct give a special approval, benefit, allowance or incentive, including but not limited to the granting of density bonuses, transfer of development rights and entering into special agreements.

- 9.9.7.2 Where in the opinion of the Council the granting of a conservation incentive is likely to affect owners or occupiers of land in the locality or adjoining the place or precinct the subject of consideration for the incentive, the Council shall consult those owners or occupiers by advertising the incentive in the manner set out in clause "11.7.3" of the Scheme and shall have regard to any submissions received from such owners or occupiers prior to making a decision in relation to the incentive.
- 9.9.7.3 In granting a conservation incentive under Clause 9.9.7.1 the Council may enter into a heritage agreement under Part 4 of the Heritage of Western Australia Act 1990 with an owner who would benefit from the incentive. The agreement may specify the owner's obligations and contain covenants noted on relevant Certificates of Title.

#### 9.9.8 Density Bonuses

- 9.9.8.1 Within a heritage precinct, the Council may permit on a residential lot an increase up to 50% of the maximum permitted dwelling density applicable pursuant to the Residential Planning Codes. The density bonus shall only be granted where the increased dwelling density would not adversely affect the cultural heritage significance, character or amenity of the place, the streetscape or precinct, and if one or more of the following circumstances apply—
  - a) provision is made for the preservation of significant landscape features, including significant trees or other vegetation; or
  - b) provision is made for the carrying out of conservation works approved by the Council on a heritage place.
- 9.9.8.2 In a case where, pursuant to clause 9.9.8.1, the Council has permitted an increase in dwelling density, the standards and provisions of the higher density coding set out in the Residential Planning Codes shall apply.

- (iii) by deleting subparagraph (iv) and "or" after that subparagraph and subparagraph (v).
- (2) Regulation 262 (2) is amended

#### Regulation 262A inserted

4. After regulation 262 of the principal regulations the following regulation is inserted —

Discharge of ballast into port waters prohibited unless approved by Harbour Master

262A. (1) A person shall not except with the approval of the Harbour Master discharge, or cause or permit to be discharged, any ballast into the waters of the port.

- (2) The Harbour Master may give or refuse approval under subregulation (1) or give approval subject to any conditions that the Harbour Master considers appropriate, including conditions
  - (a) that require the ballast to be inspected or tested by the Port Authority, as specified by the Harbour Master, before or while the ballast is discharged; or
  - (b) that require the ballast to be discharged in places, or in quantities, as specified by the Harbour Master.
- (3) In determining whether to give or refuse approval, or to give approval subject to conditions, the Harbour Master shall have regard to
  - (a) the nature of the ballast;
  - (b) the means available to the Port Authority to inspect or test the ballast;
  - (c) the movement of vessels in the port; and
  - (d) any other matter that the Harbour Master considers relevant to the discharge of the ballast into the waters of the port.
- (4) Nothing in this regulation limits the operation of section 75 of the Act.
