**FISHERIES****FI401****FISHERIES ACT 1905****PART IIIB—PROCESSING LICENCES**

FD: 0553/93.

The public is hereby notified that I have issued a permit to Caysand No. 7 Pty Ltd of 9 Caprigardi Court, Dunsborough, to establish a processing establishment to process shark, snapper, mackerel, trevally, threadfin, and salmon, in pursuance of the provisions of section 35C of the Fisheries Act 1905, on board licensed fishing boat "Isla Joy III" registration number LFB O18, subject to the following conditions.

That the processing establishment—

1. Shall comply with the requirements of the Fisheries Act 1905, and all Regulations, Orders in Council and Notices and Ministerial directions issued thereunder.
2. Shall not be used for the processing of prawns and rocklobster.
3. Shall comply with the requirements of the Health Act 1911 (amended).
4. Shall be registered as an export establishment pursuant to the provisions of Parliament of the Commonwealth Export Control Act 1982, and orders made thereunder, more specifically the Prescribed Goods (General) Orders and Fish Orders, should be used to process fish for export.
5. Shall not be used for the processing of marron (*cherax tenuimanus*) unless a licence is held under section 39C of the Fisheries Act 1905.
6. Shall not be used for the processing of fish or crustacea caught by any other vessel.

In accordance with the provisions of section 35K, any person aggrieved by this decision, may within fourteen days after publication of this notice, appeal against the decision or order by serving on the Minister for Fisheries a statement in writing on the grounds of their appeal.

RESTRICTION OF PEARLING ACTIVITIES (PEARL OYSTER HOLDING SITES) NOTICE 1995

**Citation**

1. This notice may be cited as the *Restriction of Pearling Activities (Pearl Oyster Holding Sites) Notice 1995*.

**Restriction on pearling activities**

2. Until 31 December 1996, pearling activities shall not be undertaken in that area of water described in Schedule 1 by any person other than the person named in Schedule 2.

**Schedule 1**

That area of Zone 1 contained within the area bounded by a line commencing at the intersection of 20° 32.1' south latitude and 116° 34.1' east longitude; thence to the intersection of 20° 34.0' south latitude and 116° 35.2' east longitude; thence to the intersection of 20° 34.0' south latitude and 116° 34.3' east longitude; thence to the intersection of 20° 33.0' south latitude and 116° 31.9' east longitude; thence to the intersection of 20° 32.75' south latitude and 116° 32.05' east longitude; thence to the intersection of 20° 32.7' south latitude and 116° 33.05' east longitude; thence to the intersection of 20° 32.1' south latitude and 116° 33.5' east longitude; thence in a straight line to the commencement point.

**FISHERIES ACT 1905**  
**WARNBRO SOUND (CRAB) LIMITED ENTRY FISHERY NOTICE 1995**  
**NOTICE No. 730**

FD 335/92.

Made by the Minister under Section 32.

**Citation**

1. This Notice may be cited as the *Warnbro Sound (Crab) Limited Entry Fishery Notice 1995*.
- Commencement
2. This notice shall commence operation on 30 September 1995.

**Interpretation**

3. In this Notice unless the contrary intention appears -
  - "authorised boat" means a licensed fishing boat which is authorised pursuant to this notice to be used to operate in the Fishery;
  - "authorised person" means the nominated operator of a licence, or if no nominated operator then the licensee of a licence;
  - "crab pot" means a device as described in clause 12 (3) and which is baited for the purpose of taking crabs;
  - "crabs" means any crab of the species *Portunus pelagicus*;
  - "Fishery" means the Warnbro Sound (Crab) Limited Entry Fishery declared under clause 4;
  - "licence" means any limited entry fishery licence issued or renewed pursuant to this notice, that authorises a person to operate in the Fishery or any part of the Fishery;
  - "licensed fishing boat" means a boat licensed pursuant to regulation 2 of the Regulations;
  - "measured length" means the measured length of the boat as defined by and determined in accordance with the department of Transport Instruction to Surveyors notice 7/87 (reworked September 1994) effective from 21 September 1994, as reworked or superseded from time to time;
  - "net" means a demersal gill net;
  - "nominated operator" means the person approved by the Director, as the nominated operator of a licence, in accordance with clause 8;
  - "operate" means—
    - (a) to search for crabs;
    - (b) to attempt to take crabs;
    - (c) to take crabs; or
    - (d) to engage in any other activity that can reasonably be expected to result in the taking of crabs;
  - "pull" in relation to a net or crab pot means to bring the net or crab pot from the seabed to the surface of the sea;
  - "Regulations" means the *Fisheries Regulations 1938*;
  - "set" in relation to a net or crab pot means to position and release the net or crab pot into the water;
  - "Shoalwater Islands Marine Park" means all the waters of the Indian Ocean as shown delineated in black and bordered in red on Department of Land Administration Miscellaneous Plan No. 1687;
  - "transfer" means the passing of ownership or effective control of the licence from one person to another person;
  - "Warnbro Sound" means the area of water described in Schedule 1.

**Declaration of limited entry fishery**

4. It is hereby declared that the taking of crabs, or otherwise operating by any means from the waters described in Schedule 1 shall constitute a limited entry fishery named the *Warnbro Sound (Crab) Limited Entry Fishery*.

**Prohibition on taking or selling crabs**

5. (1) A person other than a person to whom section 32(5) of the Act applies shall not operate by any means in the Fishery other than in accordance with this Notice.  
(2) A person shall not sell, dispose of or otherwise deal with or attempt to sell, dispose of or otherwise deal with crabs taken in contravention of this Notice.

**Criteria for a person to operate in the Fishery**

6. A person, other than a person to whom section 32(5) of the Act applies, shall not operate in the Fishery unless—
  - (a) the person holds a Professional Fisherman's licence issued pursuant to the Regulations; and
  - (b) the person is operating from an authorised boat.

**Criteria for issue of a licence**

7. (1) The criteria that shall be applied to determine whether a licence may be issued in relation to a licensed fishing boat is that—

- (a) the boat was used in Warnbro Sound -
  - (i) to take at least 600 kilograms of crabs;
  - (ii) to take crabs in at least 2 months,

in each year of any five years during the period 1 January 1986 to 31 December 1991;

- (b) the boat has replaced a boat to which paragraph (a) applies.

(2) In this clause, "year" means the period from 1 January to 31 December in any one year.

**Licence**

8. (1) The licensee of a licensed fishing boat as described in clause 7 may apply to the Director for the issue of a licence.

(2) Where more than one person (whether natural persons or otherwise) or a body corporate is the proposed licensee, the proposed licensee must nominate a natural person to be the nominated operator and a licence shall not issue unless the Director approves such nomination.

(3) A nomination made under subclause (2) shall be in writing to the Director on the approved form.

(4) The nominated operator of a licence shall not be replaced.

(5) A licensee may apply to the Director for the renewal of a licence at any time after 31 July in the year in which the licence expires.

(6) If the Director considers that it is appropriate to do so, the Director may in the case of an application under—

- (a) subclause (1)—approve the issue of a licence;
- (b) subclause (3)—approve the person nominated to be the nominated operator of the licence;
- or
- (c) subclause (5)—approve the renewal of a licence.

(7) Where the Director has approved the issue or the renewal of a licence, the licence expires on 30 September of the year for which it was issued.

(8) A licence may be issued or renewed subject to conditions that shall be endorsed on it.

(9) When a licence is issued or renewed, the licence shall be endorsed to show—

- (a) the name and licensed fishing boat number in respect of which it is issued;
- (b) the name and address of the licensee and nominated operator (if any) of that boat;
- (c) the name of the Fishery;
- (d) the licence number;
- (e) the date of issue or renewal;
- (f) the period for which the licence is valid; and
- (h) any conditions imposed on the licence.

**Ministerial discretion**

9. (1) Notwithstanding the provisions of clause 7, the licensee of a licensed fishing boat that does not satisfy the criteria mentioned in clause 7, may, on application and with the written approval of the Minister, be issued with a licence to operate in the Fishery.

(2) The Minister may, pursuant to this clause, direct that any licence be issued.

(3) Without limiting subclause (2), a licence issued under this clause may be restricted—

- (a) to any part of the Fishery;
- (b) to any period of operation; and
- (c) by any conditions that the Minister may impose.

**Closures within the Fishery**

10. (1) Subject to subclause (2) a person shall not operate in the waters of the Fishery other than—

- (a) during the period commencing on 1 December in any year and ending on the last day in February in the following year, between the hours of 0430 and 1200 on any day;
- (b) during the period commencing on 1 March and ending on 30 June in any year, between the hours of 0530 and 1300 on each day;
- (c) during the period commencing on 1 July and ending 30 September in any one year, between the hours of 0630 and 1400 on each day.

(2) A person shall not—

- (a) operate by means of nets in the waters described in Schedule 2 at any time; nor
- (b) operate by means of crab pots in the waters described in Schedule 3 at any time.

**Licensee or nominated operator to control operations within the Fishery**

11. Unless otherwise authorised in writing by the Director, an authorised person shall—

- (a) when the authorised boat is in the waters of the Fishery, be on board the authorised boat;

- (b) when the authorised boat is being used to operate in the waters of the Fishery, be in control of or in charge of those activities; and
- (c) when the authorised boat is being used to operate in the waters of the Fishery, ensure that any undersize or female spawning crabs taken are returned to the waters of the Fishery within 5 minutes ( if crab pots are being used ) or 60 minutes ( if nets are being used ) of being brought aboard the authorised boat.

#### **Permitted means of operating in the Fishery**

**12.** (1) The only means of operating in the Fishery that may be used from an authorised boat are—

- (a) not more than 100 crab pots, all of which may be pulled only once in any 24 hour period (commencing at midnight); or
- (b) nets having a combined length of not more than 2,400 metres, of which not more than 1,200 metres may be pulled in any 24 hour period ( commencing at midnight ).

(2) A net used in the waters of the Fishery shall have -

- (a) the licensed fishing boat number clearly marked on either -
  - (i) every tenth lead weight marked clearly with lettering a minimum of 4 millimetres high;
  - (ii) every fifth net float marked clearly with lettering a minimum of 10 millimetres high; or
  - (iii) tags attached every 30 metres along the headrope, marked clearly with lettering a minimum of 10 millimetres high,
- (b) a maximum depth of 10 meshes;
- (c) a minimum mesh size of 152.3 millimetres;
- (d) a maximum monofilament line size of 0.48 millimetres diameter (8 line) or multifilament size 210/9 ply;
- (e) a maximum length of 1,200 metres.

(3) A crab pot used in the waters of the Fishery shall—

- (a) have two rings each of diameter no greater than 1.16 metres; and
- (b) when set, have a height between the rings of no greater than 450 millimetres, and have attached to it by negatively buoyant rope one float that—
  - (i) has a diameter of not less than 190 mm, and
  - (ii) is branded or stamped in legible letters not less than 80 mm high and not less than 15 mm wide with the initial letter of the port at which that licence is issued followed by the distinguishing number allotted under sub regulation (4) of regulation 2 of the regulations in respect of the licensed fishing boat that is used to set or lift the crab pot.

(4) An authorised person shall, within 5 working days after the Director has approved the issue of a licence and within 5 working days before 1 December of any year for which the licence is in force, deliver to a licensing officer of the Metropolitan District office of the Fisheries Department (Fremantle) a written notice electing the use of either crab pots or nets in the Fishery.

(5) Subject to subclause (6) the authorised person shall operate in the Fishery only—

- (a) if an election is made in accordance with subclause (4); and
- (b) by the means elected.

(6) An authorised person may only change the means used to operate in the Fishery by—

- (a) delivering to a licensing officer of the Metropolitan District Office of the Fisheries Department (Fremantle) within 5 business days before the day in the month specified in Schedule 4 a written notice electing to change the means of operating in the Fishery and specifying the change; and
- (b) within the first 2 days of the month immediately following the month relevant to subclause (6)(a), changing the means of operating in the Fishery in accordance with the specified change.

(7) Where a change of means of operating in the Fishery is being given effect pursuant to subclause (6)—

- (a) a conversion ratio of 50 crab pots for 1,200 metres (total length) of net shall apply;
- (b) the authorised person shall not set crab pots or net in the waters of the Fishery until all net or crab pots (as the case may be) have first been removed from the waters of the Fishery; and
- (c) the authorised person shall not have on board the authorised boat at any time both crab pots and net.

(8) Notwithstanding the provisions of this clause from 1 January 1999 a person shall not use a net in the Fishery.

#### **Boat replacement**

**13.** (1) An authorised boat may be replaced by another licensed fishing boat with the prior written approval of the Director.

(2) An authorised boat—

- (a) which is less than 5.5 metres measured length; and
- (b) in respect of which no authorisation other than a licence is in force,

may, on application by the licensee to the Director, be replaced by another licensed fishing boat which is not more than 5.5 metres measured length.

(3) An authorised boat to which subclause (2) does not apply may, on application by the licensee to the Director, only be replaced by another licensed fishing boat of measured length less than or equal to the that of the authorised boat.

(4) The measured length of a boat shall in the case of any disagreement or where otherwise necessary, be determined by an officer of the Department of Transport nominated in writing by the Director and appointed in writing by the licensee of the boat at the licensee's cost.

(5) Any change effected to the measured length of an authorised boat shall be, for the purposes of this Notice, taken to be a replacement of the authorised boat.

(6) Where an authorised boat is replaced other than in accordance with this clause, the replacement boat shall not be an authorised boat for the purposes of this Notice.

#### **Transfer of licence**

14. A licence shall not be transferred.

#### **Applications and prescribed fees**

15. An application to the Director under this notice shall be—

- (a) made on the form approved by the Director;
- (b) lodged subject to any direction in this notice, in accordance with the directions on the form; and
- (c) accompanied with the prescribed fee, if any.

#### **Publication of details**

16. The Director may, by letter, or by notice published in *The West Australian* newspaper or in the *Western Fisheries* magazine published by the Fisheries Department, give notice of the names and addresses of the persons who hold licences to operate in the Fishery.

#### **Determination of position by reference to the Australian Geodetic Datum**

17. (1) Where for the purposes of this Notice it is necessary to determine a position on the surface of the earth by geographical co-ordinates, that position shall be determined on the Australian Geodetic Datum which is defined by an ellipsoid having a semi-major axis (equatorial radius) of 6 378 160 metres and flattening of 1/298.25 and fixed by the position of the origin being the Johnston Geodetic Station in the Northern Territory of Australia.

(2) The Johnston Geodetic Station referred in subclause (1) shall be taken to be situated at 25° 56' 54.5515" south latitude and at 133° 12' 30.0771" east longitude and to have ground level elevation of 571.2 metres above the ellipsoid referred to in that subclause.

#### **Schedule 1**

##### **(Clause 4)**

The waters of the Indian Ocean bounded by a line commencing at a point on the high water mark at the northern end of Cape Peron, known as John Point; thence extending in a northerly direction towards South West Point on Garden Island until it intersects a line bearing 244° 03' 18" (the northern boundary of the marine park); thence in a south westerly direction to the intersection of 32° 15' 44" south latitude and 115° 40' east longitude; thence in a southerly direction to the intersection of 32° 22' 40" south latitude and 115° 40' east longitude; thence in an westerly direction to Becher Point; thence in a generally northerly direction along the high water mark to the point of commencement.

#### **Schedule 2**

##### **(clause 10)**

All the waters contained within the Special Purpose Wildlife Conservation Zone within the boundaries of the Shoalwater Islands Marine Park Reserve.

#### **Schedule 3**

##### **(clause 10)**

All that portion of the Fishery lying west of a line starting at the western extremity of Becher Point in Warnbro Sound and extending in a northerly direction to the western extremity of Mersey Point.

#### **Schedule 4**

##### **(clause 12)**

1. 27 February of any year.
2. 30 May of any year.

**MARINE AQUARIUM FISH LIMITED ENTRY FISHERY NOTICE 1995**  
Notice No. 728

376/83

Made by the Minister under section 32.

**Citation**

1. This notice may be cited as the *Marine Aquarium Fish Limited Entry Fishery Notice 1995*.

**Commencement**

2. This notice shall come into operation on 30 September 1995.

**Interpretation**

3. In this notice unless the contrary intention appears—

“authorised boat” means a licensed fishing boat which is authorised pursuant to this notice to be used in the Fishery;

“commencement date” means the date that this notice commences operation;

“diving equipment” includes -

- (a) any diving apparatus dependent upon the use of compressed air; and
- (b) any other diving apparatus whatsoever;

“Fishery” means the Marine Aquarium Fish Limited Entry Fishery declared under clause 4;

“licence” means a limited entry fishery licence issued or renewed pursuant to this notice;

“licensee” means the licensee of a licence issued pursuant to this notice;

“marine aquarium fish” means any marine fish of the Class Osteichthyes (all bony fishes) or the Class Chondrichthyes (all cartilaginous fishes);

“measured length” means, in relation to a boat, the length as determined in accordance with regulations made under the *Western Australian Marine Act 1982*, expressed in metres to 1 decimal point (with an amount of 0.05 metres or more being rounded upwards to the next 0.1 of a metre);

“nominated operator” means a natural person approved by the Director as the nominated operator of a licence in accordance with clause 9;

“nominated person” means a natural person approved by the Director as a nominated person in accordance with clause 10;

“operate” means—

- (a) to search for marine aquarium fish;
- (b) to attempt to take marine aquarium fish;
- (c) to take marine aquarium fish; or
- (d) to engage in any activity that can reasonably be expected to result in the taking of marine aquarium fish;

“Regulations” means the Fisheries Regulations 1938.

**Declaration of limited entry fishery**

4. It is hereby declared that the taking or attempted taking of marine aquarium fish by means of diving equipment shall constitute a limited entry fishery in all Western Australian waters below high water mark on the landward side of the 200 metre isobath.

**Prohibition on taking or selling marine aquarium fish**

5. (1) A person, other than a person to whom section 32(5) of the Act applies, shall not operate in the Fishery other than in accordance with this notice.

(2) A person shall not, for gain or reward, sell or otherwise dispose of marine aquarium fish taken from the Fishery in contravention of this notice.

**Criteria for a person to operate in the Fishery**

6. A person shall not operate in the Fishery unless the person holds a professional fisherman's licence issued pursuant to the Regulations and—

- (a) is a licensee, nominated operator or a nominated person; and
- (b) operates from an authorised boat or is authorised by licence to so operate.

**Criteria for the issue of a licence**

7. (1) The criteria that shall be applied to determine whether a transferable licence shall be issued to an applicant are that—

- (a) the applicant was, at the commencement date, the holder of a professional fisherman's licence which was endorsed to permit the holder to take marine aquarium fish;
- (b) the applicant submitted monthly fishing returns for marine aquarium fish taken during at least five days in each of four months during the period commencing 1 August 1992 and ending 31 July 1993; and
- (c) the minimum collective wholesale value of the fish referred to in the returns was \$5,000.

(2) The criteria that shall be applied to determine whether a non transferable licence shall be issued to an applicant are that—

- (a) either—
  - (i) the applicant was, at the commencement date, the holder of a professional fisherman's licence which was endorsed to permit the holder to take marine aquarium fish;
  - (ii) the applicant submitted monthly fishing returns for marine aquarium fish taken during at least five days in each of two months during the period commencing 1 August 1992 and ending 31 July 1993;
  - (iii) the minimum collective wholesale value of the fish referred to in the returns was \$2,500; and
  - (iv) the applicant is a natural person;
- (b) or—
  - (i) the applicant is one of the persons mentioned in the Schedule.

(3) A non-transferable licence shall be cancelled if for the period of one year commencing from the commencement date—

- (a) the licensee does not fish for at least five days in each of at least four months; or
- (b) the minimum collective wholesale value of the marine aquarium fish referred to in the returns lodged during that year is less than \$5,000.

**Licences**

8. (1) A person who satisfies the criteria as described in clause 7 may apply to the Director for a licence.

(2) A person may apply to the Director for the renewal of a licence at any time within 30 days before the licence expires.

(3) If the Director considers that it is appropriate to do so, the Director may in the case of an application under—

- (a) subclause (1)—approve the issue of a licence; or
- (b) subclause (2)—approve the renewal of a licence.

(4) A licence expires on 30 June of the year following the year in which the licence was issued or last renewed.

(5) A non transferable licence shall only be issued to a natural person.

(6) A licence may be issued or renewed subject to conditions that shall be endorsed on it.

(7) When a licence is issued or renewed, the licence shall be endorsed to show—

- (a) the name and address of the licensee;
- (b) the name and address of the nominated operator (if any) and the nominated persons;
- (c) the name and licensed fishing boat number of the boat, if any, in respect of which it is issued;
- (d) the licence number;
- (e) the date of issue or renewal;
- (f) the period for which the licence is valid; and
- (g) any conditions imposed on the licence.

**Nominated operator**

9. (1) Where more than one person (whether natural persons or otherwise) or a body corporate is a proposed licensee, the proposed licensee must nominate one natural person to be the nominated operator and a licence shall not issue unless the Director approves such nomination.

(2) A licensee may apply to the Director for a nominated operator to be replaced by another natural person.

(3) Subject to the prior written approval of the Director, a nominated operator may be replaced by another natural person.

(4) Only one nominated operator shall be endorsed on a licence at any one time.

(5) A person shall not be a nominated operator on more than one licence.

**Nominated persons**

10. (1) A licensee may apply to the Director for a natural person to be a nominated person in respect of a licence and the Director may approve such nomination.

(2) Subject to clause 12(2), a nominated person is a person other than the licensee or nominated operator of a licence (as the case may be) who may take or attempt to take marine aquarium fish in the Fishery.

(3) A licensee may apply to the Director for a nominated person to be replaced by another natural person.

(4) Subject to the prior written approval of the Director, a nominated person may be replaced by another natural person.

(5) A maximum of two nominated persons may be endorsed on a licence at any one time.

(6) A person shall not be a nominated person on more than one licence.

**Criteria for a boat to be used in the Fishery**

11. (1) A person shall not use a boat in the Fishery unless—

(a) that boat is endorsed on a Western Australian fishing boat licence issued pursuant to regulation 2 of the Regulations; and

(b) the boat is endorsed on a licence issued pursuant to this notice.

(2) Unless otherwise specified on the licence, an authorised boat shall not be used to take any fish other than marine aquarium fish.

**Permitted means of operating in the Fishery**

12. (1) Unless otherwise authorised in writing by the Minister, a person shall not take or attempt to take marine aquarium fish in the Fishery other than by a net or nets held in the hand.

(2) A person shall not operate in the Fishery or permit or suffer another person to operate in the Fishery unless—

(a) the licensee; or

(b) the nominated operator (if one has been approved by the Director pursuant to clause 9);

is actually present and in control of the fishing operations.

(3) At any one time, no more than—

(a) the licensee or nominated operator; and

(b) two nominated persons each holding a professional fisherman's licence;

may operate in the Fishery pursuant to a licence.

**Transfer of a licence**

13. (1) A licensee may apply to the Director to transfer a transferable licence.

(2) If the Director considers it appropriate to do so, the Director may approve an application made under subclause (1) and transfer that licence.

**Replacement of an authorised boat**

14. (1) A licensee may apply to the Director to replace an authorised boat with another licensed fishing boat.

(2) If the Director considers it appropriate to do so, the Director may approve an application made under subclause (1) and replace an authorised boat endorsed on a licence with another licensed fishing boat.

(3) Notwithstanding the provisions of subclause (1) and subclause (2) an authorised boat shall not be replaced by a boat which has a measured length of less than 8 metres.

**Applications and prescribed fees**

15. An application to the Director under this notice shall be—

(a) made on the form approved by the Director;

(b) lodged in accordance with the directions on the form; and

(c) accompanied with the fee, if any, prescribed by the Regulations.

**How the Director may give notice**

16. The Director may, by letter, or by notice published in *The West Australian* newspaper or in the *Western Fisheries* magazine published by the Fisheries Department, give notice of the names and addresses of the persons who hold licences to engage in the Fishery and the areas to which those licences apply.

Whereas on the 13 September 1995 I notified the public by a notice published in *The West Australian* newspaper that, under Part IIIB on the Fisheries Act 1905, I have issued a permit to Alan Leith Pritchard on behalf of Geraldton Fishermen's Co-Operative Ltd to establish a processing establishment to process rock lobster.

whereas that notice omitted to inform the public of either the—

- (a) intended location of the processing establishment; or
- (b) the conditions attached to the permit,

I, Peter Rogers, Executive Director of the Fisheries Department hereby notify the public that I have issued a permit to Alan Leith Pritchard on behalf of Geraldton Fishermen's Co-Operative Ltd, to establish a processing establishment to process rock lobster in pursuance of the provisions of Section 35C of the Fisheries Act 1905 at Jurien Fishing Boat Harbour, subject to the following conditions—

That the processing establishment subject to this permit—

1. Shall comply with the requirements of the Fisheries Act 1905, and all Regulations, Orders in Councils, and Notices and Ministerial Directions issued thereunder.
2. Shall not be used for the processing of prawns.
3. Shall comply with the requirements of the Health Act 1911 (amended).
4. Shall comply with the requirements of any Town Planning Scheme or Interim Development Order gazetted under the provisions of the Town Planning and Development Act 1928 (amended) or the Metropolitan Region Town Planning Scheme Act 1959 (amended).
5. Shall be registered as an export establishment pursuant to the provisions of the Parliament of the Commonwealth Export Control Act 1982, and orders made thereunder, more specifically the Prescribed Goods (General) Orders and the Fish Orders, should you wish to process fish for export.
6. Shall not be used for the processing of marron (*Cherax tenuimanus*) unless a licence is held under Section 39C of the Fisheries Act 1905.
7. Rock Lobster shall not be processed or received for processing on Christmas Day, New Year's Day and Good Friday.
8. The licensee shall lodge with the Department of Fisheries no later than the 15th day of each month, a return of all fish purchased for the proceeding month, specifying the name of the fisherman, the boat registration number or Professional Fisherman's Licence Number, anchorage from which the vessel operates, the species and live weight purchased. Where no fish have been purchased a nil return shall be submitted.
9. The granting of a licence for these premises to be dependant on the removal of processing licence 1013 from Kalbarri to Jurien or the issue of a new licence in lieu of licence 1013.
10. The processing establishment may be used for processing the flesh of rock lobster forming the group of muscles comprising the antennal peduncle muscles (three segments), the antennular

plate muscles, the promoter and depressor antennal muscles and the epistome muscles (commonly referred to as "horn" or scalp" meat), subject to the processed flesh being packed as follows—

- (a) in whole form as extracted from the shell, with the epidermis on, in packs of not more than 1.5kg in weight and not more than 3cm in depth, and if such packs are wrapped or placed in a bag such wrapping or bag shall be transparent; or
  - (b) where the group of muscles has been individually quick frozen in whole form as extracted from the shell with the epidermis on, in packs not more than 3m deep and if such packs are wrapped or placed in a bag, such wrapping or bag shall be transparent.
11. Shall be permitted to pack live rock lobster for direct export from holding tanks on Christmas Day, New Year's Day and Good Friday.
  12. The licensee shall ensure—
    - (i) that the rock lobster inspection facilities set out hereunder will be continuously available within the premises covered by this licence for use at any time by a Fisheries Officer;
    - (ii) that satisfactory arrangements are made to make containers of rock lobster selected by Fisheries Officers available for inspection as prescribed hereunder;
      - (A) An inspection table shall be provided and constructed such that the table top—
        - (i) is approximately 85cm from the floor;
        - (ii) is fitted with sides and ends sufficient to contain rock lobsters;
        - (iii) can hold two containers or rock lobsters no more than two rock lobsters deep across the surface of the table; and
        - (iv) is fitted with a chute so the contents can be pushed from the table surface.
      - (B) facilities shall be available for basket holders on the inspection table.
      - (C) the area or areas set aside for inspection of Lobsters shall be—
        - (i) sufficient in area to permit two Fisheries Officers to undertake inspections at the table simultaneously;
        - (ii) adequately lit and ventilated;
        - (iii) located close to the rock lobster receival section of the licensed premises;
        - (iv) adequately screened from spraying water or other materials; and
        - (v) free from excessive machinery noise.
      - (D) The contents of each selected bag or container or rock lobsters shall be placed upon an inspection table by employees of the licensee and shall be removed from the table as necessary after inspection.  - 13. The licensee shall—
    - (1) not permit any abalone from Zones 1, 2 or 3 of the Limited Entry Abalone Fishery to be received on the premises licensed under Part III B of the Fisheries Act, or upon the premises of any person authorised as a receival agent of the licence holder, unless the abalone is accompanied by a "Catch and Disposal Record" form known as "ALEF2".
    - (2) not permit any Green Lipped Abalone (*Haliotis leavigata*), Brown Lipped Abalone (*Haliotis conicopora*) or Roe's Abalone (*Haliotis roei*) to be received on the premises licensed under part III B of the Fisheries Act unless the abalone is accompanied by a form "ALEF2".
    - (3) when abalone is received from Zones 1, 2 or 3 of the Limited Entry Abalone Fishery by an authorised receival agent, cause the "ALEF2" to accompany the abalone to the licensed processing establishment.
    - (4) cause Part B of the "ALEF2" to be completed in full, in respect of any abalone received from Zones 1, 2 or 3 of the Limited Entry Abalone Fishery.
    - (5) cause the completed form "ALEF2" to be forwarded to the Fisheries Department office described on the form within twenty four hours of receipt.
  - 14. The licensee shall not—
    - (1) be in possession or control, or have on any licensed premises any setose rock lobster or tarspot rock lobster.
    - (2) sell or cause to be sold, offer or expose for sale any setose rock lobster or tarspot rock lobster.
    - (3) be in possession or control, or have on any licensed premises any female western rock lobster with a carapace length greater than 115mm.
    - (4) sell or cause to be sold, offer or expose for sale any female western rock lobster with a carapace length greater than 115mm.
    - (5) accept from any person or have in possession on any licensed premises any female western rock lobster with a carapace length greater than 105mm which were taken from waters north of 30 degrees 48 minutes south latitude.

In accordance with the provisions of Section 35K, any person aggrieved by this decision, may within fourteen days after publication of this notice, appeal against the decision of order by serving on the Minister for Fisheries a statement in writing on the grounds of their appeal.

4. No moneys advanced by the AMP Society, a wholly owned subsidiary of the AMP Society or a trust of which the AMP Society is a beneficiary being held by the said persons on behalf of the Borrower.
5. The said persons not being responsible for approving loans on behalf of the AMP Society, any subsidiary of the AMP Society or a trust of which the AMP Society is a beneficiary.
6. The exception for any person continuing only for so long as that person discloses to all intending Borrowers with whom that person is dealing that commission is payable to that person by the AMP Society, a wholly owned subsidiary of the AMP Society or a trust of which the AMP Society is a beneficiary.
7. The AMP Society providing to the Ministry of Fair Trading at least annually a list of all agents of the AMP Society who may be affected by this exception.

Notice to owners and/or occupiers of land outside the Metropolitan Fire District in the Shire of Swan

The firebreak is to be not less than 2.44 metres (8 feet) wide and provided in the following positions—

Notice to all Owners and/or Occupiers of Land within the Municipality of the Shire of Murray

Pursuant to the powers contained in section 33 of the Bush Fires Act 1954, you are required to carry out fire prevention work on land owned or occupied by you in accordance with the provisions of this order.

This work must be carried out on or before the 30th day of November 1995 or within fourteen days of the date of your becoming owner or occupier should this be after the 30th day of November 1995 and thereafter up to and including the 26th day of April, 1996.

#### 1. RURAL LAND

1.1 To have a firebreak clear of all flammable materials, not less than two (2) metres wide and within fifty (50) metres of all boundaries of land abutting gazetted roads, railway reserves and Department of C.A.L.M. land boundaries, as well as land abutting "Special Rural" and "Urban Lands".

1.2 Have firebreaks not less than two (2) metres wide so far as to surround all buildings, sheds, haystacks and fuel depots/storage areas. The inner perimeter of such firebreaks to be within twenty (20) metres of the buildings, sheds, haystacks and fuel depots/storage areas.

#### 2. SPECIAL RURAL LAND (Other than rural as previously described)

2.1 Where the area of land is 2 024 sqm (approximately half an acre) or less, remove all flammable material on the land except living standing trees, from the whole of the land,  
or

2.2 Where the area of land exceeds 2 024 sqm (half acre), provide firebreaks of at least 2 metres wide, immediately inside all external boundaries of the land and also immediately surrounding all buildings situated on the land. Where several adjoining lots are held or used by the owner/occupier, the firebreaks may be provided inside and along the external boundaries of the group or lot and the requirements of items 2.1 and 2.2 shall be maintained throughout the summer months until the expiration of the restricted burning period, ie 26th April 1995.

#### 3. URBAN LAND (Residential, Commercial and Industrial land within a townsite or within any area subdivided for residential purposes.)

In respect of land owned or occupied by you within any townsite or any area, subdivided for other purposes, you shall—

3.1 Where the area of land is 2 024 sqm (approximately half an acre) or less, remove all flammable material on the land except living standing trees, from the whole of the land.

3.2 Where the area of land exceeds 2 024 sqm (half acre), provide firebreaks as in section 2.2.

Inspection of firebreaks will be carried out in all areas of the Shire by an authorised officer.

Persons who fail to comply with the requirement of this order may be issued with an infringement notice (penalty \$80) or prosecuted (of penalty not more than \$1 000), and additionally, Council may carry out the required work at cost to the owner or occupier.

If for any reason it is considered impracticable to comply with the provisions of this order, you may make a written application for variation to the Chief Executive/Shire Clerk which must reach him not less than two weeks prior to the date by which the firebreak is required to be established.

No such application will be considered unless it bears the signature of the Fire Control Officer of the area signifying his agreement to the variation. If the application is not approved by the Chief Executive/Shire Clerk, you shall comply with the requirements of this notice.

#### N.B. ISLANDS IN RIVER SYSTEMS—

Owners and/or occupiers of Island Locations are required on or before the 30th November 1995, and thereafter up to and including the 26th April 1996, to have a firebreak clear of all flammable material at least 2 metres wide immediately inside all boundaries of land.

#### 4. CANAL SYSTEM LOCATIONS

The requirements of Section 3, Urban Land, apply where the area of land is 2 024 sqm or less and is subject to owners and/or occupiers complying with the following requirements—

(i) Undeveloped (vacant) lots shall not be ploughed, rotary hoed or cultivated in order than land remains stabilised and not become subject to erosion by wind and water.

#### 5. FUEL AND GAS DEPOTS

In respect of land owned or occupied by you on which is situated any container normally used to contain liquid or gas fuel, including the land on which any ramp or supports are constructed, you shall maintain the land clear of all flammable materials.

**6. HARDWOOD/SOFTWOOD PLANTATIONS**

Plantations established since the 30th November 1984, are required to provide firebreaks—

- 6.1 Not less than 20 metres wide around the perimeter of each plantation;
- 6.2 Not less than 10 metres wide along those portions of the plantations which abut a used road;
- 6.3 Not less than 10 metres vertical clearance, in width in such a position that no part or compartment of the plantation exceeds 30 hectares in area; and
- 6.4 All firebreaks must be maintained in trafficable condition and trees on both sides of breaks progressively pruned to a minimum height of 4 metres to allow unrestricted access of maintenance and fire fighting equipment and so as to maintain an effective width of firebreak.

Bush Fire Order 1995/96

Notice to all owners and/or occupiers of land in the Shire of Capel

With reference to section 33 of the Bush Fires Act, you are required to carry out fire prevention work on land owned or occupied by you in accordance with the provisions of this order.

This work must be carried out by 30th November 1995, and kept maintained throughout the summer months until the close of the Restricted Burning Period on 26th April 1996.

An inspection of firebreaks and hazard removal will be carried out in all areas of the Shire by an Authorised Officer after 30th November 1995.

Persons who fail to comply with the requirements of this order may be issued with an infringement notice or prosecuted with an increased penalty, and additionally, Council may carry out the required work at a cost to the owner or occupier.

Definitions: For the purpose of this order the following definitions apply—

“Firebreak” means ground from which all flammable material has been removed and on which no flammable material is permitted to accumulate during the Prohibited and Restricted Burning Periods.

“Fuel Free Zone” means the removal of dead grass, leaf litter, trash and understorey bush.

“Greenbelt Area” means all rural and urban land located west of—

- (i) Minninup Road—from the northern boundary of the Shire of Capel to the junction of Minninup Road and Fishermans Road.
- (ii) The unmade portion of Minninup Road—from the junction of Minninup Road and Fishermans Road to its junction with Mangles Road.
- (iii) Mangles Road—from its junction with the unmade portion of Minninup Road in (ii) south to its junction with Roberts Road.
- (iv) Roberts Road—from its junction with Mangles Road West to its junction with Mallokup Road.
- (v) Mallokup Road—from its junction with Roberts Road South to its junction with Ludlow North Road.
- (vi) Ludlow North Road—from its junction with Mallokup Road South to the Southern Boundary of the Shire of Capel.

“Haystack” means any collection of hay including fodder rolls placed or stacked together.

“Low Fuel Zone” means the removal of dead grass, dead trees, leaf litter and trash.

“Plantation”—

- (i) A Plantation is any area of planted pines or eucalyptus species exceeding 3 hectares in area.
- (ii) A windbreak is planted area a maximum of 15 metres wide but with no defined length.

**Minimum Fire Hazard Removal Requirements****A. Rural Land (All land other than land described below)—**

1. Firebreaks at least 2 metres in width and not more than 20 metres from the perimeter of all buildings and haystacks situated on the land so as to completely surround the buildings and haystacks.
2. Firebreaks at least 2 metres in width immediately inside and along all external boundaries so as to form a continuous break all around the holding except where an exemption has been granted (Roadside firebreaks do not constitute a legal firebreak under the Bush Fires Act.)
3. Lessees of Railway Reserves shall have a firebreak at least 3 metres in width along the common boundary between the land leased from Westrail and other land owned or occupied.

**B. Special Rural Land**

The owners of all existing small Rural holdings zoned as Special Rural land under Town Planning Schemes must maintain clear of all flammable material, a firebreak not less than 2 metres inside all external boundaries of land and a 20 metre wide low fuel zone around all buildings on the land.

On the vertical plane on the side of the firebreak the trees are to be pruned to a minimum height of 5 metres.

**C. Special Rural Lots—Part Boyanup AA Lot 157, Gelorup (Ramblewood Stage 4)**

Lots 66, 68, 70, 71, 72, 73, 74 and 77 of Part Boyanup AA Lot 157 are required to maintain the 5 metre wide strategic firebreak that is on the land. On lots 66 to 68 and lots 70 to 77 of Part Boyanup AA Lot 157 which have buildings situated on them, a 20 metre wide fuel free zone is required around all buildings.

**D. Urban Land (Residential, Commercial and Industrial land within a townsite or within any area subdivided for residential purposes, including Gelorup)—**

1. Where the area of land is 2 000 m<sup>2</sup> or less, remove all flammable material on the land except living standing trees from the whole of the land.
2. Where the area of land exceeds 2 000 m<sup>2</sup>, but not more than 5 000 m<sup>2</sup>—
  - (a) A 2 metre wide firebreak is required immediately inside all external boundaries of the land. On the vertical plane on the side of the firebreak the trees are to be pruned to a minimum height of 3.5 metres.
  - (b) Remove all flammable material (including ground fuel build up) on the land by either slashing, grazing or burning.
3. Where the area of land exceeds 5 000 m<sup>2</sup> a firebreak not less than 2 metres wide inside all external boundaries of the land and a 20 metre wide low fuel zone around all buildings on the land is required.

On the vertical plane on the side of the firebreak the trees are to be pruned to a minimum height of 5 metres.

**E. Greenbelt Area: A 2 metre wide firebreak is required on the west side of the roads defining the "Green Belt" area, unless an exemption has previously been granted.****F. Peppermint Grove Townsite: All land situated within Peppermint Grove Townsite are exempt from the order to install a firebreak, but Council does retain the right to remove any fire hazard at the owner and/or occupier's expense following the failure of an owner and/or occupier to comply with the requisition of an order in writing to clear a fire hazard or firebreak in accordance with section 33 of the Bush Fires Act.****G. Plantations—****Boundary Firebreaks—**

On the horizontal plane a firebreak shall be provided 15 metres wide and immediately adjoining all external boundaries of the planted area. The outer 10 metres will be cleared of all flammable material while the inner 5 metres, i.e. that portion closest to trees may be kept in a reduced fuel state, i.e. by slashing or grazing grass provided that the height of the grass does not exceed 8cm.

On the vertical plane a clear space 4 metres high will be maintained above outer 10 metres of the firebreak.

**Internal Firebreaks—**

Plantations shall be subdivided into areas not exceeding 30 hectares by firebreaks 6 metres wide which shall be cleared of all flammable material.

In the vertical plane a clearance of a minimum height of 4 metres from the ground level will be maintained above the firebreak.

**Special Risks—****(i) Public Roads and Railway Reserves—**

Firebreaks 15 metres wide shall be maintained where a planted area adjoins public roads and railway reserves. The specification will be as for "Boundary Firebreaks" on planted areas.

**(ii) Powerlines—**

Firebreaks shall be provided along powerlines where they pass through or lie adjacent to planted areas. The specification of the width and the height of clearing shall be in accordance with State Energy Commission of Western Australia specifications.

**Fuel and/or Gas Depots—**

In respect of land owned or occupied by you on which is situated any container normally used to contain liquids or gas fuel, including the land on which any ramp or supports are constructed, you shall have land clear of all flammable materials.

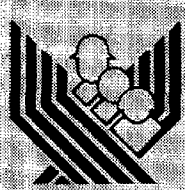
