FIRE BRIGADES (METROPOLITAN FIRE DISTRICT) ORDER (No. 2) 1995

Made by the Governor in Executive Council under section 5.

Citation

1. This order may be cited as the Fire Brigades (Metropolitan Fire District) Order (No. 2) 1995.

Metropolitan Fire District

2. The boundaries of the Metropolitan Fire District are adjusted so that the boundaries are in accordance with the description in Schedule 1.

thence southerly to the northeastern corner of that lot; thence southeasterly along a line joining the northeastern corner of that lot; thence southeasterly along a line joining the last mentioned corner with the northwestern corner of Lot 4 of Location 1224, as shown on Land Titles Office Diagram 29401 to the centreline of Gnangara Road; thence generally easterly along that centreline to the centreline of Alexander Drive; thence generally southeasterly and generally southerly along that centreline to the prolongation westerly of the westernmost southern boundary of part Lot 98 of Location 1315, as shown on Land Titles Office Diagram 55514; thence easterly to and easterly and generally southeasterly along boundaries of that part lot to the western corner of part Lot 99; thence southeasterly along the southwestern boundary of that part lot to its southern corner; thence southeasterly to the western corner of part lot to its southern corner; thence southeasterly to the western corner of part Lot 3; thence southeasterly along the southwestern boundary of that part lot to its southern corner; thence southeasterly to the westernmost southwestern corner of the northwestern severance of Lot 23 of Locations H, I, K and 1315, as shown on Land Titles Office Plan 12769; thence generally southeasterly along boundaries of that severance and onwards to the westernmost northwestern corner of the southern severance of Lot 23; thence easterly along the northern boundaries of that lot and Lot 68 to the northwestern corner of Lot 135 (Class "A" Reserve 7537); thence easterly and southerly along boundaries of that lot to a northern side of Great Eastern Highway; thence southeasterly, generally thence generally southwesterly along sides of that road to the northernmost northern side of Great Eastern Highway; thence southeasterly, generally northeasterly and generally easterly along sides of that highway to the prolongation northerly of the eastern boundary of Greenmount Suburban Lot 68 (Class "A" Reserve 6922); thence southerly to and along that boundary and southerly along the easternmost eastern boundary of Lot 553 (Reserve 28383) and onwards to the eastern side of Newman Road; thence southerly along that side and onwards to a southeastern boundary of Swan Location 10791; thence generally southwesterly along sides of that street to the prolongation southeasterly of the centreline of Holmes Street; thence northwesterly to and generally northwesterly along that Street; thence northwesterly to and generally northwesterly along that centreline and onwards to the centreline of Warton Road; thence generally southwesterly along that centreline to the centreline of Nicholson Road; thence generally northwesterly along that centreline to the prolongation easterly of the centreline of Acourt Road; thence westerly to and westerly and generally northwesterly along that centreline and onwards to the centreline of Johnston Road; thence generally northerly, northwesterly and generally northeasterly along that centreline to the prolongation easterly of a southern side of the eastern section of Leeming Road; thence westerly to and generally westerly along sides of that road and onwards to and along the southern side of the central section of Leeming Road to the centreline of the proposed Controlled Access Highway, known as Roe Highway, as shown on Department of Planning and Urban Development Plan Numbers 1.1967, 1.1966 and 1.1965/1; thence generally southwesterly along that centreline to the northwestern boundary of Location 3824 (Reserve 42656); thence the northwestern boundary of Location 3824 (Reserve 42656); southwesterly along that boundary to a northern boundary of Jandakot Agricultural Area Lot 170; thence easterly, generally southeasterly, generally southwesterly, southerly and southeasterly along boundaries of that lot and onwards to the northernmost northeastern corner of Lot 169; thence generally southeasterly, generally southwesterly and again generally southeasterly along boundaries of that lot and onwards to the prolongation northeasterly of the centreline of Prinsep Road; thence southwesterly to and along that centreline to the prolongation southwesterly of the westernmost southeastern boundary of Lot 10 of Lot 156, as shown on Land Titles Office Diagram 63466; thence northeasterly to and northeasterly, southeasterly and again northeasterly along boundaries of that lot to the southwestern corner of Lot 15 of Lot 158, as shown on Land Titles Office Diagram 52773; thence southeasterly along the southwestern boundary of that lot and onwards to a southeastern side of Solomon Road; thence southwesterly along that side and onwards to the centreline of Forrest Road; thence generally southeasterly along that centreline to the prolongation northerly of the centreline of Tapper Road; thence southerly to and southerly, easterly and generally southerly along that centreline and onwards to the centreline of the eastern section of Bartram Road; thence generally westerly along that centreline and onwards to the centreline of the western section of Bartram Road; thence generally westerly along that centreline and onwards to the centreline of Hammond Road; Citation

1. This order may be cited as the Fire Brigades (Mundaring Fire District) Order 1995.

Mundaring Fire District

2. That portion of the Shire of Mundaring described in Schedule 1 is constituted as the Mundaring Fire District.

THE KIMBERLEY DEMERSAL LINE INTERIM MANAGED FISHERY **MANAGEMENT PLAN 1995**

Management Plan No. 1

Made by the Minister under section 54.

Citation

1. This plan may be cited as the Kimberley Demersal Line Interim Managed Fishery Management Plan 1995.

Interpretation

- 2. In this management plan, unless the contrary intention appears—
 - "the Act" means the Fish Resources Management Act 1994;
 - "authorised boat" means a licensed fishing boat in respect of which a permit is issued pursuant to this management plan;
 - "demersal line" means any fishing line used to take demersal scalefish, including but not limited to, handline, dropline, trotline, and longline;
 - "demersal longline" means a main line anchored to the seabed at both ends and at intervals along its length, to which hooks or branch lines with hooks are attached;
 - "demersal scalefish" means fish of the class Osteichthyes, excluding the family Scombridae;
 - "dropline" means a weighted line which has not less than 6 and not more than 40 hooks attached (when used either attached to or thrown from the boat);
 - "entitlement" means the type and number of demersal lines to be specified on the interim managed fishery permit.
 - "fishing boat licence" means a licence issued pursuant to Regulation 117 of the Fish Resources Management Regulations 1995;
 - "Fishing Permit (Commonwealth)" means a fishing permit issued pursuant to the Fisheries Management Act 1991 of the Commonwealth;
 - "handline" means a weighted line to which no more than 5 hooks are attached;
 - "Kimberley Prawn Fishery" means the managed fishery described in Notice 600 of 22 October 1993;
 - "length" means the measured length of the fishing boat as defined by and determined in accordance with the Department of Transport Instruction to Surveyors notice 7/87 (reworked September 1994) effective from 21 September 1994, as reworked or superseded from time to time;

- "licence package" means those licences, permits or both issued in respect of a licensed fishing boat registration number under any Commonwealth or any State or Territory fisheries legislation;
- "licensed fishing boat" means a boat in respect of a fishing boat licence is held;
- "licensed fishing boat number" in respect of a licensed fishing boat means the letter and number allocated under Regulation 118 (3) of the Fish Resources Management Regulations 1995 in respect of the boat;
- "Northern Prawn Fishery" is the fishery described within the Northern Prawn Fishery Management Plan 1994, determined under the Fisheries Management Act 1991 of the Commonwealth;
- "trotline" means a main line suspended above the seabed between two vertical lines anchored to the seabed, one at each end of the mainline, to which hooks or branch lines with hooks are attached

Identification of the Fishery

3. The fishery to which this management plan relates is the fishing for all demersal scalefish by demersal line in all WA waters east of 120 degrees east longitude off the coast of north western Western Australia ("the Fishery").

Fishery Declared an Interim Managed Fishery

4. The Fishery is declared to be an interim managed fishery under section 56(1)(b)(ii) of the Act.

Commencement Date of the Fishery

- 5. (1) This management plan will commence on 1 January 1996.
 - (2) This management plan will have effect until 31 December 1996.

Persons Prohibited from Fishing in the Fishery

- 6. (1) A person other than—
 - (a) a person engaged in recreational fishing within the waters of the Fishery; or
 - (b) a person who—
 - (i) holds a commercial fishing licence issued under the Regulations; and
 - (ii) is fishing from an authorised boat

is prohibited from fishing in the Fishery.

- (2) To the extent that a method of fishing forms part of the Kimberley Gillnet and Barramundi Fishery and part of the Fishery, a person licensed in the Kimberley Gillnet and Barramundi Fishery may take or attempt to take fish in that part of the Fishery without obtaining a licence under this Management Plan, provided that the person complies with the requirements of the Kimberley Gillnet and Barramundi Management Plan 1989* and of any licence issued or renewed pursuant to that management plan.
- (3) To the extent that a method of fishing forms part of the North Coast Shark Fishery and part of the Fishery, a person licensed in the North Coast Shark Fishery may take or attempt to take fish in that part of the Fishery without obtaining a licence under this Management Plan, provided that the person complies with the requirements of the North West Coast Shark Fishing (Professional) Notice 1993** and of any licence issued or renewed pursuant to that management plan.
- (4) A person who contravenes subclause (1) commits an offence and for the purposes of Section 75 of the Act this clause is a major provision.

Use of Boats in the Fishery

- 7. (1) A person shall not use a boat in the Fishery—
 - (a) for commercial fishing for scalefish by demersal line unless the boat is a licensed fishing boat specified in an interim managed fishery permit and the person is fishing under the authority of that permit, or
 - (b) to carry demersal scalefish for a commercial purpose unless—
 - (i) that boat is a licensed carrier boat; or
 - (ii) that boat is an authorised boat and those fish have been taken by the use of that boat.
- (2) A person who contravenes subclause (1) commits an offence and for the purposes of Section 75 of the Act this clause is a major provision.

The Taking of Demersal Scalefish for Recreational Purposes within the Fishery

- 8. (1) A person who holds an authorisation to take prawns within the Northern Prawn Fishery or Kimberley Prawn Fishery may take or be in possession of two demersal scalefish (other than those species of fish mentioned in Part 1 of Schedule 1) by demersal line within the Fishery for immediate consumption.
- (2) A person fishing in accordance with subclause (1) shall not take or be in possession of a fish of a lesser or greater length (as the case may be) set opposite to the name of that species of fish in Part 2 of Schodule 1
- (3) A person who contravenes subclause (1) or (2) commits an offence and for the purposes of Section 75 of the Act this clause is a major provision.

Interim Managed Fishery Permits

- 9. The criteria that are to be satisfied by a person applying for an interim managed fishery permit in respect of the Fishery, before the Executive Director can grant a permit to that person, are that the applicant—
 - (a) is the holder(s) of a current fishing boat licence with a demonstrated fishing history, whilst fishing in respect of this boat licence over a period of at least two months of 1994, of taking at least 1000 kg of demersal scalefish by demersal line in the area east of 120 degrees east longitude off the north west coast of Western Australia; or
 - (b) was the holder of a Fishing Permit (Commonwealth) at 2 February 1995 allowing fishing by demersal line in the area east of 120 degrees east longitude off the north west of Australia and can demonstrate a history of taking, over a period of at least two months of 1994, at least 1000 kg of demersal scalefish by demersal line whilst fishing in this area; or
 - (c) is the holder of a current fishing boat licence whose operations were based in the area east of 120 degrees east longitude off the north west of Western Australia during at least the calendar years 1993 and 1994; and
 - can show a commitment and dependence on fishing for demersal scalefish in the area during at least this two year period; and
 - can demonstrate that at least 1000 kg of demersal scalefish has been caught whilst fishing by demersal line in respect of this licence in this area between 1 January and 30 June 1995.

Interim Managed Fishery Permit Entitlements

- 10. (1) The extent of entitlements conferred by interim managed fishery permits shall be fixed by the Executive Director.
- (2) Each interim managed fishery permit shall specify the entitlements as the type and number of demersal lines conferred by that permit.
- (3) Subject to subclause (4), the entitlement that is to be conferred by an interim managed fishery permit in respect of the Fishery when that permit is granted or renewed is the type of demersal line for which the person met the entry criteria specified in clause 9.
- (4) The maximum number of each type of demersal line which may be specified on an interim managed fishery permit is as follows—
 - (a) five handlines;
 - (b) five droplines;
 - (c) 1 longline;
 - (d) 1 trotline.
 - (5) The entitlement specified on an interim managed fishery permit shall not be exceeded.
- (6) A person who contravenes subclause (5) commits an offence and for the purposes of Section 75 of the Act this clause is a major provision.

Fees for Application and Issue of Interim Managed Fishery Permits

- 11. (1) The fee set out in Part 1 of Schedule 2 opposite a particular type of application is the fee to be paid to make that application.
- (2) The fee set out in Part 2 of Schedule 2 is the fee to be paid in respect of the grant or renewal of the interim managed fishery permit (as the case may be).

Period of Interim Managed Fishery Permit

12. An interim managed fishery permit in respect of the Fishery expires on 31 December.

Matters to be Specified on an Interim Managed Fishery Permit

- 13. (1) An interim managed fishery permit granted or renewed in respect of the Fishery shall specify the following—
 - (a) name and address of the permit holder;
 - (b) name of licensed fishing boat, licensed fishing boat number and length of any licensed fishing boat which may be used for fishing in the Fishery;
 - (c) the permit number;
 - (d) the date of expiry of the permit;
 - (e) the name of the interim managed fishery to which the permit refers;
 - (f) the type and maximum number of fishing gear to be used; and
 - (g) any conditions imposed on the permit.
- (2) The Executive Director may, at any time, by notice in writing given to the holder of an interim managed fishery permit for the Fishery vary or delete any condition imposed on the permit apart from those specified in this management plan, or add new conditions to the permit.

Non-Transferability of Permits

- 14. (1) An interim managed fishery permit granted in respect of the Fishery, or any entitlement granted in respect of a permit, may not be transferred.
- (2) If the holder of a licence package transfers all or any part of the licence package of which this interim managed fishery permit is a part, this permit shall lapse.

Boat Replacement Policy

15. (1) The holder of an interim managed fishery permit may apply to replace an authorised boat with another licensed fishing boat.

Regulation of Use of Fishing Gear

- 16. (1) A person must not carry on a boat or use demersal lines in the Fishery unless permitted to do so as specified on the interim managed fishery permit.
- (2) The use of mechanised hauling devices for hand or drop lines is prohibited unless authorised in writing by the Executive Director.
- (3) The use of metal snoods on droplines or longlines is prohibited unless authorised under the North Coast Shark Fishing (Professional) Notice 1993**.
 - (4) A person who contravenes this clause commits an offence.

Carrying of Observers or Research Personnel

- 17. (1) The holder of an interim managed fishery permit must carry observers or research personnel on board a boat for the purposes of research, monitoring or compliance programs if required by a Fisheries Officer.
 - (2) A person who contravenes this clause commits an offence.

Research Logbooks

- 18. (1) The holder of an interim managed fishery permit must keep a research logbook as approved by the Executive Director of the Fisheries Department of Western Australia.
 - (2) The holder of an interim managed fishery permit—
 - (a) must submit the completed pages of the logbook regarding the fishing activities carried out each month pursuant to the interim managed fishery permit; and
 - (b) must submit those pages regarding fishing activities carried out each month to the Research Division of the Fisheries Department (at Waterman) to arrive no later than the 15th day of the next month.
 - (3) A person who contravenes subclause (1) or (2) commits an offence.
- (4) The making of an entry or statement that is false or misleading in a logbook required to be kept or submitted under this management plan is prohibited.
- (5) A person who contravenes subclause (4) commits an offence and for the purposes of Section 75 of the Act this clause is a major provision.

The Purchase or Sale of Fish

- 19. (1) A person shall not, for gain or reward, purchase or sell or otherwise dispose of fish taken in contravention of this management plan.
- (2) A person who contravenes subclause (1) commits an offence and for the purposes of Section 75 of the Act this clause is a major provision.

Procedure before Amending the Management Plan

20. For the purposes of section 65 of the Act, the holders of interim managed fishery permits are specified as those persons to be consulted before this management plan is amended or revoked

Use of Carrier Boats

- 21. (1) The holder of an interim managed fishery permit, or persons acting on behalf of the holder, may not carry demersal scalefish within the area of the Fishery from another boat unless the appropriate authorisation is held.
- (2) In the case of an emergency, written approval to carry another fishing boat's demersal scalefish must be sought from the Officer-in-Charge, Fisheries Department, Broome.
- (3) A person who contravenes a condition of an authorisation given under subclause (1) or an approval given under subclause (2) commits an offence and for the purpose of section 75 of the Act this clause is a major offence.

Repeal of Notice No. 709

- 22. (1) The Kimberley Interim Demersal Line Fishery Notice 1995*** is hereby repealed.
