#### SPECIAL PROVISIONS

#### 1.0 Plan of Subdivision

- 1.1 Subdivision of Special Rural Zone Area No. 11 shall generally be in accordance with the Subdivision Guide Plan endorsed by the Shire Clerk.
- 1.2 Minor variations to the subdivision design, if approved by the Western Australian Planning Commission may be acceptable, but further breakdown of the lots created shall not be permitted.
- 1.3 The minimum lot size shall be 1.0 hectare.
- 1.4 Subdivision of Special Rural Zone Area No. 11 shall be staged as shown on the Subdivision Guide Plan endorsed by the Shire Clerk.

#### 2.0 Objectives of the Zone

The objective of Special Rural Zone Area No. 11 is to create rural residential retreats which blend in with the landscape, minimise visual impact from Nanazup and Prideaux Roads and minimise nutrient export from the site.

#### 3.0 Permitted Uses

- (a) Within Special Rural Area No. 7 the following uses are permitted:
  - Residential dwelling house
- (b) The following uses are not permitted unless specific approval is granted by Council:
  - Livestock Grazing;
  - Arts and Craft Manufacturing and sales only if produced on site
  - Cottage Industry
  - Country Kitchen
  - Bed & Breakfast establishment forming part of the dwelling and limited to 2 guest rooms
  - Home Occupation
  - Public Recreation
  - Public Utility
  - Stables
  - Viticulture
  - Other incidental or non-defined activities considered appropriate by Council which are consistent with the objective of the zone.

#### 4.0 Keeping of Livestock/Animals

- 4.1 Intensive agricultural pursuits such as piggeries and horticultural operations are not permitted.
- 4.2 The keeping of horses, sheep, goats and other grazing animals shall be subject to Special Provision 3.0. Animals shall be restricted to fenced areas of the lot to the satisfaction of Council. The Owner/Tenant shall be responsible for the construction and maintenance of stock proof fencing to protect native vegetation, and revegetation. Animal numbers shall not exceed the stocking rates recommended by the Department of Agriculture. Calculation of stocking rates shall be based on the internal dimensions of the fenced stock holding area. The keeping of animals shall not result in the removal or damage of revegetation and trees or result in soil degradation and dust pollution.

4.3 Where in the opinion of Council, the continued presence of animals on any portion of land is likely to contribute, or is contributing to the removal or damage of revegetation and trees, dust pollution or soil degradation, notice may be served on the owner of the said land, requiring immediate removal of those animals specified in the notice for a period specified in the notice.

When notice has been served on a landowner in accordance with this Clause the Council may also require the land to be fully rehabilitated within 3 months of serving the notice. In the event that such action is not undertaken, Council may carry out such works as are deemed necessary, with all costs being borne by the landowner.

#### 5.0 Location of Buildings and Structures

- 5.1 Buildings and structures shall not be constructed within the Development Exclusion Area, as shown on the Subdivision Guide Plan.
- 5.2 All buildings and structures shall be set back a minimum of 40 metres from the lot boundary abutting Nanarup Road and 15 metres from all other lot boundaries.
- 5.3 Buildings and structures shall be sited so as to allow a low fuel area, not less than 20 metres wide which does not encroach on any revegetation.
- 5.4 Fences shall not be permitted across Strategic Fire greaks.
- 5.5 All dams require the approval of Council prior to construction. The location of dams should be sited to avoid visual impact from Nanarup and Prideaux Roads, to the satisfaction of Council.

#### 6.0 Building Design, Material & Colour

- 6.1 Houses and outbuildings shall be designed and constructed of materials which allow them to blend into the landscape of the site. Council may refuse to approve walls and roofs constructed of reflective materials such as unpainted 'zincalume' and pale or 'off white' colours. Council will be supportive of walls and roofs having green, brown or red tonings in keeping with the amenity of the area.
- 6.2 Dwelling houses and all outbuildings shall not exceed 7.5 metres in height which is measured vertically from the natural ground level.
- 6.3 No boundary fencing shall be constructed of fibre cement, metal sheeting or wooden picket. If fencing is utilised, it should be of rural construction such as post and strand (or similar) to the satisfaction of Council.

#### 7.0 Vegetation Protection

- 7.1 No clearing of vegetation shall occur except for:
  - (a) clearing to comply with the requirements of the Bush Fires Act 1954 (as amended);
  - (b) clearing as may reasonably be required to construct an approved building and curtilage;
  - (c) trees that are dead, diseased or dangerous
  - (d) clearing to gain vehicular access to an approved dwelling or any other clearing which may be approved by the Council.
- 7.2 Revegetation shall be undertaken in accord with a Revegetation Plan approved by Council and as shown on the Subdivision Guide Plan. Revegetation shall be designed so as to minimise the visual impact of development from Nanarup and Prideaux Roads and provide for landscaping of highly visible cleared areas and the ridgeline.
- 7.3 Council's support for the subdivision of stages two and three shall be subject to the implementation of the approved revegetation plan, to Council's satisfaction, for the whole of Special Rural Zone Area 11.
- 7.4 Additional tree planting may be required as a condition of development approval.

#### 8.0 Water Supply

8.1 Potable water supplies shall be developed to the standards of Council, the Health Department of WA and the Water Authority of WA.

#### 9.0 Effluent Disposal

- 9.1 On-site effluent disposal shall be the responsibility of the individual landowners. The disposal of liquid and/or solid wastes shall be carried out with an effluent disposal system approved by Council and the Department of Health. Systems shall be designed and located to minimise nutrient export and/or release into any waterway or groundwater.
- 9.2 Council shall require the use of amended soil type effluent disposal systems, such as Eco max/ATU's in the following situations
  - where a 100 metre setback from a creek line or water course cannot be achieved;
  - where soil conditions are not conducive to the retention of nutrients;
  - in low lying areas; and
  - in areas where there is a perched winter water table.

- No effluent disposal system shall be permitted within a 50 metre setback from a creekline or watercourse.
- 9.3 Where the applicant is able to substantiate that a conventional septic system can be used without detrimental effect on the environment, it shall be set back a minimum of 100 metres from any natural permanent watercourse or water body and situated 2 metres above the highest known groundwater level.
