# HORTICULTURAL PRODUCE COMMISSION ACT 1988 STRAWBERRY GROWERS' COMMITTEE DIRECTIONS 1996

Given by the Horticultural Produce Commission.

#### Citation

1. These directions may be cited as the Strawberry Growers' Committee Directions 1996.

#### Commencement

2. These directions come into operation on the day on which they are published in the Government Gazette.

#### Interpretation

- 3. In these directions, unless the contrary intention appears
  - "strawberry grower" means a person who produces strawberries in Western Australia for sale:
  - "member" means a member of a committee and includes the chairperson;
  - "the Committee" means the Strawberry Growers' Committee established under section 11 of the Act.

#### Constitution of the Committee

4. Subject to the Act, there is to be a Committee consisting of 5 members appointed by the Commission, one of whom one is to be appointed by the Commission as chairperson.

#### Term of member

5. A member holds office for such term, not exceeding 3 years, as is fixed by the Commission.

#### Removal from office

6. The Commission may remove a member from office on the ground that that member is mentally or physically incapable of performing the duties of a member, or for incompetence, neglect of duty or misconduct.

#### Vacation of office

- 7. The office of a member becomes vacant if the member
  - (a) dies:
  - (b) is absent from 4 consecutive meetings of the Committee without the permission of the Committee;
  - (c) is an undischarged bankrupt or a person whose property is subject to an order or arrangement under the laws relating to bankruptcy; or
  - (d) is removed from office by the Commission under direction 6.

#### Casual vacancy

- 8. (1) Where an office of a member of the Committee becomes vacant otherwise than by effluxion of time, the Commission is to appoint a person to take the place of the person who has vacated the office.
- (2) A person appointed under subdirection (1) holds office for the balance of the term of the member whose place he or she takes.

#### Disclosure

- 9. (1) A member of the Committee who has a direct or an indirect pecuniary interest in a matter being considered or about to be considered at a meeting of the Committee must, as soon as possible after the relevant facts have come to his or her knowledge, disclose his or her interest at a meeting of the Committee.
- (2) A disclosure under subdirection (1) is to be recorded in the minutes of the meeting of the Committee and the member must not, unless the meeting otherwise determines
  - (a) be present during any deliberation of the Committee with respect to that matter; or
  - (b) take part in any decision of the Committee with respect to that matter.
- (3) For the purpose of the making of a determination by the Committee under subdirection (2), in relation to a member who has made a disclosure under subdirection (1), a member who has a direct or an indirect interest in the matter to which the disclosure relates must not
  - (a) be present during any deliberation by the Committee for the purpose of making that determination; or
  - (b) take part in the making by the Committee of that determination.

#### Meetings

- 10. (1) The chairperson is to convene the first meeting of the Committee and from then on, subject to subdirection (2), meetings may be held at such times and places as the Committee determines.
- (2) A special meeting of the Committee may at any time be convened by the chairperson of the Committee.
- (3) The chairperson of the Committee presides at any meeting of the Committee at which the chairperson is present and, in the absence of the chairperson, the members present are to elect one of their members to preside.
  - (4) At a meeting of the Committee, 3 members constitute a quorum.
- (5) At any meeting of the Committee the member presiding at the meeting has a deliberative vote, and in the case of an equal number of votes being cast for and against any question, has a casting vote.

#### Resolution without meeting

11. A resolution in writing signed or assented to by letter, or electronic means of communication, by each member of the Committee is as valid and effectual as if it had been passed at a meeting of the Committee.

#### **Procedures of the Committee**

12. Except to the extent that they are prescribed or as set out in these directions, the Committee may determine its own procedures.

#### STATE SUPPLY COMMISSION ACT 1991

STATE SUPPLY COMMISSION AMENDMENT REGULATIONS 1995

Made by the Lieutenant-Governor and deputy of the Governor in Executive Council.

#### Citation

1. These regulations may be cited as the State Supply Commission Amendment Regulations 1995.

#### Principal regulations

- 2. In these regulations the State Supply Commission Regulations 1991\* are referred to as the principal regulations.
  - [\* Published in Gazette of 13 March 1992 at pp. 1206-7. For amendments to 2 November 1995 see 1994 Index to Legislation of Western Australia, Table 4, p. 269.]

#### Regulation 1A inserted

3. After regulation 1 of the principal regulations the following regulation is inserted —

#### Interpretation

1A. In these regulations -

"accountable officer" of a public authority means the chief executive officer or other officer of that public authority appointed as such under section 52 of the Financial Administration and Audit Act 1985.

#### Regulation 5 inserted

4. After regulation 4 of the principal regulations the following regulation is inserted —

#### Consequences of non-compliance with supply policies

- 5. Where the Commission is of the opinion that a public authority is not complying with a supply policy or a direction supplementing a supply policy the Commission may, in addition to any action which may be taken under any other enactment, take one or more of the following actions
  - (a) give to the public authority notice in writing specifying the manner in which the public authority is failing to comply and
    - (i) detailing the measures to be taken by the public authority to comply with the policy or direction; and
    - (ii) specifying the period within which the measures referred to in subparagraph (i) are to be taken;
  - (b) require an accountable officer of the public authority to attend at a meeting of the Commission to answer questions or give information relating to the supply procedures of the public authority;

- (c) appoint an officer, employee or representative of the Commission to supervise and advise the public authority on its supply procedures and require the public authority to reimburse the Commission for the costs of providing the services of that officer, employee or representative;
- (d) publish in the annual report submitted by the accountable authority of the Commission under section 66 of the Financial Administration and Audit Act 1985 the name of the public authority and the manner in which that public authority has failed to comply;
- (e) recommend to the Minister that the exemption of the public authority under section 20 of the Act be cancelled.
