WILDLIFE CONSERVATION ACT 1950

WILDLIFE CONSERVATION (CLOSE SEASON FOR WHALE SHARKS) NOTICE 1996

Made by the Minister under section 14 (2) (a).

Citation

1. This notice may be cited as the *Wildlife Conservation (Close Season for Whale Sharks) Notice 1996*.

Object of this notice

2. The object of this notice is to allow limited interaction between humans and whale sharks in State waters, while protecting whale sharks from disturbance and molestation, by setting out acceptable approach distances, etc., for vessels, swimmers and divers when in proximity to a whale shark, and to prevent some other activities that may disturb whale sharks.

Interpretation

3. (1) In this notice—

“**contact vessel**” means a vessel, and any tender vessel accompanying the vessel, within a contact zone;

“**contact zone**” means the area within a radius of 250 metres of any whale shark that is in State waters;

“**whale shark**” means the fauna *Rhincodon typus*.

(2) It is the responsibility of the person in charge of a vessel to comply with a requirement placed on that vessel by this notice.

Declaration of a close season

4. (1) Subject to clauses 5 to 14, a close season is declared in respect of whale sharks in all State waters.

(2) The close season is for the period commencing on the day on which this notice is published in the *Government Gazette* until the day on which this notice is cancelled or this clause is varied by a notice under section 14 (2) (b) of the Act.

Restriction on number of vessels in or near contact zone

5. (1) A vessel must not enter a contact zone if another vessel is in the contact zone.

(2) If a vessel is in a contact zone and a second vessel is within 400 metres of the relevant whale shark, any other vessels must maintain a distance of at least 400 metres from that whale shark.

Restriction on period in contact zone

6. A contact vessel must not remain in the same contact zone for longer than 90 minutes.

Restriction on vessel speed in contact zone

7. (1) Subject to subclause (2), a contact vessel must not exceed 8 knots in a contact zone.

(2) If, for reasons of safety, a contact vessel must exceed 8 knots in a contact zone, that vessel must leave the contact zone as soon as is practicable.

Proximity of contact vessel to whale shark

8. A contact vessel must at all times maintain a distance of at least 30 metres from the nearest whale shark.

Direction of approach

9. If swimmers or divers are to enter the sea from a contact vessel to view a whale shark, the contact vessel must approach a whale shark from the opposite direction of travel to the whale shark's direction of travel.

Physical contact with whale sharks prohibited

10. Subject to clause 12, a person must not touch or ride on, or attempt to touch or ride on, a whale shark.

Proximity of swimmers or divers to whale shark

11. Subject to clause 12, a person in the sea must at all times maintain a distance of at least—
- (a) 3 metres from the head or body of a whale shark, when approaching a whale shark from any direction; and
 - (b) 4 metres from the tail of a whale shark, when approaching the tail from any direction.

Exception when authorized under the Act

12. Clauses 10 and 11 do not apply to a person who is authorized under the Act to make physical contact with a whale shark, if that contact is in accordance with the authorization (*eg. authorized under a scientific licence*).

Motorized swimming or diving aids, and other aids, prohibited

13. (1) A person must not use a submersible motorized or otherwise powered swimming or diving aid in a contact zone.

(2) A person must not use any device capable of towing or carrying a person, that is towed behind a vessel, in a contact zone.

Other taking, etc., of whale sharks prohibited

14. (1) A person must not capture, disturb, molest or take in any other way, a whale shark unless that person does so in accordance with this notice and the *Wildlife Conservation Act 1950*, or unless it is lawful for that person to do so—

- (a) under the *Fish Resources Management Act 1994*; or
- (b) under the *Conservation and Land Management Act 1984*.

(2) To the extent that this notice and the *Wildlife Conservation (Fauna of Ningaloo Marine Park) Notice 1992** are inconsistent, this notice prevails.

FB301**FIRE BRIGADES ACT 1942****FIRE BRIGADES (ESPERANCE FIRE DISTRICT) ORDER 1996**

Made by His Excellency the Governor in Executive Council under section 5.

Citation

1. This order may be cited as the *Fire Brigades (Esperance Fire District) Order 1996*.

Esperance Fire District

2. The boundaries of the Esperance Fire District are adjusted so that the boundaries are in accordance with the description in Schedule 1.

Schedule 1

[Clause 2]

ESPERANCE FIRE DISTRICT

All that portion of land bounded by lines starting from the intersection of the low water mark of the Southern Ocean with the prolongation southerly of the centreline of Dunn Street and extending northerly to and along that centreline and onwards to the centreline of Stewart Street; thence southwesterly along that centreline to the prolongation southerly of the western boundary of Esperance Location 69 (Reserve 27626); thence northerly to and northerly and easterly along western and northern boundaries of that location to the southwestern corner of Location 64 (Reserve 27626); thence northerly along the western boundary of that location and onwards to the centreline of Thompson Street; thence northwesterly along that centreline to the centreline of Connolly Street (Road Number 15208); thence generally northwesterly along that centreline to the centreline of Cherry Well Road (Road Number 17816); thence generally northwesterly along that centreline to the prolongation southerly of the southernmost eastern boundary of Location 333; thence northerly to and northerly, easterly and again northerly along boundaries of that location to the southeastern corner of Location 94; thence northerly along the eastern boundary of that location and onwards to the centreline of Pink Lake Road; thence generally south-easterly along that centreline to the prolongation southerly of the eastern boundary of Location 4 (Reserve 3473); thence northerly to and northerly along that boundary and the eastern boundaries of Locations 170 and 2 (Reserve 3473) to the westernmost northwest-

ern corner of Location 180; thence easterly, northerly, southeasterly and southerly along boundaries of that location to the prolongation northwesterly of a northeastern side of Rouse Street; thence southeasterly to and along that side to the northwestern corner of Location 117; thence easterly along the northern boundary of that location to the southeastern corner of Location 122; thence northerly, westerly and again northerly along boundaries of that location and onwards to the centreline of an unnamed road passing along the southwestern boundary of Lot 1 of Locations 126 and 125, as shown on Land Titles Office Diagram 70181; thence southeasterly along that centreline and onwards to the centreline of Sims Street; thence northerly, generally northeasterly and easterly along that centreline to the prolongation southerly of the westernmost western side of Beckwith Street; thence northerly to and along that side to the southwestern corner of Lot 626 of East Location 21, as shown on Land Titles Office Diagram 69093; thence northerly, easterly and southerly along boundaries of that lot to the prolongation westerly of the northern boundary of Lot 495, as shown on Land Titles Office Diagram 59402; thence easterly to and along the northern boundaries of that lot and Esperance Lot 833 (Reserve 35641) to the western side of Harbour Road (Road Number 13801); thence northerly along sides of that road to the southern corner of Lot 630 of East Location 21, as shown on Land Titles Office Plan 15913; thence northerly along the western boundary of that lot to the southern boundary of Lot 764, as shown on Land Titles Office Diagram 76121; thence westerly and generally northerly along boundaries of that lot and onwards to the centreline of Stable Road; thence generally easterly along that centreline and onwards to and easterly along the centreline of Frearson Street and again onwards to the eastern side of Clare Road; thence southerly along that side to a northeastern side of Fisheries Road (Road Number 4125); thence generally northwesterly along sides of that road to the eastern corner of Lot 112 of East Location 22, as shown on Land Titles Office Plan 19063; thence southeasterly to the northeastern corner of Lot 48 as shown on Land Titles Office Plan 12389; thence southeasterly to the westernmost northwestern corner of Lot 64, as shown on Land Titles Office Diagram 80539; thence southeasterly along the southwestern boundary of that lot to the northernmost northwestern corner of Esperance Lot 881 (Reserve 39635); thence southwesterly, southeasterly, northeasterly, again southeasterly, again southwesterly, northwesterly, again southwesterly, again southeasterly, again southwesterly and southerly along boundaries of that lot and onwards to the low water mark of Esperance Bay; thence generally southwesterly, generally southeasterly, generally northeasterly and again generally southwesterly along that mark to the low water mark of the Southern Ocean and thence generally westerly along that mark to the starting point.

RETAIL TRADING HOURS ACT 1987 PETROL ROSTER ORDER (No. 1) 1996

Made by the Minister for Fair Trading.

Citation

1. This Order may be cited as the Petrol Roster Order (No. 1) 1996.

Commencement

2. This Order shall come into operation on 9 March 1996.

Petrol Roster

3. Shopkeepers of zoned filling stations specified in the Schedule shall be open during the days and times respectively specified in that Schedule for the sale of fuel and requisites.

Fuel and Requisites to be sold

4. All forms of fuel and the following requisites, namely—

- (a) oil;
- (b) lubricants;
- (c) tyres;
- (d) batteries;
- (e) distilled water; and
- (f) such other requisites as the shopkeeper has in stock at the filling station,

shall be sold by shopkeepers of zoned filling stations specified in the Schedule during the days and times so specified.

Revocation

5. The Petrol Roster Order (No. 5) 1995 [published in the *Gazette* on 12 January 1995 at pp 102-103] is hereby revoked.

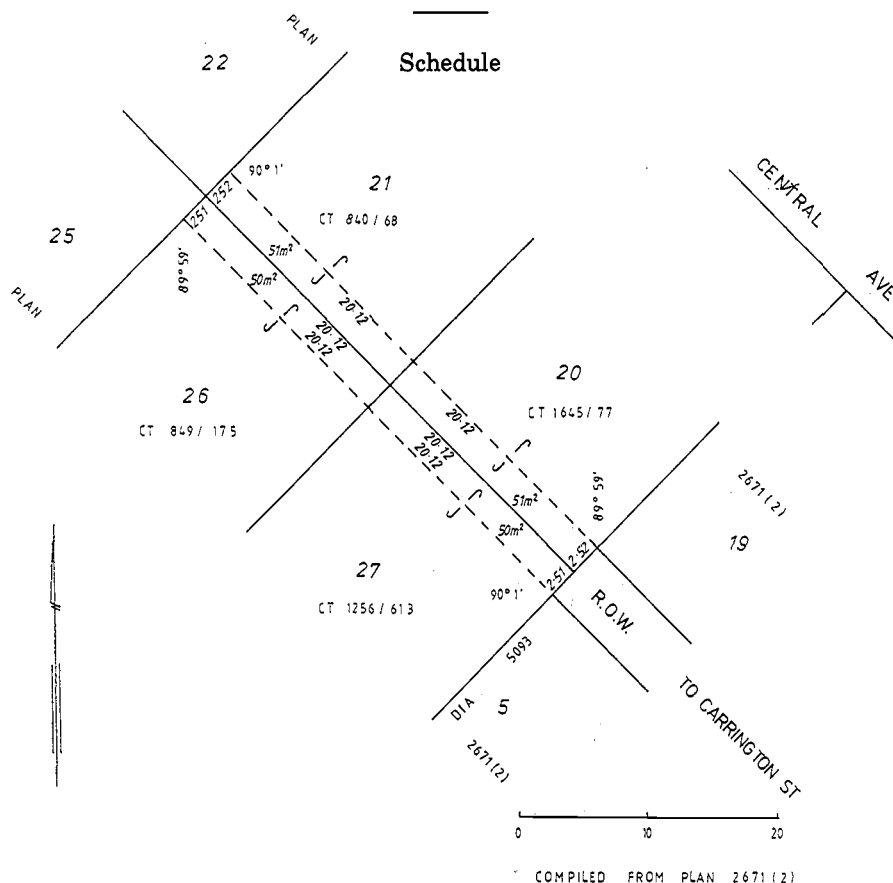
