LOCAL GOVERNMENT ACT 1960

THE MUNICIPALITY OF THE SHIRE OF RAVENSTHORPE

By-law Relating to Parks, Reserves and Foreshores

In pursuance of the powers conferred upon it by the abovementioned Act, and of all other powers enabling it, the Council of the abovementioned Municipality, hereby records having resolved on 20th September 1990 to make and submit for confirmation by the Government the following by-law—

1. In this by-law unless the context otherwise requires—

"Act" means the Local Government Act 1960;

"Authorised Officer" means an Officer of the Council who is authorised by the Council to serve notices under sections 669C and 669D of the Act;

"Building" is as defined by the Act;

- "Council" means the Council of the Municipality of the Shire of Ravensthorpe;
- "Foreshore" means all the land contiguous to the Shire of Ravensthorpe which lies between the low water mark and the high water mark of the Southern Ocean and is applicable only to the lands listed in the Third Schedule.
- "Owner" in relation to a vehicle means the person who is the holder of the requisite vehicle licence under the Road Traffic Act 1974 in respect of that vehicle, or, if the vehicle is not licensed under that Act, the person who owns the vehicle or is entitled to its possession.
- "Reserve" means the public Reserves or Parks vested in or under the care, control or management of the Shire of Ravensthorpe as listed in the Third Schedule but does not include a road reserve.
- "Vehicle" has the same meaning as is given to that word in the Road Traffic Act 1974 (as amended) from time to time but includes trail bikes, beach buggies and other recreational vehicles whether licensed or unlicensed but does not include a wheelchair being used by a physically impaired person.
- 2. (1) On a reserve or a foreshore a person shall not—
 - (a) throw or discharge any stone, arrow, bullet or other missile;
 - (b) commit or cause a nuisance;
 - (c) behave in a disorderly manner, create or take part in a disturbance, use foul or indecent language or commit any act of indecency;
 - (d) climb over or upon a fence or gate;
 - (e) destroy, damage, injure or cause harm to any bird or animal;
 - (f) damage or injure any plant, lawn, flower, shrub or tree;
 - (g) cut or damage any soil or turf;
 - (h) deposit or leave any rubbish, refuse, offal, paper, bottles, broken glass, china or litter of any kind whatsoever except in a receptacle provided for the purpose;
 - (i) alter, damage, deface or remove any part of any building, structure or water system.

except where a person is carrying out duties as directed by Council.

3. A person shall not without the consent of the Council-

- (a) drive or ride or bring any vehicle onto or permit any person to drive or ride or bring any vehicle onto a reserve except on or over such parts of the reserve as are set aside as roads or driveways or vehicle parking areas or onto reserves designated for use by recreational vehicles;
- (b) drive or ride or bring any vehicle onto or permit any person to drive or ride or bring any vehicle onto Reserve 35379 except for the purpose of launching boats in designated areas;
- (c) park or stand any vehicle on a reserve except in an area set aside for that purpose.
- 4. On a reserve or foreshore a person shall not without the consent of the Council: -
 - (a) sell, expose for sale or invite any offer to buy any goods, wares, food refreshments, fruit or other merchandise or things (whether of the like kind as the foregoing or not), except in an area set apart for the purpose by the Council and then only with the prior consent of the Council;
 - (b) hire, expose for hire, or invite any offer to take on hire any vehicle, boat or other vessel or thing (whether of the like kind as the foregoing or not), except in an area set apart for the purpose by the Council and then only with the prior consent of the Council;
 - (c) play or practice golf or strike a golf ball except on an area set aside for that purpose;
 - (d) take part in a procession or demonstration;
 - (e) organise, address or participate in a political meeting or rally;
 - (f) use or install a loud speaker or amplifier;
 - (g) distribute or exhibit any printed or written pamphlet, hand bill, placard or notice in any manner whatsoever;
 - (h) stamp, stencil, affix, construct or erect or cause to be stamped, stencilled, affixed, constructed or erected any signboard, hoarding, placard, hand bill, notice, advertisement or document whatsoever;
 - (i) light a fire other than in a fire place provided for the purpose where fire places are provided;
 - (j) erect a tent or any other temporary cover for the purpose of entertainment or for the display of any merchandise;
 - (k) unlock or fasten any gate;
 - (1) erect, place, alter or relocate any building, fence, gate, garden furniture, playground equipment, goal post, goal net or flood lighting equipment.

5. On a reserve a person shall not practice or play any game in such a way as to cause inconvenience or annoyance to any other person.

6. No person shall on any Foreshore or Reserve, willfully obstruct, disturb, interrupt, or annoy any other person engaged in the proper use thereof of any Foreshore or Reserve.

- 7. (a) In this clause reference to an "animal" does not include a dog.
 - (b) The Council may set aside a reserve or foreshore or portion of a reserve or foreshore as an area upon which a person may ride or drive an animal or onto which a person may bring an animal.
 - (c) A person shall not ride or drive or bring an animal onto any reserve or foreshore or any part thereof that has not been set aside for that purpose pursuant to subclause (b) of this clause.
 - (d) A person shall not ride, drive, graze or tether, exercise, train or race any animal on any part of a reserve or foreshore set aside under subclause (b) of this clause in a manner so as to create or become a nuisance.
- 8. (a) The Council may set aside a reserve or portion of a reserve as an area on which persons may operate any motorised or radio controlled model aeroplane, vehicle or vessel and the Council may define or limit the hours and days which such models may be operated.
 - (b) A person shall not operate any motorised or radio controlled model aeroplane, vehicle or vessel on a reserve or portion of a reserve that has not been set aside pursuant to subclause (a) of this clause or at a time or on a day defined or limited by the Council under subclause (a) of this clause.

9. The Council may set aside a reserve or portion of a reserve as a children's playground.

- 10. (a) In Clauses 10, 11 and 12 of this by-law the term "function" means and includes any concert, fete, show, exhibition, gymkhana, sport, match or test between opposing teams in any game or any single social gathering consisting of more than 20 persons.
 - (b) No person shall organise, arrange or take part in any function on a reserve or foreshore unless a permit to hold or organise that function has been granted by the Council or the lessee of the ground.
 - (c) The Council may grant a permit to a person to hold a function on a reserve or foreshore subject to such conditions as it sees fit. This permit shall be in the form of the second schedule form 2.
 - (d) A permit to hold a function on a reserve or foreshore shall specify: -
 - (i) the purpose for which such permit is granted;
 - (ii) the dates and times during which the function may be held;
 - (iii) the portions of the reserve or foreshore allocated to the permit holder;
 - (iv) the Council reserves the right to demand the lodgements in cash of a security bond of up to \$400 for any function or series of functions.
 - (e) No person issued with a permit to hold a function shall be authorised to use any building or structure except those open for public use on any reserve or foreshore unless such permission is expressly granted and stated under the conditions of the permit.

11. Subject to Clause 12, no person to whom a permit has been granted shall exclude any member of the general public from attending a function if such person requests admission and pays any required admission charge.

- 12. (a) No person visibly under the influence of alcohol or acting in a riotous or disorderly manner shall attend a function;
 - (b) A person to whom a permit has been granted shall take all possible action to prevent persons under the influence of alcohol or persons acting in a riotous or disorderly manner from attending a function.

13. If the Council is satisfied that the person to whom a permit has been granted has committed or permitted or authorised the commission of a breach of any of the terms or conditions of the permit or has committed a breach of the by-law, may by a notice in writing to such person, cancel the permit and thereupon the permit shall be null and void.

- 14. (a) The Council may in writing under the hand of the Shire Clerk appoint an officer or officers to carry out the powers and duties conferred by this by-law, including authorisation to serve notices under sections 669C and 669D of the Act.
 - (b) Any officer appointed under this clause shall on demand show an identification card and/or certificate of appointment.

15. A person shall not hinder or interfere with an officer appointed under Clause 14 of this by-law in the course of that officer's duties.

16. A person who does not do a thing which by or under this by-law he is required or directed to do and a person who does a thing which by or under this by-law is prohibited from doing, commits an offence.

17. A person who commits an offence against this by-law is liable on conviction to a maximum penalty of \$500.00.

18. In Clauses 19 and 20 "offence" means an offence of which the use, driving, parking, standing or leaving of a vehicle is an element.

19. The modified penalty for an offence against Clause 3 of this by-law if dealt with under section 669D of the Act, is \$30.00.

- 20. (a) A notice served under subsection (2) of section 669C of the Act in respect of an offence against this by-law shall be in or to the effect of Form 1 of the first schedule of this by-law.
 - (b) Subject to subclause (c) of this clause an infringement notice served under section 669D (1) of the Act in respect of an offence alleged to have been committed against Clause 3 of this by-law shall be in or to the effect of Form 2 of the first schedule of this by-law.
 - (c) An infringement notice served under section 669D (2) of the Act in respect of an offence against Clause 3 of this by-law shall be in or to the effect of Form 3 of the first schedule of this by-law.

FIREBREAK NOTICE

Notice to all Owners and/or Occupiers of land in the Shire of Broome

Pursuant to the powers contained in Section 33 of the above Act, you are hereby required on or before 1 May 1996 and thereafter up to and including 31 December 1996 to have firebreaks clear of all inflammable material in accordance with the following—

- (a) Rural lands, being all land outside townsites and not being land held under pastoral lease, firebreaks are required to be—
 - 1. not less than four metres wide inside, along and with 10 metres of the external boundaries,
 - 2. not less than three metres wide and within three metres of the perimeter of all boundaries and/or haystacks, or groups of buildings
 - 3. Any tree within two metres of firebreak that may compromise the firebreak must be lopped.
- (b) Pastoral lands, being all land outside townsites held under pastoral lease, fire breaks are required to be not less than three metres wide and within three metres of the perimeter of all haystacks, buildings or groups or buildings.

- 1.0 Plan of Subdivision
 - 1.1 Subdivision of the subject land shall generally be in accordance with the Subdivision Guide Plan endorsed by the Shire Clerk.
 - 1.2 Minor variations to the subdivisional design if approved by the Western Australian Planning Commission may be acceptable.
 - 1.3 The minimum lot size shall be Four (4) hectares.

2.0 Objective of Zone

2.1 Within the Special Rural Zone Area No. 10 the objective is to provide for low density rural retreats, conserve existing remnant vegetation, protect the underground water resource, contain all nutrients within the site, minimise the visual impact of new development and allow for low intensity rural pursuits.

- 3.0 Landuse
 - 3.1 Within Special Rural Zone Area No. 10 the following uses are permitted.
 Rural Residential Dwelling
 - 3.2 The following uses may be permitted subject to the special approval of Council.
 - Livestock Grazing
 - Home Occupation
 - Stables
 - Public Utility
 - Cottage Industry
 - Other incidental or non defined activities considered appropriate by council which are consistent with the objective of the zone.
 - 3.3 All other uses not mentioned under 3.1 or 3.2 are not permitted and with the intention of preventing land degradation and practices detrimental to the environmental amenity of the zone, this includes the keeping of any animals considered detrimental by Council.

4.0 KEEPING OF LIVESTOCK/ANIMALS

- 4.1 Intensive agricultural pursuits such as piggeries and horticultural operations are not permitted.
- 4.2 The keeping of horses, sheep, goats and other grazing animals shall be subject to the prior approval of the Council and these animals shall be restricted to fenced areas of the lot to the satisfaction of Council. The Owner/Tenant shall be responsible for the maintenance of stock proof fencing to protect remnant vegetation and revegetation areas. The keeping of animals shall not result in the removal or damage of significant vegetation and trees or result in soil degradation or dust pollution.

Where, in the opinion of Council, the continued presence of animals on any portion of land is likely to contribute, or is contributing to dust pollution, soil degradation or the removal of significant vegetation, notice may be served, on the owner of the said land, requiring immediate removal of those animals specified in the notice.

When notice has been served on a landowner in accordance with this Clause the Council may also require the land to be fully rehabilitated within three (3) months of serving the notice.

In the event that such action is not undertaken, Council may carry out such works as are deemed necessary, with all costs being borne by the landowner.

5.0 LOCATION OF BUILDINGS AND STRUCTURES

- 5.1 Buildings, tanks and structures shall not be constructed within the "Development Exclusion Area" denoted on the Subdivision Guide Plan.
- 5.2 All buildings and structures shall be setback a minimum of 150 metres from the lot boundary abutting Pt Lot 66 and 15 metres from all other lot boundaries.
- 5.3 Buildings shall be sited to allow a low-fuel area not less than 20 metres wide, which does not encroach any Development Exclusion Area that is located on a ridge line.
- 5.4 Fences shall not be permitted across strategic fire breaks.

6.0 BUILDING DESIGN MATERIALS AND COLOUR

- 6.1 Dwellings and outbuildings shall be designed and constructed of materials which allow them to blend into the landscape of the site. Council shall refuse to approve walls and roofs constructed of reflective materials such as unpainted 'zincalume' and 'off- white' colours. Council will be supportive of walls and roofs with green, brown or red tonings in keeping with the amenity of the area.
- 6.2 Dwelling houses and all outbuildings shall not exceed 7.5 metres in height which is measured vertically from the natural ground level.
- 6.3 No boundary fencing shall be constructed of fibre cement, metal sheeting or wooden picket. If fencing is utilised, it should be or rural-construction such as post and strand (or similar) to the satisfaction of Council.
- 6.4 Water tanks shall be painted or coloured an appropriate shade of brown or green or suitably screened with vegetation to the satisfaction of Council.

7.0 VEGETATION PROTECTION AND REVEGETATION

7.1 No clearing of vegetation shall occur except for:

- (a) clearing to comply with the requirements of the Bush Fires Act 1954 (as amended);
- (b) clearing as may reasonably be required to construct an approved building and curtilage;
- (c) trees which are dead, diseased or dangerous;
- (d) clearing to gain vehicular access to an approved dwelling or any other clearing which may be approved by the Council.

7.2 Council may request the Commission impose a condition, at the time of subdivision, requiring the revegetation of Special Rural Zone Area 10, as shown on the Subdivision Guide Plan.

The subdivider shall maintain such revegetation for a period of at least three years from the release of titles or enter into a bonding guarantee with Council to ensure the maintenance of the revegetation.

- 7.3 Council may request the Commission to impose a condition at the subdivision stage requiring the protection by stock proof fencing of significant remnant vegetation, revegetation areas and ridgelines, as shown on the Subdivision Guide Plan.
- 7.4 Additional tree planting may be required as a condition of development approval.
- 8.0 WATER SUPPLY

Where lots are not serviced by a reticulated water supply, each dwelling house shall be provided with a water supply with a minimum capacity of 92,000 litres. This may be supplied from Water Authority of WA licensed underground water supplies or rainwater storage systems to the satisfaction of Council and the Health Department of Western Australia.

9.0 EFFLUENT DISPOSAL

- 9.1 Effluent disposal shall be the responsibility of the individual landowner and shall be effected by a septic or other approved waste disposal system to the specification of Council.
- 9.2 Effluent disposal systems shall be set back a minimum of 100 metres from groundwater extraction wells and located 2 metres above the highest known groundwater level.
- 9.3 No more than one effluent disposal system will be permitted per lot .

10.0 BUSHFIRE MANAGEMENT AND CONTROL

- 10.1 Council may request the Commission to impose a condition at the subdivision stage for the provision and construction of Strategic Fire Breaks to the satisfaction of Council and the Bush Fires Board.
- 10.2 Strategic Fire Breaks shall be designed and constructed so as to avoid erosion impacts.
- 10.3 Where a lot is traversed by a Strategic Firebreak as shown on the Subdivision Guide Plan, the owner of the lot shall maintain such firebreak to the satisfaction of Council. Access along the strategic firebreak shall remain available at all times. Gates across the strategic firebreak shall only be permitted at the discretion of and to the satisfaction of Council and the Bushfires Board. Such gates shall not be locked.
- 10.4 Low fuel buffers, at least 20 metres wide shall be established and maintained around all buildings.
- 10.5 In cases where only part of the area is developed, Council may request the Commission to impose a condition at the subdivision stage requiring that an alternative fire break system or strategic fire break system be prepared and put in place, to the satisfaction of Council and the Bushfires Board.
- 10.6 Council may request the Commission to apply a condition at the subdivision stage requiring a financial contribution for the provision of fire suppression and prevention equipment and measures in the locality. Council will facilitate discussions between the subdivider and the Bush Fires Board to determine said financial contribution.
- 10.7 Council may request the Commission to impose a condition at the subdivision stage requiring that water for fire fighting purposes be available. This may take the form of a minimum 25 000 litre storage tank (including a continuous fill mechanism) capable of providing 450 litres per minute at the outlet or standpipe.

- 7. Removing Lots 5, 6, 7 and 8 Johnston Road from the "Light Industry" zone and including the land within the "Public Purpose-Recreation" reserve.
- 8. Including portions of the land, the subject of the amendment within a Policy Precinct (Special Design) designated "Precinct Yarloop 1".

Amending the Scheme Text by—

- 1. Amending Clause 4.2 (Places of Heritage Value) by the insertion of a new Clause 4.2.12 (Precinct Yarloop 1) to read as follows—
 - "4.2.12 POLICY PRECINCTS (SPECIAL DESIGN)
 - 1. PRECINCT YARLOOP 1 (P.Y.1)

The following Building Design Guidelines shall apply to the construction of new dwellings and other buildings on land contained within the Precinct Yarloop 1 Area (PY1) as outlined on the Scheme Map.

The objective of the Precinct-

- to encourage development which is sympathetic in design and appearance to the traditional Mill housing within the townsite.
- a. Scale and Proportion

Traditionally, buildings associated with mill towns have a greater height to width ratio. There is a strong vertical element of roof pitch, verandah, door and window details. Ceiling heights average 2.7 metres.

b. Roof

A pitch in excess of 26° is common, with the use of corrugated iron material. Additions and new buildings should use similar roof shapes, pitches and materials to existing buildings. Use of custom orb steel sheeting (colorbond) is an acceptable alternative to corrugated iron.

- c. Wall cladding
 - Horizontal weatherboards (or a similar material which is acceptable to Council) which replicates the traditional profiles will be a requirement of Council.
 - Council will consider applications for the development of buildings which may not comply with the above requirement but which exhibit traditional design and/ or materials consistent with the general provisions of these guidelines.
- d. Windows and Doors
 - Critical to maintain consistency.
 - Use of timber frames with a vertical emphasis.
 - Large window area in relation to the balance of walls is not permitted.
 - Aluminium frames for windows and doors is to be discouraged, where they are specially fabricated to replicate the traditional timber windows, they may be approved.
- e. Verandahs
 - Verandahs are to be a traditional split pitch skillion roof.
 - Enclosure of verandah on the front elevation is to be discouraged.
- f. Fences
 - Use of shaped post and rail with or without cyclone mesh wire, or timber pickets is recommended.
 - No fibro cement, solid materials or brick walls will be permitted.
- g. General
 - Retain existing vegetation (mature trees) and natural landform features to the fullest extent possible, and replant local native vegetation.
 - Colours and materials—use of natural traditional tones of low reflective quality. Colours may include olive, ochre, light brown, fawn, greys, blue-greys.
 - Solar access-improvements in thermal comfort and reduced cooling and heating costs can occur through careful orientation and siting of buildings. This may also be achieved by design of windows, verandahs and material choice.

• Council will require an application for single dwelling be the subject of an application for planning approval in accordance with the provisions of the Scheme, adhere as closely as possible to the intent of the Policy Statement and to the Development Guidelines, and Council when considering the application may negotiate with the applicant means of carrying out the development in order to achieve the Council's objective.

- 2. In Table I—Zoning Table, a new Use Class 13A—"Commercial Vehicle Parking" and making this a—
 - (i) 'P' Use in Special (Rural) Industry, Light Industry, High Wycombe Light Industry and General Industry zones;
 - (ii) "AA" use in Residential, Service Station, Rural, Private Clubs and Institutions, Special Residential, Special Wattle Grove, Rural Agriculture, Rural Conservation, Rural Landscape Interest, Rural Living, Residential Bushland and Service Commercial Zones with a footnote "15" in Table 1 for Rural Agriculture, Rural Conservation, Rural Landscape Interest, Rural Living, Rural, Special Rural and Special Wattle Grove zones which states that "Commercial Vehicle Parking of more than one commercial vehicle is permitted without reference to Council if it can be demonstrated that such vehicle(s) are used in connection with approved agriculture or horticulture operations on the subject land"; and a footnote "16" for Residential zone which states that "Commercial Vehicle Parking is prohibited in residential areas coded R20 and above";

- (b) Council shall seek opinions from affected landowners before any decision on an application to park a commercial vehicle is made.
- (c) Council reserves the right to amend the conditions of an approval or to revoke an approval to park a commercial vehicle (i) as a result of a justified complaint received or (ii) due to changes (or potential changes) of the zoning, subdivision or development of the subject or nearby land.
- (d) If a commercial vehicle owner who has been granted Council approval to park a commercial vehicle on a lot wishes to replace the vehicle with another commercial vehicle, a further application to Council is required, except where the replacement vehicle is of the equivalent tare weight or less. In such cases, only notification and submission of a photograph of the new commercial vehicle to Council is required by the owner.
