Firebreak By-Laws

In pursuance of the powers conferred upon it by the abovementioned Act and of all other powers enabling it, the Council of the abovementioned Municipality hereby records having resolved on 15 November 1995 to amend the By-Laws relating to Firebreaks published in the *Government Gazette* on 7 December 1979 as follows—

1. In the Interpretation after (g) add
 - (h) "Rural Holding" means a farm holding of more than one location which has a contiguous boundary.
2. Delete (a) "Rural Land" and replace it with the following—
 - (a) Rural Land
Firebreak not less than 3 metres wide as follows—
 - (i) Immediately inside all external boundaries of the land or Rural Holding and if any portion of the land or Rural Holding adjoins a public road or a railway line a firebreak must also be constructed along that boundary.
 - (ii) Immediately surrounding all buildings, haystacks and fuel ramps situated on the land or Rural Holding.

ENVIRONMENTAL PROTECTION ACT 1986**ENVIRONMENTAL PROTECTION (WESTERN COLLIERIES LTD,
PREMIER COAL MINE NOISE EMISSIONS) EXEMPTION ORDER
1996**

Made by the Minister with the approval of His Excellency the Governor in Executive Council under section 6.

Citation

1. This order may be cited as the *Environmental Protection (Western Collieries Ltd, Premier Coal Mine Noise Emissions) Exemption Order 1996*.

Exemption

2. (1) Sections 49, 51, 79 and 80 of the Act and the *Noise Abatement (Neighbourhood Annoyance) Regulations 1979* are declared not to be applicable to the emission of noise from the Premier Coal Mine east of Collie operated by Western Collieries Ltd.

(Note. The noise emissions from the Premier Coal Mine are to be controlled by way of conditions imposed by the Minister under Part IV of the Act.)

(2) If regulations are made under the Act making provision concerning the emission of noise and repealing the regulations referred to in subclause (1), this order ceases to have effect on the coming into operation of those regulations.

(ELECTIONS) AMENDMENT REGULATIONS 1996**

Made by His Excellency the Governor in Executive Council.

Citation

1. These regulations may be cited as the *Real Estate and Business Agents Supervisory Board (Elections) Amendment Regulations 1996*.

Principal regulations

2. In these regulations the *Real Estate and Business Agents Supervisory Board (Elections) Regulations 1980** are referred to as the principal regulations.

Regulations 4A and 4B inserted

3. After regulation 4 of the principal regulations the following regulations are inserted —

“

Candidates details with ballot papers

4A. (1) On or before the day and time appointed under regulation 4 for a particular election, each nominated candidate may contact the returning officer with a brief summary of that candidate's biographical details (not exceeding 300 words in length) to be sent to the voters along with the ballot paper.

(2) If, in the returning officer's opinion, the candidate's summary is excessive, or any part of it is unsuitable, the returning officer may edit the summary, after making reasonable attempts to contact the candidate.

Order of names on ballot papers

4B. After all nominations have been received by the returning officer for a particular election, the returning officer shall determine the order in which the names of the candidates will appear on the ballot paper by a process of drawing lots.

”

Regulation 5 amended

4. Regulation 5 (1) of the principal regulations is amended —

- (a) by inserting after “shall” the following —
 “ , if an election is required, ”;
- (b) by deleting “so as to reach him not later than seven days prior to” and substituting the following —
 “ within 7 days of ”; and

 “ on the day appointed for the receipt of nominations ”.

5. Regulation 6 of the principal regulations is amended —

- (i) by deleting "counterfoil,"; and
- (ii) by inserting after "addressed envelope" the following —
- " with declaration "

Regulation 8 amended

6. Regulation 8 (2) of the principal regulations is amended by deleting paragraphs (d) and (e) and substituting the following paragraphs —

- "
- (d) enclose the envelope marked "Ballot Paper" in the envelope marked with the address of the returning officer;
- (e) write his name in block letters, and sign his name, on the voter's declaration on the envelope addressed to the returning officer;
- "

Regulations 9 and 10 repealed and regulations substituted

7. Regulations 9 and 10 of the principal regulations are repealed and the following regulations are substituted —

" Issue of duplicate ballot paper or addressed envelope

9. (1) Where, on application before the time of the close of the ballot in an election, the returning officer is satisfied that a ballot paper or an addressed envelope issued to a voter has not been received or has been lost, destroyed or spoilt, he shall issue to that person a duplicate ballot paper, or addressed envelope, as the case may be.

(2) An application under subregulation (1) by a person for a duplicate ballot paper, or addressed envelope, for an election shall be in writing setting out the grounds on which the application is made and declaring that the person has not voted in the election and shall, if practicable, be accompanied by any evidence that is available of that non-receipt, loss, destruction or damage.

Voter's eligibility to be checked

10. (1) The returning officer, before proceeding to count the number of votes to ascertain which candidate is successful in the election, shall, for each envelope received, check the voter's declaration against the list referred to in regulation 5 and —

- (a) if the voter's declaration is found to be in order, mark the roll; or
- (b) if the voter's declaration is not in order, mark the envelope with the word "**rejected**" and set the envelope aside for safe keeping.

(2) If a voter's declaration is found to be in order, the returning officer shall place that envelope in a sealed ballot box, together with all other envelopes purporting to contain ballot paper envelopes (other than rejected envelopes) received by him up to the close of the poll.

(3) An envelope purporting to contain a ballot paper envelope received after the close of the poll shall not be admitted to the scrutiny.

Counting of votes received

10A. (1) As soon as practicable after the close of the poll, and after all the voter's declarations are checked, the returning officer, in the presence of any scrutineer, shall open the sealed ballot box, open each envelope bearing a valid voter's declaration, and set those opened envelopes aside for safekeeping.

(2) The returning officer shall then, in the presence of any scrutineer, open each ballot paper envelope and proceed with the count.

Regulation 11 amended

8. Regulation 11 of the principal regulations is amended —

(a) by inserting after the regulation designation "11." the subregulation designation "(1)";

(b) by deleting "A ballot" and substituting the following —

" Subject to subregulation (2), a ballot ";

(c) in paragraph (a), by deleting "or signature of the Returning Officer or a person authorized in that behalf by the Returning Officer" and substituting the following —

" of the returning officer or a facsimile of those initials

and

(d) by inserting the following subregulation —

" (2) If a ballot paper has not been completed in accordance with regulation 8 (2) (b), but the ballot paper clearly indicates the voter's intention, the ballot paper shall not be informal, and shall be given effect to in accordance with the voter's intention.

Regulation 14 amended

9. Regulation 14 of the principal regulations is amended by deleting "scrutineer" and substituting the following —

" scrutineer "

Regulation 17 amended

10. Regulation 17 of the principal regulations is amended by repealing subregulations (2) and (3) and substituting the following subregulations —

" (2) The returning officer and any other officers assisting the returning officer are entitled to such remuneration as is determined by the Electoral Commissioner.

Note: If a person is nominated as a candidate for both member and deputy member at the same election the nomination for deputy member is invalid — Regulation 4 (4).

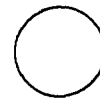

SETTLEMENT AGENTS AMENDMENT REGULATIONS 1996**

Made by His Excellency the Governor in Executive Council.

Citation

1. These regulations may be cited as the *Settlement Agents Amendment Regulations 1996*.

Commencement

2. These regulations come into operation on the day on which Part 9 of the *Business Licensing Amendment Act 1995* comes into operation.

Principal regulations

3. In these regulations the *Settlement Agents Regulations 1982** are referred to as the principal regulations.

Regulation 4A inserted

4. After regulation 4 of the principal regulations the following regulation is inserted —

“

Holding fee

4A. (1) In this regulation —

“**holding fee**” means the fee set out in item 8 of the First Schedule and referred to in section 30 (3a) (b) of the Act.

(2) The holding fee is payable —

(a) in the case of a licensee who, on the coming into operation of Part 9 of the *Business Licensing Amendment Act 1995*, holds a licence but does not hold a triennial certificate in respect of the licence, within 60 days after the coming into operation of that Part, and triennially after that payment; or

(b) in any other case, within 60 days after a licensee ceases to hold a current triennial certificate in respect of the licence held by the licensee, and triennially after that payment.

(3) The Board may refund to a licensee —

(a) two-thirds of the holding fee paid by the licensee if the licensee is granted a triennial certificate less than one year after paying the holding fee; or

(b) one-third of the holding fee paid by the licensee if the licensee is granted a triennial certificate one year or more, but less than 2 years, after paying the holding fee.

ENFORCEMENT AMENDMENT REGULATIONS (NO. 2) 1996**

Made by the Lieutenant-Governor and deputy of the Governor in Executive Council.

Citation

1. These regulations may be cited as the *Fines, Penalties and Infringement Notices Enforcement Amendment Regulations (No. 2) 1996*.

Principal regulations

2. In these regulations the *Fines, Penalties and Infringement Notices Enforcement Regulations 1994** are referred to as the principal regulations.

Regulation 6 amended

3. (1) Regulation 6 (1) of the principal regulations is amended in paragraph (a) by inserting after "time to pay" the following —

" order ".

(2) After regulation 6 (1) of the principal regulations the following subregulation is inserted —

"

(1a) On an application —

(a) under section 33 for a time to pay order; or

(b) under section 34 to have a time to pay order amended,

a court officer may require the applicant to produce documentary evidence to verify the applicant's income or expenditure.

Regulations 8A and 8B inserted

4. After regulation 8 of the principal regulations the following regulations are inserted —

Recommencing enforcement after successful application under s 101 or 101A

8A. (1) If on an application by a person under section 101 the justices make an order cancelling the licence suspension order concerned, the Registrar may again take proceedings under Part 3 of the Act to enforce the infringement notice that gave rise to that licence suspension order, such proceedings to be commenced by issuing a notice of intention to suspend licences under section 18.

(2) If on an application by a person under section 101A the justices make an order cancelling the licence suspension order concerned, the Registrar may again take proceedings under Part 4 of the Act to enforce the fine that gave rise to that licence suspension order, such proceedings to be commenced by issuing a notice of intention to suspend licences under section 42.

Recommencing enforcement after an appeal (s. 101B)

8B. (1) This regulation applies if —
