BUSH FIRES ACT 1954

Shire of Moora

1996/97 Fire Break Notice to All Owners and/or Occupiers of Land

1. Fire Breaks

Pursuant to the powers contained in Section 33 of the above Act, you are hereby required, on or before the 26th day of October, 1996 to plough, scarify, cultivate or otherwise clear and thereafter maintain free of all inflammable material until the 22nd day of March, 1997 in the following positions and of the following dimensions on the land owned or occupied by you.

2. Rural Land

Firebreaks must be provided not less than two metres in width inside and along the whole of the external boundaries of the properties owned or occupied by you, where this is not practicable the firebreaks must be provided as near as possible to, and within, such boundaries with the exception that firebreaks can be modified or not required if after consultation with the Brigade Captain and neighbours it is decided that a natural barrier or man made structure will act as a firebreak.

3. Farm Buildings and Unattended Electric Motors and Haystacks

Firebreaks at least three metres in width completely surrounding and not more than twenty metres from the perimeter of any building, group of buildings or haystacks. All inflammable material must be removed from an area two metres in width immediately surrounding the building. All inflammable material must be removed from an area three metres in width immediately surrounding an unattended electric motor site.

4. Unattended Fuel Operated Motors

All inflammable material must be removed from an area three metres in width immediately surrounding an unattended fuel operated motor whether the motor is intended to be used or not.

5. Townsites

On or before the 26th October, 1996 all town lots within the townsites of Moora, Miling, Watheroo, Bindi Bindi, and Coomberdale are required to be treated as follows—

- (a) Where the area of land is less than 3 000 square metres remove all inflammable material from the whole of the land.
- (b) Where the area of land is 3 000 square metres or more a firebreak must be provided not less than two metres in width inside and along the whole of the external boundaries of the properties owned or occupied by you and all inflammable material must be cleared two metres distance from all buildings and/or haystacks situated on the land and maintained free of such material until 22nd March 1997.

6. Fuel Pumps (Fuel Depots)

On or before the 26th day of October 1996 all grass and similar material is to be cleared from such areas where drum ramps are located and where drums, full or empty, are stored and such areas are to be maintained cleared of grass and similar inflammable material until the 22nd day of March 1997.

7. Incinerators

Residents of townsites throughout the Shire are reminded that incinerators for the burning of waste material should be of an approved type and be in good condition. Open drums etc. are not acceptable.

8. Penalty

The penalty for failing to comply with this notice is a fine of up to \$1 000.00 and a person in default is also liable, whether prosecuted or not, to pay the cost of performing the work in this notice, if it is not carried out by the Owner or Occupier by the date required by this notice.

NOTE: Attention of landowners is drawn to the fact that this order allows for provision of firebreaks in situations other than immediately within property boundaries subject to approval. The Appointed Fire Control Officers have been authorised to act for Council in this matter.

Infringement notices will be issued to owners or occupiers where no or insufficient firebreaks are provided.

BUSH FIRES ACT 1954

Shire of Boddington FIREBREAK ORDER

Important information relating to your responsibility as a landholder in the Boddington Shire.

With reference to Section 33 of the Bush Fires Act 1954, you are required to carry out fire prevention work on land owned or occupied by you in accordance with the provision of this order.

An inspection of firebreaks will be carried out in all areas of the shire by an authorised officer.

Failure to comply with this Firebreak Order is an offence under Section 33 of the Bush Fires Act. Penalty \$1 000. Additionally Council may carry out the required work at cost to the owner or occupier.

If it is considered for any reason to be impractical to clear firebreaks or remove flammable materials as required by this notice, or if natural features render firebreaks unnecessary, you may apply to the Council in writing not later than the fifteenth day of October for permission to provide firebreaks in alternative positions or to take alternative action to abate fire hazards on the land. If permission is not granted by the Council, you shall comply with the requirements of this notice.

Rural Lands

- (a) This work must be carried out by 15th November and kept maintained throughout the summer months until 15th April.
- (b) A firebreak not less than 2.5 metres wide must be constructed along and within 100 metres of the external boundary of each property (i.e. cleared or part cleared land) and where the boundary is adjacent to or adjoins a used gazetted road.
- (c) In the interest of protection from soil erosion, firebreaks may be constructed on the land contours but only with prior approval of the Council or its duly authorised officer.
- (d) An area 10 metres wide cleared of all flammable material shall be established immediately around the perimeter of all homesteads, buildings, haystacks and fuel storage areas.
- (e) In such positions as is necessary to divide land in excess of 200 hectare into areas not exceeding 200 hectare each completely surrounded by a firebreak.
- (f) A fire fighting unit with a minimum capacity of 450 litres is to be kept available at or adjacent to harvesting operations.
- (g) Where there is agreement between adjoining land owners for one or the other to provide a firebreak on their boundary, this firebreak will be deemed the boundary of the adjoining property, subject to insurance company approval. Please contact your fire control officer if any uncertainty exists.

Pine and Eucalyptus Plantations

Any pines or eucalyptus planted for commercial purposes constitutes a pine or eucalyptus plantation and you are hereby required to keep clear of all flammable materials firebreaks not less than 10 metres wide around the perimeter of each plantation, and any plantation exceeding 29 hectares will also require a subdivisional firebreak 6 metres in width for each 30 hectares, and bush surrounding planted areas is to be kept in a low fuel condition.

Small Lot Holders or Hobby Farms 20 Hectare or Less

- (a) On or before 15th October every year a firebreak not less than 2.5 metres wide must be constructed along and within 100 metres of the external boundary of each property (i.e. cleared or part-cleared land) and where the boundary is adjacent to or adjoins a used gazetted road.
- (b) An area 10 metres wide cleared of all flammable material shall be established immediately around the perimeter of all homesteads, buildings, haystacks and fuel storage areas.

Townsites of Boddington and Ranford

On or before 15th October every year all town lots under 4 000 square metres in area and all fuel depots within the shire are required to be cleared of all debris and flammable material. Lots 4 000 square metres and over are to have a minimum 2.5 metre firebreak installed immediately inside all external boundaries.

Special Note to Land Owners and Occupiers

The requirements of this order are considered to be the minimum standard of fire prevention work to protect not only individual properties but the district generally.

In addition to the requirements of this order Council may issue separate special orders on owners or occupiers if hazard removal is considered necessary in specific areas.




