#### Outcome of Submissions

Amendment No. 978/33; File: 809-2-1-45.

The Western Australian Planning Commission has considered all the submissions received in respect of the Amendment proposals for the "Darling Range Regional Park" Amendment (No. 978/33). This proposal was first published in the *Government Gazette* on 3 May 1996. The Commission has recommended that the Amendment proposal be modified.
