STOCK (IDENTIFICATION AND MOVEMENT) ACT 1970

Notice amending the identification requirements of stud cattle

Section 13 (3), Section 30

I, John Reginald Edwards, Registrar of Brands, appointed under the provision of Section 20 (1) of the *Stock (Identification and Movement) Act 1970*, having considered it necessary in the interests of the identification of stud cattle that are older than three years of age and being sold without stud registration papers for the purpose of immediate slaughter, hereby, under the provisions of Section 13 (3) and Section 30 of the said Act, permit those stud cattle to be identified by the following alternate methods of identification, either by—

- (a) an eartag with the brand of the proprietor which is registered under the provisions of the Stock (Identification and Movement) Act 1970 permanently printed thereon; or
- (b) the brand of the proprietor which is registered under the provisions of the Stock (Identification and Movement) Act 1970 applied to the near rump or shoulder of the animal by means of a waterproof, waterbased paint with the size of the brand when applied being not less than 150 millimetres long and not less than 50 millimetres in height; or
- (c) in addition to an approved property tail tag, a tail tag upon which the brand of the proprietor which is registered under the provisions of the Stock (Identification and Movement) Act 1970 is legibly printed in permanent ink.

This notice is to come into effect on the date of publication in the Government Gazette.

STOCK DISEASES (REGULATIONS) ACT 1968 ENZOOTIC DISEASES REGULATIONS 1970

Notice prohibiting vaccination for the control of virulent footrot

Regulation 22

I, John Reginald Edwards, Chief Inspector of Stock, appointed under the provision of Section 8 (1) of the *Stock Diseases (Regulations) Act 1968*, having considered it necessary in the interests of the control of footrot, being a disease listed in the First Schedule of the *Enzootic Diseases Regulations 1970* and acting under the provision of Regulation 22 of the *Enzootic Diseases Regulations 1970*, hereby prohibit the inoculation by any person of any sheep or goat with sera or vaccine that may control footrot caused by protease thermostable *Dichelobacter nodosus*.

This notice is to come into effect on the date of publication in the Government Gazette.

FOREST MANAGEMENT REGULATIONS 1993

PUBLIC FIREWOOD AREAS ORDER (No. 3) 1996

Made by the Executive Director under regulation 98 of the Forest Management Regulations 1993.

Citation

1. This order may be cited as the Public Firewood Areas Order (No. 3) 1996.

Interpretation

2. (1) References in this order to CALMAPS are to maps produced by the Department of Conservation and Land Management.

(2) Copies of the maps are available for inspection by the public during normal office hours at the places referred to in clause 4.

Public firewood areas

3. (1) The areas of State forest named in column 1 and described in column 3 of Schedule 1 are set aside for the purposes of the collection of firewood by members of the public.

(2) The areas set aside under subclause (1) are delineated on the relevant CALMAPS referred to in column 2 of Schedule 1.

(3) Regulation 100 of the Forest Management Regulations 1993 applies to the areas described in Part 1 of Schedule 1 to this order.

(4) No fees are payable in respect of the removal of firewood from the areas designated in Part 2 of Schedule 1 to this order.

Inspection of CALMAPS

4. A CALMAP referred to in Schedule 1 may be inspected at the following Department of Conservation and Land Management offices —

- (a) Dwellingup District Office, Banksiadale Road, Dwellingup;
- (b) Mundaring District Office, Weir Road, Mundaring;
- (c) Perth District Office, 5 Dundebar Road, Wanneroo;
- (d) State Operations Headquarters, 50 Hayman Road, Como; and
- (e) Swan Regional Office, 3044 Albany Highway, Kelmscott.

COMPETITION POLICY REFORM (WESTERN AUSTRALIA) ACT 1996

COMPETITION POLICY REFORM (WESTERN AUSTRALIA) SAVINGS AND TRANSITIONAL REGULATIONS 1996

Made by His Excellency the Governor in Executive Council.

Citation

1. These regulations may be cited as the Competition Policy Reform (Western Australia) Savings and Transitional Regulations 1996.

Definitions

2. In these regulations —

"commencement day" means the day on which these regulations are published in the *Gazette*;

"specified period" means the period beginning on 21 July 1996 and ending immediately before the commencement day;

"TPA" means the Trade Practices Act 1974 of the Commonwealth;

"TPA authorization" means an authorization granted under the TPA;

"TPA notice" means a notice given under section 93 of the TPA.

Application of TPA authorizations granted before commencement day

3. (1) If a TPA authorization is in force immediately before the commencement day, a corresponding authorization is taken to have been also granted under the Competition Code.

(2) The corresponding authorization has the same effect for the purposes of the Competition Code as the TPA authorization has for the purposes of the TPA, and may be amended, revoked or otherwise dealt with under the Competition Code.

(3) If a TPA authorization was in force at any time during the specified period, a corresponding authorization is taken to have been also in force under the Competition Code at the same time and to have had the same effect for the purposes of the Competition Code as the TPA authorization had for the purposes of the TPA.

Application of TPA notices given before commencement day

4. (1) If a TPA notice is in force immediately before the commencement day, a corresponding notice is taken to have been also given under section 93 of the Competition Code.

(2) The corresponding notice has the same effect for the purposes of the Competition Code as the TPA notice has for the purposes of the TPA, and may be withdrawn or otherwise dealt with under the Competition Code.

(3) If a TPA notice was in force at any time during the specified period, a corresponding notice is taken to have been also in force under the Competition Code at the same time and to have had the same effect for the purposes of the Competition Code as the TPA notice had for the purposes of the TPA.

(4) This regulation applies to a notice under section 93 (3) of the TPA, as well as to a notice under section 93 (1) of the TPA.
