PLANT DISEASES ACT 1914

PLANT DISEASES AMENDMENT REGULATIONS 1997

Made by His Excellency the Governor in Executive Council.

Citation

1. These regulations may be cited as the Plant Diseases Amendment Regulations 1997.

Principal regulations

- 2. In these regulations the *Plant Diseases Regulations 1989** are referred to as the principal regulations.
 - [* Published in Gazette 30 June 1989, pp. 1980-93. For amendments to 5 February 1997 see 1995 Index to Legislation of Western Australia, Table 4, pp. 214-15 and Gazette 2 February, 7 June, 20 August and 3 September 1996 and 14 January 1997.]

Regulation 17 repealed

3. Regulation 17 of the principal regulations is repealed.

Schedule 1 amended

4. (1) Schedule 1 to the principal regulations is amended in Part A by inserting in the appropriate alphabetical positions the following items —

 - (c) in the item relating to "Sorghum" in column 4 by inserting after "23" the following
 - " , 23A ".

- (3) Schedule 1 to the principal regulations is amended in Part B
 - (a) in item 1 in the entry relating to "Sorghum" by inserting after "(Contarinia sorghicola)" the following
 - ", Ergot (Claviceps spp.) ";
 - (b) after item 4 (a) (i) by deleting "or";
 - (c) after item 4 (a) (ii) by inserting "or" and the following subparagraph
 - (iii) having been fumigated with methyl bromide for 2 hours at one of the following rates —

- (d) by inserting after item 23 the following item -
 - 23A. Sorghum seed Ergot (Claviceps spp.)
 - (1) Seed for sowing is to be
 - (a) certified as treated in the following manner
 - (i) immersed for 1 minute in a 10% salt (sodium chloride) solution;
 - (ii) all floating material removed, examined by a plant pathologist and found to be free from Ergot (*Claviceps spp.*); and
 - (iii) dipped in a solution of 2% available chlorine for 5 minutes or dusted in Thiram 80% at the rate of 200 g/100 kg of seed;
 - (b) certified as
 - (i) harvested before 1 December 1994 and kept separate from any seed harvested after that date from an infected area; and
 - (ii) sampled at the rate of 1 kg/100 kg (or part of 100 kg) of seed with each sample treated in the following manner
 - (I) immersed for 1 minute in a 10% salt (sodium chloride) solution; and
 - (II) all floating material removed, examined by a plant pathologist and found to be free from Ergot (Claviceps spp.);

or

- (c) certified as
 - (i) grown more than 50 km from an outbreak of Ergot (Claviceps spp.);
 - (ii) sampled at the rate of 1 kg/100 kg (or part of 100 kg) of seed with each sample treated in the following manner
 - (I) immersed for 1 minute in a 10% salt (sodium chloride) solution; and

(II) all floating material removed, examined by a plant pathologist and found to be free from Ergot (Claviceps spp.);

and

- (iii) dipped in a solution of 2% available chlorine for 5 minutes or dusted in Thiram 80% at the rate of 200 g/100 kg of seed
- (2) Seed for use other than sowing is to be certified as sampled at the rate of 1 kg/tonne (or part of a tonne) of seed with each sample treated in the following manner
 - (a) immersed for 1 minute in a 10% salt (sodium chloride) solution; and
 - (b) all floating material removed, examined by a plant pathologist and found to be free from Ergot (Claviceps spp.).
- (e) by deleting item 27; and
- (f) by inserting after item 52 the following items
 - 53. Plants and cut flowers (except corms free from trash) of Babiana (baboon flower, baboon root), Crocos, Crocosmia aurea (Planchon), Gladiolus, Tritonia and Watsonia Gladiolus Rust (Uromyces transversalis)

To be certified by an officer of the Department of Agriculture (or its equivalent) in the exporting State, Territory or country as grown in an area where the disease Gladiolus Rust has not been detected.

54. Chickpea: Plants and seed — Asochyta rabiei

Entry of plants and seed into Western Australia from another State or a Territory is prohibited except with the prior approval of the Director General.

STOCK DISEASES (REGULATIONS) ACT 1968

ENZOOTIC DISEASES AMENDMENT REGULATIONS 1997

Made by His Excellency the Governor in Executive Council.

Citation

1. These regulations may be cited as the Enzootic Diseases Amendment Regulations 1997.

Principal regulations

- 2. In these regulations the *Enzootic Diseases Regulations 1970** are referred to as the principal regulations.
 - [* Reprinted as at 21 March 1989. For amendments to 20 December 1996 see 1995 Index to Legislation of Western Australia, Table 4, pp. 264-5, and Gazette 3 September and 10 December 1996.]

Regulation 4 amended

- 3. Regulation 4 of the principal regulations is amended by deleting the definition of "disease" and substituting the following definition
 - "disease" means a disease that is specified in the First Schedule or a disease that is not identified but appears not to be an exotic disease, and a reference to disease includes a reference to
 - (a) the presence of signs of disease;
 - (b) the presence of the causative agent of disease;
 - (c) test results consistent with the presence of disease or the presence of the causative agent of disease; and
 - (d) other evidence of disease,

and "diseased" has a corresponding meaning;

Regulation 5 amended

- 4. (1) Regulation 5 (1) of the principal regulations is amended by deleting "Part D" and substituting the following —
- " Part C ".
- (2) Regulation 5 (2) of the principal regulations is repealed and the following subregulation is substituted $\,$
 - (2) Subregulation (1) does not apply to or in relation to the existence of a disease specified in Part B of the First Schedule in any part of the State declared to be an infected area under regulation 41.

Regulation 6 amended

- Regulation 6 of the principal regulations is amended
 - (a) by deleting "Part D" and substituting the following
 - " Part C"; and

(b) by deleting "regulation 5" and substituting the following —

"regulation 5 (1)".

Regulation 11 amended

- 6. (1) Regulation 11 (1) of the principal regulations is amended by deleting "subregulation (1a)," and substituting the following —
- " this regulation, ".
 - (2) Regulation 11 (1a) of the principal regulations is amended
 - (a) by deleting "and" after paragraph (a);
 - (b) by deleting the full stop at the end of paragraph (b) and substituting the following $-\!\!\!\!\!-$
 - "; and "; and
 - (c) by inserting the following paragraph
 - (c) may, with the prior approval of the Chief Inspector, exercise the power in subregulation (1) in relation to a disease that
 - (i) affects the stock in question or is suspected by the inspector of affecting that stock or of existing on the land in question; and
 - (ii) having been investigated by a veterinary surgeon, is not identified but appears not to be an exotic disease.
- (3) Regulation 11 (1b) of the principal regulations is repealed and the following subregulation is substituted
 - (1b) An inspector shall not exercise the power in subregulation (1) in relation to the existence or suspected existence, as the case may require, of a disease specified in Part B of the First Schedule among any stock, or on any land, in any part of the State declared to be an infected area under regulation 41.

Regulation 11A inserted

7. After regulation 11 of the principal regulations the following regulation is inserted —

Directions by inspector as to quarantined stock

- 11A. (1) The owner of any stock which is the subject of a declaration given under regulation 11 may be directed by an inspector
 - (a) to muster, keep confined and present for treatment in a manner specified in the direction, any animals which the inspector believes, on reasonable grounds
 - (i) are or may be potential carriers or in contact with a potential carrier; or
 - (ii) have been or may have been in contact with a potential carrier;
 - (b) to treat the animals in a manner specified in the direction;
 - (c) to allow the animals to be so treated by a person authorized in writing by the inspector;

,,

,

- (d) not to treat the animals in any manner, or in a manner specified in the direction, that may conceal any sign of disease in the animals; and
- (e) to provide such facilities as the inspector reasonably considers necessary in connection with the treatment of the animals.
- (2) An inspector who gives a direction under subregulation (1) may require the person given the direction to provide to the inspector
 - (a) any information specified by the inspector as to the treatment of the animals; and
 - (b) within 7 days after the animals have been treated, a written and signed statement as to the matters specified in the direction.
- (3) Where an owner of stock refuses or fails to comply with a direction given to him by an inspector under subregulation (1), or where the inspector is not satisfied that such a direction has been complied with, or fully complied with, the inspector may arrange for the animals to which the direction applies to be mustered and treated in compliance with the direction, and for that purpose he may employ any assistance and provide any facilities he believes are necessary.

Regulation 20 repealed and a regulation substituted

8. Regulation 20 of the principal regulations is repealed and the following regulation is substituted —

Sale or exhibition of diseased stock

- 20. (1) In this regulation
 - "diseased stock" means stock, or an animal product, which, in the opinion of the inspector concerned, is or may be affected by an enzootic disease, whether or not the disease is specified in the First Schedule.
- (2) If an inspector considers that it is necessary for the prevention or control of disease in stock, the inspector may
 - (a) prohibit the sale of diseased stock or require compliance with any condition imposed by the inspector in relation to the sale of diseased stock;
 - (b) direct diseased stock to be withdrawn from sale;
 - (c) direct that diseased stock that is for sale be moved to a place specified in the direction;
 - (d) mark, or require the marking of, diseased stock that is for sale; or
 - (e) where diseased stock intended for slaughter is for sale, require the immediate slaughter of the stock.
- (3) An owner of stock who refuses, neglects or fails to comply with a prohibition, direction or requirement that applies to the stock under subregulation (2) commits an offence.

Penalty: \$1 000.

Regulations 79 and 80 repealed and regulations 79, 79A, and 80 substituted

9. Regulations 79 and 80 of the principal regulations are repealed and the following regulations are substituted —

Interpretation

79. In this Part —

"tag" means a tag or label of an approved kind;

"tail tag" means a tag wrapped securely around the tail of cattle, immediately above the brush of the tail.

When the requirements of this Part do not apply

79A. A requirement set out in this Part does not apply to or in relation to —

- (a) cattle in respect of which the Chief Inspector has granted an exemption from
 - (i) that requirement; or
 - (ii) the regulation that imposes that requirement;
- (b) cattle moved from a place within a part of the State declared to be a cattle tick infected area to another place within that infected area if
 - (i) the cattle are moved for the purpose of immediate slaughter; and
 - (ii) every consignment of those cattle is kept separate from every other consignment, both before and after slaughter;
- (c) cattle
 - (i) moved within 30 days after an earlier movement; and
 - (ii) still identified by a tail tag designating their property of origin from which that earlier movement was made:

or

(d) cattle moved, within 30 days after having been inspected on their property of origin, directly to a port for the purpose of immediate loading onto a vessel for export from Australia.

Cattle to be tail tagged

80. (1) In this regulation —

"feedlot" has the same meaning as it has in regulation 27B;

"permit to move" means a permit in the form of Form No. 3;

- "responsible agency" means the agency responsible under a written law or a law of the Commonwealth for the inspection of cattle before they are slaughtered and for giving consent for the cattle to be slaughtered after inspection;
- "specified percentage" means the percentage specified by the Chief Inspector from time to time for the purposes of this regulation.
- (2) An owner of cattle shall not move the cattle or cause the cattle to be moved -
 - (a) if the cattle are subject to a permit to move, from the property of origin of the cattle; or

- (b) if the cattle are not subject to a permit to move, from the place where the cattle are situated to a feedlot or to a place where any of the cattle are to be
 - (i) offered for sale;
 - (ii) held, grazed or fed before being slaughtered;
 - (iii) slaughtered;
 - (iv) held for testing, treatment or inspection before being exported from the State; or
 - (v) held for testing, treatment or inspection before being moved under a permit to move to another part of the State,

unless, at the time the cattle are moved, each animal is identified by a tail tag designating its property of origin.

- (3) Where cattle arrive at a feedlot and any animal is not identified by a tail tag designating its property of origin, the owner of that animal at the feedlot shall cause the animal to be identifiable to its property of origin by means of a tail tag or eartag or in some other approved manner.
- (4) Where cattle arrive at a place where any of the cattle are to be $\stackrel{\textstyle \leftarrow}{-}$
 - (a) offered for sale;
 - (b) held, grazed or fed before being slaughtered;
 - (c) held for testing, treatment or inspection before being exported from the State; or
 - (d) held for testing, treatment or inspection before being moved under a permit to move to another part of the State,

and any animal is not identified by a tail tag designating its property of origin, the owner of the animal at that place shall cause the animal to be identifiable to its property of origin by means of a tail tag.

(5) Where cattle are moved from their property of origin to a place where any of the cattle are to be offered for sale, a person shall not sell, or conduct the sale of, any animal unless it is identifiable to its property of origin by means of a tail tag.

(6) Where —

- (a) cattle arrive at a place where any of the cattle are to be slaughtered; and
- (b) any animal is not identifiable to its property of origin by means of a tail tag,

the owner of the animal at that place shall cause the animal to be identifiable to its property of origin by means of a tail tag unless an authorized officer of the responsible agency waives that requirement.

(7) Where —

- (a) cattle arrive at a place where any of the cattle are to be offered for sale or slaughtered; and
- (b) the owner of the cattle at that place is required by these regulations to cause any animal there to be identifiable to its property of origin by means of a tail tag,

the owner shall, in relation to each consignment of cattle in respect of which that requirement arises and whether or not the requirement is waived under subregulation (6) —

(c) record in an approved manner such details of the consignment as the Chief Inspector may require; and

- (d) make that record available on demand to an inspector.
- (8) Where cattle arrive at a place and more than the specified percentage of the cattle are not identifiable to their property of origin as required by these regulations, the owner of the cattle at that place shall hold the cattle there, inform an inspector accordingly, and comply with any directions given to the owner by the inspector.
- (9) Where cattle arrive at a place and are not identifiable to their property of origin as required by these regulations, an inspector may direct the owner of the cattle at that place in relation to any matter that the inspector may think necessary, including
 - (a) to hold the cattle at that place or at another place specified by the inspector;
 - (b) to arrange for tail tags designating the property of origin of the cattle to be provided;
 - (c) to identify the cattle with tail tags, in such manner as the inspector may direct; and
 - (d) to move the cattle to a place specified by the inspector and there to comply with the directions of the inspector in relation to identifying the cattle with tail tags.
- (10) An owner of cattle shall comply with a direction given to the owner by an inspector under subregulation (9).

APPENDIX A.8—DEVELOPMENT PLAN No. 8 QUEEN VICTORIA STREET, TYDEMAN ROAD, STIRLING HIGHWAY AND THE SWAN RIVER

1.0 GENERAL

- 1.1 The use and development of land within the Development Zone bounded by Queen Victoria Street, Tydeman Road, Stirling Highway and the Swan River, North Fremantle, is to be in accordance with the provisions of this Development Plan.
- 1.2 Notwithstanding the above, Council may, at its discretion, approve variations to the Development Plan, provided that the objectives of the Plan are not prejudiced thereby.

2.0 OBJECTIVES

- 2.1 That objectives of Development Plan No: 8 are—
 - (i) to provide guidance for change in a major area of North Fremantle where opportunities and options for such change already exists, or may be anticipated and occur, and which because of its location and character requires to be considered and planned in a comprehensive way;
 - (ii) to ensure that any future development, whether of a comprehensive nature or on a site-by-site basis, takes place and that planning decisions are made only within the established local planning framework provided by this Development Plan;
 - (iii) to ensure that planning issues of major relevance to this area, such as foreshore use and access, building form, and vehicle and pedestrian movement and access, are considered in the context of their individual and collective impacts on the area;
 - (iv) to ensure that development within the Plan area contributes positively to its surroundings, and in particular that it is integrated as far as possible with, and complements, the adjacent North Fremantle town centre;
 - (v) to ensure that development in the Plan area is of a high standard, and has a form and character appropriate to its location.

3.0 PLAN PROVISION

3.1 Land Use

In exercising its discretion as to permissible uses in the Development Zone, the Council will have particular regard to the following—

- 3.1.1 the impact of the proposal on the amenity of North Fremantle;
- 3.1.2 the compatibility of proposed uses with other existing or proposed uses within the Development Zone and its environs:
- 3.1.3 Council would support development generally within the medium density range of R25 to R60 to provide a range of housing types consistent with the residential character and amenity of Fremantle, including family-capable housing. In the case of comprehensive proposals, Council may be prepared to consider a limited component of higher density development, provided that building scale and form remains acceptable and that the average development density remains within the R25-60 range;

- 3.1.4 development proposals abutting Queen Victoria Street shall address the management of the potential impact from Port related activities upon the adjacent residential area, including noise, smell and light;
- 3.1.5 the ability of proposed uses to take advantage of the site's riverside location and accessibility to the regional road network and other facilities;
- 3.1.6 Council would support retail and commercial uses which would be of a scale and type to serve the immediate locality or to complement existing such uses in the vicinity of the Plan area. Commercial/retail uses should generally be located on the northern and western portions of the Plan area:
- 3.1.7 Council would not support the development of those retail or commercial facilities which would be more appropriately located in the Fremantle city centre. Council will support provision of regional land uses integrally associated with the operations of the North Fremantle area;
- 3.1.8 Council would support the development of entertainment and recreational uses; including restaurants and tourist-related facilities, provided that the impact of such uses is not detrimental to the amenity of other uses and activities in the area. Council would favour integrated development whilst generally acknowledging public use areas and riverside location;
- 3.1.9 Development adjacent to the public open space should not inhibit public access. Council will encourage land uses adjacent to the public open space which directly support the public's utilisation of the area;
- 3.1.10 Council may support small scale productive uses, especially where these are proposed to be combined with other activities, but will not support the development of manufacturing and other industrial activities likely to have an unacceptable impact on the amenity or other uses within the Plan area:
- 3.2 Vehicle Access and Traffic Generation
- 3.2.1 In considering development proposals the Council will have regard to, and may impose conditions relating to
 - i) the impact of the proposal on the local road network;
 - ii) the impact of the proposal on the adjacent major road network and intersections;
 - iii) the acceptability of the proposed means of vehicular access to the development, especially where it is to be taken from adjacent major roads;
 - iv) the need to prevent vehicular access, except for emergency vehicular services, to the foreshore;
- 3.2.2 Council may require that a Traffic Impact Study addressing (i) to (iv) in section 3.2.1 be submitted for major proposals. Where development proposals require modifications or improvement to the existing road network and other public infrastructure in the area, such works will be at the cost of the developer;
- 3.2.3 Cycle routes within the area should be designed, segregated where possible from traffic routes, and linked to other routes in the locality. Cycle ways which form part of routes outside the Development Plan No. 8 area and are likely to be more intensively used, should be located so as not to impact on major pedestrian areas, recreational spaces, and rehabilitated foreshore;
- 3.3 Parking
- 3.3.1 The Council will have regard to, and may impose conditions relating to—
 - (i) the amount of car parking to be provided to serve developments;
 - (ii) the manner in which parking is provided.
- 3.3.2 Parking provision should generally be in accordance with the requirements of the Council's Town Planning Scheme.
- 3.3.3 Council shall not support vehicular parking within the Parks and Recreation Reserve.
- 3.3.4 In the case of mixed-use developments, the Council may approving a provision if it is satisfied that the dual-use of some parking facilities would be possible.
- 3.4 Environment
- 3.4.1 The Council will have regard to, and may impose conditions relating to—
 - (i) the impact of proposed developments on the area's existing infrastructure;
 - (ii) the impact of proposed development on the local environment, and especially the Swan River and its environs;
 - (iii) rehabilitation of the foreshore.
- 3.4.2 The possible environmental impacts of adjacent uses and activities on new developments within the Plan area should be dealt with within the development site, including the incorporation of 'buffers' where necessary.
- 3.4.3 Council will require it to be demonstrated that the impact of previous industrial activities on the area has been fully investigated and does not prejudice or limit any intended use of the Plan area.
- 3.4.4 Council will support proposals which embody and facilitate the principles of environmentally sustainable development, including energy-efficient building design and construction, waste management and water sensitive urban design principles.
- 3.5 Public Open Space and Landscaping
- 3.5.1 The Council will have regard to, and may impose conditions relating to—
 - the extent and type of landscaping to be provided in any development, bearing in mind the type of use proposed;

- (ii) the location of open space within the Development Plant area, and relationship to adjacent sites:
- (iii) the contribution made to the overall provision and distribution of open space within the Development Plan area and in North Fremantle in general;
- (iv) For the purpose of this Development Plan; public open space means any area of land being foreshore, parkland, playgrounds, landscaped gardens, etc. that is set aside for the use and enjoyment of the public. Open space area not freely in private ownership, and 'created' areas such as jetties or wharves, will not be included in open space calculations. At least 10% of the developable land within the Plan area should be set aside for public open space;
- (v) Council will encourage the use of landscaping in both public and private areas which is appropriate to the site's location, and which complements and reinforces landscape planting and management principles adopted by the Council for adjacent areas of North Fremantle. In particular, the character of the foreshore areas east of the Stirling Bridge should be continued into the Plan area west of the bridge;
- (vi) Council will encourage a diversity of open spaces which offer opportunities for both passive and more active recreation;
- (vii) public facilities for the foreshore, including shelters, furniture and signage; should be integrated, functional and should also encourage public utilisation of the foreshore area.

3.6 Pedestrian Movement and Access

3.6.1 The Council will have regard to-

- the means and location of pedestrian access to, and provision of pedestrian spaces within, proposed developments;
- (ii) the treatment of pedestrian space and routes, including the use of hard and soft surfaces, and covered and uncovered areas:
- (iii) the relationship to, and impact of development on, footpaths adjoining the Development Plan area;
- (iv) the relationship of proposed pedestrian routes and spaces within the Plan area with routes outside the Development Plan No. 8 area including linkages along the river foreshore, and linkages to the North Fremantle town centre;

3.7 Development Form and Scale

- 3.7.1 In exercising its discretion when considering development proposals, the Council will have regard to the following—
 - the overall form of development should be consistent with the present form and scale of North Fremantle's built environment. In respect of residential use in particular, this implies low and medium rise, up to a maximum of five storeys, developments offering a range of dwelling types;
 - (ii) in determining appropriate form and scale of development Council will seek to minimise additional fill on the site;
 - (iii) development standards for nonresidential development should comply with the requirements of Table Two of the Town Planning Scheme for the inner urban zone, however, the Council may consider variations to these requirements which would in the Council's view better achieve the objectives and principles of the Development Plan. In particular, Council may consider increases in plot ratio which would permit the achievement of a building form which better meets the townscape objectives of this Plan;
 - (iv) residential development should generally comply with the requirements of the Residential Planning Codes for the density proposed, however, the Council may consider variations to those requirements which in the Council's view would better achieve the objectives and principles of this Development Plan;
 - (v) the scale of development should be carefully considered in terms of its individual and/or collective impact on both local and more distant views. The height and bulk of buildings will be dealt with on the basis of a detailed analysis and assessment of visual impact statements;
 - (vi) Council will encourage and support a pattern and form of development which acknowledges and reflects the existing urban structure and pattern of development in North Fremantle, for example, by reinforcing existing urban axes, significant vistas and other important local townscape elements;
 - (vii) in considering the impact of development proposals, the Council may require the submission of supporting illustrative and analytical material, including cross-sections, perspective, models and photo-montages, to clearly demonstrate and allow assessment of the development's effect including building bulk, scale and form of the development on the locality in urban design terms.

3.8 The Foreshore

- 3.8.1 (i) the Council will seek the delineation of a public foreshore reserve across the full width of the Plan area prior to development;
 - (ii) the Council will not support the creation of new water basins, canals or other similar incursions of water areas into the Plan area; however, the Council may support minor variations to the current alignment of the foreshore which would facilitate or enhance public access and movement options;

- (iii) the Council may consider the development of a 'hard', man-made foreshore at the western end of the area's river foreshore, however, the majority of the foreshore should be maintained with a predominantly, informal and undeveloped character;
- (iv) the Council will not permit development abutting the foreshore area to intrude upon the reserve;
- (v) small scale developments which are related to the use of the reserve and which are of benefit to the public will be considered by the Council;
- (vi) the setback of commercial development from the foreshore shall be determined by Council for each proposed development to ensure that all activity of the development is contained on the development site and does not intrude on the foreshore reserve;
- (vii) the development of the foreshore should occur by an integrated development plan agreed to by the Council, the Swan River Trust and the Western Australian Planriing Commission. Elements to be incorporated into the plan should include delineation of the high water mark, detail of land and soft river edge treatments, river structures, foreshore treatments works, public furniture, signage, lighting, public facilities and landscaping;
- (viii) in considering development proposals, the Council will pursue the provision of a limited number of moorings. The majority of these shall be for short term public use.
- 3.9 Integration with the North Fremantle Town Centre
- 3.9.1 The Council will seek to ensure that development in the Plan area, especially on those portions of the site having the closest visual and physical relationship to the town centre—
 - (i) are integrated in visual terms with, and reinforce the townscape qualities, of the town centre;
 - (ii) have an appropriate relationship with uses in the town centre, by reinforcing and supporting rather than competing with those uses;
 - (iii) that pedestrian linkages between the Plan area and the town centre are convenient and attractive as possible.

3.10 Heritage

- 3.10.1 The Council may require any development proposals to be accompanied by a professionally prepared report, illustrated with maps and photographs from various periods, documenting the land use and development history of the site and identifying any places or objects of cultural significance, including both European and Aboriginal history and use.
- 3.10.2 The Council will impose conditions on the granting of planning consent; to ensure that any such identified places or objects are conserved and that opportunities are created to enable the documentation and/or conservation of objects that may be located or revealed during development.
- 3.10.3 The Council will encourage proposals which seek to reflect and/or authentically commemorate the area's social and physical development history, for example through the use of appropriate names or themes for public streets and other public places within the Plan area, or through the re-establishment of historic development patterns and relationships. Of particular significance are considered to be—
 - (i) the area's Aboriginal history;
 - $(ii) \ \ the \ \mbox{`market garden' phase of the area's development history;}$
 - (iii) the 'Pensioner Guards' land grant and developments which established the area's original pattern of subdivision; and
 - (iv) the natural environment.
