#### HEALTH ACT 1911

SHIRE OF GINGIN HEALTH AMENDMENT LOCAL LAWS 1996

Made by the Council of the Shire of Gingin under the Health Act 1911.

#### Citation

1. These local laws may be cited as the Shire of Gingin Health Amendment Local Laws 1996.

#### Principal local laws

2. In these local laws, the *Model By-laws Series* "A"\* made under the Health Act 1911 and as adopted by the Council of the Shire of Gingin on 20 March 1964, by notice published in the *Government Gazette* on 16 June 1964 and as amended from time to time by notices published in the *Government Gazette* are referred to as the principal local laws.

#### Part IX amended

3. The principal local laws are amended in Part IX by deleting "Section" or "section" wherever occurring and substituting for following—

"Division" or "division".

#### General amendment

- 4. The principal local laws are amended—
  - (a) by deleting "By-law" or "by-law" wherever occurring and substituting the following—
    - "Section" or "section" as the case requires; and
  - (b) by deleting "sub by-law" wherever occurring and substituting the following—
    "subsection"

5. Before Part I of the principal local laws, the paragraph headed "Interpretation" is repealed and the following is inserted—

#### "PART IA—GENERAL

#### Citation

1. These local laws may be cited as the Shire of Gingin Health Local Laws 1964."
