#### MENTAL HEALTH (TREATMENT FEES) AMENDMENT REGULATIONS 1997

Made by His Excellency the Governor in Executive Council.

#### Citation

1. These regulations may be cited as the Mental Health (Treatment Fees) Amendment Regulations 1997.

#### Commencement

2. These regulations come into operation on 1 April 1997.

#### MENTAL HEALTH (PUBLIC HOSPITALS) AMENDMENT ORDER 1997

Made by His Excellency the Governor in Executive Council.

#### Citation

1. This order may be cited as the Mental Health (Public Hospitals) Amendment Order 1997.

#### Commencement

2. This order comes into operation on 1 April 1997.

#### Principal order

- 3. In this order the Mental Health (Public Hospitals) Order 1994\* is referred to as the principal order.

#### Clause 4 repealed and a clause substituted

4. Clause 4 of the principal order is repealed and the following clause is substituted —

### Parts of public hospitals set aside and declared as approved hospitals

- 4. (1) The part of a public hospital listed in column 1 of Schedule 1 marked on the plan listed opposite that hospital in column 2 of Schedule 1 in the manner set out opposite that hospital in column 3 of Schedule 1 is set aside under section 19 (3) of the Act for the purpose of providing the services mentioned in section 19 (1) of the Act.
- (2) The part of a public hospital listed in column 1 of Schedule 1 marked on the plan listed opposite that hospital in column 2 of Schedule 1 in the manner set out opposite that hospital in column 4 of Schedule 1 is declared under section 19 (3) of the Act to be an approved hospital.
  - (3) In this clause —

"plan" means a plan the original of which is held in the offices of the Health Department of Western Australia at Perth.

#### MENTAL HEALTH AMENDMENT ORDER 1997

#### Citation

This order may be cited as the Mental Health Amendment Order 1997.

#### Commencement

2. This order comes into operation on 1 April 1997.

#### Principal order

#### Clause 4 amended

- 4. Clause 4 of the principal order is amended
  - (a) by deleting paragraph (a);
  - (b) in paragraph (d)
    - (i) by deleting the semicolon after subparagraph (v) and substituting a comma; and
    - (ii) deleting subparagraph (vi);
  - (c) by deleting paragraph (e) (ix); and
  - (d) in paragraph (f)
    - (i) after subparagraph (x) by deleting "; and" and substituting a full stop; and
    - (ii) by deleting subparagraphs (viii) and (xi).

#### Clause 5 amended

5. Clause 5 of the principal order is amended by deleting paragraph (aa).
