MENTAL HEALTH ACT 1962  
**MENTAL HEALTH AMENDMENT ORDER (No. 2) 1997**

Made by the Governor in Executive Council.

**Citation**

1. This order may be cited as the *Mental Health Amendment Order (No. 2) 1997*.

**Commencement**

2. This order comes into operation on 1 July 1997.

**Principal order**

3. In this order the *Mental Health Order 1988\** is referred to as the principal order.

**Clause 4 amended**

4. Clause 4 of the principal order is amended —

- (a) by deleting paragraph (b);
- (b) by deleting paragraph (c) and substituting the following paragraph —
  - “
    - (c) for the services mentioned in section 19 (1) (f) of the Act, North Fremantle Workshops, 98 Stirling Highway, North Fremantle as a sheltered workshop;”,
- (c) in paragraph (d) —
  - (i) after subparagraph (iii) by deleting the semicolon and substituting a comma; and
  - (ii) by deleting subparagraphs (i), (iv) and (v);
- (d) in paragraph (e) —
  - (i) by deleting subparagraphs (i) and (x); and
  - (ii) by deleting “as community based child and adolescent psychiatric clinics;” and substituting the following —
    - “
      - as a community based child and adolescent psychiatric clinic;”,
- and
- (e) in paragraph (f) —
  - (i) by deleting subparagraphs (i), (vi) and (x);
  - (ii) after subparagraph (ix) by deleting the semicolon and substituting a comma; and

- (iii) by deleting “as specialist psychiatric facilities.” and substituting the following —

“ as a specialist psychiatric facility. ”.

**Clause 5 amended**

**5.** Clause 5 of the principal order is amended —

- (a) at the end of paragraph (b) by deleting “Department;” and substituting the following —

“ Department; and ”; and

- (b) by deleting paragraphs (a) and (c).

**Citation**

1. This notice may be cited as the *Hospital Boards (Derby, Numbala Nunga, Fitzroy Crossing, Broome, Wyndham, Kununurra and Halls Creek) Re-organisation Notice 1997*.

**Commencement**

2. This notice is to take effect on 1 July 1997.

**Amalgamation of boards**

3. The board of Derby Regional Hospital, the board of Numbala Nunga Nursing Home and Hospital, the board of Fitzroy Crossing District Hospital, the board of Broome District Hospital, the board of Wyndham District Hospital, the board of Kununurra District Hospital and the board of Halls Creek District Hospital are re-organised by amalgamating the boards to form a new board.

**Assignment of Corporate Name**

4. (1) The corporate name assigned to the new board formed under Clause 3 is "Kimberley Health Service".

(2) The Kimberley Health Service is constituted as the board in relation to the following public hospitals —
