PROPOSED CONSERVATION ORDER

Jarrah Tree, Corner Third Road and Church Avenue, Armadale

Whereas in my opinion it is necessary and desirable to provide special protection in respect to that place being part of Armadale Lot 14 the subject of Certificate of Title Volume 1762 Folio 890 located at Corner Third Road and Church Avenue, Armadale, and more particularly being the land upon which the old Jarrah Tree ("the tree") in the car park on Lot 14 grows, having an area with a circular boundary being a radius of 9 metres from the centre of the tree's trunk ("the place") pursuant to Section 59 of the above Act, I, Graham Kierath, Minister administering the above act, hereby make an order prohibiting on the place—

- (i) the carrying out of any work whatsoever the subject of the demolition licence issued by the City of Armadale on July 23rd 1997;
- (ii) the cutting down, uprooting or removal of the tree;
- (iii) the carrying out of any activity which is likely to cause disturbance to, or affect detrimentally the well being of the tree; and
- (iv) except with my prior approval, the removal of limbs or branches from the tree.

LG403**BUSH FIRES ACT 1954***Shire of Collie***Firebreak Order****Important Information Relating to Your Responsibility as a Landholder in the Collie Shire**

With reference to section 33 of the Bush Fires Act 1954 you are required to carry out fire prevention work on land owned or occupied by you in accordance with the provisions of this order.

This work must be carried out by 1 December 1997 and kept maintained throughout the summer months until 15 April 1998.

An inspection of firebreaks and hazard removal will be carried out in all areas of the Shire by an authorised officer.

Persons who fail to comply with the requirements of this order may be issued with an infringement notice (penalty \$100) or prosecuted with an increased penalty, and additionally, Council may carry out the required work at the cost to the owner or occupier.

If it is considered for any reason to be impracticable to clear firebreaks or remove flammable materials as required by the notice, or where—

- (a) compliance with this order may aggravate soil erosion problems, or
- (b) the owner or occupier of land considers a more effective system of fire protection can be obtained, or
- (c) natural features render firebreaks unnecessary.

You may apply to the Council or its duly authorised officer not later than 15 November 1997 for permission to provide firebreaks in alternative positions or to take alternative action to abate fire hazards on the land.

Approval of variations to this order must be endorsed by the duly authorised officer and such variation once approved shall have effect for the current fire season or if it is revoked by the Council.

If permission is not granted by the Council or its duly authorised officer, you shall comply with the requirements of this notice.

If the requirements of this notice are carried out by burning, such burning must be in accordance with the relevant provisions of the Bush Fires Act.

Forestry firebreaks will only be accepted if approved by the Department of Conservation and Land Management and the duly authorised officer in writing.

1. RURAL LAND

- (a) Land holdings 5 ha or less are exempt from fire breaks on their property providing the flammable material in the paddock likely to create a fire hazard (except standing live green trees and shrubbery), is less than 200mm in height and the property does not abut CALM land, Crown land, river reserve, Main Roads Department road reserve and property of more than 5 ha. Properties that do abut CALM land, Crown land, river reserve, Main Roads Department road reserve and property of more than 5 ha, require firebreaks along those abutting boundaries.

- (b) In respect of all lands owned or occupied by you (other than land within a townsite) you shall clear all flammable material, firebreaks not less than 2.5 metres wide immediately inside all external boundaries of your land which is used for pasture.
- (c) Within 100 metres of the perimeter of all buildings and/or haystacks or groups of buildings and/or haystacks, provide firebreaks 4 metres wide so as to surround the buildings and haystacks.
- (d) 4 metre wide firebreaks be cleared around fuel drums, and that the land on which the fuel drums are stacked be kept clear of all flammable material.

2. TOWNSITE LAND (Includes Residential, Commercial and Industrial Land)

In respect of land owned or occupied by you within any townsite, you shall—

- (a) Where the area of land is 2 025 square metres (1/2 acre) or less, remove all flammable material on the land from the whole of the land.
- (b) Where the area of land exceeds 2 025 square metres (1/2 acre), reduce all flammable material to clear all flammable material firebreaks not less than 2.5 metres wide immediately inside all external boundaries of your land and immediately surrounding all buildings and/or haystacks on the land.

3. FUEL AND/OR GAS DEPOTS

In respect of land owned by you on which is situated any container normally used to contain liquids or gas fuels, including the land on which any ramp or support is constructed, you shall have the land clear of all flammable materials.

4. PINE AND EUCALYPT PLANTATIONS

Definitions—

- (1) Plantations: Any area of planted pines or eucalyptus species exceeding 3 hectares.
- (2) Windbreaks: Are defined as planted areas not exceeding 15 metres in depth with an unrestricted length (windbreak plantings are not to be construed as plantations).

Firebreak Standards—

- (a) Firebreaks not less than 15 metres in width around the perimeter of land on which pines or eucalypts are planted.
- (b) No less than 15 metres in width along those portions of pine or eucalypt plantations which enjoy a common border with sealed road reserves.
- (c) Not less than 10 metres in width along those portions of pine or eucalypt plantations which enjoy a common boundary with unsealed road reserves.
- (d) No less than 6 metres in width in such positions that no part or compartment of a pine or eucalypt plantation shall exceed 28 hectares in area.
- (e) All firebreaks must be maintained in a trafficable condition and trees on both sides of breaks progressively pruned to a minimum height of 4 metres to allow unrestricted access of maintenance and fire fighting equipment and so as to maintain an effective width of firebreaks.
- (f) Where power lines pass through plantation area firebreaks as per State Energy Commission specifications must be provided.
- (g) Buffer zones between Special Rural Zones/Special Rural Policy Areas and any pine or eucalypt plantation—the plantation owner shall ensure that a minimum distance of 100 metres is maintained from the outside line of trees on the plantation to the nearest building envelope within the Special Rural Zone/Special Rural Policy Area.

SPECIAL NOTICE TO LAND OWNERS AND OCCUPIERS

The Council forwards a copy of this firebreak order with rate assessments each year. The notice is also published in the Collie Mail and additional copies are obtainable at the Shire office counter.

The aim of the Council is to eliminate destructive bush fires and to this aim some areas of the Shire are subject to hazard removal and roadside burning which is carried out by the Shire's bush fire brigades and Council workforce.

The requirements of this order are considered to be the minimum standard of fire prevention work required to protect not only individual properties but the district generally in addition to the requirements of this order, Council may issue separate special orders on owners of occupiers if hazard removal is considered necessary in some specific areas.

These dates are subject to slight variation according to seasonal conditions, but any alterations will be advertised locally.

BUSH FIRES ACT (Summary)

- 1. Permits to burn are required for the whole of the Restricted Periods and can only be obtained from the area Fire Control Officers listed overleaf.

2. Any special conditions imposed by the Shire Control Officer when issuing permits must be strictly adhered to.
3. The permit holder shall give notice of his intention to burn to—
 - (a) The Shire Office on the morning of the day the fire is to be lit or if the permit is issued on a weekend or a holiday, the first working day after the issue date.
 - (b) The owner or occupier of Adjoining land.
 - (c) The nearest CALM office, if the land is situated within 3km of the State Forest Land. The Department of CALM will issue the permit holder with a log number which is to be noted on the burning permit form (Dept CALM phone 97341988) (notification to be during normal office hours of 8am to 4.30pm Monday to Friday).
4. Period of notice to neighbours prior to burning cannot be more than 28 days or less than 4 days although lesser notice may be determined by mutual agreement of all neighbours.
5. Your attention is drawn to items 5, 6 and 7 printed on the back of the permit.
6. All land owners and occupiers who incur a bush fire have an obligation to assist each area Fire Control Officer to complete a Fire Report Form.
7. Garden refuse or rubbish burnt on the ground may be lit only between 6pm and 11pm and must be completely extinguished with water or earth by midnight. All flammable matter is to be cleared within 5 metres of all points of the site of the fire. And a person must be in attendance during the whole time the fire is burning.
8. Any incinerator used to burn rubbish must be properly constructed—an open drum with or without a lid is not an appropriate incinerator.
9. It is in the interest of all rural residents to be registered members of the bush fire brigade covering the area wherein they own land. Member of the bush fire brigade covering the area wherein they own land. Membership of a brigade is the safest way to ensure cover under the Shire's bush fire insurance policy which covers personal injury and damage to equipment resulting from fighting bush fires.

CAMPING AND COOKING FEES

With reference to the provisions of section 25 (1a) of the Bush Fires Act, notice is hereby given that the lighting of cooking and camping fires is prohibited throughout the whole of the Shire of Collie during the prohibited burning time (December 15 to March 14, of any year), except with the written authority of Council, or in properly constructed fire places situated in authorised areas.
