## FISH RESOURCES MANAGEMENT ACT 1994

PROHIBITION ON FISHING (SHARK BAY EASTERN GULF PINK SNAPPER BREEDING GROUND) ORDER 1997 Order No. 6 of 1997

FD 365/97 [160]

Made by the Minister under section 43.

## Citation

1. This order may be cited as the Prohibition on Fishing (Shark Bay Eastern Gulf Pink Snapper Breeding Ground) Order 1997.

#### **Prohibition on fishing**

2. Notwithstanding the provisions of any management plan made under section 54 of the Act, a person must not fish by any means at any time in the waters of Shark Bay bounded by a line commencing at the intersection of  $25^{\circ} 40.59^{\circ}$  south latitude and  $113^{\circ} 48.78^{\circ}$  east longitude; thence east to the intersection of  $25^{\circ} 40.59^{\circ}$  south latitude and  $113^{\circ} 50.19^{\circ}$  east longitude; thence south to the intersection of  $25^{\circ} 42^{\circ}$  south latitude and  $113^{\circ} 50.19^{\circ}$  east longitude; thence west to the intersection of  $25^{\circ} 42^{\circ}$  south latitude and  $113^{\circ} 50.19^{\circ}$  east longitude; thence west to the intersection of  $25^{\circ} 42^{\circ}$  south latitude and  $113^{\circ} 48.78^{\circ}$  east longitude; thence morth to the commencement point. MARINE AQUARIUM FISH MANAGEMENT PLAN AMENDMENT 1997

#### Citation

1. This amendment may be cited as the Marine Aquarium Fish Management Plan Amendment 1997. **Principal Plan** 

2. In this amendment the Marine Aquarium Fish Management Plan 1995\* is referred to as the principal Plan.

#### Schedule amended

3. The Schedule to the principal Plan is amended by adding the following item—

"Mr Ian Sean Stocker of Karratha, W.A.".

SOUTH WEST TRAWL MANAGEMENT PLAN AMENDMENT 1997

FD 714/96 [122]

Made by the Minister under section 54.

## Citation

1. This amendment may be cited as the South West Trawl Management Plan Amendment 1997.

## **Principal Plan**

2.~ In this amendment the South West Trawl Management Plan 1989\* is referred to as the principal Plan.

## Arrangement amended

- 3. The arrangement to the principal Plan is amended by—
  - (a) deleting "5. Prohibition on taking fish" and substituting the following—
    - "5. Prohibition on trawling for fish";
  - (b) inserting after "10. Closure of Fishery" the following—
     "10A. Stowage of otter boards and otter trawl nets"; and
  - (c) deleting "18. Determination of position by reference to the Australian Geodetic Datum" and substituting the following—
    - "18. Procedure before this Plan may be amended
    - 19. Offences".

## **Clause 3 amended**

- 4. Clause 3 of the principal Plan is amended by-
  - (a) deleting the item commencing "licence" and substituting the following item-
    - " "licence" means a managed fishery licence which authorises a person to trawl for fish in the Fishery; "; and
  - (b) inserting after the item commencing "otter trawl net" the following item— ""regulations" means the Fish Resources Management Regulations 1995; ".

## Clause 5 deleted and substituted

5. Clause 5 of the principal Plan is deleted and the following clause substituted-

## " Prohibition on trawling for fish

- 5. A person must not fish by means of an otter trawl net in the Fishery other than— (a) under the authority of a licence; and
  - (b) in accordance with this Plan. ".

## **Clause 10 amended**

- 6. Clause 10 of the principal Plan is amended by—
  - (a) deleting "and" at the end of paragraph (c);
  - (b) deleting the full stop at the end of paragraph (d) and substituting the following—
    - " ; and "; and
  - (c) inserting after paragraph (d) the following—
    - " (e) the waters described in item 4 of Schedule 2 during the period commencing on 1 December in any year and ending on 31 January in the following year.".

## **Clause 10A inserted**

7. The principal Plan is amended by inserting after clause 10 the following clause—

## " Stowage of otter boards and otter trawl nets

10A. Otter boards, warp wires and trawl nets carried or attached to any boat shall be secured to that boat and kept out of the water at all times in any waters of the Fishery that are closed to trawling for fish. ".

## Clause 18 deleted and substituted

8. Clause 18 of the principal Plan is deleted and the following clause substituted-

## " Procedure before this Plan is amended

18. For the purposes of section 65(1) of the Act, all the licence holders are the persons to be consulted before this Plan is amended or revoked. ".

## **Clause 19 inserted**

- 9. The principal Plan is amended by inserting after clause 18 the following clause-
  - " Offences

19. A person who contravenes a provision of clause 5, 6, 10, 10A, 11, 14, 15 or 16 commits an offence.".

## Schedule 2 amended

- 10. Schedule 2 of the principal Plan is amended—
  - (a) by deleting paragraph (f) of item 1 and substituting the following—
    - " (f) Becher Point to Robert Point

All waters of the Fishery bounded by a line commencing at the high water mark on the western most point of Becher Point and extending due west to a point 800 metres from that high water mark; thence extending in a generally southerly direction parallel to the high water mark on the mainland to  $32^{\circ} 27' 24''$  south latitude; thence extending to the nearest point being the intersection of  $115^{\circ} 43' 48''$  east longitude and an arc of a circle of 3.5 nautical miles radius from the high water mark of the northern most point of Robert Point; thence anti-clockwise around that arc to its intersection with  $115^{\circ} 40'$  east longitude; thence due south along that longitude to a point due west of the northern most point of Robert Point; thence due east to the high water mark at the northern most point of Robert Point; thence in a northerly direction along the high water mark to the commencement point. ";

- (b) by deleting paragraph (g) of item 1 and substituting the following—
  - " (g) Robert Point to Cape Bouvard:

All waters of the Fishery bounded by a line commencing at the high water mark of the northern most point of Robert Point and extending due west to a point 3 nautical miles from that high water mark; thence in a southerly direction parallel to the high water mark on the mainland to a point 3 nautical miles due west of the high water mark at the western most point of Cape Bouvard; thence due east to the high water mark at the western most point of Cape Bouvard; thence in a northerly direction along the high water mark to the commencement point. "; and

- (c) by inserting after item 3 the following item-
  - "4. All waters of the Fishery south of a line extending from the high water mark on the northern most point of McKenna Point to the intersection of 115° 01' east longitude and the high water mark on the northern most point of Cape Naturaliste.".

- (c) Fuel Depots—In addition to any firebreaks required in paragraphs 1 and 2 herein, you shall clear of all inflammable material the whole of any land occupied by drums used for the storage of inflammable liquid, whether the drums contain inflammable liquid or not, including any land on which ramps for holding the drums are constructed and an area outside the land so occupied to a distance of not less than three metres.

If it is considered to be impracticable for any reason to clear firebreaks or to remove inflammable material from land as required by this notice, you may apply to the Council or its duly authorised Officer, not later than October 1st of each year for permission to provide firebreaks in alternative position or to take alternative action to abate fire hazards on the land. If permission is not granted by the Council or its duly authorised Officer, you shall comply with the requirements of this notice.


