WESTERN AUSTRALIAN MEAT INDUSTRY AUTHORITY AMENDMENT REGULATIONS (No. 2) 1997

Made by the Governor in Executive Council.

Citation

1. These regulations may be cited as the *Western Australian Meat Industry Authority Amendment Regulations (No. 2) 1997*.

Principal regulations

2. In these regulations the *Western Australia Meat Industry Authority Regulations 1985** are referred to as the principal regulations.

Western Australia, Table 4, p. 314, and Gazette 24 June 1997.]

Regulation 3 amended

3. Regulation 3 of the principal regulations is amended —
 - (a) by inserting after the regulation designation “3.” the subregulation designation “(1)”; and
 - (b) by inserting the following subregulation —

“

(2) In these regulations a reference to stock which is yarded for transshipment is a reference to stock which is yarded at the Midland Saleyard for the purpose of being transported from the Saleyard to another place without being offered for sale at the Midland Saleyard.

”

Regulation 27 amended

4. Regulation 27 of the principal regulations is amended —
 - (a) after paragraph (a) by deleting “and”;

- (b) at the end of paragraph (b) by deleting the full stop and substituting the following —

“ ; and ”; and

- (c) after paragraph (b) by inserting the following paragraph —

“

- (c) comply with any directions given by the Authority in relation to the care, feeding and watering of the stock.

”.

Regulation 29 amended

5. Regulation 29 (2) (b) of the principal regulations is deleted and the following paragraph is substituted —

“

- (b) the stock is to be treated, for the purposes of regulations 34 and 35, as if it had been yarded for transhipment.

”.

Regulation 30A inserted

6. After regulation 30 of the principal regulations the following regulation is inserted —

“

Abandoned stock

- 30A. (1) If stock remains uncollected from the Midland Saleyard for more than 2 weeks —

- (a) if it was yarded for sale, after it was offered for sale; or
(b) if it was yarded for transhipment, after it was delivered to the Saleyard,

and the Authority, after making reasonable efforts, is unable to identify the owner of the stock, the Authority may arrange for the sale of the stock by auction and retain the proceeds of that sale.

- (2) If, within 3 months of the sale of the stock under subregulation (1), a person satisfies the Authority that he or she was the owner of the stock immediately prior to the sale, the Authority is to pay to that person an amount equal to the proceeds of the sale less —

- (a) the cost of caring for the stock prior to sale;
(b) the cost of selling the stock; and
(c) any fees payable under regulation 29 (2) (b).

”.

Regulation 34 amended

7. (1) Regulation 34 (2) of the principal regulations is amended by deleting “for stock” and substituting the following —

“ for each 24 hours (or part thereof) for which stock is ”.

- (2) Regulation 34 (4) of the principal regulations is repealed and the following subregulation is substituted —

“

- (4) If stock which is not sold when first submitted for sale is re-submitted for sale on the same day and by the same stock agent, no fee is payable under subregulation (1) in respect of the second and each subsequent time the stock is so offered for sale.

”.

BULK HANDLING ACT 1967
COMPANIES (CO-OPERATIVE) ACT 1943

**CO-OPERATIVE BULK HANDLING LIMITED - AMENDMENTS TO
MEMORANDUM AND ARTICLES OF ASSOCIATION**

Made by Co-operative Bulk Handling Limited under section 22 of the *Companies (Co-operative) Act 1943* and approved by the Governor in Executive Council under section 10 of the *Bulk Handling Act 1967*.

PART 1 — PRELIMINARY

Commencement

1. These amendments come into operation on the day on which the approval of the Governor is obtained.

PART 2 — AMENDMENTS TO THE MEMORANDUM

Memorandum of Association

2. In these amendments the Memorandum of Association of Co-operative Bulk Handling Limited (as amended from time to time) is referred to as the Memorandum.

Clause 3 deleted

3. Clause 3 of the Memorandum is deleted.

Clause 5 deleted

4. Clause 5 of the Memorandum is deleted.

Clause 8 amended

5. Clause 8 of the Memorandum is amended —
 - (a) by deleting “of dividend or”;
 - (b) by deleting “or both”; and
 - (c) by deleting “conferring preferential rights as to dividend in excess of the rates mentioned in Clause 3 hereof or”.

PART 3 — AMENDMENTS TO THE ARTICLES

Articles of Association

6. In these amendments the Articles of Association of Co-operative Bulk Handling Limited (as amended from time to time) are referred to as the Articles.

Article 7 amended

7. Article 7 of the Articles is amended —
 - (a) by deleting “a fixed or preferential dividend or any other”; and
 - (b) by deleting “conferring preferential rights as to dividend in excess of the rates mentioned in Clause 3 of the Memorandum of Association or”.

Article 18 amended

8. Article 18 of the Articles is amended by deleting "to receive any dividend or".

Article 23 amended

9. Article 23 of the Articles is amended by deleting "Such forfeiture shall include all dividends declared in respect of the forfeited shares and not actually paid before the forfeiture."

Article 30 deleted

10. Article 30 of the Articles is deleted.

Article 45 amended

11. Article 45 of the Articles is amended —

- (a) by deleting "to dividends or"; and
- (b) by deleting "Clauses 3 or" and substituting the following —
" Clause ".

Articles 110 to 122 deleted and Articles substituted

12. That part of the Articles headed "PROFITS AND DIVIDENDS" (comprising that heading and Articles 110 to 122 inclusive) is deleted and the following Part is substituted —

"

INCOME AND PROPERTY

110. No part of any income or property of the Company shall be, directly or indirectly, paid or transferred as a profit, by way of a dividend or bonus or otherwise, to any shareholder.

111. All the income and property of the Company shall be applied towards the objects of the Company as set out in the Memorandum of Association and not otherwise.

112. The Directors may set aside out of the profits of the Company such sums as they think fit as reserves for application, in the discretion of the Directors, in meeting contingencies or in achieving any other purpose that is, under the Memorandum of Association or these Articles, a proper purpose for the application of the profits of the Company.

113. Where any reserves set aside pursuant to Article 112 are not immediately required for application in accordance with that Article, they may, in the discretion of the Directors, be applied in the business of the Company or in furthering the objects of the Company as set out in the Memorandum of Association, paying off or reducing some or all of its debentures for the time being outstanding, or liquidating any other indebtedness of the Company, or they may be invested in such investments as the Directors think fit.

114. If the Company is wound up and any surplus assets remain after payment of its debts and liabilities and the costs of winding up and repaying to shareholders the capital paid upon those shares, those surplus assets shall not be distributed amongst the shareholders, but shall be distributed or applied in such other manner as shall be determined by the liquidator, subject to prior confirmation from the Commissioner of Taxation that the distribution complies with the requirements of section 23 (h) of the *Income Tax Assessment Act 1936*, or the equivalent section or sections in the then prevailing income tax legislation.

ENVIRONMENTAL PROTECTION ACT 1986

**ENVIRONMENTAL PROTECTION (LIQUID WASTE) AMENDMENT
REGULATIONS 1997**

Made by His Excellency the Governor in Executive Council on the recommendation of the Authority.

Citation

1. These regulations may be cited as the *Environmental Protection (Liquid Waste) Amendment Regulations 1997*.

Principal regulations

2. In these regulations the *Environmental Protection (Liquid Waste) Regulations 1996** are referred to as the principal regulations.

[* Published in Gazette 7 June 1996, pp. 2335-70.]

Regulation 2 amended

3. Regulation 2 of the principal regulations is amended by deleting paragraph (a) of the definition of "liquid waste".

Regulation 10 amended

4. Regulation 10 of the principal regulations is amended by inserting after subregulation (1) the following subregulation —

“

(1a) If the holder of a licence or certificate of registration has been charged with an offence under the Act relating to the transport or disposal of liquid waste or an offence under these regulations, the Chief Executive Officer may suspend the licence or certificate of registration until the charge in respect of the offence has been finally dealt with or determined according to law.

”

Regulation 12 amended

5. Regulation 12 (2) of the principal regulations is repealed and the following subregulation is substituted —

“

(2) In subregulation (1) —

“liquid waste” does not include waste —

- (a) that is discharged under a licence under Part V of the Act;
- (b) from an apparatus for the treatment of sewage; or
- (c) from a grease trap or oil interceptor on the premises of a registered occupier.

”

Regulation 24 amended

6. Regulation 24 of the principal regulations is amended by inserting after subregulation (3) the following subregulation —

“

(4) It is a condition of each licence authorizing a driver to collect and transport liquid waste from a grease trap or oil interceptor that the driver is to comply with the Code of Practice published by the Chief Executive Officer, as amended from time to time, on the collection and transport of that liquid waste.

”

Regulation 33 amended

7. Regulation 33 of the principal regulations is amended —

- (a) by inserting after the regulation designation “33.” the subregulation designation “(1)”;
- (b) by deleting paragraph (e) and substituting the following paragraph —

“

- (e) such other equipment, system or modifications as the Chief Executive Officer may require as a condition of registration of the vehicle or under regulation 33A.

”; and

- (c) by inserting the following subregulation —

“

(2) Nothing in subregulation (1) (e) limits the power of the Chief Executive Officer at any time —

- (a) under regulation 6 to impose, add to, change or remove conditions upon a certificate of registration in respect of equipment, systems or modifications; or

- (b) under regulation 33A to require a carrier to install a system referred to in that regulation.

Regulation 33A inserted

8. After regulation 33 of the principal regulations the following regulation is inserted —

“

Equipment to be installed and maintained

33A. (1) The Chief Executive Officer may by written notice require a carrier —

- (a) to install in a vehicle of the carrier that is used, or proposed to be used, for the transport of liquid waste, a system specified in the notice that is capable of transmitting to the Chief Executive Officer at any time accurate information as to —
- (i) the geographic position of the vehicle; or
- (ii) the level of liquid waste in the vehicle's tank,
- or both of those matters; and
- (b) to have the system serviced by an approved service agent at intervals specified in the notice.

(2) A carrier who fails to —

- (a) install a system in accordance with a requirement under subregulation (1) (a) within the period specified in the notice of requirement;
- (b) service the system as required under subregulation (1) (b);
- (c) maintain the system in good working order; or
- (d) ensure that the system is operating effectively at all times,

commits an offence.

(3) A carrier who collects or transports liquid waste in a vehicle —

- (a) in which a system required to be installed under subregulation (1) is not in good working order or is not operating effectively; and
- (b) in respect of which a permit issued under subregulation (8) is not in effect,

commits an offence.

(4) A driver who —

- (a) wilfully damages, destroys or removes a system installed under subregulation (1); or
- (b) collects or transports liquid waste in a vehicle —
- (i) in which a system required to be installed under subregulation (1) is not in good working order or is not operating effectively; and
- (ii) in respect of which a permit issued under subregulation (8) is not in effect,

commits an offence.

(5) In proceedings for an offence against subregulation (2) (c) or (d), (3) or (4) (b) it is a defence for the person charged to prove that that person did not know and could not reasonably be expected to have known that the system was not in good working order or was not operating effectively, as the case requires.

(6) If data received at the approved central base station for a system installed under subregulation (1) indicates that the system is not operating effectively, the Chief Executive Officer is to suspend the registration of the vehicle in which the system is installed for a such period and on such conditions as the Chief Executive Officer thinks fit.

(7) Despite regulation 10, the Chief Executive Officer is not required to give the relevant carrier written notice of a proposal to suspend registration under subregulation (6) or the reasons for the proposal, and the suspension takes effect when written notice of the suspension is given to the carrier.

(8) The Chief Executive Officer may give written permission to a carrier to collect and transport liquid waste in a vehicle in which a system installed under subregulation (1) is not in good working order or is not operating effectively.

(9) A permit issued under subregulation (8) may be —

- (a) subject to such conditions as the Chief Executive Officer specifies in the permit; and
- (b) revoked or varied by the Chief Executive Officer.

(10) If a condition to which a permit issued under subregulation (8) is subject is breached, the permit ceases to be of effect.

”.

Regulation 34 amended

9. Regulation 34 (1) of the principal regulations is repealed and the following subregulation is substituted —

“

(1) In addition to the grounds specified in regulation 10, the Chief Executive Officer may cancel, suspend for a fixed period or refuse to renew a certificate of registration of a vehicle if —

- (a) modifications relating to any of the matters referred to in regulation 33 (a) to (e) are made to the vehicle without the approval of the Chief Executive Officer;
- (b) a system required to be installed in the vehicle under regulation 33A —
 - (i) is not installed as required under that regulation; or
 - (ii) is not serviced as required under that regulation; or
- (c) the vehicle, any of the equipment, or a system required to be installed under regulation 33A, on the vehicle, is not maintained in good working order.

”.

Regulation 38 amended

10. Regulation 38 (1) of the principal regulations is amended by inserting after “regulation 14” the following —

“ or a condition imposed on a licence under Part V of the Act ”.

Regulation 39 amended

11. Regulation 39 (1) of the principal regulations is amended —

- (a) in paragraph (a) —
 - (i) by deleting “(4)” and substituting “(5)”; and
 - (ii) by deleting “(3)” and substituting “(4)”;
and
- (b) in paragraph (b) by deleting “(4)” and substituting “(5)”.

Regulation 45 amended

12. Regulation 45 (4) of the principal regulations is amended by deleting “use” and substituting the following —

“ re-use ”.

Regulation 46A inserted

13. After regulation 46 of the principal regulations the following regulation is inserted —

“

Conditions of Part V licence for premises discharging liquid waste

46A. For the purposes of section 62 (1) (h) of the Act the Chief Executive Officer may specify as a condition of a licence under Part V of the Act held by an occupier of premises from which liquid waste is discharged that the occupier must ensure that —

- (a) the liquid waste is discharged in a condition that is suitable for transport and disposal, and for that purpose must ensure that —
 - (i) hexavalent chromium is converted to trivalent chromium (with a total hexavalent chromium in the discharged waste not exceeding 100 milligrams per litre);
 - (ii) the liquid waste is neutralized to within the pH range 2.5 to 12;
 - (iii) free cyanide is oxidized to a level not greater than 5 milligrams per litre; and
 - (iv) the liquid waste does not contain any flammable material (petrol or solvents) with a flash point greater than 61 degrees centigrade;
- (b) waste oils and solvents are collected separately for re-use;
- (c) the disposal of the liquid waste from the premises at a disposal site is booked, at least 3 days in advance, with the operator of the disposal site;
- (d) the liquid waste is removed from the premises during normal business hours, Monday to Friday, and at no other time;
- (e) the Chief Executive Officer is notified immediately if liquid waste of a category other than a category specified in the licence is discharged from the premises;
- (f) each collection tank on the premises —
 - (i) has an identification plate, or is part of a group of collection tanks with an identification plate, issued by

the Chief Executive Officer and endorsed with a number allocated to it or to the groups by the Chief Executive Officer; and

- (ii) has attached to it, or in close proximity to it in a place that is clearly visible, the identification plate issued for that collection tank or group of tanks;
- (g) liquid waste is not placed in a collection tank on the premises if the liquid waste is of a category other than a category specified in the licence (unless the Chief Executive Officer has otherwise approved).

”

FIREBREAK REGULATIONS

Notice to All Owners and/or Occupiers of Land in the Shire of Dumbleyung

Pursuant to the powers contained in Section 33 of the above Act, you are hereby required on or before the 1st day of November 1997 or within 14 days of the date of your becoming Owner or Occupier should this be after the 1st day of November 1997 and thereafter up to and including the 31st day of March 1998 to have a fire break clear of all inflammable material on—

1. RURAL LAND

- (a) Boundary firebreaks at least 3 metres wide shall be cleared of all inflammable material immediately inside all external boundaries of the land and immediately inside boundaries which adjoin cleared roads.
- (b) Internal firebreaks at least 3 metres wide shall be cleared of all inflammable material divided into lots no greater than 300 ha of crop and/or pasture.
- (c) Firebreaks at least 3 metres wide shall be cleared of all inflammable material parallel to a 20 metre distance from boundaries which adjoin railway reserves.
- (d) Building/Structure firebreaks at least 3 metres wide shall be cleared of all inflammable material at a distance of 20 metres from the perimeter of all haystacks and buildings, or groups of buildings and haystacks and fuel storage areas and shall completely encircle such buildings and haystacks.
- (e) The area between the buildings and haystacks and the firebreak mentioned in (d) above shall be cleared of all inflammable material by the 15th day of December 1997.
- (f) On Farm Grain Depots or Bunkers requirements for approval—
 1. All inflammable material for a radius of 50 metres of where trucks, loaders and engines are operating, be cleared
 2. The bunker or depot must be immediately adjacent to the farm's main access road and/or shed areas.
 3. The bunker or depot must be inspected by a local FCO before the 1st November each year and a fee of \$100 be paid to the Shire Officer—after which the registration will be listed.
 4. During loading or unloading there must at all times be an approved mobile fire fighting unit (see Item 4) on hand, during harvest and movement of vehicles in paddock bans. This unit must escort the truck onto and off the property.

NOTE: Firebreaks need not follow the perimeter of any paddock, but may follow contours.

2. TOWN LAND

- (a) Where the land is .40 hectares or less all inflammable material on the land shall be removed from the whole of the land.
- (b) Where the land exceeds .40 hectares in area, firebreaks at least 1.829 metres wide shall be cleared of all inflammable material immediately inside all external boundaries of the land and also immediately surrounding all buildings situated on the land.

If the requirements of this notice are carried out by burning, such burning must be carried out in accordance with the relevant provisions of the Bush Fires Act. "Inflammable Material" does not include green growing trees or green growing plants, or lawns in gardens.

3. GENERAL

If for any reason it is considered by the owner or occupier of land, that it is impractical to comply with the requirements of this notice a request may be made to the Council Officers not later than 1st September 1997.

Where approval of a proposed variation is not granted by Council you shall comply with the requirements of this notice.

The penalty for non-compliance with this notice is a maximum of \$1,000 and notwithstanding prosecution, Council may enter on the land and carry out the requisite works at the owner/occupiers expense.

4. HARVESTING OPERATION**MOBILE FIRE FIGHTING UNIT**

Pursuant to the power under the Bush Fires Act 1954 it is compulsory that an operational mobile engine powered fire fighting pump unit with not less than 450 litres of water be in attendance during grain harvesting operations.

Fire fighting units mounted on trailers must be connected to a towing vehicle at all times.

5. TRACK CHAINING OR ROCK WINDROWING

Mobile fire fighting unit as defined in Item 4 is to be in attendance during track chaining/rock windrowing operations through the period of 1st November to 30th April each year.

A person shall not operate any harvesting machine or header in any crop during the prohibited burning times or the restricted burning times, unless a fire extinguisher is carried on the machine.

Notice to Owners and Occupiers of land within the Shire of Kojonup 1997-98

Pursuant to the powers contained in Section 33 of the above Act, you are hereby required to have firebreaks clear of all inflammable material, in the position, of the width, and for the period as specified hereunder.

1. URBAN LAND (Land within a townsite)

During the period from the 15th December to 31st May inclusive, you still have firebreaks in the following positions—

- 1.1 On land which is 4000 square metres or less in area, you shall remove all inflammable material from the whole of the land.
- 1.2 On land which exceeds 4000 square metres (one acre) in area as per item 2.1 hereunder.
- 1.3 However, owners of property with an area greater than 4000 square metres that boundaries a developed residentially zoned property, must install 2.4 metre wide boundary firebreak on their land abutting that residential property.

2. RURAL LAND—

HOMESTEADS, BUILDINGS, HAYSTACKS, BULK FUEL, DRUMS AND LIQUID PETROLEUM.

- 2.1 During the period from 15th December, to the 31st May inclusive you shall have fire breaks at least 20 metres wide, if provided by burning, cultivating or spraying or 60 metres wide, if provided by being closely grazed or mowed to the satisfaction of a Bush Fire Control Officer in such positions as are necessary to completely surround the perimeter of any homestead building (excluding isolated non flammable buildings) fuel installation (including drums), hay stack (but only haystacks within 100 metres of any building) or group of such structures or installations. In each case the outer 2.4 metres of an area must be totally free of any inflammable material and where mowing is the method used all residue of the mowing process must be removed from the area.

NOTE

Boundary firebreaks are not compulsory within the Shire of Kojonup Rural Area. Land holders can provide fire breaks if they wish.

GENERAL INFORMATION:

If its considered impractical for any reason to clear firebreaks on the land as required by this notice you may apply to Council or its duly authorised officer for permission to provide firebreaks in alternative positions or take alternative action to abate fire hazards on the land. If permission is not granted by Council or its duly authorised officer you shall comply with the requirements of this notice.

PLEASE NOTE: Following the method adopted by Council to inspect the firebreaks required in this notice, it is not necessary for Council to notify you or give you any prior warning that legal action may proceed for failing to comply with the requirements of this notice.

The penalty for failing to comply with this notice is a fine of not less than \$80 and a person in default is also liable, whether prosecuted or not to pay the cost of performing the work directed in this notice if it is not carried out by the required date.

HARVESTING: As per the Bush Fires Act it is now compulsory that an engine powered pumping unit and not less than 400 litres of water be in attendance during grain harvesting operations. Trailed units must have the towing vehicle attached at all times. Fire fighting unit must be adjacent to paddock being harvested at all times.

SWATHERS AND BALERS: are subject to the same conditions as **HARVESTING**, ie; an engine powered pumping unit and not less than 400 litres of water be in attendance during operations from 1st December.

OXYACETYLENE, Arc welders, friction cutting equipment (whilst used in the open) are subject to the same conditions as swathers and balers, and that in addition, the worksite, be adequately cleared of flammable material prior to the use of the above mentioned equipment.

PLEASE NOTE: The Bushfire Advisory Committee recommends the prior installation of a preliminary chemical firebreak around your house and sheds and also around the 20 metre boundary mark to burn your break from/to. This practice will help reduce the number of protective burns which escape. The chemical break should be installed in June, or thereabouts, however, annual seasonal conditions should be considered.

4. Rezoning Pt. Lot 41 of Cockburn Sound Location 16 from "Rural" to "Centennial Park Development Zone," "Local Recreation" and "District Recreation," as shown on the accompanying amendment map.

5. Inserting the following new clauses in the Scheme Text.

4.8 Centennial Park Development Zone

- 4.8.1 The primary purpose of the Centennial Park Development Zone is to provide for regional transportation requirements, future residential, urban-related and peri-urban development after comprehensive planning has been carried out for the relevant areas provided that this conforms with any regional structure plans and policies of the Western Australian Planning Commission and any local structure plans, planning policies and retail strategy adopted by the Council.

- 4.8.2 Generally, uses within the Centennial Park Development Zone shall be in accordance with those identified on the approved Outline Development Plan and the associated technical guidelines adopted by Council. More particularly, the specified uses permitted within each general use classification shall conform with the permitted uses and development standards set out in the Centennial Park Development Standards Table. Where a use permitted under the Outline Development Plan is not mentioned in the Centennial Park

Development Table, it shall conform with the requirements set out in the other Zoning and Development Tables of the Scheme for the equivalent zoning.

- 4.8.3 Where alternative permitted uses and development standards are adopted as part of an Outline Development Plan and Technical Guidelines, those permitted uses and development standards shall apply.
- 4.8.4 Council may adopt an Outline Development Plan with or without modifications over the whole or portion of the zone.
- 4.8.5 The Outline Development Plan shall include—
 - (i) the overall layout and identification of land uses;
 - (ii) the proposed major road system;
 - (iii) the location of community and recreation facilities;
 - (iv) the proposed staging of development;
 - (v) the Residential Planning Code which shall apply to the appropriate areas of land;
 - (vi) a report to support and outline the location and layout of the plan; and
 - (vii) such other information as the Council may require.
- 4.8.6 Within the Centennial Park Development Zone, subdivision shall be generally in accordance with the Outline Development Plan, or any variation approved by the Western Australian Planning Commission.
- 4.8.7 Within the Centennial Park Development Zone, approval to development shall not be determined by Council until the Outline Development Plan and any associated Technical Guidelines have received approval from both the Council and the Western Australian Planning Commission.
- 4.8.8 Prior to determining non-residential land use applications so provided within an Outline Development Plan where a proposal is strictly not in accordance with the terms, conditions and provisions of an approved Outline Development Plan or the Technical Guidelines attached thereto, Council will be required to advertise and deal with the proposal set out in Clause 6.2.
- 4.8.9 All development shall accord with an approved Outline Development Plan and Technical Guidelines.
- 4.8.10 The Outline Development Plan, together with any modifications when adopted by the Council and approved by the Western Australian Planning Commission, shall be kept available at the office of the Council for inspection by any interested person to the same extent as the documents forming part of this Scheme.
- 4.8.11 An Outline Development Plan may be modified by such means as the Council deems appropriate, provided that any modification which, in the opinion of the Council and the Western Australian Planning Commission, is substantial, shall be dealt with by procedures similar to those for the approval of the Plan.
- 4.8.12 Any applicant aggrieved by a decision of the Council or the Western Australian Planning Commission in regard to the approval or amendment of an Outline Development Plan shall have a right of appeal pursuant to the provisions of Part V of the Act.
- 4.8.13 Notwithstanding the specific provisions relating to the Centennial Park Development Zone, the following shall apply to development of land in that Zone, and shall be addressed in the Outline Development Plan and Technical Guidelines required under sub-clause 4.8.7—
 - a) The Outline Development Plan should include provisions for visual and acoustic buffering between residential areas and major regional transport routes;
 - b) Commercial centres shall be provided for in the general location as indicated on the Outline Development Plan adopted by Council. The exact location and area to be included in these centres shall be subject to detailed design and shall be included in any Development Plan. The Commercial centres shall be in the form of—
 - one District Shopping Centre of 19,500m² net lettable retail floorspace.
 - Local Shopping Centres with a combined total of 3,000m² net lettable retail floorspace.
 - c) The assessment of the significance and conservation value of remnant vegetation, and inclusion in appropriate reserves or imposition of suitable conservation controls.
 - d) Have regard to the impact of development on wetlands and that appropriate wetland buffers and stormwater drainage management techniques (i.e. sediment/nutrient traps) are employed.
 - e) Proposals relating to wetlands shall be referred to the Department of Environmental Protection for advice.
 - f) Regard shall be had to the impact of groundwater extraction and approval of the Water Corporation of WA.
 - g) Regard shall be had to the impact of the proposal on groundwater quality and quantity and the employment of water sensitive design techniques.

- h) A dual use path system shall be designed with provision of facilities for bicycling in accordance with the WAPC Policy No. DC 1.5 (Bicycle Planning); WAPC Policy No. DC 2.6 (Residential Road Planning) and "Bikewest Guidelines for the Design of Bicycle Facilities."
- i) The provision of community facility sites in accordance with the policy of the Western Australian Planning Commission.
- j) Within the Centennial Park Development Zone, all residential development shall conform with the density codings shown on the approved Outline Development Plan, or any modification approved in accordance with the Scheme.
- k) Assessment of Aboriginal Heritage Sites.
- l) Assessment of impact on water catchment areas (where applicable) including; soil erosion effects such as sedimentation, tree decline, soil acidity and salinity, declining soil structure and fertility, turbidity and pollution;
- m) The impact of the proposal on waterbirds shall be assessed with regard to—
 - species diversity and richness of migratory and endemic waterbirds;
 - adequacy of foreshore reserves;
 - disturbance of wildlife by noise, light, water quality impacts, increased predation by introduced fauna etc; and
 - maintenance of ecosystem and habitat.
- n) Notwithstanding the requirements in the preceding paragraphs of this sub-clause, the Council may request that an Outline Development Plan provide such other additional information it considers appropriate.
