Persons who fail to comply with the requirements of this order may be issued with an infringement notice or prosecuted with an increased penalty, and additionally, Council may carry out the required work at a cost to the owner or occupier.

Definitions—

For the purpose of this order the following definitions apply—

"Firebreak" means ground from which all flammable material has been removed and on which no flammable material is permitted to accumulate during the Prohibited and Restricted Burning Periods.

"Fuel Free Zone" means the removal of dead grass, leaf litter, trash and understorey bush.

"Greenbelt Area" means all rural and urban land located west of-

- (i) Minninup Road—from the northern boundary of the Shire of Capel to the junction of Minninup Road and Fishermans Road.
- (ii) The unmade portion of Minninup Road—from the junction of Minninup Road and Fishermans Road to its junction with Mangles Road.
- (iii) Mangles Road—from its junction with the unmade portion of Minninup Road in (ii) south to its junction with Roberts Road.
- (iv) Roberts Road—from its junction with Mangles Road West to its junction with Mallokup Road.
- (v) Mallokup Road—from its junction with Roberts Road South to its junction with Ludlow North Road.
- (vi) Ludlow North Road—from its junction with Mallokup Road South to the Southern Boundary of the Shire of Capel.

"Ilaystack" means any collection of hay including fodder rolls placed or stacked together.

"Low Fuel Zone" means the removal of dead grass, dead trees, leaf litter and trash.

"Plantation"-

- (i) Λ Plantation is any area of planted pines or eucalyptus species exceeding 3 hectares in area.
- (ii) A windbreak is planted area a maximum of 15 metres wide but with no defined length. Minimum Fire Hazard Removal Requirements
 - A. Rural Land (All land other than land described below)—
 - Firebreaks at least 2 metres in width and not more than 20 metres from the perimeter of all buildings and haystacks situated on the land so as to completely surround the buildings and haystacks.
 - 2. Firebreaks at least 2 metres in width immediately inside and along all external boundaries so as to form a continuous break all around the holding except where an exemption has been granted (Roadside firebreaks do not constitute a legal firebreak under the Bush Fires Act.)

- 3. Lessees of Railway Reserves shall have a firebreak at least 3 metres in width along the common boundary between the land leased from Westrail and other land owned or occupied.
- 4. When such land abuts a residential or special residential area such land shall have a three (3) metre wide firebreak along the common boundary between such land and the residential or special residential area.

B. Special Rural Land

The owners of all existing small Rural holdings zoned as Special Rural land under Town Planning Schemes must maintain clear of all flammable material, a firebreak not less than 2 metres inside all external boundaries of land and a 20 metre wide low fuel zone around all buildings on the land.

On the vertical plane on the side of the firebreak the trees are to be pruned to a minimum height of 5 metres.

C. Special Rural Lots—Part Boyanup AA Lot 157, Gelorup (Ramblewood Stage 4)

Lots 66, 68, 70, 71, 72, 73, 74 and 77 of Part Boyanup AA Lot 157 are required to maintain the 5 metre wide strategic firebreak that is on the land. On lots 66 to 68 and lots 70 to 77 of Part Boyanup AA Lot 157 which have buildings situated on them, a 20 metre wide fuel free zone is required around all buildings.

- D. Urban Land (Residential, Commercial and Industrial land within a townsite or within any area subdivided for residential purposes, including Gelorup)—
 - 1. Where the area of land is 2 000 m² or less, remove all flammable material on the land except living standing trees from the whole of the land.
 - 2. Where the area of land exceeds 2 000 m², but not more than 5 000 m²—
 - (a) A 2 metre wide firebreak is required immediately inside all external boundaries of the land. On the vertical plane on the side of the firebreak the trees are to be pruned to a minimum height of 3.5 metres or
 - (b) Remove all flammable material (including ground fuel build up) on the land by either slashing, grazing or burning.
 - 3. Where the area of land exceeds 5 000 m² a firebreak not less than 2 metres wide inside all external boundaries of the land and a 20 metre wide low fuel zone around all buildings on the land is required.

On the vertical plane on the side of the firebreak the trees are to be pruned to a minimum height of $5\ \mathrm{metres}$.

- E. Greenbelt Area: A 2 metre wide firebreak is required on the west side of the roads defining the "Green Belt" area, unless an exemption has previously been granted.
- F. Peppermint Grove Townsite: All land situated within Peppermint Grove Townsite are exempt from the order to install a firebreak, but Council does retain the right to remove any fire hazard at the owner and/or occupier's expense following the failure of an owner and/or occupier to comply with the requisition of an order in writing to clear a fire hazard or firebreak in accordance with section 33 of the Bush Fires Act.
- G. Plantations—

Boundary Firebreaks-

On the horizontal plane a firebreak shall be provided 15 metres wide and immediately adjoining all external boundaries of the planted area. The outer 10 metres will be cleared of all flammable material while the inner 5 metres, i.e. that portion closest to trees may be kept in a reduced fuel state, i.e. by slashing or grazing grass provided that the height of the grass does not exceed 8cm.

On the vertical plane a clear space 4 metres high will be maintained above outer 10 metres of the firebreak.

Internal Firebreaks—

Plantations shall be subdivided into areas not exceeding 30 hectares by firebreaks 6 metres wide which shall be cleared of all flammable material. In the vertical plane a clearance of a minimum height of 4 metres from the ground level will be maintained above the firebreak.

Special Risks-

(i) Public Roads and Railway Reserves—

Firebreaks 15 metres wide shall be maintained where a planted area adjoins public roads and railway reserves. The specification will be as for "Boundary Firebreaks" on planted areas.

(ii) Powerlines—

Firebreaks shall be provided along powerlines where they pass through or lie adjacent to planted areas. The specification of the width and the height of clearing shall be in accordance with State Energy Commission of Western Australia specifications.

Fuel and/or Gas Depots-

In respect of land owned or occupied by you on which is situated any container normally used to contain liquids or gas fuel, including the land on which any ramp or supports are constructed, you shall have land clear of all flammable materials.

Firebreak Variations-

If it is considered impractical for any reason to clear firebreaks or remove flammable materials from the land as required by this notice, you may make written application and include a plan of your land detailing your fire prevention measures to the Council or its duly authorised Officer, no later than the 31st day of October, 1997 for—

- (i) Permission to provide firebreaks in alternative positions or take alternative action to abate fire hazards on the land,
- (ii) an exemption from the requirement to provide firebreaks for either a twelve month or a five year period.

This application must be countersigned by the Bush Fire Control Officer for the area in which the land is situated to signify his agreement to the variation. If permission is not granted by the Council or its duly authorised Officer, you shall comply with the requirements of this order.

Campfires-

Camp fires are totally banned within the whole of the Shire during the prohibited burning period, except in recognised camping and picnic areas where properly constructed facilities exist.

Fire Hazard Reduction Notice 1997/1998

Notice to Owners and/or Occupiers of Land within the Shire of Nannup

All owners and occupiers of land in the Shire of Nannup are required to carry out fire prevention work on land owned or occupied by you in accordance with the provisions of this order.

This work must be completed by-

1st December, 1997, in townsites,

15th December, 1997, in rural areas.

This work must be maintained throughout the summer months until the close of the restricted burning period in 1998.

A copy of this notice, including additional information and a list of Fire Control Officers, appears in Council's Information Booklet which is enclosed with all rate notices.

1. ALTERNATIVE MEASURES

- (a) If it is considered impractical for any reason, to clear firebreaks or remove inflammable material, as required by this notice, you may apply to the Council by no later than the 1st November each year for permission to provide firebreaks in alternative positions or take alternative measures to abate the fire hazards on the land. Any such application must bear the signature of the Fire Control Officer for the area signifying this agreement to this variation. If permission is not granted, you shall comply with the requirements of this Notice. Applications for alternative measures must be renewed each year.
- (b) Strategic Firebreak Plans submitted by a Bush Fire Brigade must be agreed to at a properly constituted Bush Fire Brigade Meeting. Brigade Strategic Firebreak Plans, Amendments and Renewals must be submitted to Council by 31 August each year. Plans must be approved by Council's Bush Fire Advisory Committee and ratified by Council. Brigade Strategic Firebreak Plans must be renewed, as above, each year.

2. MINIMUM STANDARDS

The requirements of this order are considered to be the minimum standard of fire prevention work required to protect not only individual properties but the district generally. In addition to this order Council may issue special orders to owners/occupiers if hazard removal is considered necessary in some specific areas.

3. PENALTIES

Persons who fail to comply with the requirements of this notice may be issued with an infringement notice fine of \$80.00 or prosecuted with an increased maximum fine of \$1,000.00. Council may also carry out the required works at the owner/occupier's expense.

4. INSPECTIONS

Inspections of Firebreaks and hazard reductions will be carried out by an authorised officer on or after the specified work completion dates.

5. CONTIGUOUS HOLDINGS

Contiguous holdings of land which are owned and/or occupied by the same owner or occupier shall be treated as one holding of land for the purpose of this notice.

6. FIRE HAZARDS

Where in the opinion of an Authorised Officer or the Area Fire Control Officer the land contains an amount of inflammable material which is considered hazardous, the land owner shall clear such hazard upon service of a notice requiring such works to be carried out.

7. YOUR RESPONSIBILITY

(i) Rural Land

- (a) For the purposes of this Order rural land means all land located within the Shire of Nannup that is zoned rural pursuant to Council's Town Planning Scheme, however, does not include land being used for commercial plantation purposes.
- (b) Firebreaks clear of all inflammable material not less than 2 metres wide shall be constructed inside and within 20 metres of the boundary of each property where land adjoining that boundary is predominantly pasture or crops.
- (c) Trafficable firebreaks clear of all inflammable material and not less than 3 metres wide shall be constructed inside and within 20 metres of the boundary of each property where the land adjoining that boundary is predominantly trees, bush or scrub.
- (d) Firebreaks not less than 2 metres wide shall be constructed within a perimeter of 20 metres of all homesteads, buildings, haystacks and fuel storage areas on the land.

(ii) Special Rural Land

- (a) Special Rural land means rural holdings of land within the Shire of Nannup zoned as Special Rural under the Shire's Town Planning Scheme.
- (b) Firebreaks clear of all inflammable material not less than 2 metres wide shall be constructed inside and within 6 metres of the boundary of each property where land adjoining that boundary is predominantly pasture or crops.
- (c) Trafficable firebreaks clear of all inflammable material and not less than 3 metres wide shall be constructed inside and within 6 metres of the boundary of each property where the land adjoining that boundary is predominantly trees, bush or scrub.
- (d) All inflammable material except for live standing trees and live garden plants shall be cleared within a 20 metre radius of all buildings.
- (e) Where a special rural subdivision is protected by strategic firebreak measures it shall be the responsibility of all landowners abutting the strategic firebreaks to maintain that portion of the firebreak which adjoins the boundary of their property, or runs through their property.

(iii) Urban Land

- (a) Urban land means land within the Shire of Nannup which is within the townsite or is within any area which is sub-divided for residential purposes.
- (b) Where the area of land is less than or equal to 2024m² (approx. 0.5 acre) all inflammable material shall be removed from the whole of that land, with the exception of live, standing trees and live garden plants.
- (c) Where the area of land exceeds 2024m² (approx. 0.5 acre) firebreaks not less than 2 metres wide shall be constructed inside and within 6 metres of the external boundaries of the land
- (d) All inflammable material except for live standing trees and live garden plants shall be cleared within a 20 metre radius of all buildings.

(iv) Plantations

- (a) A plantation is any area of planted pine trees or eucalyptus species exceeding 3 hectares.
- (b) All plantations require Planning Approval from Council prior to development. Council may require plantation fire protection measures to be fulfilled as a condition of Planning Approval.
- (c) Firebreaks not less than 15 metres wide, shall be constructed on the boundaries of plantations or on such alternative location as may be agreed between the Local Government Council and the plantation owner.

Boundary firebreaks shall consist of area 15 metres wide cleared of all flammable material and—

- * the outer 10 metres having no overhanging tree branches for a vertical clearance of at least 10 metres.
- * trees may not be planted closer than 15 metres to the outer edge of the firebreaks.
- (d) Internal firebreaks clear of all inflammable material and not less than 6 metres wide shall be constructed surrounding compartments of approximately 30 hectares.

All internal firebreaks must be maintained in a trafficable condition and trees on both sides of the breaks progressively pruned to a minimum height of 4 metres to allow unrestricted access to maintenance and fire fighting equipment and so as to maintain an effective width of firebreak.

- (e) Where power lines pass through, or near plantation areas, additional obligations are required by the state power authority. Plantation owners and/or managers should consult Western Power for advice on their responsibilities.
- (v) Camp Fires—

(Bush Fires Act Section 25 (1a), (1aa), (1b), (1c), (1d) and (2)).

- (a) Lighting of fires in the open air for the purpose of camping or cooking is prohibited in the Shire of Nannup during the prohibited burning period each year.
- (b) Areas which are set aside for cooking by the State Authority or Local Authority responsible for the care, control or management of the land are excluded from Clause 7 (v)(a) above providing properly constructed cooking facilities are provided.
- (c) The provisions of Section 25 (1c) and 25 (1aa) of the Bush Fires Act 1954 shall be complied with in relation to a fire lit pursuant to Clause 7 (v)(b) above.

Each year, Council forwards a copy of this Order and other fire information to all owners/occupiers. The Fire Break Notice is also published in the local newspaper/s and additional copies are available from the Shire Offices, 15 Adam Street, Nannup.

(2) Lot Sizes

In considering development and subdivision, Council shall recommend a minimum lot size of two hectares. The average lot size should conform to the recommendations of the Shire of Chittering Local Rural Strategy;

(3) Tree Preservation Areas

Tree Preservation areas shall be defined on the Development Plan.

In the areas identified for the preservation of trees, no clearing shall be permitted outside the designated building envelope on the Development Plan.

Council may require a land owner, as a condition of building approval, to commence tree planting to its specification, and to maintain those trees for a period of not less than two summer seasons;

(4) Building Envelopes

Building enveloped shall be defined on the Development Plan and shall not exceed 1000m² without prior approval of the Council and on the advice of the Bush Fires Board;

(5) Fencing

No side or rear boundary fences shall be permitted in tree preservation areas or stocking restriction areas identified on the Development Plan.

Within this restrictive fencing area, Council may permit the construction of a fence around the building envelope;

(6) Crossovers

Council may request, as a condition of subdivision, the construction of crossovers to each lot on accordance with Council's specifications;

(7) Potable Water

Each dwelling shall have a water supply from roof catchment of a minimum of 120,000 litres, of which 10,000 litres shall be kept in reserve for fire fighting purposes;

(8) Land Management

Any remedial or new works depicted on the Development Plan for the purpose of water catchment and management shall be implemented prior to subdivision.

The maintenance of any swales and associated tree planting shall be the responsibility of the owner/occupier;

(9) Dams and Water Courses

The construction of dams and the extraction of surface water is not permitted without the approval of the Council, Water Corporation and Agriculture WA;

(a) Specified Areas or Localities (b) Special Provisions to refer to Special Rural Zones

(10) Fire Control

Strategic Fire Breaks as shown on the Development Plan, shall be constructed by the developer and maintained to the satisfaction of the Council and the Bush Fires Board.

(11) Effluent Disposal

The Development Plan shall depict areas where conventional septic tanks may not be suitable. In these areas, Alternative On-Site effluent Disposal Systems areas shall be limited to high performance environmental systems acceptable to the Council and the Health Department;

(12) Permitted Uses

Single Residence Additional Accommodation

Recreation Home Occupation

No more than one single dwelling per lot shall be permitted.

(13) Domestic Pets

The keeping of domestic cats shall be prohibited.

(14) Stocking Restrictions

The Development Plan shall depict areas for grazing. Stocking rates for those lots specified for grazing in part or in whole shall be determined by Agriculture WA and the Council.

The prior approval of Council is required for the keeping of any grazing animal on a lot.

If, in the opinion of the Council, any lot is overgrazed or constitutes land degradation, it may order the removal of any or all stock, either temporarily or permanently, until the remedial works are carried out by the landowner to render the land stable.

The keeping of pigs, horses or goats is not permitted.

(15) Landscape Buffer Strip

A 100 metre wide landscape buffer along Blue Plains Road shall be depicted on the Development Plan and be established by the developer prior to subdivision.

Maintenance of the landscape buffer shall be the responsibility of the owner/occupier of those affected lots, to the satisfaction of the Council.

(16) Drainage Easements

Where an easement for land drainage traverses a lot, the owner/occupier of that lot shall maintain that drainage line in accordance with the requirements of the Council.

(17) Vendor Responsibility

The developer/vendor shall inform prospective purchasers of the lots, in writing, of the provisions of the Council's Town Planning Scheme relating to the management of the land. PD408*
